Senator C. WILLIAMS. Madam President, warmer weather means trips to the beach, vacations with the family, opportunities to work in the yard or in the garden, and a chance to enjoy beautiful sunny days. It also means greater exposure to skin cancer, which can be caused by exposure to harmful ultraviolet rays. Melanoma, the deadliest skin cancer, affects more than 58,000 Americans annually, and about 8,000 will die. It is the fastest-growing cancer and will affect 1 in 50 Americans by the year 2010. The statistics for this kind of cancer are truly alarming. Melanoma is the most common cancer in young adults ages 20 to 30. There are currently more cases of melanoma than HIV/AIDS. Melanoma is the primary cause of cancer deaths in women age 25 to 30, and the second leading cause of death after breast cancer in women age 30 to 35. Melanoma has the fastest-growing incident rate of all cancers in the United States.

There is another statistic that I find very interesting. There is a lower rate of skin cancer in married men than in single men. Men can thank their wives for this, for not only pointing out potentially cancerous moles when they see them, but also insisting that their husbands seek medical attention. I always remind my husband that I am too old to be a young widow.

Research has not yet determined a cause for this type of cancer. The good news is that it is a potentially preventable disease, and if caught in its earliest form, it oftentimes can be cured. In more advanced stages, however, despite treatment and surgery, the chance of surviving 5 years after diagnosis is less than 5 percent. Education and awareness are the keys to preventing melanoma.

I urge you, and I hope you will join me in declaring May as Melanoma Awareness Month in Pennsylvania. Through research and effective treatments, a cure can be found and lives can be saved.

## **PETITIONS AND REMONSTRANCES**

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Madam President, I rise to once again discuss prescription drug abuse. It is a prevalent and growing problem. According to national statistics, nearly 6 million Americans abuse prescription drugs in one form or another. Attorney General Pappert is concerned that the problem could become worse with the introduction of a generic version of the powerful painkiller OxyContin and another new painkiller. He has recently been touring the State to discuss prescription drug abuse and steps that can be taken to stem its growth.

One particular appeal he has made has been of specific interest to me. He has asked that the General Assembly introduce and pass doctor shopping legislation. As it happens, I introduced such a bill in the year 2003. My Senate Bill No. 365 would make it a third-degree felony to visit multiple doctors or practitioners with the intent to buy controlled substances for abuse or for sale. But, I did not stop there, Madam President. I also have introduced legislation, Senate Bill No. 363, that would make it a third-degree felony to steal and then use a medical practitioner's prescription form. This is a fairly common practice by drug abusers, and we need an effective law to make it uncommon. Additionally, I introduced Senate Bill No. 364 which would make it a third-degree felony to steal a controlled substance from either a person, medical office, or any other location that houses prescription drugs. Right now in Pennsylvania, far too many prescription drugs are improperly dispensed or diverted for nonmedical purposes. I encourage my colleges to join me in helping to combat this abuse. My bills effectively attack this problem from three different directions, while complimenting and enhancing the current efforts of our Attorney General's Office.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Madam President, I will do my best to be brief, but it is an important issue that I think is important to be raised. This week, throughout the entire country, we are celebrating and raising up the issue of the over 49 million people in this country who have no health insurance. This is Cover the Uninsured Week, Madam President. In the Commonwealth of Pennsylvania, about 1.4 million people have no health insurance, and our adult basic program, while we have thankfully 42,000 people being covered with a bare amount of insurance, albeit they are covered, we also have almost 90,000 people who are signed up on the waiting list. We need to be clear that the folks who are uninsured, 75 percent of them are working individuals. They are in our lives on a daily basis working hard, making a difference, doing the things that they are asked to do, and being participants in our society, in our economy. However, they have no health insurance. The majority of these individuals are women, heads of households, doing what it is that they need to do to make life better for themselves and their families, but unfortunately, we have not found the capacity in this State or in this country to provide health insurance for these individuals. The Robert Wood Johnson Foundation did a study about a year or two ago, and we found out that throughout the entire country in a 2-year snapshot, about 75 million people for a 6-month period had no health insurance, and that is really unacceptable, Madam President. We have to do better. When folks have no health insurance, they get sicker, and what happens when they get sicker? They wind up eventually in an emergency room. There is no costlier type of health care provided than in an emergency room. Everyone testifies to this, and we have been at the hearings, we have held the hearings and heard the testimony. The Chair has analyzed the problem from her various vantage points in public policy over the years. We have to come to a resolution on this matter, and

hopefully, on this day, in this week, Pennsylvania will stand up again to try to make a difference on this issue and try to move forward on this issue.

Earlier today our policy chairman, Senator Kasunic, convened a press conference announcing public hearings that the Senate Democratic Policy Committee will be having across the State over the next several months, and hopefully, when we come back in the fall, we will have some specific resolutions to be brought up and put into legislative form so we can move on this issue. But, we could not go forward at the end of this legislative week, Madam President, and not raise the attention of this body to this particular issue.

Thank you very much for giving me a few moments to speak on this issue.
