The Senate met at 2 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Connie Williams.

Senator C. WILLIAMS. Madam President, I would like to tell you all about a friend of mine, Betty Hewit Roeder, who is over 80 years old. I do not want to tell you how much older. She likes to play bridge, travel, and is active in her community and lives in her own home. She is a fabulous live wire on any social occasion. and always has on the latest fashions. Last year at my senior expo, she delivered a wonderful speech on what it is like to be blind. When you meet Betty, you will notice a person with a zest for life and a fabulous sense of humor. What you will not notice is that she suffers from macular degeneration, a leading cause of vision loss and blindness in Americans 65 and older. In macular degeneration, the light-sensing cells of the macula of the eye malfunction and may, over time, cease to work. People who suffer from macular degeneration lose all but their peripheral vision. It generally starts with seeing shadowy areas in your central vision or experiencing unusual fuzziness or distorted vision. There is generally no pain. One way to tell if you have a problem is to look at a chart of black lines arranged in a grid, and if they start to appear wavy or if some patches of the grid appear blank, you might have a problem. Over the course of time, you will lose your eyesight.

Madam President, this disease affects as many as 15 million Americans. As our population ages, the number of cases of this disease will rise. The disease also affects 1 in 10,000 children. There is no cure for macular degeneration, but if you ask Betty, she will tell you that there is hope. Through organizations like the Macular Vision Research Foundation in Philadelphia, people are learning more about this disease, and money is being raised to prevent the disease, as well as finding a cure. Betty is very active in the foundation and has become a walking encyclopedia with their help.

Today I ask your support in declaring May 2005 as "Macular Degeneration Awareness Month" in Pennsylvania, and to draw attention to this disease and to help Pennsylvanians and let your

constituents know that there is help in dealing with this. I might also add that the House has also introduced a similar resolution. Quoting from the Macular Vision Research Foundation founder, Herb Lotman, whose wife, Karen, contracted the disease in 1989, "Most people take their vision for granted until an injury or vision abnormality makes them realize that the ability to see is fundamental to our daily life and an irreplaceable asset." So I ask for a positive vote on this, and for all of you to open your eyes to this terrible problem that affects so many of our eyes.

Thank you, Madam President.
