MONDAY, September 19, 2005

The Senate met at 2:30 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

PRAYER

May He who blessed our forefathers Abraham, Isaac, and Jacob, may He bless those soldiers who are representing our country all over the world, who stand guard over our land and the cities of our God, wherever they may be. May the Almighty God cause the enemies who rise up against them to be struck down before them. May the Holy One, blessed is He, preserve and rescue our fighting men from every trouble and distress and from every plague and illness, may He send blessings and success in their every endeavor, may He lead our enemies under their sway, may He adorn them with a crown of salvation and with a diadem of triumph, and may it be fulfilled for them from the verse, for it is God, our God, who goes with you to battle your enemies and He is there to save you. Let us say Amen.

Now, if I may, all these prayers do not cost any extra, this is all free of charge, so I would like to say a prayer for the Members of the Senate. I brought a lot of papers with me, but I am not going to use them all. I know you are all happy to hear that.

It pays to come when the Rabbi is here, you have to remember that. I think the Senate should make a motion that everybody has to be here when the Rabbi is here or else learn from that, so I hope to hand that out to everyone. I will do it very quickly so I do not disturb you.

I would like to take the opportunity to wish all of you a happy and healthy new year. May God bless all of you with success and happiness and joy as you begin this new year. May He guide you and help you to overcome any trials and tribulations that you may encounter as politicians here in the Senate and at home among your constituents, as I am sure you will, as we all do. I do from my congregation, too. We all have problems with our constituents, but remember, I answer to a higher authority. Remember that, as we all do.

Again, may God bless all of you and grant you much health and happiness and success. Amen.
