WEDNESDAY, September 28, 2005

The Senate met at 1:20 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

BILLS REREPORTED FROM COMMITTEE AS AMENDED ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 358 (Pr. No. 1141) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, defining "combat zone;" and further providing for limitations in educational assistance program.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Madam President, just very briefly, Senate Bill No. 358 is a bill for members of the Pennsylvania Army National Guard who are deployed and serving on active duty and who initially went into the National Guard based on an Educational Assistance Program, which is an incentive for them to go into the National Guard. We were notified about this problem by Sergeant Matthew Chase, who is from northeastern Pennsylvania and deployed in Iraq, who is there as a member of the Pennsylvania Army National Guard under the Educational Assistance Program. What Sergeant Chase was told, the program works this way: That for every 5 years that you serve in the National Guard, you then qualify for 10 semesters of college. It has to run continuously unless you have been deployed. So what took place with Sergeant Chase and others is that they were enrolled in school, they were activated by the National Guard, they were deployed. They were then told that while they were deployed, that the 5 years kept running with regard to the 10 semesters of school, so it literally meant that if they were deployed for 1 year when they could not go to college, then they would only have 4 years to make up the 10 semesters, which is basically impossible. Based on the request of Sergeant Matthew Chase, who sent me an e-mail from Iraq back in February asking if we would agree to extending the time that they could participate in the Education Assistance Program equal to the amount of time that they have spent on active duty so that they would be able to take full advantage of the program that they initially had signed up for, I introduced Senate Bill No. 358. I would like to thank Senator Don White for bringing the bill out of committee, and Senator Jubelirer for his support of the proposal, and I think it is something that all of our colleagues here in the Senate would be very, very interested in, because we all have members within our districts who are serving in Iraq and who are members of the National Guard, who I am sure enlisted or enrolled in the National Guard under the auspices of having

this tuition program being made available to them. It extends the

period of time for a Guardsman who has been deployed, serving on active duty, the amount of time they have been deployed would equate to the extension of time they would have to be able to continue the program of the Educational Assistance Program to continue their college education and to ultimately get a college degree.

I would ask for an affirmative vote, and once again I would like to thank Senator Don White and Senator Jubelirer for their help on this particular issue.

The PRESIDENT. The Chair recognizes the gentleman from Columbia, Senator Gordner.

Senator GORDNER. Madam President, I want to commend Senator Mellow for introducing this legislation. I, too, was contacted by two of my constituents in early June who had similar circumstances. Their 12-month period was from late September to late September of the next year. When you think of that, it actually affected three different semesters for them. They were unable to participate in a fall semester, a spring semester, and then by the time they got back, they were again unable to participate in the following fall semester. I had hoped that we would have been able to act on Senator Mellow's legislation in late June. We were not able to do that, but I am pleased that it is moving forward. Certainly, these folks have made great commitments and great sacrifices of both themselves and their families for us, and I applaud this effort and hope that the House will quickly move on it so that they can make sure that they get the educational assistance that they were promised.

The PRESIDENT. The Chair recognizes the gentleman from Bucks, Senator Tomlinson.

Senator TOMLINSON. Madam President, ever since I began the task of gaming at racetracks in Pennsylvania, I have always included a contingent to give a dedicated funding source to the volunteer fire companies, and unfortunately, the Supreme Court struck down that provision of Act 71 when we did the gaming bill. It is important for us now to restore that. Unfortunately, we were not aloud to create the fund in the same legislation in which we funded it, therefore we needed to introduce a separate bill outside of the gaming bill, so I introduced Senate Bill No. 867,

which will restore that valuable funding to the volunteer fire companies.

Our first responders do so voluntarily. The equipment is expensive, the fire companies are expensive to run, and we have needed this dedicated funding resource for years. We should not have to rely on funding from budgets year after year and worry whether we have extra money or not. By taking the first \$25 million of gaming money and dedicating it to our volunteer fire companies, we eliminate the negotiations in our budget to do that, so we will always have a dedicated funding source of \$25 million taken off all gaming resources.

I want to thank Senator Don White and Senator Logan for their help and leadership in trying to keep this issue alive after it was struck out by the Supreme Court, and I ask the Members for their unanimous support of Senate Bill No. 867.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Madam President, on behalf of the Senate Democrats, I want to rise also to ask our colleagues to support this very important legislation. I want to thank Senator Tomlinson for his efforts in bringing this forward and making certain that we do have the resources to provide to our local fire departments and our local communities. Senator Logan has been at the forefront of this legislation, as was stated by Senator Tomlinson, as has Senator Don White, and we truly appreciate their consistent efforts to try to make certain we provide these resources.

So, on behalf of the Senate Democrats, we join with our colleagues on the other side of the aisle to support this very important piece of legislation.
