The PRESIDENT. The Chair recognizes the gentleman from Indiana, Senator Don White.

Senator D. WHITE. Madam President, I rise today in support of House Bill No. 599, which would provide \$25 million to the Volunteer Fire Company and Volunteer Ambulance Service Grant Act for the current fiscal year. As we all know, this program received strong support from both the Senate and House last year, but the funding was not included as part of the budget for fiscal year 2005-06 that we approved last July. Therefore, I am very pleased that this important grant program is part of the proposed 2006-07 budget, but more importantly, we are establishing the funding for this year through House Bill No. 599 as amended so that the Commonwealth can offer these grants to our emergency responders this year.

As in previous years, these grants will be used to improve and enhance the capabilities of volunteer fire companies and ambulance services across the Commonwealth. Madam President, we owe a great debt of gratitude, as we all know, to our volunteer firefighters and EMS crews. They provide a tremendous and invaluable service to our communities, and with these grants, we

can show our support for their fine work. We can help them buy the equipment they need, improve the stations, and help the people they serve, and I think it is about time.

Thank you very much, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Waugh.

Senator WAUGH. Madam President, I rise today to also support House Bill 599. As the chairman indicated, this bill is extremely important for the health and success of the volunteer fire and ambulance companies across this Commonwealth. House Bill No. 599 would extend \$25 million from the General Fund to the Volunteer Fire and Volunteer Ambulance Grant Program for this fiscal year. I think it is a bit unfortunate that we waited until the last half of the fiscal year, but at least we are approving it today, and hopefully the commissioner's office will be able to get these grants into the hands of our volunteers as soon as possible.

This program has become, and really is, the most direct funding link that we have in providing State assistance to the fire, rescue, and EMS volunteers across this Commonwealth, and there are many of them, and I mean many, thousands in fact, who brave the perils of the job of keeping us safe and helping us all in times of trouble.

So, thank you, Madam President, and I encourage all Members to strongly support House Bill No. 599.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Madam President, I rise to also support this appropriate legislative appropriation. I do want to offer thanks to Senator Logan from Allegheny County, in particular, because of his leadership in the past on this issue. I represent probably a three-county region in addition to the city of Pittsburgh, which, as we know, has a professional firefighting work force, a well-paid professional work force that is an expensive part of the city of Pittsburgh's operating budget, but I also proudly represent a large number, as do many of my colleagues on the floor, of volunteer firefighting companies, as well as emergency ambulance service companies.

I want to thank Senator Logan for his leadership on this issue. Over a year ago, we fought hard to make sure that some of the gaming proceeds that would be anticipated would be, indeed, directed towards this very vital local municipal public safety service. Until those funds are provided, however, from anticipated gaming, it is important that we step up to the plate. We did that this past year. There was a strong commitment in the Governor's Budget Address today to continue this funding this year, as well as next year.

So I proudly vote in support of this legislation. I also want to point to a joint study done by the House and the Senate that had a series of recommendations coming out of an analysis and review of the operations of our local volunteer fire companies. So, in addition to the action today to financially support this grant program, a grant that could be as little as \$2,500 and possibly as much as \$15,000 for a particular volunteer firefighting company, there is another set of recommendations that I hope the State Senate will continue to be supportive of, a broad range of issues confronting local firefighting volunteer companies.

So today I proudly will be casting an "aye" vote, and I want to thank Governor Rendell for his leadership on this legislation.

Senator O'PAKE. Madam President, this is indeed a day for which we waited a long time. As was mentioned, the Supreme Court struck this money out of the gaming legislation. We have waited a long time, and as a result of the bipartisan cooperation of a lot of Senators from both sides of the aisle, finally we will be able to give the volunteer firefighters what they need very badly, now more than ever before, with all the concerns about security and emergency response.

I would also like to add that another piece of the package, which I hope we will address soon, is legislation which I introduced to give tax credits to the individual volunteers who respond to fire and emergency calls, and that number is dwindling throughout Pennsylvania. We need an additional incentive to not only help the fire companies, but also to encourage more individuals to participate as volunteers to save property, to save lives, and respond to hazardous and other accident situations.

This is important, it represents a lot of work from a lot of Senators, and we urge its support on this side of the aisle and hope that we can consider the other piece recommended in the study, which is to help with tax credits to have more people join and serve and respond as volunteers throughout Pennsylvania.

Senator BOSCOLA. Madam President, is there somebody who can answer a question with regard to this legislation? I am trying to get an answer, and I could not get one in the last 5 minutes.
