Senator PIPPY. Madam President, it is always a pleasure to introduce individuals to the Senate floor who have done a lot, especially when they are Pittsburgh Steelers. Today I have the pleasure of introducing a gentleman who not only captured the hearts and minds of all Steelers fans as a football player, but more importantly, or just as importantly, as a good person off the field. They had an outstanding record of 14 and 1, and the last game they played was their only loss, so they were undefeated for the entire season until the playoffs. They were guided by Head Coach Chris Fiegel and Assistant Coaches Dale Balasco, Lou Shragher, Ed Horne, and Bill Tobin and are in the gallery. They visited Representative Petri, and they are here to visit us, and I wish the Senate would give them a warm welcome, please.

The PRESIDENT. Would the Northampton Indians and all

their coaches and family please rise. (Applause.)

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, this bill, Senate Bill No. 691, basically is a tax break, and although it is being couched as a tax break to consumers, it is actually a tax break that has been stimulated by the cell phone companies. They are behind this massive advertising campaign that is going on, and what I wanted to say is if we are going to give away a billion dollars in taxpayer

money, what I wanted to say to these companies is, well, if this is really about consumers, let us protect consumers. This amendment says, if you want to take advantage of this tax break, you cannot charge a consumer a fee to turn off your service after they have been with you for 6 months. This is one of those hidden fees that happens along the way. A person signs up, after 6 months if they want to cancel, there is a fee for them to do that.

So all I am saying, Madam President, if we are really going to help consumers, then let us help the consumers. I do not want to kid anybody. A bunch of consumers did not get together to put up the millions of dollars for campaign ads that we see running throughout the Commonwealth and the Web site on this, and everything else. So, if we are going to give them a break in taxes, we should start to protect consumers. I have this and other consumer-oriented amendments to offer to this bill, if we are going to really be about consumer rights.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, I respectfully disagree with the gentleman from Philadelphia. I am going to ask for a negative vote on amendment A7042. For the record, hopefully, of the \$200 million this bill on final passage will return to hardworking men and women of the Commonwealth, approximately 80 percent goes to the individual consumer, the citizen. I laud the maker of the amendment, but I ask for a "no" vote, in part because current Federal statute would preempt such action, and also in part, if you look at the national competitive nature of cell phones, cell phone plans, et cetera, usually termination fees are waived at the point of sale, so I ask my colleagues for a negative vote on this amendment.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, just to correct the record, this would not conflict with Federal preemption.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, I request a temporary Capitol leave for Senator Hughes.

The PRESIDENT. Without objection, the leave will be granted.

And the question recurring, Will the Senate agree to the amendment?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, in the spirit of consumerism, we are going to continue on. Currently, when you receive a cell phone call, your charges start as soon as you receive the call, whether you want the call or not. What is currently going on is that cell phone companies are going to begin selling your phone number to people who will be calling you with solicitations, buying things, and things of that nature. What this says is, again, if you want to take advantage of this tax break, you cannot sell or give away a cell phone number without the owner's written permission. This is to protect you from spam phone calls, the ones you get in the evening. When they call you on your home phone, it does not cost anything, it is just a burden, and we went so far as to pass laws to try to stop that. This is an effort to stop that in advance, not only do you get bothered, but you also are going to pay to get bothered, so I ask for an affirmative vote, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, I ask for a negative vote on this amendment. I appreciate the Senator bringing this issue of consumer protection to our attention today. The fact of the matter is that this body unanimously approved, not too long ago, Senate Bill No. 713 which does that and more. It provides for those of us who buy cell phones, at the point of service, to tell the cell phone providers that we do not want our number to opt into the types of directories that were described in this amendment. That bill passed unanimously in the Senate and has already passed out of committee in the House, and we anticipate a full vote in the House, hopefully, in the next several weeks. So again, Madam President, I ask for a "no" vote on this amendment.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, we are still waiting for the House to pass lobbying reform. I do not think this Chamber is very much persuaded by what goes on over there. When we see it, we will believe it. But, Madam President, there is nothing wrong with voting on this again. In fact, this is the way to get it done. You hook it on to something that the big companies want, so they have to swallow. Now, I will admit, if you are trying to protect cell phone companies, you do not want this. But if you want to protect consumers, put them on the line, and they are going to get a \$200 million break, but I think the number is \$300 million. By the way, Madam President, when that \$300 million hole is in the budget, we will be raising other taxes to fill it. Do not let anybody kid you into thinking that we are going to cut spending around here, because in the last 15 years I have not seen us ever pass a budget below whatever any Governor proposed, so we are going to fill that hole. That is not the issue, the issue is on the full bill.

Madam President, if you are serious about this, if you are not just trying to con the voters, if you really want to protect consumers, you will vote on this again and put it in the bill where it will get passed and something will get done.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, again, just to speak specifically to the amendment that was drawn as we understand very recently, we do not think that it goes far enough. We think Senate Bill No. 713 as unanimously passed does, it is proconsumer. Again, it is important that what we are making the wireless industry do, under Senate Bill No. 713, is spell out in bold terms the ability for consumers to opt out of certain directories. As to the gentleman's comments about the fiscal impact, we are talking about the measure on the amendment before us, currently amendment A7032, and I ask for a negative vote

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, if the gentleman wants us to go over this bill until tomorrow so we can make an even better amendment, I will gladly do that. I suspect he does not want to do that, because he does not really want to deal with this issue. He would rather be an advocate for the companies. The \$200 million number was the one that he used. I am telling you it is

\$300 million, but who cares, we will raise the income tax.

Madam President, if you are really about consumer protection, if you really do not want your consumers bothered by these current phone calls, and if you really do not want them to pay when they get these phone calls, you will vote "yes" for this. If not, when they do get calls, I will be the first to come back and read the roll call of everyone who wanted to support the spam artists so they could call their constituents and make them pay for the spam phone calls.

Thank you, Madam President, it is a very simple amendment. The PRESIDENT. We already voted amendment A7042, Senator Wonderling. This is the vote on amendment A7032, which says we cannot give out cell numbers without written permission.

Senator WONDERLING. Thank you, Madam President. I stand corrected, but I still ask for a negative vote on the clarified amendment.

The PRESIDENT. Senator Wonderling asks for a negative vote and Senator Fumo asks for a positive vote on amendment A7032.

(m) Applicability of Phaseout Provisions.—The phaseout provisions of subsection (l) shall not apply to any mobile telecommunications services provider until such time as the telecommunications service provider has submitted and received a determination by the Pennsylvania Public Utility Commission of the reasonableness of the provider's rates for service. For the purposes of this provision, the mobile telecommunications service provider shall be deemed to be a public utility within the meaning of 66 Pa.C.S. § 102 (relating to definitions).

On the question,

Will the Senate agree to the amendment?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, this amendment is in the name of consumerism. There was a time, and I was here at that time, when cell phones were only available to extremely wealthy people, their use was very, very rare, and there was a debate over whether or not they should be at the PUC. At that point in time, many, many years ago, we agreed and said, no, because we could never envision where we are today. Today there are probably more cell phones in use than there are land line phones.

Madam President, this says that before one of these companies can take advantage of this tax break, they have to register with the PUC as a utility and prove and file that their rates are reasonable and that their provider's rates and services are reasonable. People right now have no place to complain when they are cut off in the middle of a phone call, yet they are billed for that. In fact, it is so bad that people are constantly asking, what can I do? You get in the middle of a phone call, click, you dial it again. The example I like to use is the fact that when you call and get voice mail for the person, they give you this long speech, if you want immediate action, hit 5; if you want this, hit number 6; if you want to leave a message, hold the line, and you are paying for that 30 seconds of air time.

So, Madam President, those are things that we hope the PUC, with more expertise than us, would be able to regulate. As I said, we require the PUC to regulate land line phones, and there was a time when there were very few cell phones. Now there are more cell phones than there are land line phones, and this says if you want to take advantage of the tax break, nothing is free. If you want to take advantage of the tax break, give consumers a place to complain about their rates and services and listen to the PUC, which has the expertise. The PUC, I might add, is dominated by Republicans. It is not a Democratic PUC, so I do not think anybody on that side of the aisle should fear the PUC, but we want a place for these people to be able to vent their frustration, if nothing else.

Thank you, Madam President.

The PRESIDENT. On A7031, Senator Fumo is requesting that before a company can take advantage of the tax break, they must now register with the PUC.

The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, I am going to ask my colleagues for a negative vote on this amendment. The Senator is correct that there are more cell phone users than in days gone by, but there are also more cell phone service providers. I think what we have seen over the last several years is that competition does work, and allowing the free market to determine prices and packages on behalf of consumers is very proconsumer. My fear about this amendment, Madam President, is the proverbial nose in the camel's tent, the notion, and the Senator used the term "regulate," I know that there was a time and place when the PUC did a great job in the history of this Commonwealth regulating monopolies, Madam President. That is not the case here. Competition is flourishing in this industry. We think it is proconsumer, and I ask for a negative vote on this amendment.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Madam President, I think we are comparing apples and oranges here. Land lines are public utilities that get a guaranteed rate of return. Cell phone companies, Madam President, built their own network. They advertise their own product. They went from a place where once there were very few and sort of elite, and through competition, mind you, competition, they were able to lower that price significantly to where almost everyone can afford a cell phone. I cannot think of any way to stunt the growth of an industry than to bring it under government control when it is working without government control. They have brought it down from an elite item to something almost everyone can own. They did it by building their own network. There was no government money in their networks. They did it on their own, and I would say that competition has worked very well in this industry. Although the amendment is well-intended, I ask for a negative vote.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentlewoman from Venango, Senator Mary Jo White.

Senator M.J. WHITE. Madam President, I think Senator Corman is generous in saying that these amendments are well-intended. I think, in fact, it is no secret that the administration is opposed to the repeal of this tax, and what we are seeing here is an attempt to kill the bill with kindness, dressed up as consumer protection. I think this particular amendment might be the one that could kill it. I think, in my opinion, and I have studied some utility law, I believe the Federal Communications Commission authority, the Federal government has the exclusive authority to regulate cellular telephones. I think to attempt to give this authority unilaterally by the State to our Public Utility Commission could very well render this bill unconstitutional, and I ask for a negative vote.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, I just want to clarify a few things. I am shocked and dismayed to hear Senator Corman say that land lines get a guaranteed rate of return. I thought that is why we just did Chapter 30, and he was on this floor telling me that they did not get that, that there was this vast competition that existed out there. I am glad now he admits that there is no competition, that they are a monopoly, yet we do not regulate their rates. They do not get a guaranteed rate of return.

Secondly, as for the Federal government's preemption, that is not true as well. The State of Connecticut regulates their cell phone companies, and it is only because of our definition in this Commonwealth that we do not do that. The Feds have not preempted us on this particular area of the law.

Now, Madam President, getting back to the heart of the argument, forgetting all the esoteric mumbo-jumbo, what this does, if nothing else, if nothing else, it allows the consumers and taxpayers in Pennsylvania a forum where they can express their frustration with their service and their rates. If it does nothing else, it lets the taxpayers who are being taxed have some kind of representation. You have a place to go, you have a place to complain, and you have a place to get your service problems rectified and remedied. That is all this says, Madam President. I am shocked and dismayed to think that there is not competition in Pennsylvania in land lines. I am really amazed at that.

Madam President, what this does is protect consumers. When I started this, all I said was that these were amendments that were designed to protect consumers from the very companies that are spending tens of millions of dollars to tell people that they have to lower this tax. If you want to lower the tax, you have some responsibilities. You pay for that. There is no free lunch. There is a price to pay for everything. If you want \$200 million, and my number is actually \$300 million, but I will go with \$200 million, if you want to take \$200 million out of the Treasury of the Commonwealth of Pennsylvania, out of the mouths of people, out of education and everywhere else, all I am saying is that I should get my telephone call completed when I am on my cell phone, and if I do not, I should have a place to complain.

Thank you, Madam President.

Madam President, if we are going to do this for cell phone customers, then we should do it for land line customers. If we are here, we might as well get rid of the income tax as well. All this

does is focus it and limit it where it is supposed to be focused. Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, I ask for a negative vote on this as well, in part, because I think there may have been a technical error in drafting the amendment as offered, as language was deleted on page 5, but not on page 3. As to the point of why we are here, and the hour is getting late, let us not forget the philosophical basis for the bill, and that is not to provide tax breaks to corporations, but to provide some relief to 6 million cell phone users across this Commonwealth. By the way, Madam President, these are users who are young and old. Those who pay the personal income tax in this Commonwealth are described by a different set of demographics than those who use cell phones.

So, Madam President, I ask for a negative vote on this amendment.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, just to remind the Senator of his earlier numbers, when he told me that of the \$200 million, that 80 percent of it would be reaped as an advantage to consumers. Madam President, I will use his numbers, that means that 20 percent goes to big business and corporations. Now, I know it is not a lot of money, it is only \$40 million, by his own estimate, but let us not kid anybody, Madam President, this is a tax break for Verizon. That is what this one is about.

Madam President, I ask for an affirmative vote on this. If we are going to do something for cell phone consumers, which I highly doubt, let us not do it for the big corporations as well. Let us just do it for the so-called little guy.

Madam President, you know, there is an old story that bulls and bears will eat and pigs will choke. In this case, I think Verizon should choke on this amendment.

#### **BILL ON FIRST CONSIDERATION**

Senator VANCE. Madam President, I move that the Senate do now proceed to consideration of a bill reported from committee for the first time at today's Session.

The motion was agreed to by voice vote.

The bill was as follows:

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, last month, United States Senator Russ Feingold, a Wisconsin Democrat, introduced a resolution to censure George W. Bush for breaking the law by engaging in domestic spying without a warrant. The response from the administration was predictable and partisan. Dick

Cheney said in a speech the next day, and I quote, "Instead of acknowledging the urgent need to track enemy communications in wartime, some Democrats in Congress have decided that the president is the enemy."

Shortly after that, Republican Senator Wayne Allard of Colorado chimed in with the same theme. He accused Senator Feingold of siding with terrorists.

These are reprehensible tactics of men who are afraid to have a legitimate debate about the constitutional issues that are of grave importance to the freedoms we have historically enjoyed in this country. They try to win their arguments by instilling fear. Because they cannot refute ideas on merit, they attack their fellow Americans and accuse them of a lack of patriotism and being soft on terrorism.

Contrary to the statement of Dick Cheney, Democrats do acknowledge the need to track enemy communications in wartime, but we simply believe the President should follow the fairly easy legal procedures for doing so. The issue is not whether or not the President should be allowed to snoop on terrorists. Clearly, he should be. The issue is whether he should be allowed to snoop on American citizens without a warrant. Clearly, he should not and cannot do that. Those who speak out against the warrantless domestic spying programs are being patriotic. They are standing up for the freedoms that the United States Constitution and the Bill of Rights guarantee to all Americans. As for siding with terrorists, many people, including many who are much more knowledgeable on the topic than I am, have pointed out that George Bush's occupation of Iraq is hurting us in the war on terror because it has distracted us from the real enemy.

But while I have been as critical of Bush's policies as anyone, and while I believe he is doing great damage to our nation's security in more ways than one, I have never claimed that he was motivated by a lack of patriotism. The administration and its apologists, however, do not mind stooping that low. If the Bush administration is going to argue that they can wiretap without a warrant in the name of fighting terror, it is not a great leap of logic to think that they might regard physical searches in the same way. Electronic eavesdropping was not an issue for colonial America, but warrantless physical searches were one of the chief grievances that led to the American Revolution. It is no surprise that very issue was discussed in the Bill of Rights.

Sure enough, in its March 27 issue, U.S. News and World Report revealed that a group of lawyers at the White House and the Justice Department had prepared a series of memos arguing that they had the same authority to conduct physical searches as they do to listen in on conversations. We have no conclusive evidence that they have actually conducted physical searches without a warrant yet, but the fact that the Bush administration is even making the argument that it would be legal is something that should frighten all patriotic Americans. Keep in mind that a warrantless search was exactly what the Watergate break-in was, as were all the other infamous crimes of the Nixon administration, such as the break-in at the office of Daniel Ellsberg's psychiatrist. Maybe that is why a former high-ranking official in the Nixon administration, ex-White House counsel John Dean, said last week that he supports Senator Feingold's

censure resolution. Dean, who served 4 months in prison over Watergate, said that if Congress had exercised greater oversight when the abuses of the Nixon administration first surfaced, the nightmare of Watergate might never have occurred. Dean even went a step further. He said that Bush's domestic spying programs exceed the wrongdoings that brought down the Nixon presidency, and that perhaps Bush should not only be censured, but perhaps even impeached.

Lest anyone think that I am making a partisan attack on George Bush here, let me say that my own political party has not distinguished itself on the issue as well. Only two other Senate Democrats have signed on to cosponsor Senator Feingold's censure resolution. Democrats on the national scene have been far too reluctant, in my opinion, to speak out against Bush's unconstitutional domestic spying. They need to exhibit a little more courage, and not be frightened just because opinion polls show that a slight majority of Americans are not concerned about warrantless searches and spying.

The reason we have a Constitution, the reason we have a Bill of Rights is so that our basic principles of freedom cannot be violated on a temporary whim of a small majority. The Constitution and the Bill of Rights are permanent protections against the fervor of the moment, and people in both parties in Washington have a solemn duty to defend them. So even though I cannot vote on them in Washington, I am not afraid to stand here before this body and say that I support the Feingold resolution. George Bush should not be allowed to undermine democracy in the United States while he is supposedly trying to establish it in the Middle East.

American soldiers continue to fight and die for what George Bush says is an effort to make Iraq a democracy. Their sacrifice is truly in vain. In fact, it is a tragic hoax if, while they are overseas, George Bush is allowed to steal democracy in their American homeland. To date, 2,336 American soldiers have been killed in Iraq. Another 17,381 have been wounded, and 7,987 of them too seriously to return to action.

Now, Madam President, I would like to honor the memory of two more brave Pennsylvanians who died in Iraq just last month. Sergeant 1st Class Randy D. McCaulley, age 44, of Indiana, Pennsylvania, died in a Habbaniyah, Iraq, on March 23, when his dismounted patrol came under small arms fire during combat operations. Sergeant McCaulley was assigned to the Army National Guard's 1st Battalion, 110th Infantry, 2nd Brigade Combat Team, 28th Infantry Division.

Specialist Frederick A. Carlson, age 25, of Bethlehem, Pennsylvania, died in Taqqadum, Iraq, on March 25, while not involved in combat. Specialist Carlson was assigned to the Army National Guard's 228th Forward Support Battalion, 2nd Battalion, 28th Infantry Division. The circumstances of his death are currently under investigation.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Madam President, 30 years ago we passed Pennsylvania's Child Protective Services Law, and since we enacted that law, which I authored, we have seen over 20,000 cases a year of suspected child abuse reported in Pennsylvania, physical abuse, sexual abuse, emotional abuse, and neglect.

April is Child Abuse Prevention Month, and it is important that we take stock of where we have come from and where we need to go in the very important responsibility of preventing child abuse in Pennsylvania. Under the existing law, there is a ChildLine available 24 hours a day, 7 days a week, to report child abuse when you see it. There is mandatory reporting for physicians and teachers and day care workers and those who work with children on a daily basis. There is a central registry of child abusers available.

What we need to do now, Madam President, and the reason I rise is to invite cosponsorship of an amendment which will bring Pennsylvania more Federal dollars for our efforts to prevent child abuse in this State. The bill I have introduced is Senate Bill No. 1183. I invite cosponsorship. It already has sponsorship from both sides of the aisle, and if this bill is enacted, and I hope it will be considered by the committee sometime in April as a lasting contribution of Child Abuse Prevention Month, it will do several things.

Number one, it provides for the establishment of citizen panels to review the services and practices by our county agencies and proposed changes in the delivery of services. I am sure we have all had complaints about the way the Child Protective Services Law is being carried out by the Children and Youth Service workers throughout Pennsylvania. This will allow citizen panels to review whether or not these practices have been effective and what can be done to improve them. It will also require an annual report by the Department of Public Welfare in all cases where children are killed or seriously injured. It will require health professionals to report when children are born with exposure to illegal substances, and it will expand the specific instances where a parent's rights can be terminated for habitual child abuse.

These changes, which have been developed with the support of the Department of Public Welfare and county agencies, will improve the transparency and response of the county agencies, as well as increase child safety and public confidence in this system.

So, as I said, as we celebrate the 30th anniversary of this important legislation, I am inviting cosponsorship, and I hope that the improvements that I am suggesting here in Senate Bill No. 1183 can be passed very quickly. The bottom line is, however, no matter what laws we pass, the effective implementation of this, as in many laws, depends on citizen involvement, concern, awareness, and participation. Therefore, once again, I want to remind the public that if you see child abuse, and I hope you would be alert and vigilant to its possibility, if you see child neglect, there is a toll-free hotline available, the ChildLine, and that number is 1-800-932-0313. When you report the suspected abuse, your confidentiality will be protected and an investigation will be undertaken in the county where the victim, an infant or a child, is possibly being molested or sexually or physically abused.

So, we need to recognize child abuse and child abuse prevention, and we have to focus on not only changing the law, but also on having citizens throughout Pennsylvania be a part of protecting children against abuse and hopefully preventing the ultimate tragedy, which is so often the result when child abuse is repeated and repeated.

So, Madam President, the bill is with the Secretary of the Senate, Senate Bill No. 1183, and as we begin Child Abuse Prevention Month in Pennsylvania, I urge bipartisan support and hopefully consideration by the committee to which it was referred.

Thank you, Madam President.
