**SB 727 (Pr. No. 881)**

An Act establishing the Drug and Alcohol Treatment and Prevention Fund; and providing for the deposit of a portion of the liquor tax into the fund and for use of fund.

**SB 934 (Pr. No. 1225)**

An Act establishing the Medical Safety Automation Account; and providing grants to implement medical safety automation systems.

**HB 755 (Pr. No. 4196) (Amended)**

An Act amending the act of September 9, 1965 (P.L.497, No.251), known as the Newborn Child Testing Act, further providing for newborn child screening and testing; and making editorial changes.

Senator M.J. WHITE, from the Committee on Environmental Resources and Energy, reported the following bills:

An Act amending the act of March 1, 1988 (P.L.82, No.16), known as the Pennsylvania Infrastructure Investment Authority Act, further providing for definitions; establishing the Water and Wastewater System Connection Funding Program to provide certain low-interest loans; providing for transfer of certain moneys; and making editorial changes.

### SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR MICHAEL J. STACK PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Madam President, I have in the gallery, as you know, one of the best senior citizen groups in the whole Commonwealth of Pennsylvania, the Tacony Senior Citizens group. They arrived a little late because their bus driver accidentally drove all the way to Scranton until they were able to take over and grab the steering wheel away from the bus driver and lead them back to Harrisburg. I assured them that we are, and I would appreciate it if the Senate would give a warm welcome to the great senior citizens group, Tacony Senior Citizens from northeast Philadelphia.

There was a gentleman by the name of William Kerr who lived in Collier Township from 1911 to 1928, and back in 1888 he started with the idea or goal of making Flag Day a national holiday. His persistence and patriotism were boundless, he never rested, and he actually sat beside President Harry Truman as he signed the Flag Day bill in 1949. He has always been involved. Madam President, I think it would be a great honor, not only to the city of Philadelphia but to the Commonwealth of Pennsylvania and the entire northeast, if Philadelphia were to be selected to be the host city, and I congratulate them and the committee for putting forth the effort to get this done, and I am sure that the Members of the Senate would agree that Philadelphia would be a tremendous venue for the 2016 Olympics. I certainly urge an affirmative vote.

### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, today I introduced a resolution that would discharge the Senate's Committee on Labor and Industry from further consideration of House Bill No. 257, which was passed overwhelmingly by the House of Representatives on April 5, 2006. This bill would raise Pennsylvania's minimum wage to \$7.15 an hour. I have introduced legislation which would raise Pennsylvania's minimum wage for the past three legislative Sessions, Madam President, and we have yet to see a bill come before the Senate for a vote.

I introduced Senate Bill No. 369 on March 16, 2005. Last year about this same time, action to vote that bill was delayed on a promise that we would hold public hearings over the summer of 2005 and then have a vote when we returned to Session last fall. Well, Madam President, we had a public hearing in Philadelphia last September and proved that there is sufficient public support to vote on that legislation, and here we are, a year later, and the Republicans will still not allow us to vote on this legislation. We attempted to compromise with the Majority party and the business lobbyists. Their idea of compromise was to raise the minimum wage to a point well below \$7.15 an hour and load the bill up with business-friendly amendments that would transform the bill from one benefitting low-wage workers to one that would benefit the business community.

Those who oppose the raising of the minimum wage said it will hurt small business. Madam President, the fact is that 86 percent of small business owners say that the minimum wage has no effect on their business, and 46 percent of small business owners say they believe the minimum wage should be increased. And for those who say raising the minimum wage will result in job loss, there is data on this, Madam President. We do not need to rely on the nay sayers and the well what-if predictions. Studies show that employment has actually increased in small businesses where States have increased the minimum wage.

Madam President, I could go on all day, but the time for debate and discussion has passed. We have rallied, argued, and debated. Now it is the time to vote. It is truly disappointing, Madam President, that while 80 percent of Pennsylvanians support raising our minimum wage, 1 percent of the Senate's Majority party can keep us from a vote. I am disappointed that democracy has stopped at the door of the Senate's Committee on Labor and Industry.

Madam President, Senate Bill No. 926 and House Bill No. 257 are simple bills. They would raise Pennsylvania's minimum wage to \$7.15 an hour. It is that simple.

With today's discharge resolution, we are saying, give us the opportunity to vote. If you disagree, vote "no." Just give us the chance to have a vote. It is that simple, Madam President.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Madam President, I just want the record to reflect that Senator Tartaglione has the unequivocal support of every Democratic Senator in this Chamber. Every Democratic Senator signs on and supports in any way possible the opportunity to have a vote on this legislation. The current Senators, the new one getting ready to join us, he signs on, everybody is prepared and ready to support Senator Tartaglione in her effort to get this issue moving. We have been waiting far too long to get the opportunity to vote for this issue. As Senator Tartaglione just said, if you do not like it, vote against it. If you are not for raising the minimum wage of Pennsylvania's workers, Pennsylvania's low-income workers, Pennsylvania's low-wage workers, if you are not interested in supporting them to move themselves out of poverty, to work themselves out of poverty, then fine, just do not vote for her bill, or vote for the bill that passed the House of Representatives overwhelmingly, or vote for the bill that the people in Pennsylvania support overwhelmingly, that the Governor wants overwhelmingly, unequivocally. He said he would sign it. He has been waiting for it, but there is no action. Everybody wants some action except the Majority party in the Senate. They are holding up this legislation, they are not moving on it, so consequently Senator Tartaglione has made the decision to move this issue. She has the unequivocal support of every Democratic Senator, and I daresay there is probably a whole bunch of Republican Senators who also support the measure, but we need the opportunity to vote.

Pennsylvania's people are waiting, and they are waiting in desperate conditions, not having the opportunity to add a few dollars to their paycheck and not having the opportunity to work themselves out of poverty. We should be mindful that the current minimum wage keeps people under the Federal poverty level, and that the policies of the Majority in this Chamber have indicated that they are prepared to keep people under the Federal poverty level, and that really is unacceptable, Madam President.

So consequently, I rise to make sure that the record reflects that every Democratic Senator, and I daresay a few Republicans, support, but I daresay more than a few Republicans support Senator Tartaglione in the effort to raise the minimum wage in this Commonwealth. We have been waiting, we continue to wait, we had an arrangement that we were going to have a vote in January, that arrangement was broken. The voters spoke on the matter in the spring primary. The people are waiting, everybody is waiting, the folks are waiting, the House moved on it, the Governor is waiting, we are waiting, the workers, most importantly, the workers are waiting. The people who work every day, trying to make a difference in their lives every day, they play by the rules, they pay their taxes, inflation is going up, interest

rates are going up, gas prices are going up, but the wage of Pennsylvania's workers at that scale are going down. Not meeting the mandate of the people of Pennsylvania is a shame, and we should be acting, so we support Senator Tartaglione's effort to move this issue forward, and it needs to happen now.

Thank you, Madam President.

The PRESIDENT. Thank you, Senator Hughes, for your support of Senator Tartaglione's petition concerning the minimum wage and House Bill No. 257.
