  - (2) Whether the victim was a minor.
  - (3) The manner of weapon or physical force used or threatened.
  - (4) If the offense involved unauthorized entry into a room or vehicle occupied by the victim.
  - (5) If the offense was part of a course or pattern of conduct involving multiple incidents or victims.
  - (6) Previous instances in which the offender was determined guilty of an offense subject to this subchapter or of a crime of violence as defined in section 9714(g) (relating to sentences for second and subsequent offenses).
- Section 2. Section 9798.1(b) and (c) of Title 42, added November 24, 2004 (P.L.1243, No.152), are amended to read:

Amend Sec. 1 (Sec. 9798.1), page 3, lines 2 through 30; page 4, lines 1 through 12, by striking out all of said lines on said pages and inserting:

- (c) Information permitted to be disclosed regarding individuals.—Notwithstanding 18 Pa.C.S. Ch. 91 (relating to criminal history information), the Internet website shall contain the following information on each individual:
  - (1) For sexually violent predators only the following information shall be posted on the Internet website:
    - (i) name and [any] all known aliases;
    - (ii) year of birth;
    - (iii) the street address, [city] <u>municipality</u>, county and zip code of all residences, <u>including</u>, <u>where applicable</u>, the name of the prison or other place of confinement;
    - (iv) the street address, [city] <u>municipality</u>, county [and], zip code <u>and name</u> of any institution or location at which the person is enrolled as a student;
    - (v) the [city] <u>municipality</u>, county and zip code of any employment location;
    - (vi) a photograph of the offender, which shall be updated not less than annually;
    - (vii) a description of the offense or offenses which triggered the application of this subchapter provided for by section 9795.4(d.1) (relating to assessments); and
    - (viii) the date of the offense [and], conviction[,] and, where applicable, the release or earliest possible release from confinement, if available.
    - (2) For all other lifetime registrants and offenders subject to

registration only the following information shall be posted on the Internet website:

(i) name and [any] all known aliases;

(ii) year of birth;

(iii) the [city] street address, municipality, county and zip code of all residences, including, where applicable, the name of the prison or other place of confinement;

(iv) the [city] municipality, county [and], zip code and name of any institution or location at which the person is en-

rolled as a student;

(v) the [city] street address, municipality, county and zip code of any employment location;

(vi) a photograph of the offender, which shall be updated not less than annually:

(vii) a description of the offense or offenses which triggered the application of this subchapter provided for by section

9795.4(d.1); and (viii) the date of the offense [and], conviction[,] and, where applicable, the release or earliest possible release from confinement, if available.

(d) Duration of Internet posting.-

(1) The information listed in subsection (c) about a sexually violent predator shall be made available on the Internet for the lifetime of the sexually violent predator.

- (2) The information listed in subsection (c) about an offender who is subject to lifetime registration shall be made available on the Internet for the lifetime of the offender unless the offender is granted relief under section 9795.5 (relating to exemption from certain notifications).
- (3) The information listed in subsection (c) about any other offender subject to registration shall be made available on the Internet for the entire period during which the offender is required to register, including any extension of this period pursuant to 9795.2(a)(3) (relating to registration procedures and applicability). Amend Sec. 2, page 4, line 13, by striking out "2" and inserting: 3

Senator TARTAGLIONE. Madam President, good news, people are listening. It has taken 6 years, but they are finally listening. No, I am not talking about the 80 percent of Pennsylvanians who already got it, the 80 percent of Pennsylvanians who support raising minimum wage, I am talking about Republican legislators, Madam President.

Yesterday I introduced a discharge resolution for House Bill No. 257. As I said yesterday, that bill, like my bill, Senate Bill No. 926, would raise Pennsylvania's minimum wage to \$7.15 an hour. The House of Representatives passed House Bill No. 257, but here in the Senate, we cannot even bring it along for consideration by our Committee on Labor and Industry.

As we all know, Madam President, the party in the Majority, and here in the Pennsylvania Senate they are Republicans, decides what bills we will consider and what we will not. Here in our Senate, the Majority party believes that low-wage workers should not be given the opportunity to make \$7.15 an hour.

Well, Madam President, we have good news. The Republicans in Washington paid attention to our voters. They heard what the voters said on May 16. Yesterday in Washington, legislators, including seven Republicans, supported an amendment that would raise the Federal minimum wage to \$7.25. They are getting it in Washington. They hear the people. They see the 21 States that are leading the nation in this effort to help Americans fight to survive. This should send a clear message to the Pennsylvania legislature: we can be leaders, or we can be followers. We can wait for the Federal government to set the wage rate, or we can show some initiative, and, Madam President, since the Federal government is looking at the minimum wage at \$7.25 an hour, I think we should amend our proposal to reflect that rate.

Madam President, the citizens of Pennsylvania are looking for leadership from our elected officials. We need health care reform, we need property tax relief, and we need to raise Pennsylvania's minimum wage. I only hope that the people are listening today, and they will remember in November.
