#### SB 73 (Pr. No. 92)

An Act amending Title 42 (Judiciary and Judicial Procedure) and codifying Title 61 (Penal and Correctional Institutions) of the Pennsylvania Consolidated Statutes, providing for temporary release from county correctional institutions, for parole without board supervision, for judicial power to release inmates and for transfers of inmates needing medical care; further providing for State intermediate punishment; providing for other criminal provisions; amending the heading of Title 61; adding definitions, provisions relating to general administration of correctional institutions, State correctional institutions, county correctional institutions, the Philadelphia County Prison, house of detention for untried inmates and witnesses, inmate labor, medical services, visitation, motivational boot camp, execution procedure and method, miscellaneous matters relating thereto, probation and parole generally, the Pennsylvania Board of Probation and Parole, County Probation and Parole Officers' Firearm Education and Training, and correctional institution interstate compacts; and making repeals relating to codification.

#### SB 116 (Pr. No. 93)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for selection of prospective jurors.

#### SB 150 (Pr. No. 94)

An Act relating to the protection of victims of sexual violence.

#### SB 151 (Pr. No. 95)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, further providing for weapons or implements for escape and for contraband; and making a conforming amendment.

#### SB 397 (Pr. No. 122) (Amended)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, imposing a central or regional booking fee on criminal convictions to fund the start-up, operation or maintenance of a central or regional booking center; and providing for a countywide booking center plan.

# BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 10 (Pr. No. 107) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of July 31, 2003 (P.L.73, No.17), known as the Volunteer Fire Company and Volunteer Ambulance Service Grant Act, further providing for guidelines and procedures, for award of grants and for expiration of authority; providing for publication and notice, for special provisions and for a Legislative Budget and Finance Committee performance review; and repealing an obsolete act.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Madam President, I rise to ask my colleagues to support Senate Bill No. 10. Certainly, we all know the important role of professional emergency services are provided by volunteers in our community, and this bill will do much to help advance their cause. Nothing can illustrate that point more than something that I attended over the weekend on Saturday evening, and it was illustrated by the Dallas Fire and Ambulance Company honoring a 50-year member, Mr. Robert Besecker.

Mr. Besecker has served my community and my hometown for many years, and at that award presentation, it became even more clear about their role in our communities. A gentleman presented to Mr. Besecker a note and a newspaper article specifying what occurred 37 years before when Mr. Besecker helped save this gentleman's life as a newborn infant when the ambulance was called to his parents' home.

So, today I stand and ask my colleagues to support this bill to help continue the effort for our volunteer firefighters, and I ask for your concurrence.

The PRESIDENT. The Chair recognizes the gentleman from Westmoreland, Senator Regola.

Senator REGOLA. Madam President, I would like to thank Senator Baker for her comments and for bringing Senate Bill No. 10 out of her committee, but I rise today to submit my remarks for the record.

The PRESIDENT. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made a part of the record at the request of the gentleman from Westmoreland, Senator REGOLA:)

Madam President, since 2000, the General Assembly has regularly appropriated \$25 million to PEMA to provide needed assistance to volunteer fire and EMS departments.

As a legislator and an honorary volunteer fireman, I have seen the positive results of this program. It has reached all corners of our Commonwealth, helping stations purchase equipment, improve facilities, and pay for training. With these volunteers standing on the front lines every day to protect our communities, this grant program aims to make their job protecting us easier.

Thanks to the efforts of legislators like Senator Mike Waugh of York County, chairman of the Senate Firefighters and Emergency Services Caucus, the initial grant program was created in 2000. Thanks to Senator Tommy Tomlinson of Bucks County, Act 66, a permanent funding stream, was put in place last year.

This year, 28 of my colleagues joined me in sponsoring Senate Bill No. 10, which, as introduced, would reauthorize the grant program for 2007. Traditionally, the program begins in the spring. As such, this legislation was deemed a top priority of the Senate Republican Caucus. During the committee process, discussions began with Senator Lisa Baker of Luzerne County to make this a multiyear program, rather than on a year-to-year basis. Yesterday on the Senate floor, we unanimously adopted an amendment that would reauthorize the program for 5 years.

When this bill is signed into law, firefighters and EMS providers will no longer have to guess when this critical funding will arrive. They will know the program will begin 30 days after the bill is signed into law, and for the 2008 program, the process will begin this August so that the funds can be delivered in the spring of 2008. Now that the funding stream has been put into place, it is only appropriate that the grant program be squared away. The legislature will no longer have to scramble to get this done on a year-by-year basis. Rather, we will be able to review the program every 5 years and make adjustments when needed.

I am honored to see the support among my colleagues and from first responders for this program. As a Senator, I have visited many of the outstanding volunteer fire and emergency services corps in Westmoreland County. What strikes me most about these folks are two things. First, they represent such a broad section of our community. They come from all walks of life, across social, ethnic, and financial backgrounds, but that all changes when the siren goes off and the turnout jacket or stethoscope goes on. That brings me to my second point. These men and women share a true dedication to their calling. It takes a brave soul to battle a fire or tend to those injured in an automobile accident.

We are well aware of the financial and recruiting problems these organizations face. Vehicles cost hundreds of thousands of dollars. Clothing and equipment can cost thousands of dollars, and construction and maintenance of stations can go beyond the means of many departments. It is truly a shame that these volunteers work out of substandard stations or use outdated equipment. That is why this grant program is so important for our communities. By authorizing this program for 5 years, we can show our emergency responders that we are truly committed to providing the essential financial support they need.

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Waugh.

Senator WAUGH. Madam President, in the Session of 2003, Senate Resolution No. 60 called for a special commission to be formed. The commission was made up of 26 representatives from various fire and emergency service organizations, local municipalities, and other groups across the State. What came from their work in November of 2004 was the Senate Resolution No. 60 report. It was a very concise document that was put together with the help and assistance not only of those 26 very expert individuals, but also the organizations that represent emergency medical service, fire service, rescue service, hazmat organizations, and others across the State.

This bill, the bill that we are about to vote today, addresses one of the 23 recommendations that the commission submitted in their report, and I would like to read from recommendation number 6 from the SR 60 report. It reads as follows: "The legislature should provide for permanent funding so that the grant program," that is the Volunteer Assistance Grant Program, "can be administered in an efficient manner, without taking monies from other much needed emergency services programs. The Grant Program should become permanent...starting in 2006."

Well, we did not miss it by much. Here we are in 2007, Madam President, and in fact we now have a dependable funding source in place, and this bill will in fact make the program permanent, albeit with a 5-year sunset. In reality, history shows us that we have been somewhat inconsistent for various reasons, and it is not anyone's fault in particular, but this proposal by Senator Regola will now in fact put in place a permanent program that we can depend upon on a regular basis year in and year out for some 2,500 fire services and 1,500 emergency medical services statewide.

So I would like to first of all thank and congratulate Senator Regola for his work on this issue, and also commend Chairman Baker for moving this bill in swift order so that we can today vote it and move it on to the House of Representatives.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Madam President, on behalf of my colleagues on this side of the aisle, I just want to rise as well and voice our affirmative support for Senate Bill No. 10. We, too, recognize how important these resources are to our local volunteer fire companies and EMS personnel and what they mean to our communities. I think we all recognize that it is something we need to do at the State level that we have done for a number of years, and to be able to say that for the next 5 years hopefully we will be able to do this, provide these resources to these organizations, I think is very, very important.

All we need to do is think about the weather for the past couple of weeks, how terrible in terms of the cold, and today the snow and the like, we know that these individuals who represent and work with these organizations, if we have any situation that needs to be addressed by them, they are there. They leave their families, they leave their homes and they come out and work to make certain that they provide us the safety and the security that we need in our own communities.

So, Madam President, we rise to support this legislation, and we look forward to it passing this Chamber and moving on to the House and ultimately to the Governor's desk for his signature.
