(Translation from Hebrew:)

May He who blessed our forefathers Abraham, Isaac, and Jacob, may He bless the fighters of the United States Armed Forces, the Army, Navy, Air Force, and Marines, who stand guard over our land and the cities of our God, wherever they may be. May Hashem cause the enemies who rise up against us to be struck down before them. May the Holy One, blessed is He, preserve and rescue our fighting men from every trouble and distress and from every plague and illness, and may He send blessing and success in their every endeavor.

May He lead our enemies under their sway, and may He adorn them with the crown of salvation and with the diadem of triumph. May there be fulfilled for them the verse, for it is Hashem, our God, who goes with you to battle your enemies for you to save you.

(Translation from Hebrew:)

May He who grants salvation to the kings and dominion to rulers, whose kingdom is a kingdom spanning all eternities, who releases David, his servant, from the evil sword, who places a road in the sea and a path in the mighty waters, may He bless, safeguard, preserve, help, exalt, make great, extol, and raise high our beloved President, Vice President, our Governor, our Lieutenant Governor, and all the Members of our Senate.

The King who reigns over kings in His mercy, may He sustain them and protect them from every trouble, woe, and injury. May He rescue them. May He gather peoples under their sway, and cause their enemies to fall before them. Wherever they turn, may they succeed. The King who reigns over kings, in his mercy, may He put into their heart and into the heart of all their counselors and officials compassion to do good with us, and with all the people of the Commonwealth of Pennsylvania. In their days and in ours, may God bless us all. Amen.

Senator GREENLEAF. Madam President, I rise in favor of this legislation that passed the Senate last Session by a vote of 50 to 0. What it would do is provide for Protection From Abuse action for those individuals who have been victims of sexual violence. It provides that a criminal complaint does not have to be filed, and the reason for that is that only about 28 percent of the victims of sexual abuse and sexual violence report their crimes, but they are still subject to the violence, harassment, and intimidation of the perpetrator. So we would like to reach out to these individuals who have been the victims to give them at least, if they are not going to prosecute the individual, then at least they could have the protection of a Protection From Abuse action, which this would be. Basically, this extends the terms and conditions of a normal Protection From Abuse action to sexual violence victims. Many other States have adopted this, and it has the support of the Pennsylvania Coalition Against Rape. I believe it will go a long way to provide protection for those people who have been victimized in our Commonwealth, and I urge an affirmative vote.

A Resolution recognizing the month of April 2007 as "Autism Awareness Month" in Pennsylvania.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Madam President, I seek support for this resolution designating the month of April as "Autism Awareness Month" in Pennsylvania. Autism is a developmental disability that often interferes with the person's ability to communicate with and relate to others. Symptoms can be mild or severe. The symptoms usually appear during the first two or three years of life, and are four times more prevalent in boys than in girls.

While the cause of this developmental disability is still unclear, some blame the vaccine preservative Thimerosal. Researchers are also looking at genetic causes. Although autism is still a mystery,

the statistics are striking as the number of people who are diagnosed with autism grows. The number of people across the U.S. diagnosed with autism over the past 15 years has risen by a staggering 2,000 percent. One in every 150 children nationwide has some form of autism, according to the latest research from the Centers for Disease Control and Prevention. That research relied only on data from public schools, so the statistics may be even higher if we include private schools and homeschooled children. In Pennsylvania alone, 1 in 190 children have some form of autism, and 75,000 people across the State have some form of autism.

Pennsylvania is responding to this growing issue. The Department of Public Welfare has created a Bureau of Autism Services to provide expertise and support for all State agencies that serve Pennsylvanians with autism. Also, autism advocacy groups have done their part to promote awareness and understanding of autism. The Philadelphia Phillies are doing their part to raise awareness of this disorder as well. On Saturday, April 28, I am participating in an Autism Awareness Night with the Phillies and two local autism groups. A portion of the ticket proceeds will go to local autism support groups. If you enjoy baseball, or want to enjoy a night with family and friends, I encourage you to join me for Autism Awareness Night at Citizens Bank Park.

In addition to Autism Awareness Night at the Philadelphia Phillies, the Senate can do their part to spur autism awareness, research, and education, by designating April as Autism Awareness Month. Researchers have found that if children with autism get treatment by age 3, their impairments can be lessened. By raising awareness, we can improve the quality of life for people who live with autism and for future generations. For all these reasons, Madam President, I ask my colleagues for the unanimous support of this resolution.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, I commend my colleague Senator Stack for offering this resolution today. When I first arrived here in 2003, Senator Stack's kind invitation to become a member of the autism caucus was when I first learned about something that, in many respects, is still a mystery in terms of the cause, the environment, the genetics, something that, as Senator Stack has indicated, is on the rise. I would also like to commend the administration, and particularly Secretary Richman, who convened stakeholders over a 3-year period to develop the strategic plan that Senator Stack mentioned in his remarks. Indeed, it is my honor and pleasure to join him, along with my colleagues, in support of this resolution.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Madam President, autism is a problem that cuts across every community within the Commonwealth, and no matter what the income level, no matter what the ethnic composition, every community suffers from the consequences of autism, and we need to create greater awareness as the first step in ultimately trying to solve this problem, as the first step in helping every child reach their fullest potential. I, like Senator Stack and Senator Wonderling, want to thank the administration

and Secretary Richman for the initial efforts in this regard, and I look forward to continuing progress so that every Pennsylvanian has an opportunity to reach their highest potential.

Thank you, Madam President.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, last week marked the 4-year anniversary of our invasion of Iraq. It is now well documented that a large majority of Americans have decided that this war is a

mistake. They recognize that the Bush administration has managed it poorly, and they know that our foreign intelligence experts almost unanimously believe it has made us less safe against terrorism because it has created a new training ground for al-Qaeda, and has fostered hatred for America in the Arab world, even among some nations with whom we once enjoyed substantial goodwill in the wake of the 9/11 attacks.

Americans are also filled with remorse and disgust over the now 3,241 United States soldiers who have been sacrificed, and the 23,417 who have been wounded in this sad misadventure. All that is well known here in this country, and it is reflected in the opinion polls that lean so strongly against this war. So, in marking the 4-year anniversary of the war this month, I would like us to spend a few moments today thinking about another group of people for whom this war has been costly, often in a horrifying way. Our invasion has rained misery down on a population that we are supposedly trying to help, the average Iraqi citizenry.

Four years after the invasion, USA TODAY, ABC News, the British Broadcasting Corporation, and ARD, a German TV network, surveyed 2,212 Iraqis. The findings were reported in several news articles, and I want to present some of them for the record on this floor today, because they paint a sobering picture of what we have done to their country. Six in 10 Iraqis say their lives are going badly, and only one-third expect things to improve in the next year. Of the 429 Baghdad residents surveyed, no one felt safe in his or her neighborhood. Everyone interviewed in the capital said he or she often avoided going outside because of the violence.

Across the country, Iraqis say the basics of day-to-day living have deteriorated. On each of 13 aspects of life, from security to the availability of cooking fuel and medical care, a majority rated the conditions as bad.

In the poll, most Iraqis say they have altered their daily routines to accommodate the realities of violence. More than two-thirds are careful about what they say about themselves to other people, 55 percent try to avoid passing public buildings, often the targets of suicide bombers, and 54 percent stay away from markets and crowded areas. Four years of upheaval have taken their toll on Iraqis' mental health. Three in four say they have feelings of anger or depression, trouble sleeping, and difficulty concentrating at work. Four in 10 report kidnappings for ransom in their neighborhoods. Three in 10 have had car bombs explode or sniper crossfire erupt close to home. More than one in six Iraqis say someone in their household has been physically harmed by violence, and nearly half have a close friend or immediate family member who has been injured. Seven of 10 Sunnis predict that their children's lives will be worse. Some Iraqis regret having borne children to be brought up amid such hardship. Three in 10 said they would move to another country if they could, and half are already making plans to do so.

Although Iraqis, by 43 percent to 36 percent, said that life was better than before the invasion, it is noteworthy that less than half of the population believes it, hardly an endorsement of the way we have managed the war. It is also noteworthy that the number is slipping, 51 percent believed it in November of 2005.

One of the most troubling findings for America, the pollsters note, is that the United States gets most of the blame from the Iraqis for the unrest in their country. Among both Sunnis and Shiites, the number of Iraqis who call it acceptable to attack U.S. or coalition forces has soared from 17 percent in 2004 to 51 percent now.

Another poll of more than 5,000 Iraqis by the British market research firm Opinion Research Business revealed similar concerns among Iraqis for their personal security. While that survey showed some faith in the future, with the support of the government of Nouri al Malik increasingly significantly from last September, the ORB poll also shows that a majority of Iraqis believe the security situation in Iraq will get better when the multi-national forces leave. So, even among the people who live there, who believe in their new government, they trust that things will improve only when we remove our troops from that country and bring them home. We should listen to their message.

Now I would ask you to honor the memory of two more Pennsylvanians who were killed late last year in Iraq. Chief Warrant Officer John R. Priestner, 42, of Pike Township, Bradford County, died November 6 in Ballad, Iraq, of injuries suffered when his AH-64 Apache helicopter crashed. Chief Priestner was assigned to the 1st Attack Reconnaissance Battalion, 82nd Combat Aviation Brigade, 82nd Airborne Division.

Private First Class Ross A. McGinnis, 19, of Knox, died December 4 of injuries suffered when a grenade was thrown into his vehicle in Baghdad. Private First Class McGinnis was assigned to the 1st Battalion, 26th Infantry Regiment, 2nd Brigade Combat Team, 1st Infantry Division.
