### SPECIAL ORDER OF BUSINESS PRESENTATION TO SENATOR VINCENT J. FUMO

He was in Iraq from September 20, 2006, until April 16, 2007, with Battery I, Third Battalion, 14th Marines, and he was stationed at the Marine Air base in Al Asad.

Sergeant FARRELL. Ladies and gentlemen, thank you very much for your time. I would just like to say that it is wonderful to be back in the good old United States and the great State of Pennsylvania, and to see everybody's smiling faces.

While I was away, Senator Fumo actually sent me a flag that I hung up in my room for the entire time I was in Iraq. It bore the red and white 13 stripes with a snake that said, "Don't Tread on Me," a good Revolutionary War era flag. As a return gift to him for his kind support, his constant e-mails and letters that I received on a very regular basis, my unit and I flew this American Flag over our mobile combat operations center at Al Asad in Iraq on the 16th of January, 2007, so I would just like to say thank you, and present this to Senator Fumo.

(Applause.)

Senator FUMO. Thank you very much, John. And my colleagues in the Senate, as you know, every week I make a speech and talk about two of our Pennsylvanians who have lost their lives in Iraq, and many of them were Marines. I am so overjoyed to have one of our sons come home to Pennsylvania safe. He served his country well and he is back home, and I could not be happier and more proud of him. We are all proud of him, and the Members of the Senate who have met him so far have done one thing, they have all said thank you. I think we all say thank you collectively for your service.

The PRESIDENT. Let us give a round of applause to Sergeant John Farrell.

Senator FUMO. He stands and sits so straight, he embarrasses all of us.

The PRESIDENT. Welcome back, Sergeant.

Senator A.H. WILLIAMS. Madam President, the resolution speaks to the importance of arts in Pennsylvania, and I am proud to say that 29 members of this Chamber signed on to this resolution. It says a variety of things. I am not going to read it, but it does speak to the effect that the arts has had in Pennsylvania, and the effect that it has had on many of us across Pennsylvania. I would like to draw attention to those of us who know we are coming close to budget season. It speaks directly to the students of Pennsylvania and the Commonwealth and how important it is to have the arts in schools. In order for us to do that and reduce violence across Pennsylvania, create opportunities, destinations, dreams, and hopes for children in Pennsylvania, the arts has to be part of its formal education process in Pennsylvania.

I would hope that during this upcoming budget, as difficult as it may be, that we recognize we cannot afford to cut any more programs related to the cultural and arts community in Pennsylvania. That means the public schools in Pennsylvania, that means the Arts Council of Pennsylvania, that means the different programs that we support across the Commonwealth of Pennsylvania, and I would hope the 29 members who signed the resolution reflect that importance and that commitment as we approach this budgetary season. Thank you, Madam President.

Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Madam President, I rise today and ask my colleagues to join me in designating the week of May 7 through May 13 as Jury Appreciation Week.

Every year, as the Chair well knows, the legal profession, as well as the Pennsylvania Bar Association and various county bar associations, celebrate the law during the month of May. They do so with a variety of educational and outreach programs. As part of this endeavor, Madam President, we celebrate the participation of our citizens, our Commonwealth citizens who have the opportunity to serve on juries.

The jury system, as we recognize it under American jurisprudence, traces its lineage back to Henry II, who set up a system to resolve land disputes by utilizing juries. A jury of twelve free men were assigned to arbitrate these disputes, and unlike the modern jury, these men were charged with uncovering the facts and the evidence of the case on their own, rather than having to listen to arguments and the presentation of evidence in a court of law.

Madam President, the use of the jury system as we recognize it was codified for the first time in 1215 when King John signed the Magna Carte making trial by jury an implied right of the English citizenry. Many English colonies adopted the jury trial system, including Pennsylvania, which first included the right to a trial by jury in its colonial charter and later in the various constitutions adopted by this very Commonwealth.

Madam President, the right to a trial by jury was also included in the Bill of Rights adopted in 1791. Jury trials in criminal cases are a protected right in the Constitution in the Fifth, Sixth, and Seventh Amendments. And Madam President, the 14th Amendment to the Constitution insures that the right to a trial by jury applies at the State level for both criminal and civil matters, and for a grand jury for serious offenses.

The right to a trial by jury has also been described as one of the very most basic fundamental rights of a democratic society because of the fairness and equality of treatment arbitrated and attributed to a trial that is heard and decided by a group of one's peers rather than the representatives of government.

Over the last several years, the Pennsylvania Supreme Court and other groups have studied ways to enhance jury service. Various proposals have been introduced and considered that would increase juror pay, that will provide child care services for jurors, and a number of other initiatives to make it easier for people to serve on juries.

Madam President, I have been working with my colleagues here in the General Assembly and the Senate in particular, as well as members on the judiciary, such as President Judge Joseph James from Allegheny County, on ways to improve the manner in which we select juries in this Commonwealth. Specifically, Madam President, Senate Bill No. 116 was introduced and has moved out of the Senate Committee on Judiciary. That legislation is intended to expand the jury pools in our counties so that jurors are more diverse by race, age, and experience,

producing a jury that is truly representative of the community in which the trial is occurring.

However, Madam President, it is important that we today here in our Commonwealth of Pennsylvania, and in our individual counties across the Commonwealth, during the month of May recognize the service of the people who have served on juries and encourage more of our citizens to do so. Jury service is critical to our system of justice, not only to a particular trial, or a matter that a particular juror is called to hear, but to our entire system of civil and criminal justice.

To those jurors, Madam President, who have served in the past, we say thank you for serving. To those individuals who have the opportunity to do so, we hope that you take this responsibility and make yourself available to serve as a juror when called upon for this very, very important civic duty.

Thank you, Madam President.
