Provided herewith is the Annual Report of the Hazardous Material Safety Program in the Commonwealth of Pennsylvania for calendar year 2005.

This annual report is required by the Hazardous Material Emergency Planning and Response Act (Act 1990-165). This legislation, signed into law on December 7, 1990 and amended on December 20, 2000, created a comprehensive, statewide program intended to provide the health, safety, and welfare of the citizens of this Commonwealth from exposure to hazardous materials in the facilities and from transportation-related accidents.

Act 165 established a comprehensive hazardous material safety program in the Commonwealth; created funds to provide financial assistance to Commonwealth agencies and counties; established emergency notification systems; assigned responsibilities to Commonwealth and local agencies; provided for civil liability protection to officials and emergency response personnel; and established fiscal reimbursement liability to those responsible for releases.

This report is submitted by the Pennsylvania Emergency Management Council/State Emergency Response Commission to the General Assembly in order to provide information on the activities undertaken to implement the Act.

Senator STACK. Madam President, I rise to briefly thank my colleagues for their support today of Senate Bill No. 221.

Senate Bill No. 221 provides members of the National Guard and Armed Forces with a 90-day extension for a license to carry a concealed firearm. The extension would be granted if a service member was deployed overseas and his or her permit expired during that time. Service members would be required to present a copy of their military orders and their expired license as proof of their ability to carry a firearm during the extension period.

This came to my attention when a constituent who serves in the National Guard phoned my office and we talked about it. He was concerned that his license to carry a concealed firearm would expire while he was deployed. Being that he was a law-abiding citizen and committed to public service, he wanted to ensure that he and other members of the military would not be penalized for service for their country. I think this legislation addresses those concerns by giving members of the National Guard and the United States Armed Forces adequate time to renew their licenses.

The Commonwealth of Kentucky has also provided this type of protection to their citizens who serve in the military. So I appreciate my colleagues' consideration and affirmative vote for the legislation. It is a small but important step that we can take to help our service men and women, and ensure that they are not penalized for serving their country.

The PRESIDENT. The Chair recognizes the gentlewoman from Venango, Senator Mary Jo White.

Senator M.J. WHITE. Madam President, I want to briefly put some comments on the record of the Senate regarding a very beautiful ceremony that the Chair attended today with me and Senator Baker in the Soldiers' and Sailors' Grove, which is a lovely park-like area behind the Capitol.

The grove is there to recognize Pennsylvania heroes, and specifically, there are markers there with the names of all Pennsylvanians who have ever been awarded the United States Congressional Medal of Honor, which, of course, is the highest military honor that can be accorded anyone in our country.

There are 463 markers out there, plus the one that was installed today. The wars represented include everything from the Civil War, the Indian campaigns, World Wars I and II, Korea, Vietnam, and Somalia.

Today, we put a marker there representing U.S. Army Staff Sergeant John Gary Gertsch, a resident of Warren County, who received the Congressional Medal of Honor in Vietnam, and died July 19, 1969. He was truly a hero. He grew up in Warren County, but it has taken us all of these years to recognize him

because Russell, where he grew up, is right on the line with the State of New York, and when he enlisted in the United States Army, he did so from Buffalo, New York, and was recorded as being a New York citizen. So, for all these years his marker has been missing from our grove of heroes, and today that oversight was corrected while his family attended. It was truly a beautiful ceremony.

There have been 3,463 medals of honor awarded in the history of our country. In Vietnam, nationwide there were 245. I am very proud that a son of Warren, Pennsylvania, was one of those heroes. John had a tough life. He grew up in a children's home with his sisters. He did not have the luxury of parents. I think perhaps the Army was his family because he loved the Army, he loved his fellow soldiers, and he gave his life protecting them, and I simply ask the Senate to observe a moment of silence as a belated memorial to this fine young Pennsylvanian.
