The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

Department; to provide appropriations from the Judicial Computer System Augmentation Account to the Judicial Department for the fiscal year July 1, 2007, to June 30, 2008; to provide appropriations from the Motor License Fund for the fiscal year July 1, 2007, to June 30, 2008, for the proper operation of the several departments of the Commonwealth and the Pennsylvania State Police authorized to spend Motor License Fund moneys; to provide for the appropriation of Federal funds to the Executive Department of the Commonwealth and for the establishment of restricted receipt accounts for the fiscal year July 1, 2007, to June 30, 2008, and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2007; to provide for the additional appropriation of Federal and State funds from the General Fund. the State Lottery Fund and the Pharmaceutical Assistance Contract for the Elderly Fund for the Executive, Legislative and Judicial Departments of the Commonwealth for the fiscal year July 1, 2006, to June 30, 2007, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2006.

Senator BROWNE, from the Committee on Finance, reported the following bills:

SB 97 (Pr. No. 1166) (Amended)

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, further providing, in bank and trust company shares tax, for ascertainment of taxable amount and exclusion of United States obligations.

SB 375 (Pr. No. 161)

So let us recognize and have a good hand for the students from Downingtown West High School.

THIRD CONSIDERATION CALENDAR

BILL REREPORTED FROM COMMITTEE AS AMENDED ON THIRD CONSIDERATION AND FINAL PASSAGE

HB 906 (Pr. No. 1887) - The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of July 31, 2003 (P.L.73, No.17), known as the Volunteer Fire Company and Volunteer Ambulance Service Grant Act, further defining "volunteer ambulance service"; further providing for guidelines and procedures, for award of grants and for expiration of authority; providing for publication and notice, for special provisions; and repealing an obsolete act.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Madam President, I rise in support of House Bill No. 906 and urge its final approval.

This legislation, very simply, is the House-passed version of the bipartisan Senate Bill 10 that many of us cosponsored at the beginning of this Session to continue the very important and very successful \$25 million annual State grant program to help our volunteer fire companies and ambulance associations with the high cost of equipment and facilities.

While the bill was amended slightly in the Senate Committee on Appropriations yesterday and will now have to go back to the House of Representatives for concurrence before it reaches the Governor for his final signature, the most important thing is that we are moving forward in acting on the House bill, which is critical to getting this signed into law as soon as possible.

Because we now have two fiscal years converging on one another, this legislation, in addition to providing for some permanency of this vital program, will cut down on the paperwork for our volunteer fire companies and ambulance associations by enabling a combined application process for the grants for the current fiscal year and the new fiscal year that starts July 1. And, it requires that our volunteers will receive the grant for the current fiscal year by this December 14, and the grant for the new fiscal year just a month later.

Madam President, as I have said, this is an important, essential program. In the last round of grants, in my own district, a total of 63 volunteer fire companies and 12 ambulance companies in my home county of Berks received a total of \$767,923 in grants. And, so far, since the inception of the State's program, Berks County's volunteer fire and ambulance companies have been awarded nearly \$3 million in State grants. That is a lot of chicken barbecues, breakfasts, ham and bean suppers, and pizza sales, and it is the least we in State government should be doing. Because, the fact is, our volunteers perform a critical public service in our communities, a service we cannot do without.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Westmoreland, Senator Regola.

Senator REGOLA. Madam President, as the prime sponsor of the Senate version, I rise in support of House Bill No. 906. This legislation would provide critical funding for our volunteer fire and ambulance departments.

Since 2000, the Pennsylvania General Assembly has regularly appropriated \$25 million for grants for volunteer fire and EMS departments. With last year's grant program expiring, it is vital that we pass reauthorization legislation.

Our volunteer fire and ambulance companies are the first line of defense in emergencies. Throughout Pennsylvania, our volunteer fire and ambulance companies rely on this program to help them make ends meet so they can focus on protecting our communities and less time on fundraising.

I am pleased that the Senate has made these grants a top priority, moving quickly to pass Senate Bill 10 in February and taking up House Bill No. 906 in a timely manner. The most important aspect of this legislation is that it reauthorizes the grant program for 5 years, rather than a year-to-year basis. Firefighters will now have more certainty with this legislation.

Madam President, I would also like to thank Senator Baker and Senator Waugh for working with me on this issue. I ask for an affirmative vote on House Bill No. 906.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Madam President, I too join my colleagues in advocating for an affirmative vote on House Bill No. 906.

Madam President, it has been stated this is a very important piece of legislation that accomplishes a number of goals. First and foremost, Madam President, it allows us to continue working in a very important bipartisan way in making certain that we provide the resources to our volunteer fire companies, as well as to our ambulance service organizations that exist throughout this Commonwealth. Also, it provides for a 5-year extension, Madam President, which I think is important, as was stated by my colleague Senator Regola, that it allows for the departments to have some certainty about what type of programs and what type of investments they will be able to make with the understanding that there will be resources there for them at least for the next 5 years. Also, by going to a 2-year type of program, it cuts some of the administrative costs that are associated with the program.

Madam President, I think this legislation is very important, as I said, for some of the reasons I just outlined. I also want to take a moment to make certain that for those who are watching today's Session debate about this legislation, that they make certain that their volunteer fire companies do, in fact, participate and apply for these grants before the deadline date that was stated. As we now know that this legislation provides for a 2-year period, if you do not get your application in I think in the early part of the process by the original deadline, you may not have the opportunity to participate in the second year. So I would encourage those departments that are out there watching today's program to make certain that they apply for these grant programs so they are not left on the outside looking in with respect to these programs.

Madam President, I think it is important that we acknowledge and recognize, and it is our acknowledgment to the local fire companies and to the EMS folks, that we truly appreciate the work they do. We know how they struggle to raise resources. As Senator O'Pake mentioned, they have to go through the bake sales and a variety of other ways to raise the resources to make certain that they have the adequate equipment, the state-of-the-art equipment in our respective communities, because the investment of their time and effort to protect all of us is so vitally important that it is only appropriate that the Commonwealth demonstrate its appreciation for those folks by providing this \$25 million grant program to all these communities.

I am very happy to join my colleagues in a affirmative way to support this legislation, and I, too, want to thank both parties who were involved with this legislation, because this is the type of stuff that we need to do in the manner which we have accomplished it, in a bipartisan manner.

Madam President, thank you very much.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Madam President, one comment I would like to make is if the citizens understood how much fire service would cost without these volunteers, it would be millions and millions of taxpayers' dollars. The least we can do is to support these companies with these grants for equipment and training.

Additionally, I want to thank Senator Regola and Senator Baker, and the Committee on Veterans Affairs and Emergency Preparedness, because from our point of view it was not a Senate bill, it was not a House bill, it was what bill would get through the quickest so that we can get this help for our fire companies, and the Senate showed great leadership by withdrawing our bill and essentially supporting the House bill so we could do this quickly. I think we did that, and both Senator Regola and the Committee on Veterans Affairs and Emergency Preparedness should be thanked for that. I am happy to rise in support of this as well.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Madam President, today will be a big step for the citizens' army, the volunteer firefighters, the EMTs, those who day in and day out risk their own welfare and safety for our benefit to make sure that we in Pennsylvania have our lives and property protected and ensure our safety. To them we owe a deep debt of gratitude, and recognizing their efforts and assisting them and the municipal governments, it is our obligation to vote "yes" for this bill, which I know my colleagues will. It is an important step and a big step. Kudos to the General Assembly for stepping up to the plate and for the Governor for signing the bill to assist our volunteer firefighters and our EMTs.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Madam President, we are spending a little bit of time importantly to thank our volunteer firefighters and men and women out in our communities who are special people. They run into a building when most people are running out of the building.

So I am very pleased, but since we are issuing a few thank you's, I do want to thank my colleague Senator Logan, who first came to me at least 3 years ago, as I first arrived in the Senate 4 years ago, and said we need to make sure that we have a dedicated revenue source for this \$25 million pot of money so it is not always on the chopping block of prioritizations each year when we are struggling to approve a State budget. I want to note and also thank Senator Logan for his leadership by making sure that we, as the elected officials both in the House and the Senate, grapple with the difficult issue of making sure we have money systemically in the budget from the original source of gaming revenue dollars.

So for those folks who continue to maybe have a little bit of concern about gaming, I would hope that they would recognize the important social purpose of these dollars being dedicated. I know in my three-county area I am proud to represent over 50 volunteer firefighting units, and I in my own family, my brother is a professional firefighter now retired. So I know a little bit about what a family goes through, and even yesterday in the city of Pittsburgh we had the death of five children, a horrific incident that is just heart wrenching.

So I think all of us on this floor know how important this service is to the community, how vital it is, and I am very pleased that we found a way to make sure that each and every year we do not have to argue about budget priorities when it comes to trying to get money back to these dedicated men and women in these very important volunteer fire units, paramedics, and first responders.

Thank you very much, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Waugh.

Senator WAUGH. Madam President, I rise today certainly to support House Bill No. 906 that is before us, and as previously mentioned, this is an extremely important bill to continue funding for fire and EMS services statewide. This is a program that over the years our volunteer organizations have come to rely on, depend on, and they are certainly deserved in all regions of the State.

I was not going to speak, Madam President, but I would just like to reemphasize the fact that also included in this proposal is a long-sought provision that would in many ways institutionalize this program, albeit a 5-year window, it is certainly better than we have had.

As you well know, each year we seem to go through this process of wrangling over what bill is going to be the one that provides grants to fire services. Therefore, we have had implementation periods that just run the gauntlet across the entire calendar year. Here we are again at the eleventh hour in fiscal year 2006-07 searching for ways to get the money out and into the hands of these folks, and fortunately, through the provisions in this bill, we are looking at not only doing this for the 2006-07 fiscal year, but in a proactive way, and hopefully a way that we will be able to continue in the future, looking at the upcoming fiscal year now so that that appropriation can be put in place.

I would just like to implore that the House of Representatives look at this bill seriously as it comes to them. Unfortunately, this is the second time the Senate has done this, we sent a bill to the House of Representatives earlier this year and they saw fit not to use the Senate bill but to extend the process by way of support of the administration and other organizations to drag it out, and now again put it back in the hands of the Senate. So here we are a second time.

It is high time, we are at the eleventh hour, to get this bill passed and in the hands of the Governor. The House of Representatives and those who speak for this bill need to understand that if it is held up again, it is their fault, not the fault of the Senate.

So I ask all those beyond this point who are involved in the process to take heed and move this bill along so we can get these funds distributed to our volunteer fire services statewide post-haste.

- (2) An open-end mortgage as defined in 42 Pa.C.S. § 8143(f) (relating to open-end mortgages), the proceeds of which are used to pay all or part of the cost of completing erection, construction, alteration or repair of the mortgaged premises secured by the open-end mortgage[.] or to secure certain advances under 42 Pa.C.S. § 8144 (relating to mortgages to secure certain advances).
- (3) Any substitution, refinance or modification of a mortgage referred to under paragraphs (1) and (2).

(a) Contractor. The maximum amount for which an interest in real property may be subject to a lien under this act for one or more lien claims filed pursuant to this act shall not be greater than the price of the contract between the owner and the contractor less the amount of payments made by the owner to the contractor or to another lien claimant prior to receipt by the owner of a notice of intention to file a lien claim pursuant to section 501.

(b) Subcontractors.

(1) In the case of a lien claim filed by a subcontractor in privity of contract with the contractor, the maximum amount for which an interest in real property may be subject to a lien under this act for one or more lien claims filed under this act shall not be the greater than the lesser of:

(i) the amount provided in subsection (a); or

(ii) the price of the contract between the contractor and subcontractor less the amount of payments, if any, justifiably made prior to receipt by the contractor of a copy of a notice of intention to file a claim by the contractor to the subcontractor or to another lien claimant in privity of contract with the subcontractor.

(2) In the case of a lien claim filed by a party of privity in contract with a subcontractor, the maximum amount for which an interest in real property may be subject to a lien under this act for one or more lien claims filed under this act shall not be greater than the lesser of:

(i) the amount provided in subsection (a); or

(ii) the price of the contract between the contractor and subcontractor with whom the party has contracted, less the amount of payments justifiably made, if any, prior to receipt by the contractor of a copy of the notice of intention to file a claim to the subcontractor or to another lien claimant; or

(iii) the price of the contract between the subcontractor and the party less the amount of payments justifiably made, if any, by the sub-

contractor to the party.

(c) Breach. For purposes of determining the maximum amount for which an interest in real property may be subject to a lien in the event that a contractor or subcontractor is in breach under the terms of a contract to which it is a party, the price of the contract shall be deemed to have been reduced by the damages incurred by the nonbreaching party to the contract as a result of the breach.

(d) For purposes of this section.

(1) The term "price of the contract" shall include amounts due for labor or material which are furnished as a result of:

(i) a contract;

(ii) a written amendment to a contract; or

(iii) any change order or other directive for labor or materials in addition to the scope of work under an initial contract, provided that the lien claimant has notified the party with whom it is in privity of contract within seven (7) days of the receipt of the change order or other directive that the furnishing is alleged to be in addition to the scope of work under the contract; or

(2) in the case of a supplier, "price of the contract" includes a delivery or order slip signed by the owner, contractor or subcontractor, or

an authorized agent of any of them.

(3) "Price of the contract" does not include an agreement predominantly intended to reduce the credit risk of a party, including a joint check arrangement, payment guarantee or similar credit agreement.

Senator KITCHEN. Madam President, I rise today to ask for unanimous support for a resolution recognizing June 16, 2007, as "Juneteenth National Freedom Day" in Pennsylvania.

"Juneteenth National Freedom Day" commemorates the anniversary of Juneteenth Day, in which slaves in the American southwest learned that they had been set free. This commemoration originated in Galveston, Texas, on June 19, 1865. More than 140 years later, Americans continue to celebrate this day of freedom.

"Juneteenth National Freedom Day" is the oldest African-American holiday observance in the United States. The holiday commemorates a joyous day for all African Americans. It also symbolizes optimism for people of all backgrounds.

Although the Fourth of July is a day for all Americans to celebrate our independence, Juneteenth Day is another reminder that the spirit of freedom is still alive today in this great nation. Juneteenth has become a day of reflection and renewal for people of all races, nationalities, and backgrounds.

Madam President, I hope that recognizing "Juneteenth National Freedom Day" in Pennsylvania will give everyone a chance to remember those who suffered in the bonds of slavery, and those who were set free. At the same time, we can all celebrate the progress we have made to ensure that all people, of all origins, have equal rights.

Thank you, Madam President.

And the question recurring,
