The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Madam President, I have a number of amendments here, all relatively identical, so to shorten this, they are for Senate Bills No. 953 to 959 inclusive. Every year in June it is time for the nonpreferreds, and everyone knows that every year I make this statement: There are hundreds of museums in the Commonwealth of Pennsylvania that do not receive one thin dime, and many of them are in the districts of my colleagues here in this Chamber. As a matter of fact, I am counting 1, 2, 3, 4, 5, 6, 7, 8, that for some reason deserve more than all of the other hundreds of museums in this State.

What I am going to do now, because every year I try to zero out these nonpreferreds, and I have nothing against the museums, but just like George Orwell's Animal Farm, all the animals are equal, but the pigs are a little more equal. A lot of these have hired lobbyists who come down here and fight for their money. I do not want to take all their money away, but here is what I am

going to try to do this year with the support of all the other Senators who do not have these nonpreferreds in their districts, but have museums. I am taking one-half of their appropriations and deleting them. I am then going to take the aggregate of all those halves and put that money into a fund called the Pennsylvania Museum Commission, which is a competitive grant program for all the other museums that do not get taken care of every year.

So, what I am asking for this year is ask the Members to support my amendments and take one-half away from the haves and give that other half to the have-nots and allow them to compete for some of the grants that they have never been able to acquire.

What I will do is get a good bellwether after the first two roll-call votes, and then if things do not work the way I would like, I will expedite the program, and then on final passage if I am not successful with these amendments, I will be voting in the negative on all the museums.

I have nothing against museums, I visit them all the time. They are good for culture, they are good for the mind, but if you are going to bring candy to school, you have to take care of everybody and not just a few.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Madam President, while I appreciate the gentleman's comments, I would note that these items are consistent with the Governor's Budget Address. We are working through the Governor's Budget Address and proposal in trying to reach a budget for the State of Pennsylvania, and this is part of that process. I would also note that these items have been reduced by approximately 9 percent when compared to last year's appropriation, and I have been told that these items have been in the budget with the last item added to this list over 10 years ago.

So, while I am sure there are other worthy institutions across Pennsylvania, I do not think that these institutions, which are worthy in themselves, should be penalized for the fact that others are not included. If there is a desire to add others or to fund other museums, I think that is a separate debate, and I do not believe today is the time for that debate. I would respectfully request a negative vote on the amendment.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Pippy.

Senator PIPPY. Madam President, I sit on the board for the Heinz History Center, which is one of the regional museums that gets its funding through the commission. What we have to do is show the need, and we work very hard to make sure that money is used appropriately. We are the only Smithsonian-affiliated museum in western Pennsylvania, and yet we are not on this list either. Over the last couple of years, we have been trying to get on the list, but we are kept being told no, and I think we have to start asking, why are they on the list? Well, I am going to vote "no" on the gentleman's amendment today because I think it is a little late in the process.

I think the gentleman from Johnstown will have a lot of colleagues, both Democrat and Republican, who are willing to sit together and put together a bill. I think that arbitrarily taking away 50 percent of the appropriation for these organizations and museums such as the Carnegie Science Center is inappropriate,

but I do believe we need to get this issue resolved, and with the new and open process that we have, this may be a time to do it.

So, I will be voting "no" on the gentleman's amendment, but I will offer to him and to my colleagues who have some excellent organizations which would do well in a competitive environment that maybe we should start getting together more often than we do and try to get these issues resolved. The museums are a good model for maybe some other issues that should be addressed within the Commonwealth, and although I am going to vote "no" on this amendment, I do support what the gentleman is trying to do and think we should be moving forward on it, potentially at a later time.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Madam President, the gentleman from Allegheny County is with me in spirit if not in purpose, and to the distinguished Republican Leader, I also respect the Governor and know these are all negotiated items, but as three co-equal branches, and this is one part of that co-equal branch. From my civics class, the legislative branch also has a say, and this is a battle I have been carrying for 20 years and not once have the haves ever said, Senator, you are right, we do need to sit down with all the other museums and work something out. They have theirs and the heck with everybody else.

Madam President, what I am trying to do is say, let us share some of this wealth and let some of those museums in Cambria County, Blair County, Monroe County, Indiana County, Lackawanna County, Scranton, and all the other places in between, have a chance at competitively going after some of these dollars.

Thank you very much, Madam President.
