(a) Authorization.—The Department of General Services, with the approval of the Governor and the Department of Military and Veterans Affairs, is authorized and directed on behalf of the Commonwealth of

Pennsylvania to grant and convey to the Borough of Mansfield certain land situate in the Borough of Mansfield, Tioga County for fair market value as determined by independent appraisal.

(b) Description.—The property to be conveyed pursuant to subsection (a) consists of approximately 1.23 acres and an armory building bounded and more particularly described as follows:

BEGINNING at a point at the western edge of the now or late Erie Railroad Company right-of-way, the Southeast corner of land of the now or late Mansfield Joint School Authority and the Northeast corner of land of the now or late Mansfield School District, the POINT OF BEGINNING; thence South 77 degrees 50 minutes West along lands of the now or late Mansfield School District, a distance of 273.67 feet to a point, the Southwest corner hereof; thence North 13 degrees 30 minutes West along lands of the now or late Mansfield Joint School Authority, a distance of 252.25 feet to a point, the Northwest corner hereof; thence North 76 degrees 30 minutes East along lands of the now or late Mansfield Joint School Authority a distance of 153.00 feet to a point at the western edge of the now or late Erie Railroad Company right-ofway, the Northeast corner hereof; thence along the said Railroad Company right-of-way, South 27 degrees 48 minutes East, a distance of 12.00 feet to a point; thence South 38 degrees 55 minutes East along said Railroad Company right-of-way, a distance of 272.25 feet to a point, the place of beginning.

CONTAINING 1.23 acres more or less.

- (c) Easements.—The conveyance shall be made under and subject to all lawful and enforceable easements, servitudes and rights of others, including streets, roadways and rights of any telephone, telegraph, water, electric, gas or pipeline companies, as well as under the subject to any lawful and enforceable estates or tenancies vested in third persons appearing of record, for any portion of the land or improvements erected on the land.
- (d) Use restriction.—Any conveyance authorized under this section shall be made under and subject to the condition, which shall be contained in the deed of conveyance, that no portion of the property conveyed shall be used as a licensed facility as defined in 4 Pa.C.S. § 1103 (relating to definitions) or any other similar type of facility authorized under State law. The condition shall be a covenant running with the land and shall be binding upon the Grantee, its successors and assigns. If the Grantee, its successors or assigns, permits any portion of the property authorized to be conveyed in this section to be used in violation of this subsection, the title shall immediately revert to and revest in the Granter.
- (e) Deed.—The deed of conveyance shall be by Special Warranty Deed and shall be executed by the Secretary of General Services in the name of the Commonwealth of Pennsylvania.
- (f) Costs and fees.—Costs and fees incidental to this conveyance shall be borne by the Grantee.
- (g) Proceeds.—The proceeds from the conveyance shall be deposited in the State Treasury Armory Fund.
- (h) Alternate disposition.—In the event that this conveyance is not executed within 12 months of the effective date of this section, the property may be sold by the Department of General Services, with the approval of the Department of Military and Veterans Affairs, for fair market value as determined by an independent appraisal.

Amend Sec. 3, page 33, line 2, by striking out "3" and inserting: 4

On the question,

An Act establishing the Resource Enhancement and Protection Tax Credit Program for the stewardship of agricultural lands and riparian corridors; creating opportunities for private investment in best management practices and riparian corridors; establishing a sponsorship program; authorizing the transferability of the tax credits; and imposing powers and duties on the Department of Revenue and the State Conservation Commission.

On the question, Shall the bill pass finally?

POINT OF ORDER

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Brubaker.

Senator BRUBAKER. Madam President, I rise to ask for a ruling on whether I am precluded from voting on this bill. This bill will provide tax credits as an incentive to private and agribusinesses for installing best management practices to reduce pollution and sediments coming from farms.

I currently own an agricultural consulting business that could consult with farmers and other affected parties regarding best management practices and utilization of tax credit incentives under this bill. So I ask, Madam President, for a ruling on whether I am precluded from voting on this bill.

The PRESIDENT. Senator Brubaker, in the factual situation you just presented, the Chair finds you do not face any conflict of interest, and in accordance with the Senate rules, you will be required to vote on this matter. The Chair finds that these issues are not particularly personal to you. You are a member of a class of people or consultants who may or may not be affected by this legislation. Further, the Chair finds that there is no personal pecuniary interest that would preclude you from voting.

And the question recurring, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Waugh.

Senator WAUGH. Madam President, I rise this evening to solicit support of my fellow Senators for Senate Bill No. 690. This proposal provides an important tool for the Commonwealth in offering incentives for the implementation of conservation practices on farms across the Commonwealth, and it does so by leveraging private dollars.

As the burden to improve the environment increases on our farmers throughout the State, with Federal mandates, regulations, and other policies that require them to watch their waste and keep

our streams clean, and that is a good thing, but in fact, a lot of pressure is being put on the farms to do that. There has been considerable demand from agricultural producers and farmers for financial assistance to support the adoption of additional conservation practices and best management practices in the field. In 2004 alone, Pennsylvania producers requested \$37.5 million more in conservation support from the United States Department of Agriculture's Natural Resource Conservation Service than was really available.

This proposal, REAP, as it has become known under its acronym, and actually named the Resource Enhancement and Protection Tax Credit Act, represents a real opportunity for us to help alleviate some of the burden that we have placed upon the farm community, while recognizing the financial limitations within which we as a State must operate. It is an investment in the future of our agricultural communities, an investment in the future of our environment, and in fact, I believe a generally good investment on behalf of this Commonwealth.

This program will provide tax credits for private investment in the implementation of a variety of proven and cost-effective best management practices, including improvement to barnyards, pasture cleanup and improvements, the implementation and construction of riparian corridors along stream banks, the development and implementation of nutrient management plans on farms across the State, remediation of legacy sediment deposits in streambeds and pasture areas, and other approved, and I stress approved, practices.

All eligible projects will be required to meet the design and construction standards established by the United States Department of Agriculture, NRCS, or the State Conservation Commission. The projects will also have to be certified by registered professional engineers. Credits will be available for personal and corporate income tax, the capital stock and franchise tax, and the sales and use tax. Depending on the practice, qualified applicants will receive a tax credit ranging from 25 to 75 percent of the project cost.

Other elements of the program provide that tax credits may be transferred or sold, if you will, to other entities for business or individual sponsorship of a project installed by a landowner and for a carryover of tax credits for a maximum of 15 years.

Madam President, I am sure you will recall, during the last Session, as part of the Farmers First agenda that our good friend, retired Senator Noah Wenger, and I had introduced, we held a hearing on this proposal, and there was extremely strong support by every agricultural organization and many environmental groups.

I think that alone speaks volumes, because you know from time to time it is hard to get those groups in the same room and come up with the same solution. In this case, we have had a significant response and it has all been positive, so I stand before this body asking for support of the program and appreciate the hard work and time that has been invested over the years, and I once again call up the name of a former Member who had an awful lot to do with this, Senator Noah Wenger.

Thank you very much, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Madam President, as a cosponsor of this legislation, I would like to commend Senator Waugh, and as he mentioned, Senator Wenger. He put a lot of work into this and it is good to see that the fruit of his labors is finally being recognized. I also rise in support of Senate Bill No. 690, the Resource Enhancement and Protection Act, or REAP, as it is commonly called, and I urge my colleagues on both sides of the aisle to support this important legislation.

As it has been stated many times in this Chamber over the years, agriculture is Pennsylvania's number one industry, but unfortunately, we have lost farms and farmers over the past 10 years. During that time, we have lost 23 percent of our dairy farms, which has resulted in a drop of 5 percent in our overall milk production.

Senate Bill No. 690 will give farmers, especially dairy operations, much needed assistance to install farm conservation practices that not only reduce nutrients and sediment runoff, but also increase farm productivity and reduce costs. That means more usable income for our farmers at this critical time. I believe REAP will be an effective tool, and it comes at the right time for our farmers and for the environment, so I urge favorable consideration by the Senate today.

Senator BAKER. Madam President, a press event was held yesterday at the Capitol to mark the kickoff of the Pennsylvania Project here in our Keystone State.

A national model, the Pennsylvania Project will assist Federal agencies in locating families of missing soldiers from the Korean War, Vietnam, and Cold Wars in order to obtain mitochondrial DNA samples.

The organization works to declassify Korean and Cold War era documents and to increase government awareness of POW/MIA issues.

The project also encourages veterans to offer critical information about the possible location of fallen and missing comrades so the Department of Defense can deploy search and rescue teams to recover and identify the remains.

The initiative was established by Robin Piacine of Mechanicsburg, Pennsylvania, in honor of her uncle, a member of the United States Air Force and an MIA from the Cold War period. Once implemented in Pennsylvania, the project is set to be introduced across the nation.

According to the figures compiled by the Department of Defense's Joint POW/MIA Accounting Command, in total, over 88,000 United States soldiers never returned home after fighting for our country in World War II, the Vietnam War, the Korean War, the Cold War, and the Gulf War. Officials believe there are

recoverable remains of over 45,000 of these soldiers in Europe, the Pacific, Southeast Asia, and the Middle East.

Here in Pennsylvania, 702 families are still waiting for their loved ones, soldiers who served in the Cold War, the Korean War, and the Vietnam War, soldiers whom their families would like to bring home.

The Pennsylvania Project gives us hope that our lost soldiers, heroes fallen on battlefields past and forgotten, might find their way home and their families might find peace.
