PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, I would like to offer some comments regarding the resolution that was passed unanimously by this Senate earlier today, Senate Resolution No. 162. I know some Members were clamoring for me to make comments regarding Posh Spice or soccer player Beckham's ankle, but I am not going to do that. I am going to be serious for a moment

This designation as "Youth Soccer Month in Pennsylvania" in many respects goes to every hamlet and village in this Commonwealth, where so many young people play soccer not only during this time of the year, but also throughout the 12 months of the year. The resolution which I offered today, and as I did last year, was offered in the memory of a good friend of mine, a youth soccer coach who passed from this earth very unexpectedly a number of years ago. That citizen in the Commonwealth, the late Rob Schaefer, loved soccer and played in high school and college at high levels, but, more importantly, he saw how soccer could change the life of an individual, a young Pennsylvania, and a family.

In his memory, our community has organized the Rob Schaefer Memorial Soccer Tournament that occurs each year in Lower Salford Township, Montgomery County, Pennsylvania. It was the volunteers of this event last year who asked me to introduce the resolution in Rob's memory, and not so much in Rob's memory, but in the notion that through sports, community activity, and the spirit of volunteerism, good things could happen to a community. Madam President, I do this today and in the years forthcoming in Rob's memory.

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Madam President, the Senate convened yesterday in Special Session to focus on the future and the future energy needs of this Commonwealth. The sources of energy that we use to fuel our cars and power our economy today may become scarce, unreliable, or even unaffordable at some point in the future, so this Special Session provides us with a choice: we can work together to help provide all Pennsylvanians with cleaner, cheaper, and more sustainable sources of energy for years and years to come, or we can go back home and tell the people who sent us here, sorry, but you are on your own.

Every consumer, worker, and small business owner in every corner of Pennsylvania has a huge stake in what we do. The consequences are enormous. All you have to do is look at what happens when the price of gasoline suddenly spikes higher. Family budgets are strained, and the higher costs of business means higher costs for goods and services. Family vacations are suddenly out of the question, carpooling is no longer an option but

a necessity, and every little yellow school bus you see on the road becomes a very big drain on every school budget.

Even though the price of oil is now over \$80 per barrel, the rising price of gasoline is not the only challenge facing us on this energy horizon. In fact, it may not even be the biggest challenge to Pennsylvania's economy and the quality of life of our citizens. I see the wisdom in helping electric customers save money through smart meters and day-of-rate time and rate structures, but those pennywise savings will be wiped out a thousand times over when the electric rate caps expire and come off in a few short years.

Unfortunately, I feel the same way about educating consumers about energy conservation. When the rate caps do come off, electric customers are going to need a lot more than education, they are going to need resuscitation, and I am not talking about just residential customers. I have already been approached by both small business owners and large industrial customers in my district who are afraid that market rates will put them out of business when their electric bills increase by 50 percent.

We cannot allow good paying jobs to disappear when the rate caps disappear, and that is why no matter what we do in this Special Session, we must not forget to address this issue. I know you have heard this before, but I am going to say it again, doing nothing is not an option. All you need to do is look at other States like Illinois and Ohio that are taking drastic measures to deal with this fallout caused by the so-called free market. What has already happened in other States can and will happen here. Unless we really do something bold, energy independence is going to be the biggest hoax to the people of Pennsylvania that they have ever witnessed.

In just 3 years, the people back home who pay our bills are going to be hit with 50-percent higher electric bills, 50-percent higher electric bills in the next couple years. By that time, the price of gasoline could be \$5 a gallon, and the price of milk, meat, and dozens of other items in the family's shopping cart will be incredibly more expensive because of the growing demand for corn to make ethanol. While it is important that we encourage solar and wind power, and provide tax credits for clean energy, biofuel plants, and advanced energy technologies, we must not add to the heavy burden of Pennsylvania's electric bills, and we cannot pretend that phony competition, self-dealing, and market abuse is what any of us envisioned when Pennsylvania started down this road to deregulation 10 years ago.

Like I said before, Madam President, this Special Session provides us with a choice, and that is more than consumers and small business owners will have in the few short years ahead unless we do something now to prevent this economic train wreck that is not just heading our way, but is also picking up speed.
