An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, further providing for the educational assistance program; and, in charter schools, further providing for enrollment.

And the question recurring, Shall the bill pass finally?

POINT OF ORDER

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia. Senator Anthony Williams.

Senator A.H. WILLIAMS. Madam President, I rise for a point of order.

The PRESIDENT. The gentleman will state his point.

Senator A.H. WILLIAMS. Madam President, I request a ruling from the Chair under Senate Rule No. XXI. I serve as the president of a charter school in Philadelphia County, Riverside Charter School, and I am concerned about a potential conflict, and I want to know if I am permitted to vote on this legislation.

The PRESIDENT. Senator Williams, in the situation you have just described, the Chair would rule that you face no conflict of interest and therefore, in accordance with the Senate rules, you must vote on this matter. First, the Chair finds that you are a member of a class of directors of your particular school and a member of a class of all directors of various charter schools around the Commonwealth. The Chair finds that there is nothing particularly personal to your Senate position insofar as this bill is concerned.

Senator A.H. WILLIAMS. Thank you, Madam President.

The Schuylkill River Valley is one of the most historically significant geographic regions in the United States. A variety of people, from our early settlers on, settled in the Schuylkill River Valley home. Its abundant natural resources and productive soils made it an early industrial center and breadbasket for the colonies. The Schuylkill River and the canal systems were major arteries in the industrial revolution, transporting coal, manufactured goods, and crops to the port of Philadelphia. Today, the valley still boasts abundant cultural, natural, and recreational resources along this landmark.

Madam President, I am pleased to offer the resolution, and I would like to say that the Schuylkill River and the Schuylkill River Valley are receiving a lot of attention of late from the Montgomery County Community College under Dr. Karen Stout and the dean of the Pottstown campus, Dean Foster, along with Kurt Zwikl and his group, the Schuylkill River Greenway Association, to promote the Schuylkill River, to explore environmental studies there, and promote their rich heritage.

I would also like to thank Senator Fumo, who worked with me to obtain grant money for the Montgomery County Community College Pottstown campus for the construction of an environmental resource center there, and working in conjunction with the Schuylkill River Greenway Association for environmental studies on aquatic life, on the pristine condition and keeping the river alive, on insect and plant life all along the Schuylkill River. It is an important day, and I ask for an affirmative vote.

(The following prepared remarks were made a part of the record at the request of the gentlewoman from Philadelphia, Senator TARTAGLIONE, and the gentleman from Philadelphia, Senator STACK:)

Madam President, on behalf of Senator Stack and myself, I am pleased to introduce two resolutions today. One resolution designates October 2007 as "Polish American Heritage Month" and the other resolution designates October 14, 2007, as "Pulaski Memorial Day" in Pennsylvania.

Polish-Americans have been major contributors to the history of the United States. Our State is home to the nation's fourth largest concentration of Polish-Americans, nearly 825,000 people. Erie and Scranton/Wilkes-Barre boast of a large Polish-American population. Madam President, Polish-Americans have contributed greatly to our nation and our great State. They also continue to uphold their Polish customs while demonstrating their pride as Americans. It is fitting to honor the accomplishments of all Polish-Americans and their culture. Therefore, I ask my colleagues to join me in unanimous approval of these resolutions designating October as "Polish American Heritage Month" and October 14 as "Pulaski Memorial Day."
