The Senate met at 11 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

PRAYER

The Chaplain, Rabbi SOLOMON ISAACSON, of Congregation Beth Solomon Synagogue, Philadelphia, offered the following prayer:

Good morning, gentlemen and ladies. I normally do certain prayers here. I would like to add some today because we recently had what is known as the Jewish New Year. The Jewish New Year celebrates the creation of mankind; however, the creation of Adam and Eve is nonsectarian, it is the creation of the world. I just heard recently that the Chinese New Year is 1,063 years younger than the Jewish New Year. That means the Jewish people had to make their own Chinese food for 1,063 years before the Chinese came along. I do not know if that is factual or not, so we are trying to debate whether anybody had Chinese food then, or not, and we are looking into that, and I will let you know in future Sessions as to whether that ever came about.

By the way, I told somebody here earlier that the Pope went to visit Jerusalem, he met the Prime Minister, they talked about various different things, and then the Pope challenged the Prime Minister to a game of golf, and since neither of them could play they decided to send representatives. The Pope goes back to Rome and asks any of the Cardinals if they could play, and none of them could play. So one Cardinal raised his hand and said, Your Holiness, there is a nice Catholic boy by the name of Jack Nicklaus who used to be a prominent golfer. You are the Pope, you can make him a Cardinal overnight and send him to Israel, and they will not know the difference.

So, Jack goes and comes back, and the Pope asks, what happened? He said, oh, Your Holiness, this sight, that sight-- The Pope said, do not give me the sights, I know the sights. He said, what happened to the game? Jack said, I lost. The Pope said, you, Jack Nicklaus, lost? Who did you lose to? The Jewish people do not have anybody who can play golf. He said, I lost to Rabbi Tiger Woods.

Getting to more serious things, there are special prayers that are said in honor of the New Year that we believe that from the beginning of the day of Rosh Hashanah, which is the beginning of the New Year, and concludes 10 days later with the holiday of

Yom Kippur, which is the day of atonement, that God looks at our lives and decides and writes in there what is going to happen to mankind for the coming year. So, we say certain prayers. I wanted to say that because it encompasses everyone. They are:

Remember us for life, O King, who desires life, and inscribe and seal us in the book of life for Your sake, O Living God. Who is like You, Merciful Father, Who recalls His creatures mercifully for life. Inscribe and seal us, all the children of Your covenant, for a good life.

In the book of life, blessing and peace, good livelihood, good degrees, salvations and consolations, may we be remembered and inscribed and sealed before You, we and all Your people of the family all over the world that are Your creations for a good life and for peace. Amen.

I would also like to say a prayer for the soldiers, especially since I found out that my Senator decided to join the Reserves. Now they need the prayers more than ever since Senator Stack is there, so we have to see what we can do.

May He who blessed our forefathers Abraham, Isaac, and Jacob, may He bless the fighters of the United States of America from the Army, Air Force, Marines, and Navy who stand guard over our land and the cities, wherever they may be. May Hashem, the Almighty, cause the enemies who rise up against us to be struck down before them. May the Holy One, blessed is He, preserve and rescue our fighting men from every trouble and distress and from every plague and illness, and may He send blessing and success in their every endeavor.

May He lead our enemies under their sway, and may He adom them with a crown of salvation, and with the diadem of triumph. May there be fulfilled for them the verse, for it is Hashem, our God, who goes with you to battle your enemies for you to save you and let us say. Amen.

The King who reigns over all kings in His mercy, may He sustain them and protect them from every trouble, woe, and injury. May He rescue them. May He gather peoples under their sway, and cause their enemies to fall before them. Wherever they turn, may they succeed. The King who reigns over kings, in His mercy, may He put into their heart and into the heart of all of their counselors and officials compassion to do good for all the

great people of our great Commonwealth. In these days and in ours, so may it be His will. Amen.

SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR STEWART GREENLEAF AND SENATOR JOHN C. RAFFERTY PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Madam President, seated in the gallery are several high school students from Wissahickon High School in Montgomery County, joined by their teacher, Alan Ostrow, who have come to the Capitol today to share their work with FIRST Robotics, a nationwide organization in which teams of high school students compete with one another to build a robot.

This morning, when I walked into the Capitol in the East Wing atrium, I was surprised to see many high school students, obviously many of them from Wissahickon High School, and all their robotic products. It was a very, very impressive sight.

In a world where we are competing for science, and where our engineering and science graduates are declining and the rest of the world's graduates are increasing, it is important for us to provide engineering and scientific opportunities for our students. This program does exactly that. They are being taught by teachers who are qualified. Mr. Ostrow has an engineering degree in mechanical engineering, and they are being tutored to learn how to do things such as this, to compete, to share their information with other students, and with other high schools, and to provide a learning atmosphere in which they enjoy and realize that science, math, and mechanics are fun. So, as a result, it is a pleasure to be involved with this program.

The Wissahickon team, known as Miss Daisy, and they have the robotic product out there, and it is in the Rotunda for everyone to see. It is a three-time regional chairman's award winner and two-time national runner-up for the first highest honor.

Known internationally for mentoring teams, Wissahickon has mentored schools across Pennsylvania and around the world, including five rookie all-star winners. Miss Daisy has also produced large scale technology shows for the Franklin Institute, Singapore Science Center, and two NBC network affiliates, with the goal of inspiring students to pursue technological careers.

On November 10 they will hold a 36-team robotics competition, Ramp Riot 2007, at Wissahickon High School. With that, I ask the Senate to give a warm welcome to my guests, Alan Ostrow, and the students from Wissahickon High School, but before we do that, we want to hear from Senator Rafferty, who is also very proud to represent the school district of Wissahickon High School.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Thank you, Madam President. Thank you, Senator Greenleaf. The Senator and I both represent Wissahickon, which is known for its quality education. Wissahickon, participating in today's program and in a competition later in November, is not only teaching the children the importance of science and engineering, but also reminding us all that we once were at the forefront of graduating scientists and engineers, we, the United States, and we are starting to slip in that category. It is very important for us to stress science and engineering on the junior high and high school level, and then, of course, on to the college level.

What these young men and women are doing today in the competition, Madam President, competing with one another as schools, but also setting a precedent for us as the Commonwealth of Pennsylvania and the United States to compete globally and to use our education and our faculties and our resources to rise to the top in engineering and science, and maintain that position throughout the world. So, I congratulate the students from Wissahickon and congratulate all those participating in today's program. I had the chance to talk to retired Captain Bob Boyce, who is here with Malvern Prep. He lives in my district, but Malvern Prep is in Senator Dinniman's district. He was a submariner for the United States Navy and is now using his education

and tools to work with today's students. So I congratulate him as well as the Wissahickon students who are here.

On behalf of myself and Senator Greenleaf, I ask the Senate of Pennsylvania to continue with the tradition of extending a warm welcome to these students today.

Thank you, Madam President.

They are here today with Mr. Roy Wescher, and Roy, if you recall, each year brings several ASSE students to visit the Capitol, spend the day here, and learn about our system of government. In addition to Roy, I would like to introduce the six students whom he has with him and are sitting in the balcony. We have Laura Funke, from Germany; Anais Guillemaud, from France; Eugene Aleynckov, from Russia; Eric Dueck, from Germany; Maria Lisenko, also from Germany; and finally, Anna Seichter, who is also from Germany. They are all here today as our guests. We welcome them and I would appreciate a warm round of welcome from the other Senators.

Senator WONDERLING. Madam President, I understand my colleagues, Senator Greenleaf and Senator Rafferty, have already referenced several robotics teams, young men and women who are visiting Harrisburg today, and I would like to perhaps amplify their comments on the background of this nationally recognized program, the FIRST program, which was founded several years ago by Dean Kamen. Dean Kamen, for those who are not familiar with him, invented the Segway, which is a really cool ride, and if you get a chance, I highly recommend you ride a Segway.

The goal is to encourage math, science, and technology among our high school students in the Commonwealth. The FIRST program also brings together private sector adult mentors and students. Right now, approximately 5 percent of the schools in Pennsylvania have this program underway, and the goal is to triple that number within the next 5 years. Hopefully, there will be a robotics program and competition in all of my colleagues' Senate districts in the not too distant future.

With that, I would like to recognize and welcome two schools, two teams that are here. First, representing Palisades High School in upper Bucks County, is the Cybersonics Robotics Team, and also, from Montgomery County, the borough of

Lansdale, Lansdale Catholic High School, the Lansdale Crusaders Robotics Team, is here this afternoon.

Thank you, Madam President.

The PRESIDENT. Would the Palisades and Lansdale teams representing math, science, technology, and robotics please rise so we can welcome you.

BILLS OVER IN ORDER

SB 751, SB 806, SB 807, SB 808 and SB 813 -- Without objection, the bills were passed over in their order at the request of Senator PILEGGI.

BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 986 (Pr. No. 1468) -- The Senate proceeded to consideration of the bill, entitled:

An Act providing for banning bonuses provided to employees of Commonwealth agencies.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Blair, Senator Eichelberger.

Senator EICHELBERGER. Madam President, I rise to offer a bill for the betterment of this Commonwealth, a bill that is unfortunately necessary at this point in our history. Madam President, storm clouds gathered over this General Assembly early in the year when news that secret bonuses were given to select staff of Democratic and Republican House and Senate Members. Allegations quickly followed concerning the purpose of some of these bonuses. To the credit of the current leadership of all four Caucuses, information was provided to the public regarding the bonus amounts with names and salaries of the employees involved. All four Caucuses said that this would never happen again, and that we were moving on to more important things for our citizenry. Many issues were, in fact, not addressed, Madam President, issues like possible violations of the law now under investigation by the Attorney General, and the commitment of future leaders to abstain from dispensing bonus checks, as well as the unknown actions of the executive and judicial branches of this government and various State agencies.

This bill establishes a very controlled pay structure in which bonuses clearly defined in the bill would be banned, and that criminal sanctions are set forth for anyone who intentionally approves or authorizes such a bonus. More recently, the news of bonuses paid to the management employees of the Pennsylvania Higher Education Assistance Agency, or PHEAA, became a topic of conversation for most Pennsylvanians. This issue, separate and distinct from the legislative bonuses, is one that needs to be addressed in several ways. This bill addresses the PHEAA situation by providing for a personal compensation plan or employment contract to be open for public inspection, and further provides that any contract containing performance-based incentive payments must have said payments included in the written contract, and that said payments must be based on objective criteria.

Madam President, this bill in the Senate is an important first step in the process of addressing and remedying these abuses of public trust. If this bill is passed today, the Members of the House of Representatives must act swiftly and send this bill to the Governor for his signature, and the Governor must not posture, but sign this bill into law. The Attorney General must continue his investigation into the legislative bonuses and follow it into both Chambers of the General Assembly and on to both sides of the aisle. The PHEAA board and the legislature, collectively, must look at the many troubling questions surrounding this agency, and do so openly, earnestly, and without hesitation. Those remedies may be far-reaching and substantial, but are critical and need our utmost attention.

Madam President, this bill sets forth structural parameters and criminal penalties for controlling arbitrary bonus payments to a select, well-connected group of individuals, but it will take more work from public officials to ultimately fix all that is broken. I ask for the Members' votes to support this important bill.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Madam President, first, I would like to commend Senator Eichelberger for his work on this issue and on the formulation of Senate Bill No. 986, prohibiting bonuses for State employees. I have been asked questions and I think it is important for the Members and for the viewers at home, and the members of the public, to know that the definitions that are contained in Senator Eichelberger's bill defining bonus and clarifying that definition allow for good management practices, including good management practices that we follow here in the Senate.

Specifically, I have been asked about subsection 4 that deals with the annual cost-of-living adjustment equivalency payments made to individuals at the maximum of a salary range. In the compensation management plan that we have in place in the Senate, which has been in place since 2004, when employees reach the maximum pay scale, they are eligible for cost-of-living equivalency payments made to that employee to compensate them for their work, but that is not added to the base of the salary. We believe that that is a good management tool, but since I had received questions about that, I thought it would be appropriate to publicly state the intention of subsection 4 and how it fits into the compensation practices in the Senate's written compensation management plan.

With that, Madam President, I ask for an affirmative vote on Senate Bill No. 986.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Madam President, I also rise to support this bill. I think it is important that we go on record as opposing a practice which got out of hand in the State House, and it is important to let the people of this Commonwealth know our commitment to fiscal responsibility, and I thank Senator Eichelberger for introducing it.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Madam President, I to rise to compliment my friend and colleague, Senator Eichelberger, for introducing this bill, and for the hard work by leadership on both

sides of the aisle. Certainly, I have been critical of one agency in particular, but also of the practice of bonuses. Senator Orie and I have made some print of late, and I am happy to see that this bill is making its way through the Senate. We can now get a handle on this idea of bonuses, and realize that there is a public service theme that runs through employment in State government no matter what your position, no matter what branch of government, and no matter what agency. I encourage an affirmative vote.

Thank you, Madam President.

And the question recurring, Shall the bill pass finally?

The yeas and nays were taken agreeably to the provisions of the Constitution and were as follows, viz:

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Brubaker.

Senator BRUBAKER. Madam President, I am here today to talk about a very serious issue that is occurring right now in the Commonwealth of Pennsylvania. Approximately 800 homeowners were making their mortgage payments on time, every time, to their mortgage initiator. We have recently learned that the mort-

gage initiator did not forward those mortgage payments on to the rightful source. As a result, between \$40 million and \$50 million of Pennsylvania's mortgage payments are lost. As a result, Pennsylvania mortgage holders are now paying as much as two times their monthly payment for the mortgages, which in many cases they cannot afford to pay. There is a net loss of net worth in excess of \$50 million to these people.

Also, over 800 families in Pennsylvania, as a result of paying their mortgages on time, every time, only to have their mortgage payments not forwarded to the rightful destination, now have bad credit, which they do not deserve. In addition to this, this tremendous financial stress on 800 Pennsylvania families is not only causing financial stress, but also causing tremendous family stress as well, family stress and financial stress. This situation is a travesty and should have never happened. I am calling on all Members of the Senate, all Members of the General Assembly, the Governor's Office, the Attorney General, and the Pennsylvania Department of Banking to do everything within our power to correct this situation. I would like to thank the Attorney General's Office and I would like to thank the Pennsylvania Department of Banking for being proactive and working hard to attempt to get this situation resolved. We must keep the investigation going, and going strong, and allow the investigation to go wherever it may to clean up this mess.

Eight hundred Pennsylvania families need help right now. They have critical decisions to make, and they do not know where to go for help. In many cases, they are paying \$400, \$500, and \$600 more per month for their mortgages than what they originally signed up for, and they cannot afford the mortgage payments, nor can they afford to bring on an additional lawyer or accountant to help them with these difficult decisions. The Commonwealth of Pennsylvania needs to step up right now and help these 800 families and do whatever we possibly can. We need to help them with the critical decisionmaking processes that are before them, and we need to help clean up their record, which should never have been a problem in the first place.

Thank you very much for the opportunity to speak out on this very important topic.

The PRESIDENT. Thank you, Senator Brubaker, for calling our attention to this serious problem for 800 Pennsylvania homeowners.
