On behalf of the Department of Agriculture, I am pleased to provide your office with a report summarizing the activity under the State Food Purchase Program for the year ended June 30, 2007. This report is in accordance with Section 7(b) of the State Food Purchase Program Act (62 P.S. Section 4047(b)), and its attendant regulations.

The program, which is administered by the Department's Bureau of Food Distribution, provides cash grants to each of the state's 67 counties for the purchase of food for distribution to needy individuals, based on the county's weighted percentage of the state's total employment, Medical Assistance Eligibles, and Non-Public Assistance Food Stamp Eligibles.

The report includes:

The PRESIDENT. The Chair recognizes the gentlewoman from Allegheny, Senator Orie.

Senator ORIE. Madam President, today on behalf of the Allegheny County delegation, I would like to take a few moments to congratulate a constituent of mine, Mr. Bob Kopler, upon his retirement from KDKA News Radio 1020. Bob spent nearly 50 years providing distinguished service in the field of broadcasting and has earned a reputation as a true and fair professional. Before beginning his career with KDKA, Bob served his country in the United States Marines. He then embarked on a long career in his chosen profession, working for numerous radio stations.

Bob joined KDKA in 1988, where he was the popular morning anchor for many years. As a testament to his skills and popularity, he has earned six Achievement in Radio Awards for newscaster of the year, as well as the ultimate achievement, the Lifetime Achievement Award, in 2005. He has long been known by those who work with him for his exceptional talent, commitment to his craft, and integrity, and for that, he has earned the respect and admiration of his friends and colleagues.

Madam President, on behalf of my Allegheny County colleagues, I ask my colleagues to join me today in acknowledging and congratulating Bob Kopler on his retirement from 50 years of tremendous broadcasting service.

The PRESIDENT. Will the Senators all please stand in recognition of Bob Kopler for 50 years on radio news at KDKA Pittsburgh.

(Applause.)

The PRESIDENT. The Chair recognizes the gentleman from Schuylkill, Senator Rhoades.

Senator RHOADES. Madam President, if we in this Senate are looking for a problem to solve, we do not need to look any further than the gas pumps at the corner convenience stores. We do not need to search beyond the oil and gas prices that are waiting in our mailboxes. For thousands of Pennsylvanians, the price of gas and home heating fuel is a crisis. These costs are stretching family finances to the limit, and this winter, thousands of people we represent could be left out in the cold unless we do something about it. And we can do something about it today.

I have introduced two bills to help solve the problem. The first would freeze the price of gas and home heating fuels. The second would offer \$80 million in rebates to Pennsylvanians who are eligible for the Property Tax and Rent Rebate Program. Now, I know that with some people, this may be a very unpopular action. I also realize that this could impact some local distributors in the short term. But the Federal government, and I bring it out, and I will point to it, both the President and the U.S. Congress, the U.S. Senators and the U.S. Representatives, are the ones who should be acting to freeze prices for fuel producers this year, as far as any State law will allow us to go.

And the only reason I have to do this is I have not heard anything from them. When we go to the pump and are paying \$3.25 or more for a gallon of gas while people are paying \$3.25 a gallon for home heating fuel and stretching it, they are not filling up their tanks now. They cannot. They are ordering it by \$100 or whatever it takes. If you are in the LIHEAP program and you get \$300, that goes in a month's time, if not more, depending upon what the weather is like. That is gone.

What do these people do? Where do they turn? You know, one of the things to think about is that is where fires start because people try to find ways in which to heat their homes outside of the normal or usual or safe way. So I took this action, and this is the action I had to take because of the Interstate Commerce Act. A lot of the bases or the offices for these big oil companies are outside of Pennsylvania, and we cannot interfere with interstate commerce. The Federal government can, the President can, and the U.S. Congress can, and they should.

The other thing, too, is that the oil and gas companies are making more money than they can spend. Just get on the Internet and look at their percentage of profits. Right now there is also approximately \$80 million in unspent State funds in our Pennsylvania Property Tax and Rent Rebate Program.

And let me add this, because this comes to it, too. We are finally getting, I hope, to the verge of giving a property tax break to the citizens of the Commonwealth. When we do that, even those people who participate in the Property Tax and Rent Rebate Program will get money. That should help reduce demand on the property tax and rent rebate money so that they may not need as much. In other words, if they do not need the \$650 because we are giving them \$200 or \$300, that is \$200 or \$300 that is still left in the Property Tax and Rent Rebate Program.

North Off.

Right now, there was an article in this morning's paper, four of the five highest-ranking, shall we say, casinos bringing money in are located in the Commonwealth of Pennsylvania. In other words, our casinos are doing better, even though they are all not up and running, are doing better now than all the other casinos in the Northeast. Four of the five are right in Pennsylvania.

For me, the question is not why we should do this. It is not why we should enact these bills. It is not why we should solve the problem. The question is why we should not. If we do not, what are we doing here? If we do not, how do we go home and look our constituents in the eye?

Part of my thing, and I think you heard me when we had reorganization on New Year's Day, and I think we have to begin to focus on that point, one of the things we have to do is insure, I think, an entitlement of opportunity. Not welfare, but everyone has food on the table, clothes on their back, a roof over their head, affordable healthcare, and a couple of bucks to enjoy life with.

With the crisis we have in fuel oil and gas, that is being taken away from us. And I will give you some more information on that later as to where this wealth is going. We are elected to solve problems, and so often we spend time listening to the reasons why we cannot, why the problems are too hard to solve, and why the interest groups will oppose them.

Can we freeze fuel prices? Yes, we can, so let us do it. Can we give needy Pennsylvanians, can we give our senior citizens living on limited Social Security, home heating fuel rebates? Yes, we can. The money is there, so let us do it. We can do this if we have the will, if we have the courage, and if we have the strength to say, yes, we can.

I am going to continue to fight for this and for similar measures, because the people who elected me elected me to fight for them. It is awfully difficult to face them and throw your hands up and say, I cannot do anything because that is the big oil companies. Well, somebody has to stand up. And although I am big, I will probably be a David in terms of the Goliaths of the oil companies. But they have to have a responsibility as much as anyone else.

Have you also noticed, if some of you remember, the last time that we had a shortage, the price went up. But as long as you are willing to put the \$3.25 out, the only place I have seen it at \$3.05 was Love's on Routes 72 on 81 on the way down today. The rest are \$3.19 and \$3.25 at the gas pump. As long as you are willing to pay it, there is plenty of gas around. Somebody has to stand up and be counted. And if we cannot move this measure, then I want to say this to those local distributors complaining: Write to the President, write to your Congressman or Congresswoman, whoever it is, and let them know how dissatisfied you are.

I think we should say the same thing loud and clear, and maybe it should be in this Chamber. People should not have to live in the cold. People should not have to suffer and worry whether they are going to make it from one day to the next. Madam President, let us stand up for the people today. Let us help to solve this problem. Let us not allow a single one of our citizens to be out in the cold.
