Senator RAFFERTY. Madam President, I move that the Senate do now proceed to consideration of all bills reported from committees for the first time at today's Session.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Madam President, I rise to again discuss an issue that I think has been very, very important to my colleagues and, most importantly, to the residents of this great Commonwealth. Madam President, the issue of healthcare and healthcare coverage for so many Pennsylvanians is still something that needs to be addressed by this General Assembly and, more specifically, needs to be addressed by this Chamber.

Madam President, just for a brief recap, I would like to cover who the uninsured are. In this Commonwealth, 71 percent of the uninsured are employed. Seventy-six percent of those individuals have incomes of less than \$60,000 per year for a family of four. Twenty-seven percent, more than one-fourth, have been without healthcare coverage for more than 5 years, and 49 percent of those, Madam President, are between 18 and 34 years of age. Finally, and most telling, is the fact that 70 percent of those individuals who have been surveyed and polled indicate that the cost of healthcare is the reason for not having healthcare. It is the cost.

Now, Madam President, more specifically, I have numbers that I would like to share with my colleagues from Allegheny County, the second-largest county in this Commonwealth and one of the largest counties in this country, as you well know. Madam President, in Allegheny County, there are over 108,000 uninsured adults residing in our county. That represents nearly 16 percent of the entire adult population of this county. We have the 10th-highest per capita rate of uninsured adults in Pennsylvania. There were 700,882 Allegheny County residents on the adultBasic waiting list in January of this year, and this March, 6,085 people are still on the list. Madam President, there is an average of 353 new people each month being added to the adultBasic waiting list.

Now, Madam President, as I indicated, this is an important issue to my colleagues, and it is an important issue to the people we represent in this Commonwealth. Legislation has made its way forward here to the Senate, and I again am asking my Senate colleagues to join me in asking that this piece of legislation be given consideration as soon as we possibly can. Madam President, we have a few days left in Session this week before we recess for a short period for the upcoming primary election. But, Madam President, we will be returning in late April, and my hope is that we will have an opportunity to discuss, specifically, House Bill No. 1137, which currently resides here in the Senate.

Now, Senate Bill No. 1137 is a different variation of the original legislation introduced by my colleague, Senator Hughes, also introduced on the House side as well, as well as the legislation that our Governor proposed earlier this year in February. Now, Madam President, it has been refined in a number of ways and has taken into consideration a number of the aspects, a number of the concerns, that have been raised by my colleagues both here on the Democratic side of the aisle and also on the Republican side of the aisle. Madam President, I am pleased to report that this version of the legislation is something that, I think, when reviewed, when given the opportunity to assess it and look at it and determine exactly what it does and what it needs to do, that we will be able to support such a measure.

Madam President, Senate Bill No. 1137 encompasses the new PA ABC program, and under this program, Madam President, within 90 days of our enactment here in the Senate and on to the Governor, or at least for its final enactment from the time the Governor signs it, within 90 days, we could possibly have 143,000 Pennsylvanians who will have access to healthcare, much-needed healthcare. And most importantly, Madam President, it also expands the level of services that are provided from the original adultBasic program but also will include prescription drug coverage. It would also include behavioral health benefits as well, something that is not offered today in the adultBasic program.

Those 143,000 individuals represent the current 55,000 people who are on the adultBasic program now, but also would bring in those 88,000 Pennsylvanians who, today, sit on the adultBasic waiting list, waiting and waiting and waiting to get healthcare coverage, who have stepped up and said, I am willing to pay a premium in order to get healthcare coverage. I want to be on the list. I want to be next in line to be able to get that coverage so that I can provide coverage for myself and for my family. And that is what this legislation would do, Madam President. But that is not the only thing that it does. Not only will it cover 143,000 individuals rather quickly, but within a year, we will be at 214,000, and within 2 years, 264,000 individuals will be eligible for healthcare in this Commonwealth.

But Madam President, there are a couple of other things that this legislation does, as I indicated. One of the concerns that we have seen is the concern about small businesses being able to have resources to afford to participate in this program. And recognizing that, this legislation provides for a grant program to employers who fit the bill, who fit the criteria to want to be able to provide healthcare coverage for their employees. They would be able to draw down resources from our State government to protect those interests that they make and to protect the programs that they want to put into place for their employees. So we have measures in place with respect to that.

Madam President, we also have the issue of the Mcare fund, and there is a lot of discussion about the Mcare fund, particularly this month, but I think it is important that we address it head-on. Madam President, this legislation would extend for 10 years the Mcare Fund but will phase it out over the next 10 years. But most importantly, Madam President, it would lock into place, for a 10-year period, the Mcare abatement program, which has been a very successful program that has helped to maintain our doctors here in this Commonwealth and has been very successful to the extent that it is part of this particular program.

Now, Madam President, we have had an opportunity to look at some of these things. A number of us on this side of the aisle believe that Senate Bill No. 1137 is a measure that is appropriate for our further discussion, not to be placed into one of the committees and forgotten about. So I strongly encourage my colleagues to join me in asking that this legislation be considered sooner rather than later so that we have the opportunity to discuss exactly what we need to do to make certain that PA ABC is going to be something that the Members of this Senate can stand up and say they are proud to support and proud to move on to the Governor.

So, Madam President, I thank you for the opportunity to provide some remarks on healthcare, probably the single biggest issue that we need to deal with in this Commonwealth, and I ask my colleagues to join me to that end. Thank you, Madam President.
