I would like to welcome them.

The PRESIDENT. The Chair recognizes the gentlewoman from Venango, Senator Mary Jo White.

Senator M.J. WHITE. Mr. President, most of this body has heard this speech before. Every time we add another category of victim to raise an assault to an aggravated assault, we make kind of a joke out of the entire assault legislation. It started out where assault on a judge, I believe, was the first one, was raised to an aggravated assault -- and a police officer might have been the first one--and then it went on from there and exploded. We have since added caseworkers, schoolteachers, mental health workers, I think the category is up to about 30 now, and today, we are adding transportation workers.

You know, I keep saying, when are we going to get to the pizza delivery man and the taxi driver, who have to go into dangerous neighbors for their livelihoods? Pretty soon, everything will be an aggravated assault, and it will not matter. We are not talking about the level of injury; we are talking about the status of the victim, and I think we are heading down a very bad path here.

The fact that we are now at 30-plus exceptions to the assault regulations is telling you that this is automatically upping the penalty, often putting a prison sentence or a criminal record onto a person who commits these crimes. And I am not saying they should not have a criminal record. I am simply saying that to keep increasing this category to expand to an ever-growing number of victims is creating an artificial distinction that pretty soon is going to become untenable.

Senator D. WHITE. Mr. President, I rise to ask for an affirmative vote on Senate Bill No. 442. This legislation amends the Insurance Company Law to create a mini-COBRA small employer group health plan in this Commonwealth. Senate Bill No. 442 extends the COBRA guidelines, permitting temporary continuation of insurance coverage provided by small employers to groups who plan to employ 2 to 19 individuals. Currently, CO-BRA provides former employees, retirees, spouses, former spouses, and dependent children the right to temporary continuation of health coverage at their own personal expense for up to 18 months at group rates when coverage is lost. However, these benefits only apply to employers with 20 or more employees under current Pennsylvania law. It is estimated that the mini-COBRA proposal included in Senate Bill No. 442 could provide an important safety net to thousands of individuals who work for small businesses.

As you know, Mr. President, the Senate passed this bill last September, but it did not clear the House of Representatives before the end of Session. Events recently in Washington stress the need for the General Assembly to act quickly to finally enact this measure as soon as possible. The Federal Stimulus Act approved in February provides a 65-percent Federal subsidy for up to 9 months for COBRA premiums. However, until Senate Bill No. 442 becomes law, thousands of Pennsylvanians are not able to elect COBRA coverage and therefore are ineligible for the benefits afforded under the Federal stimulus. This is especially critical as we have seen Pennsylvania's unemployment skyrocket over the past few months and currently stands at over 7.5 percent.

Before we vote on this bill, I would also like to thank my colleagues across the aisle, in particular, my co-chairman, the minority chairman, Senator Mike Stack, who has been very supportive of this measure and has added distinct advice in this bill.

In closing, Mr. President, I think it is important to realize that Senate Bill No. 442 is not a silver bullet and will not solve all of the problems with Pennsylvania's healthcare system, but it is a step in the right direction. And remember, also, it is a pragmatic step in the right direction to improve the accessibility and affordability of healthcare. And most significantly, it does not cost the Pennsylvania taxpayers one dime. This measure is already in place in many other States, and it is time we make it part of our healthcare network. I ask for an affirmative vote on Senate Bill No. 442.

Thank you very much, Mr. President.

Senator STACK. Mr. President, I also want to urge passage of this bill, and I want to commend Senator Don White once again for his great work on this important issue. One of the most promising aspects of this national stimulus effort is that it promises immediate aid for those who have lost their jobs for healthcare. Help is coming soon for those who need assistance in getting over the unemployment divide, protecting their families, and preserving hope, while our country and our economy rebounds from this nationwide recession.

I am pleased with this emphasis on helping people maintain health insurance coverage that has been included in the stimulus legislation, and I want to applaud the Obama administration for their efforts to include those who worked for businesses under this protective umbrella. Under this program, stimulus money will be used to help the unemployed manage their healthcare costs, enabling displaced workers the opportunity to purchase health insurance and healthcare benefits at a discounted rate through COBRA.

I have introduced the amendment that has won the support of the Blues, the Insurance Department, the Federation of Independent Businesses, and, of course, the Insurance Federation, and now, of course, Republicans and Democrats here in the State Senate. Apart from the technical changes aimed at making it easier for businesses and insurers to administer a mini-COBRA benefit, my amendment adds language that allows those who receive mini-COBRA health insurance coverage to receive Federal subsidies to purchase COBRA health insurance benefits.

We would not have been able to get this included without the hard work of Senator Don White and his excellent staff. So, hopefully, this window of coverage will provide working people with enough time to get back on their feet, find a new job, and, hopefully, attain affordable health insurance benefits, because after all, that is in everyone's interest. One way or another, if folk's are not insured, all of us are going to have to pay.

So, once again, thank you, Mr. President. I urge passage, and I thank you all for your time.

Mr. President, today, I am offering a resolution designating April 2009 as "Alcohol Awareness Month" in Pennsylvania. Simply put, this resolution is aimed at getting the public to focus attention on the dangers of alcohol use and abuse, particularly among young people. While I wish this resolution were not necessary, reality says that it is. Alcohol is a factor in the four leading causes of death among people between 10 and 24 years of age. These include vehicle crashes, unintentional injuries, homicide, and suicide. Approximately 9.7 million current drinkers in the U.S. are between 12 and 20 years of age, and alcohol is the drug most frequently used by high school seniors.

Alcohol use is also related to sexual violence. It is linked to as many as two-thirds of all sexual assaults and date rapes of teens and college students. It is a major factor in unprotected sex among young people, increasing their risk of contracting HIV and other sexually transmitted diseases.

When you combine drinking and driving, the outcome is deadly. In 2006, 545 people died in alcohol-related crashes in Pennsylvania. On average each day, 37 alcohol-related traffic crashes occurred, and 1.5 persons were killed. The problem is even greater with teen drivers. Teenage drunk driving is responsible for one in four vehicle accidents. These accidents are the number-one killer among 15- to 20-year-olds. One teen is killed in the United States every 60 minutes because of teen drunk driving. In 2005, approximately 3,467 teens were killed and 281,000 more suffered injuries due to driving under the influence.

It is clear that alcohol, when used in excess, is as dangerous as any other deadly weapon. And it is vital that we make our young people aware of that fact so that they can make better decisions about alcohol use. I am pleased by all of the good work that is being done to combat drinking, from Students Against Drunk Driving to Mothers Against Drunk Driving to the State Police and to the Liquor Control Board, which is again hosting a conference to bring together educators, students, counselors, law-enforcement officials, and other concerned community leaders to share strategies to combat underage and high-risk drinking. "Project Blueprint: A 'How To' Conference on Building Effective Strategies to Reduce Dangerous and Underage Drinking" will be held April 2 and 3 in New Cumberland. This is the Liquor Control Board's seventh annual conference to share experiences and best practices in alcohol education.

Through our efforts, we can call upon all citizens, parents, governmental agencies, public and private institutions, hospitals, and schools to discourage underage consumption of alcoholic beverages and support alcohol recovery programs throughout this Commonwealth. Mr. President, today, I am pleased to offer a resolution designating April 2009 as "Child Abuse Prevention Month" in Pennsylvania and to raise public awareness about abuse and neglect. Both the Family Support Alliance and the Pennsylvania Coalition Against Rape have been committed to providing child abuse prevention and treatment services to families, social service organizations, and schools throughout Pennsylvania. Their missions are to help prevent abuse, through counseling, training, and reporting.

Child abuse crosses all racial, economic, and geographical boundaries and has reached epidemic proportions across this nation and throughout this Commonwealth. Each year, more than 1 million children in the United States are documented as the victims of child abuse, and at least 1,500 children die as a result. Children under the age of 4 account for 81% of the fatalities. In 2007, 46 Pennsylvania children died as a result of abuse and neglect, and over 4,162 cases of child abuse were reported. The damaging effects of child abuse include school failure, alcohol and drug abuse, and physical and psychological difficulties.

Child abuse can and must be prevented, and we must raise awareness and public attention so that families learn they have access to community resources which offer support, information, and guidance to help stop or prevent abusive behaviors or conditions. While we have accomplished a great deal - enacting the newborn Safe Haven law, passing a child abuse reform package, and allowing children to testify via videotape - we cannot stop there. That is why I am sponsoring legislation placing the Federal Adam Walsh Child Protection and Safety Act of 2006 into State law. The Commonwealth must partner with these organizations so they can help more children and families in need. They are a valuable safety net and lifeline to children who have nowhere to turn, and they provide a core service that we cannot do without.

Mr. President, today, I am offering a resolution designating April 1, 2009, as "Lupus Alert Day" in Pennsylvania. This resolution is designed to alert citizens of a disease which goes hidden from many individuals and their families. Lupus is a chronic inflammatory disease which causes the immune system to attack the body's own tissue and organs. Symptoms of lupus often mimic less serious illnesses, fooling carriers and their families, and therefore, those who have the disease go untreated.

April 1, better known as April Fools' Day, is a day to bring awareness to this disease, because lupus affects so many, but individuals are fooled by its severity. While many of us have heard of this autoimmune disease, few of us know that lupus strikes more people than leukemia, multiple sclerosis, muscular dystrophy, and cystic fibrosis combined. Lupus affects 1 out of 185 Americans, most of whom are women between the ages of 15 and 45. However, the disease reaches men and children as well. Our goal is to educate people about its symptoms and dangers so that they can seek treatment if necessary.

Mr. President, I thank all of those who give their time to address this disease, and I ask for an affirmative vote for "Lupus Alert Day."

The PRESIDENT. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentleman from Berks, Senator O'PAKE, on behalf of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)

Mr. President, in an effort to continue our support of the important work of the American Heart Association, Senator Brubaker and I are today requesting consideration of a resolution recognizing "National Start! Walking Day."

Mr. President, each year, 1.26 million Americans suffer a new or recurrent coronary attack. Cardiovascular disease is the nation's leading cause of death, with direct and indirect costs estimated to be \$475.3 billion in 2009. More physical activity can help improve these statistics. In addition to increased life expectancy, regular walking has many proven benefits for an individual's overall health. Walking can lower both bad cholesterol and high blood pressure and can reduce the risk of stroke. Mr. President, the purpose behind "National Start! Walking Day" is to get Americans to become more physically active by walking. By increasing awareness of the importance of physical activity to reduce the risk of cardiovascular disease, we can save thousands of lives each year.

I ask my colleagues to join Senator Brubaker and me in proclaiming April 8, 2009, as "National Start! Walking Day" in Pennsylvania.

Senator BRUBAKER. Mr. President, I wish to congratulate Senator Tartaglione and thank Senator O'Pake for his attention to this resolution naming April 8 as "National Start! Walking Day" in Pennsylvania.

Mr. President, regular physical activity not only reduces cardiovascular disease and increases life expectancy, but also saves money. If 10 percent of Americans began a regular walking program, \$5.6 billion in heart disease costs could be saved. By promoting a culture of physical activity, businesses can decrease healthcare costs, increase productivity, and improve the quality of life and longevity of the United States workforce.

Mr. President, along with my colleagues, Senator Tartaglione and Senator O'Pake, I ask for an affirmative vote and proclaim October 8, 2009, as "National Start! Walking Day" here in Pennsylvania.

Mr. President, this resolution honors Thaddeus Stevens, a prominent figure in the 19th century whose legacy is still to be seen in Lancaster, across the Commonwealth, and across our nation. As a State legislator, he was instrumental in establishing the free public school system, providing funding for colleges, and putting a constitutional limit on State debt. As a Congressman, he was strenuously anti-slavery and was a leader in securing adoption of the 14th Amendment to the Constitution.

As an indication of the depth of his principles, he insisted on not being buried in a cemetery because most, at that time, were limited by race. Upon his death, Stevens left a generous bequest to establish a school for the relief and refuge of homeless, indigent orphans. Today, we know that institution as the Thaddeus Stevens School of Technology, which provides an outstanding industrial skills education to citizens from across Pennsylvania. We support their important mission through the State budget each year. This resolution designates April 4, the 217th anniversary of his birth, as "Thaddeus Stevens Day," and I ask for its immediate adoption.

Our nation's school, academic, public, corporate, and special libraries make a difference in the lives of millions of Americans, today, more than ever. Librarians are trained professionals, helping people of all ages and backgrounds find and interpret the information they need to live, learn, and work in the challenging economy of today's world. Libraries are places for opportunity, education, self-help, and lifelong learning. They play a vital role in supporting the quality of life in their communities. I encourage all residents in this Commonwealth to visit their libraries during National Library Week.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, I rise today with my friends and colleagues, Senator Dinniman and Senator Leach, to seek unanimous consent for immediate consideration of a resolution honoring April 19 through 26, 2009, as "Days of Remembrance of the Victims of the Holocaust" here in Pennsylvania.

From 1933 to 1945, 6 million Jews across Europe were systematically slaughtered under Hitler's Nazi regime. The majority of these people suffered greatly before their death. Additionally, millions of other people - gypsies, disabled people, prisoners of war, Christians, and other people who resisted Hitler's agenda were also tortured and killed. The history of the genocide of millions of people who were targeted by the Nazis is nothing short of horrifying, yet it is a part of history that must never be forgotten, because it must never be repeated.

By honoring the "Days of Remembrance of the Victims of the Holocaust," we in Pennsylvania can insure that the men, women, and children who suffered and died will never be forgotten. We can also pledge to condemn all forms of anti-Semitism, ethnic intimidation, and hatred.

Mr. President, I have also worked closely with Senator Dinniman on this resolution and other issues that relate to this, and I ask the Chair to recognize Senator Dinniman.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, I rise in support of Senator Stack's resolution. I know Senator Leach also wishes to rise after me in support of the resolution. I first want to, as a member of the Jewish community of this Commonwealth, thank Senator Stack for introducing this resolution and for his service and support for Jewish causes throughout the Commonwealth. Senator Stack, last weekend, received the Man of the Year award from Rabbi Isaacson's synagogue, Congregation Beth Solomon Synagogue, which is in his district, and we congratulate Senator Stack on that.

The Holocaust is so important to remember, but we remember it in a way so that not only do we show our respect for people of the past, but that we make sure that it does not happen again. There are many holocausts that surround us in the world today: people dying from hunger, people dying in civil wars throughout the world. It is incumbent upon each and every one of us not only to show our respects to all who have suffered in the past, whether it be in the German Holocaust or whether it be in holocausts that have happened throughout our history as human beings, but that we commit ourselves today to making sure never again, never again for any ethnic group, never again for any religious group.

All that it takes for hatred to surface, and for the horror that comes from hatred, is for good people to be silent and not remember the past and not work with every ounce and fiber of their bodies to make sure that the past does not repeat itself for any ethnic group, any religious group, or for any human being within our society.

So I rise in support of this resolution, and I also ask the Chair to recognize Senator Leach.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Leach.

Senator LEACH. Mr. President, I rise in support of this resolution in a couple of different contexts. First, as a Jewish American, I am honored and pleased to be part of this resolution, and I thank the co-authors of this resolution for introducing it and for their remarks. I also want to make a couple of discreet, very brief remarks on a different aspect of the resolution, specifically the Armenian Genocide. My wife is Armenian, her family is Armenian, and that is how I became as familiar as I am with the situation there.

The Armenian Genocide, also known as the Armenian Holocaust, refers to the deliberate and systematic destruction of the Armenian population by the Ottoman Empire during and just after World War I. Over 1.5 million Armenians - men, women, and children - were killed from 1915 to 1923, and it is important that we remember their story. When Hitler was talking about the ongoing Holocaust in the 1940s, he said, "nobody remembers the Armenians." And he had a point in the sense that this is not something we have been focused on, but it is something that we should be focused on.

I am proud to say that in the House, when I introduced the Armenian Genocide resolution, it passed unanimously every time, and I hope and anticipate that it will pass unanimously in the Senate. But this is not a noncontroversial issue. It is controversial to the point where the United States Congress would not even bring the Armenian Genocide recognition resolution up for a vote, the argument being, well, we have a good relationship with Turkey. In fact, some members of my own community, some organizations, for example, the National Anti-Defamation League, have taken what I view to be unfortunate positions with regard to the Armenian Genocide because Turkey has a reasonable relationship with Israel.

As a Jewish American, I can say we would never accept the idea that, well, we have a good relationship with Germany now, so we cannot recognize or acknowledge the Holocaust. And I think the same standard has to apply with the Armenian Geno-

cide. The only reasonable question to ask in terms of recognizing a genocide is whether or not a genocide occurred, not what the political ramifications are of telling the truth. The truth should always be told, and I am grateful to my colleagues here in the Senate today for being one more voice for the truth on this issue.

Mr. President, not to belabor the point, but I just want to rise not only in support of this resolution and the fine work of my colleagues on this, but again, to recognize the individuals whom this resolution forces us to recognize today and the horror that it brings to the attention of this body.

And of course, in the next couple of weeks, I look forward to celebrating Passover with many of my Jewish friends and those Jewish residents in my community in the First District.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, this resolution names April as "Autism Awareness Month" in Pennsylvania. As you know, this Chamber has a number of very strong advocates on the issue of autism, including yourself, Senator Pileggi, Senator Rafferty, Senator Orie, and in fact, everyone in this Chamber.

Autism spectrum disorders are developmental disabilities that often interfere with a person's ability to communicate and relate with others. Symptoms range from mild to severe, and people with the disorders often learn to interact and react to sensations in different ways.

There are many theories on what causes autism, but even today, it remains a mystery. The symptoms usually appear during the first 2 or 3 years of life, and interestingly enough, autism is four times more prevalent in boys than in girls. The earlier the intervention, the quicker doctors and parents can work together to improve the child's development. In addition, the more access families have to autism-specific programs and care, the better the quality of life for the individual living with autism.

Pennsylvania is doing its part. The Department of Public Welfare has created a Bureau of Autism Services to provide expertise and support for all State agencies that serve Pennsylvanians with autism. As we mark Autism Awareness Month in Pennsylvania, we need to continue to support individuals living with autism and their families through early intervention and programs that fit their unique needs.

The PRESIDENT. The Chair recognizes the gentlewoman from Allegheny, Senator Orie.

Senator ORIE. Mr. President, I rise today to ask for my colleagues' support for this resolution, which recognizes April 2009 as "Autism Awareness Month" in Pennsylvania.

Thanks to the work of healthcare organizations, family advocates all across Pennsylvania, community groups, and legislators, more people are aware of the effects of autism and how prevalent the disease is. Although much of autism is a mystery, the number of people across the United States diagnosed with autism over the past 15 years has risen by a staggering 2,000 percent.

About 1 in 150 American children suffer from some form of autism. Latest studies show that as many as 1 in 150 kids age 10 and younger may be affected by autism or a related disorder, a total of nearly 300,000 children in the U.S. alone. The problem is five times as common as Down syndrome and three times as common as juvenile diabetes.

Last July, this body, with the strong support of Senator Don White and Senator Mike Stack, as well as the leadership on both sides of the aisle and leadership from former Speaker Denny O'Brien, enacted one of the best, and now the nationwide model, when Act 62 was adopted to provide autism insurance coverage. It is my understanding that as of today, 20 States have adopted Pennsylvania's lead and used Pennsylvania as the national model.

Although a cure for autism has not been found, those who suffer from its effects can reach their greatest potential through early diagnosis, appropriate education, and intervention. That is why it is so important to continue our commitment to provide programs and support services for autistic children and adults.

So today and throughout the month of April, I urge all Pennsylvanians to take time to raise awareness and change attitudes about autism and those who suffer from this disease.
