Senator RAFFERTY. Mr. President, as chairman of the Senate Committee on Law and Justice, with oversight of the Pennsylvania State Police, on behalf of myself and Senator Sean Logan, we would like to ask the Senate of Pennsylvania and all the people of the Commonwealth of Pennsylvania to remember today a Trooper killed in the line of duty this weekend.

We all heard the news: Two State Troopers responded to a kidnapping, a father kidnapping his 9-year-old son. When the Troopers approached the vehicle, the car in which the man was seated with his child, the man immediately opened fire on the Pennsylvania State Police. One Trooper was killed, once again performing his duties, protecting the lives of the citizens of the Commonwealth. The other Trooper was wounded, and I am happy to say he is in satisfactory condition.

Trooper Joshua D. Miller, 34 years of age, Mr. President, a 7-plus-year veteran of the Pennsylvania State Police, part of the Hazleton Troop, was killed tragically by this man when he was responding to the kidnapping offense. Trooper Robert Lombardo, 35 years of age, is the Trooper who was wounded, and I am told today that he has been upgraded to satisfactory condition at the hospital. Both were members of the Hazleton Troop, and in light of the circumstances and Trooper Joshua Miller giving his life for the young man and for the people of the Commonwealth, Mr. President, I ask that the Members of the Senate please take a moment of silence in honor of the Trooper and his memory.

The PRESIDENT. Would Members and guests please rise for a moment of silence.

(Whereupon, the Senate en bloc stood in a moment of silence in solemn respect to the memory of Trooper JOSHUA D. MILLER.)

Provided, That any charter school or cyber charter school or owner of property leased to a charter school or cyber charter school may make a municipal improvement in a street on which its school property abuts or may contribute a sum toward the cost of the improvement. This exemption shall apply only where a charter school, cyber charter school or an associated nonprofit foundation is responsible for payment of the aforementioned taxes, costs or expenses.
