### SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR JAY COSTA PRESENTED TO THE SENATE

Senator COSTA. WHEREAS, To best maximize this Commonwealth's share of American Recovery and Reinvestment Act of 2009 funds, the strategy must be transparent and nonpartisan as it leverages all opportunities with existing Federal, State, local and corporate resources; and

  (1) Provide broadband leadership at the State level, through a decentralized system that promotes Pennsylvania as a whole, much like the highly publicized California Broadband Initiative which is

- (11) Ensure that all projects receiving stimulus money have proven, identified sustainability plans after the stimulus money is used; therefore be it

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, this month, as you know, is gay pride month. And over the last few months, the media has

focused a great deal of attention on the rights of the LGBT community. But unfortunately, one event seems to have been forgotten or passed over recently in the press. Yesterday marked an important milestone in the modern gay rights movement, as many remembered the 40th anniversary of the Stonewall Riots in New York City.

For those unfamiliar with the Stonewall Riots, I will provide a very brief history. While police raids on gay bars in the 1960s was nothing out of the ordinary, this particular night, it did not go as planned for the police. During the raid of the Stonewall Inn, officers quickly lost control of the situation, inciting the crowd to riot. The palpable tension between Greenwich Village residents and the New York City Police resulted in more protests the following night, and again several nights later.

Within weeks, the area's residents had organized into activist groups, and within a month, the Gay Liberation Front was officially created. Additionally, three newspapers were founded in this timeframe to promote gay and lesbian issues. Regardless of where one stands on the issues surrounding the LGBT community, I believe it is important and extremely significant to recognize the historical significance of the Stonewall Riots.
