# **BILLS ON FIRST CONSIDERATION**

Senator FOLMER. Mr. President, I move that the Senate do now proceed to consideration of all bills reported from committees for the first time at today's Session.

The motion was agreed to by voice vote.

### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, 2 weeks from now, rate caps on electricity for almost a quarter of the residents of Pennsylvania will be coming off when PPL's rate caps expire on January 1, 2010. Eight months ago, I stood in this Chamber urging residents to call their House Members to urge them to support House Bill No. 20, which would provide for a 3-year phase-in of the proposed rate increases. Unfortunately, House Bill No. 20 has languished in the House Committee on Appropriations since late April.

And now, on January 1, 2010, PPL ratepayers are going to see an ever-increasing rate increase. Now, in late November, PPL's proposed uncapped rate per kilowatt hour was to be 10.55 cents. In early December, a phone call to PPL, asking for the price to compare, yielded the rate to be 10.68 cents per kilowatt hour. And now, it is being reported that PPL's rate will be 10.82 cents per kilowatt hour come January 1.

Last year, the General Assembly enacted Act 129, which is a step in the right direction in promoting energy conservation by utilities to minimize the rate increases. At that time, I was prepared to offer an amendment to provide for a continuation of the rate caps in our State as our country was going through this recession that we are dealing with.

Now, I went to the Governor's Office. I was called there and was requested to take my amendment off that bill so that it could be a clean bill and we could move forward with energy conservation. At the time, I knew that the only thing that I could do to try to help mitigate this rate increase was that amendment, because I knew if I offered that amendment, it was going to pass. But the Governor and certain leaders asked me to take that amendment off--and I thought it was in very good faith--and said, listen, Lisa, we will take up rate mitigation before the end of the year. Take your amendment off, and we will deal with rate mitigation. Well,

we stand here today, weeks from these rate caps expiring for 25 percent of Commonwealth residents, and I am still waiting for the action that was promised.

This General Assembly should not allow these utilities--who have been making record profits, with executives making millions of dollars with rate caps in place--to continue to improve their bottom lines during difficult economic times, when families are struggling to make ends meet and seniors are going to be forced to choose between whether they are going to pay their electric bills or pay for the prescriptions they so desperately need. Unfortunately, greed is not a strong enough word to describe some of these utility companies' actions. I do not know whatever happened to making a healthy profit. It seems like some in corporate America have no allegiance to their customers anymore, to their State, or to their country, for that matter.

To those sitting at home watching PCN, who live in PPL's territory, I want you to know that you do not have to pay the exorbitant rates that PPL will be hammering out with the new year coming. When the General Assembly passed electric deregulation in the mid-1990s, it was done because we were told that this would promote competition, and residents would have a choice. For the last 13 years, the only choice for PPL customers was PPL. Those days are changing, and you at home will now have a choice.

Four companies have already announced that they want to serve you and provide you with a rate at least 10 percent less than is being offered by PPL: ConEdison Solutions, Direct Energy, Dominion, and Liberty Power. And three more additional companies may be coming into Pennsylvania. Contact information is available on my Web site at <a href="www.senatorboscola.com">www.senatorboscola.com</a>. But still, these rates will be higher than what is currently being charged. Families struggling to pay their energy bills now will struggle even more as they lose more and more of what they have earned and saved for a rainy day.

As I said 8 months ago, it is time for the people's representatives to go out and do the people's business and keep their promises. This is a fight that matters to all of us, especially seniors living on a fixed income, who, by the way, have just received official notification that they will not receive a cost-of-living adjustment in 2010. So their rates are going to be increased by 30 percent, but they are not getting a cost-of-living adjustment. How wrong is that? And let me restate that. Our seniors receive a zero-percent COLA in 2010 but will receive a 30-percent increase in their electric rates. Not fair at all.

Now talk about when the Bethlehem Area School District and other school districts around the Commonwealth have to raise their property taxes because their bills will go up by a million dollars or so. If their electric bill goes up by that much, who is going to pay that cost? The homeowner will pay that cost. So tell me how a cost of living adjustment is not warranted.

It does matter to small business owners who will be forced to go out of business because of their higher electric bills, and there will be a lot of jobs across this Commonwealth that will be lost. And it matters to the homeowner who will see their property taxes rise because their school districts and their local governments will have to pay that 30-percent increase.

This does not have to be the case. My colleagues can join me and urge legislative action to make a difference, a real difference

in the lives of our constituents. We can pass rate mitigation language and make a real difference in people's pocketbooks and their lives.

Lastly, Mr. President, I am extremely disappointed that I was called into the Governor's Office, asked to remove an amendment, and was promised to get some kind of rate mitigation passed by the end of the year. I took leaders in good faith. I really believed in what they were saying. So I want to go on record—what is the saying? Fool me once, shame on you; fool me twice, shame on me. If ever in this building there is ever an amendment, and leaders ask me to go off of it so that a bill can remain clean, and I remain strong and firm on that amendment, that I think the language will help the people of Pennsylvania, I am not taking it off. I refuse, because I was so wrongly fooled the first time, and it will never happen again.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Earlier, I voted "no" on Senate Bill No. 1039. For those who do not know what that bill is, it is the appropriation for the University of Pennsylvania. And while I have absolutely no problem with the University of Pennsylvania and helping our young people and subsidizing their education, the House, in a very sly way, slid in a very significant amendment for a nonpreferred museum.

This Chamber, for over 2 years now, has made it clear that we are not interested in keeping artificial nonpreferreds in the budget, particularly in this very, very tight budget cycle. They took the language of a nonpreferred and placed it into the University of Pennsylvania appropriation, making it difficult for many Members to vote "no," because they wanted to take care of the educational portion.

It is not right, and I will never get caught in this situation again. This was a bill on concurrence; we had only an up or down vote. We had no opportunity to amend it and delete that particular section. It passed, but I wanted to make clear what the House did, in what I consider an unfair and unopen fashion.

#### LEGISLATIVE LEAVES

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, I request a legislative leave for Senator Piccola.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I request a temporary Capitol leave for Senator Musto.

The PRESIDENT. Senator Pileggi requests a legislative leave for Senator Piccola.

Senator Costa requests a temporary Capitol leave for Senator Musto.

Without objection, the leaves will be granted.

And the question recurring, Will the Senate agree to the motion?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, there are several provisions that I feel would be detrimental to Philadelphia or the entire Commonwealth, and there are some missing provisions that should be included in tonight's legislation.

I am really concerned about the provision that gives Foxwoods another extension to build a casino along the Delaware Riverfront. They have shown time after time that they cannot perform. How many chances can we give them?

That is not only Mike Stack's assessment. That is the assessment of the Pennsylvania Gaming Control Board's Office of Enforcement Council, who has been reviewing monthly status reports of Foxwoods. Today, they issued a recommendation to the Gaming Control Board stating that they should either outright deny the extension or allow the extension with penalties. We should not authorize an extension that our own gaming experts say is a bad idea.

It is time for Foxwoods to step up or step down. If Foxwoods does not get the extension, they still have until May 29, 2011, to build a full casino or a temporary casino. Philadelphia Park, as my friend, Senator Tomlinson, can tell you, used a temporary facility. Why cannot Foxwoods?

This legislation also needs stricter ethical standards, which the current legislation, I believe, does not have. Lobbyists should be banned from having a financial interest in casinos. Allowing them or their immediate families to have a financial interest can lead to corruption. Lobbyists can have influence on legislation

and improve their financial standing. This is exactly what the lobbying law is intended to prevent - financial reward contingent upon legislative or administrative action.

I am also concerned about extending credit to people who play the slots, and its impact on gaming addiction. Yes, I understand it is a safety precaution for some, but it is dangerous for many more.

Finally, I am concerned about the impact of former Mayor John Street's action involving casino building in Philadelphia. Prior to leaving office, he entered into payment-in-lieu-of-taxes agreements with the Philadelphia casinos using a State law from the 1970s to encourage economic development. Negotiated in private, these agreements are questionable at best. Plus, the city is leaving up to \$60 million over a 10-year period in uncollected revenue on the table. Now more than ever, we can use those funds. They need every dollar to help balance their budget and to pay the cops, firefighters, and other civil servants who make the city what it can be. Allowing the casinos to receive property tax abatements or fail to pay full use and occupancy taxes is a direct contravention of the intent of the Gaming Act.

Mr. President, I understand that no bill is perfect. And let me go on the record saying I really appreciate everything that our Leaders and Members have done to craft a bill which they think will serve the public interest. But the crucial elements that have been left out of this bill make it completely unpalatable for me to vote for it.

### MOTION TO SUSPEND RULE XIV

Senator STACK. For that reason, I move that Senate Rule XIV, Section 1, be suspended for the purpose of offering amendment No. 5287 to Senate Bill No. 711 to try to fix this legislation.

The PRESIDENT. Senator Stack moves to suspend Senate Rule XIV, Section 1, to amend Senate Bill No. 711. This motion is not debatable.

On the question,

Will the Senate agree to the motion to suspend Rule XIV?

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, without addressing the merits of the comments of the Senator from Philadelphia, I oppose the motion. We have done a good job this Session in sticking to our rules and not suspending when convenient. This is not a new issue. We voted this original bill in the Senate back in October. It has been here. We have worked for a long time on this amendment. These amendments are not timely. I oppose the motion to suspend.

And the question recurring,

Will the Senate agree to the motion to suspend Rule XIV?

The PRESIDENT. On the motion to suspend, all those in favor to suspend will vote "aye"; those opposed to suspend will vote "no."

A voice vote having been taken, the question was determined in the negative.

And the question recurring,

Will the Senate agree to the motion to concur in the amendments made by the House, as further amended by the Senate, to Senate Bill No. 711?

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I know the hour is late, so I have some remarks that I would like to submit for the record.

The PRESIDENT. Senator Tartaglione offers remarks for the record. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)

Mr. President, I want to take this opportunity to express my thoughts as it relates to the legislative intent of Section 1363A(b)(3)(I)(A) of Senate Bill No. 711. I am of the understanding that the intent of this section is that the phrase "health care" clinic is meant to include any acute care health facility which is a nonprofit subsidiary of a State-related educational institution and that such institutions shall be eligible to apply for a portion of the local share funds in Philadelphia. I understand that there has been some discussion of this section and that the language in the amendment as it was adopted in the Committee on Rules and Executive Nominations is not as clear as some would like. However, I want to clarify that this is the legislative intent of this section. Our interpretation is that nonprofit acute care health facilities that are affiliated with State-related institutions are covered by the language in this section.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, I will also be brief with my remarks. As we all know, Mr. President, Senate Bill No. 711, which passed this Chamber a few months ago, has a lot in it that we are all proud of. Gaming reform has been long overdue in Pennsylvania. People who get gaming licenses should be held to the highest standards of character. And most importantly, with regard to the contents of Senate Bill No. 711, casino owners should not be allowed to give unlimited campaign contributions to politicians. Senate Bill No. 711 addresses many of these issues head on. The reforms may not be perfect, but they are a big step in the right direction.

However, at some point between July and today, Senate Bill No. 711 stopped being a gaming reform bill and became the table games bill. For many reasons, and because of the many changes to this bill, I personally and regretfully can no longer vote for this measure. I am not going to read chapter and verse on those reasons today, as I am sure my colleagues know, from the many weeks and months that we have worked together on this issue, what my concerns are.

I do want to be clear on one point, Mr. President, about the overriding factor that runs through every single remark and position I take on gaming, because I really want everyone in this Chamber to understand this. Mr. President, there is no other legislator in the entire building, in the entire State of Pennsylvania, in either Chamber, who has not one but two casinos in their legislative district.

You may have heard me say that the casinos in my district are close to residential communities. Well, here is how close they really are. If I stood here, and you stood on the south lawn behind the Ryan Building, that is how close they are -- a big neon building, 11 million vehicle trips a year, and a 3,000-car parking garage, all 24 hours a day, 7 days a week. And the same thing is happening 3 miles down the very same street in my district.

It is this fact, this reality facing my constituents and the neighborhoods that I represent that drives my passion on this issue, and not--and I repeat--and not some moral obligation or hatred or distaste for the concept of gaming or the gaming industry. I ask you today, even if you do not agree with me on this issue, that you at least try to understand what this means to my constituents and what they and their children face as this Commonwealth's partnership with the gaming industry moves forward.

Even in the brief time that I have been here, I have learned that no single piece of legislation is perfect in all respects. But more importantly, I have learned that an imperfect bill can always be made better. Although as Members, we may not support every bill, we have an opportunity and, in my opinion, an obligation to our constituents to work hard at making it the best it can be, even if we ultimately choose not to support it. For me, it is not enough to just look at a bill I may not like and say no. I think it is incumbent upon me to do everything I possibly can to make sure that the people whom I represent are protected.

This is why I have always fought, since the day I got here, to insure that there are protections and accommodations for the communities that I represent which are near these casinos. And I am not alone in my fight. My colleagues here in the Philadelphia delegation are owed a great debt of gratitude, led by Senator Kitchen, our delegation head, and Senator Hughes, Senator Washington, Senator Williams, Senator Stack, and Senator Tartaglione. They have supported me and continue to support me on all these issues and have joined me in the fight for these communities, because each of them, Mr. President, loves the city of Philadelphia, every single part of it. They care greatly for the people they serve each and every day. I thank them for their support, and I have the utmost respect for their commitment to our city.

I would also like to thank Representative O'Brien in the House, who represents many of the same neighborhoods in my district near those casinos. His drive and passion for his constituents is unyielding. I would also like to thank my fellow Caucus Members and Caucus Leadership, specifically Senator Mellow and Senator Costa, for their support. And I thank my Republican colleagues, who reached across the aisle in the best interests of all Pennsylvanians.

I am pleased, at least as of today and at this time and at this hour, through our collective efforts, that an oversight in the original Gaming Act has been corrected in some small regard. Under this bill, communities in my district who bear the brunt of the negative effects of casinos are going to be treated the same way--and this is important--the same way as communities hosting casinos around this Commonwealth, when it comes to sharing a small part of the revenue created by this billion-dollar industry.

Senate Bill No. 711, as it stands here today, represents a major expansion of gaming in Pennsylvania. But this will not be the last day that we, as a legislative body, have to deal with issues

surrounding casinos. As my colleague, Senator Ferlo, is fond of saying, we have a 54-percent tax rate on slots. We are not just a State that has gaming, but a business partner with the gaming industry. And let us not forget what we are talking about here. This is not Joe Taxpayer mortgaging his house to open up a hardware store on Main Street. This is a billion-dollar industry that operates a very limited monopoly under the protection and authority of a State license.

Casinos should go out of their way, Mr. President, to be good neighbors. We should hold the industry to their promises, and there are a lot of promises about the facilities they intend to develop, about the way they treat communities they operate in, and about the jobs that they say they are going to produce. We must hold the industry to their promise that jobs will benefit people who actually live in Pennsylvania and the neighborhoods around those casinos. We should be vigilant of the effects this industry can have on our most financially vulnerable citizens, and we should hold the industry to its commitments of diversity in the workforce and creating good-paying jobs with upward mobility.

I hope my colleagues in this Chamber today understand my vote and heed the concerns that I have raised. We have much, much work ahead to do for the citizens of Pennsylvania. I hope we continue to do the work in the same bipartisan spirit in which we have approached this issue.

Thank you, Mr. President.

And the question recurring, Will the Senate agree to the motion?
