Senator ORIE. Mr. President, today I offer a resolution designating March as "Women's History Month" in Pennsylvania. In 1987, the United States Congress declared March "National Women's History Month." It has been celebrated in Pennsylvania each year since then to insure that the history of American women will be recognized and celebrated in schools, workplaces, and communities throughout our country. The resolution is intended to recognize the accomplishments and experiences of women and their contributions to the growth and strength of the Commonwealth of Pennsylvania.

Abigail Adams once said, "If particular care and attention is not paid to the ladies, we are determined to foment a rebellion, and will not hold ourselves bound by any laws in which we have no voice or representation."

It is a true honor and privilege to serve with my nine female Senate colleagues, who have all been tremendous trailblazers in their own right. Nationally and within the State of Pennsylvania, we have seen a trend where women are getting involved in government and now are reaching the highest levels of leadership. However, that is only one area where women are breaking through barriers and making huge contributions.

Mr. President, American women were especially important in the establishment of early charitable, philanthropic, and cultural institutions in our nation. Women of every race, class, and ethnic background served as early leaders at the forefront of every major social movement in Pennsylvania and across the nation. American women have been leaders not only in securing the right to vote, but also in the abolitionist movement, the industrial labor movement, and the civil rights movement.

Pennsylvania is home to many women leaders who made their mark on the Commonwealth of Pennsylvania. Florence Kelley of Philadelphia championed sweatshop and child labor reform while helping to organize the NAACP. Lavinia Lloyd Dock of Harrisburg was a hospital nursing reformer and a proponent for women's suffrage who was jailed four times while trying to ensure women could vote. Cornelia Bryce Pinchot, the wife of Governor Gifford Pinchot, served as a nurse during World War I, taking up the suffrage cause and women's rights. She was particularly outspoken on the subject of sweatshop reform. Famed reporter Nellie Bly was born in Armstrong County and first worked for the Pittsburgh Dispatch. Gertrude Stein, another groundbreaking writer, was born in Pittsburgh's North Side.

These and millions of other women have contributed to our great Commonwealth, and this resolution offers us a chance to remember and honor their successes. Mr. President, I ask for an affirmative vote for "Women's History Month" in Pennsylvania. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, I will be brief, but it is important to state that the context of this resolution, March 10, 2010, is the third annual "National Women and Girls HIV/AIDS Awareness Day" in Pennsylvania. This resolution is designed to promote and raise awareness across the Commonwealth about this disease, this very devastating disease which came into existence nearly three decades ago but, in spite of the many advances in terms of treatment and the knowledge learned in terms of education, still is a disease that is ravaging significant portions of our Commonwealth and folks across the nation and especially, Mr. President, has a dramatic impact on individuals all across the world.

Again, March 10, 2010, is nationally recognized as National Women and Girls HIV/AIDS Awareness Day, and this resolution calls for that awareness to occur and that recognition to occur here in the Commonwealth. Twenty-six percent of all new AIDS cases are attributed to women who have become infected with HIV through heterosexual contact and drug use. Minority women represent a disproportionate number of those affected by HIV/AIDS. In particular, Mr. President, African American women between 25 and 34 years of age see HIV/AIDS as one of the leading causes of death for that particular population. And according to the Office on Women's Health in the United States Department of Health and Human Services, community events and recognition such as these provide some support in addition to the full-fledged fight against this very devastating disease.

March 10, 2010, is recognized nationally, as I said, Mr. President, as "National Women and Girls HIV/AIDS Awareness Day," and this resolution calls for continuity in that recognition here in the Commonwealth of Pennsylvania. Thank you very much.

The residents of Susquehanna County have a deep pride in their communities, and they will honor their county with the theme "Celebrating Our Heritage," which will be prevalent during the Independence Day Parade in 2010.

I am very proud to represent a part of Susquehanna County and to be a sponsor of this resolution, along with my colleague, Senator Baker. Thank you.

Senator BAKER. Mr. President, I am pleased to join with my colleague, Senator Yaw, in extending our best wishes to the citizens of Susquehanna County on the celebration of their 200th anniversary. I am very pleased to represent 12 townships and 7 boroughs in the eastern part of the county. Senator Yaw has talked about the beautiful history of the community - the Underground Railroad in Montrose, the history in my part of Susquehanna County, recognizing the beautiful viaduct in Starrucca. It is the oldest stone railroad bridge in the United States, currently. We have the rolling hills that peak at Elk Mountain, and for those of you who enjoy skiing, whether it is by trail or a wonderful vertical drop, Elk Mountain is the place to go. We have the dairy and the bluestone industry, and sportsmen and women enjoy game preserves, game lands, and spring-fed lakes.
