TUESDAY, April 20, 2010

The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Joseph B. Scarnati III) in the Chair.

#### **PRAYER**

The Chaplain, the Very Reverend MICHAEL R. ZAK, of Saint Michael's Orthodox Church, Clymer, offered the following prayer:

In the name of the Father and the Son and the Holy Spirit, Amen. This is the day the Lord has made; we will rejoice and be glad in it.

Saint Paul reminds us that every soul and citizen of the Commonwealth of Pennsylvania is subject to the governing authorities, such as this esteemed gathering of duly elected Senators. The reason that Satan rose up against God in the first place was this lust for power. It is our task, who live in the world, to

bear witness to the fact that truth is eternal and unchanging, and that God is the ultimate source of truth. We affirm that moral problems in today's society can only be solved through the love of God, as expressed to the world in Christ Jesus.

The words of the psalmist are still true today: "Happy is he who has the God of Jacob for his help, whose hope is in the Lord his God, who made heaven and earth, the sea, and all that is in them; who keeps truth forever, who executes justice for the oppressed; who gives food to the hungry. The Lord gives freedom to the prisoners; The Lord opens the eyes of the blind. The Lord watches over the strangers; He relieves the fatherless and the widow, but the way of the wicked he turns upside down. The Lord shall reign forever -- Your God, O Zion, to all generations. Recently, we had the district attorney of Dauphin County, District Attorney Marsico, come here to the Capitol and say that he had prosecuted two events in which there was human slavery involved in Dauphin County, one involving teenage girls, another involving Chinese immigrant women. So it is here, but it is under the radar. It is important for us to bring attention to it and to develop law enforcement strategies to end and prosecute this despicable crime.

Mr. President, the crash site in Shanksville, Somerset County, will forever stand as a reminder of the cowardly 9/11 terrorist attacks and as an inspirational tribute to the heroic Americans on that plane who fought back that day. Mr. President, I have long said that the first battle in the war on terrorism took place in the skies over Somerset County, right here in Pennsylvania.

Mr. President, apart from tarnishing the memory of those who died by using our region's Federal civilian court system as a loca-

tion where a potentially more lenient trial against these terrorist suspects might take place, we do not have the finances nor the security or the capabilities that it will take in the huge effort that is necessary to accommodate these trials. It just is not feasible, Mr. President.

Mr. President, while no one is stating that these men do not deserve or are not entitled to a fair trial, our civilian court system is not the proper venue to try these terrorist combatants. Mr. President, I urge an affirmative vote on Senate Resolution No. 256.

On the question, Will the Senate adopt the resolution?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise to offer this resolution designating the week of May 17 through 21 as "Juror Appreciation Week." Mr. President, every year, the legal profession as well as the Pennsylvania Bar Association and the various bar associations throughout the Commonwealth celebrate the lull during the month of May with a variety of educational and outreach efforts. As part of that endeavor, we celebrate the participation of our citizens throughout this Commonwealth who serve on juries.

The jury system, Mr. President, as we recognize it under today's American jurisprudence, traces its lineage back to Henry II, who set up a system to resolve land disputes using juries. A jury of 12 free men were assigned to arbitrate these disputes. Unlike the modern jury, these men were charged with uncovering the facts of the case on their own rather than listening to evidence and arguments in court. The use of the jury system as we recognize it was codified for the first time in 1215 when King John signed the Magna Carta, making trial by jury an implied right of the English citizenry. Many English colonies adopted the jury trial system, including Pennsylvania, which first included the right to a trial by jury in its Colonial Charter and later in the various Constitutions adopted by this Commonwealth. The right to a trial by jury was also included, as we know, in the Bill of Rights, adopted in 1791.

Jury trials in criminal cases are protected rights in the Constitution in the fifth, sixth, and seventh amendments. Mr. President, the 14th amendment of our Constitution insures that the right to a trial by jury is applied at the State level for both criminal and civil matters, and a grand jury for serious cases. The right to a jury trial has also been described as one of the most fundamental rights of a democratic society because of the fairness and equality of treatment in a trial that is heard and decided by a group of one's peers rather than representatives of government.

Over the past several years, Mr. President, the Pennsylvania Supreme Court and other groups have studied ways to enhance jury service. Various proposals have been introduced and considered that would increase juror pay, provide childcare services for jurors, and a number of other initiatives to make it easier for people to serve on juries. Mr. President, this General Assembly, largely through the efforts of the State Senate, has put into place mechanisms to allow more individuals to participate in the jury process and to allow more folks access to the jury pools in order to participate in these programs.

Mr. President, it is important to recognize the service of the people who have served on juries in this Commonwealth and to encourage more of our citizens to do so. Jury service is crucial, not only to the particular trial or matter that a juror is called to hear, but more importantly, Mr. President, to our entire system of civil and criminal justice. And to those jurors who have served and are serving now, we say thank you. Further, we encourage all citizens, when called upon to serve for this very important civic duty, to do so.

Senator HUGHES. Mr. President, just a brief but important comment. I thank the body for taking a moment to recognize this resolution. I will read one of the first "whereas" sections from the resolution, and I think it really says to us specifically why we need to pay more attention to the issue and designate May 2010 as "Stroke Awareness Month" in Pennsylvania.

Stroke is a leading cause of serious long-term disability and is the third leading cause of death in the United States, killing more than 137,000 people nationwide and more than 7,000 people in Pennsylvania each year. It is clear that we need to do whatever we can to raise the level of attention and conversation and, hopefully, public policy, around the issue of stroke and stroke prevention. So I thank the body for its consideration of this important resolution.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, this resolution designates April 2010 as "Hemophilia Awareness Month" in Pennsylvania. Hemophilia is the name of a genetic disorder that impairs the body's ability to control bleeding. Hemophilia is defined as excessive, uncontrollable bleeding because of the missing or low-level clotting factor in the blood. Bleeding may occur even when there is no injury, and it most often occurs in the joints and in the head.

There are approximately 20,000 citizens in the United States with hemophilia, and each year, approximately 400 babies are born with the disorder. There are approximately 1,700 Pennsylvania citizens living with hemophilia, and hemophilia affects males almost exclusively - one in 7,000 - but it is found in all populations. Although there is no cure for hemophilia, it is a lifelong condition that can be controlled with intravenous infusion of factor replacement therapies.

I ask for support for the adoption of this resolution.

A Resolution designating the month of May 2010 as "Military Service-Related Post-Traumatic Stress Disorder Awareness Month" in Pennsylvania.

Will the Senate adopt the resolution?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, this resolution designates May 2010 as "Military Service-Related Post-Traumatic Stress Disorder Awareness Month" in Pennsylvania. The month of May has been designated by Congress as National Military Appreciation Month to remember those who gave their lives in defense of freedom and to honor the men and women of the United States Armed Forces who have served and are now serving this country.

Beginning with the ravages of the Civil War, a war-related syndrome has been identified and called various names: "shell shock" in World War I; "battle fatigue" in World War II; and since the Vietnam conflict, the syndrome has been known as post-traumatic stress disorder, or PTSD. Veterans currently returning from service in Afghanistan and Iraq are experiencing a high incidence of PTSD.

A study published last year in the American Journal of Public Health revealed that more than one-third of returning soldiers from Afghanistan and Iraq received a diagnosis of having a mental health disorder, of which nearly 22 percent were diagnosed with PTSD. Caused by the horrors experienced during war, PTSD has an insidious effect on the health of individuals and causes emotional, social, physical, spiritual, and communication challenges for both the veterans suffering from the disorder and their loved ones.

The National Center for Posttraumatic Stress Disorder within the United States Department of Veterans Affairs aims to advance the clinical care and social welfare of United States veterans through research, education, and training on PTSD and stress-related disorders and provides educational resources for veterans and also for healthcare providers, researchers, and the general public through its Internet Web site.

That said, it is fitting, during this month in which VE Day, Military Spouse Day, Loyalty Day, Armed Forces Day, and Memorial Day are observed, to reflect on this serious disorder that affects many of our veterans and their families, so that we may renew and increase our awareness of this disorder. I ask for the support and adoption of this resolution.

A Resolution designating May 1, 2010, as "The Battle of the Crooked Billet Day" in Pennsylvania.

Will the Senate adopt the resolution?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, during the American War for Independence at the time of the Valley Forge Encampment in 1777 and 1778, President Thomas Wharton of the Pennsylvania Supreme Executive Council commissioned Brigadier General John Lacey, the youngest general in American history and a native of Bucks County--a county which I represent--to lead the Pennsylvania militia in patrolling the countryside outside of Philadelphia.

General George Washington, Commander-in-Chief of the Continental Army, charged General Lacey with the mission to keep the local inhabitants from selling supplies to the British Army, who occupied Philadelphia, and to restore and reroute those supplies to the Continental Army at Valley Forge. Due to the success of the Pennsylvania militia, the British Army developed a plan to annihilate the Pennsylvania militia by ambush and planned to capture General Lacey.

The Pennsylvania militia was comprised of approximately 300 men from Bucks County and historic Cumberland County, as well as from other places throughout this Commonwealth. The British Army attacked the Pennsylvania militia with a force of approximately 850 men in the early morning of May 1, 1778, in

the present-day borough of Hatboro, Montgomery County--again, a borough that I represent--and the present-day township of Warminister, Bucks County, again, a township which I also represent. The Queen's Rangers attempted to push the Pennsylvania militia south toward the point of ambush along present-day Horsham Road. General Lacey was not fooled by the trap and led the Pennsylvania militia north, where they fought their way through a blockade held by British Dragoons, thereby escaping deeper into Bucks County. Twenty-six Pennsylvania militiamen were killed in action that day, and 58 Pennsylvania militiamen were captured, and the Pennsylvania militia lost all of their supply wagons.

This resolution designates May 1, 2010, as "The Battle of the Crooked Billet Day" throughout this Commonwealth to honor the men of the Pennsylvania militia under the command and leadership of Brigadier General John Lacey for their heroism, and especially for those men who paid the ultimate sacrifice on May 1, 1778; for the competent and heroic leadership of Brigadier General John Lacey in preserving the militia from annihilation and leading them to safety; and for their sacred participation in the fight and struggle for freedom in the early years of the Republic of the United States of America. I ask that we support this resolution, which I will deliver to another school in my district, Crooked Billet Elementary School, with the Senate's approval of this resolution.

Senator FONTANA. Mr. President, this resolution designates May 8 through 16 as "National Travel and Tourism Week" in Pennsylvania and also recognizes tomorrow, April 21, as "Tourism Day" in Pennsylvania. I am proud and happy to offer this resolution, along with Senator Earll.

People are often surprised to find that tourism ranks as the second-largest industry in the Commonwealth and that Pennsylvania is the fourth-most visited State in the country. We all should be aware that tourism is not just people visiting our local, State, and national landmarks, though. Tourism encompasses our

hotels, amusement parks, restaurants, ski areas, stadiums, small businesses, and so much more.

Mr. President, it is very important for us to understand that the tourism industry generates \$10.7 billion in wages and benefits. Its 400,000-strong workforce accounts for almost 7 percent of all individuals employed in Pennsylvania. From 2003 to 2007, the tourism industry has grown State and local tax revenues by 16.5 percent, and in 2007 alone, direct spending by travelers to the Commonwealth generated \$28 billion. That is new dollars from visitors to Pennsylvania who are putting money into our State's economy, \$2.8 billion of which was in State and municipal tax revenues. Tourism provides a return for tax dollars invested, and we are lucky to have such a robust industry in this economic climate.

So for all of you out there, please visit Pennsylvania and spend more time in our Great Lakes region, the Pennsylvania Wilds, upstate Pennsylvania, Pittsburgh and its countryside, the Alleghenies and her valleys, the Dutch Country roads, Philadelphia and the countryside, or the northeast. Better off, why not visit them all? What you are looking for is just down the road.
