An Act amending Titles 23 (Domestic Relations) and 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, further providing for modification of existing support orders; and providing for assignment of custody and visitation rights during military deployment.

Upon motion of Senator PILEGGI, and agreed to by voice vote, the bill was rereferred to the Committee on Appropriations.

Mr. President, today I join with my colleague from Allegheny County, Senator John Pippy, in recognizing the 25th anniversary of the Pennsylvania Student Assistance Program, and I would like to thank Dr. Lawrence Korchnak, superintendent of the Baldwin-Whitehall School District, for bringing this milestone to our attention.

The Student Assistance Program is celebrating 25 years of serving students by identifying and removing the external barriers those students have to learning. Students referred to the Student Assistance Program receive help in the form of one-on-one counseling. Based on their individual needs, they are connected with educational groups, mental health groups, or drug- and alcohol-related groups to help them address and deal with the barriers that exist in their lives. With each school district in the Commonwealth trained in the program, there have been more than 1 million referrals. In Allegheny County alone, over 10,000 students were referred to the program just last year.

The program is a valuable asset to districts, as it helps school workers serve at-risk students by providing support for the most vulnerable in the school system. According to the users of the program, many of those students were referred because of evidence of academic failure, followed by lack of attendance and behavioral issues. Students can be referred by a number of people involved in their lives, including school counselors, teachers, school social workers, parents, and even the students themselves.

Thanks to the Student Assistance Program, more and more students are able to gain the tools that they need to deal with the external issues in their lives, to focus on their schooling, and to graduate and move beyond high school to focus on their futures. Mr. President, I am proud of the work that the Student Assistance Program does throughout the Commonwealth for our students, and I am happy to offer this resolution congratulating them on 25 years of serving our children.

Senator RAFFERTY. Mr. President, it is with a very sad heart that I stand here today before my colleagues in the Senate to report that one of the family members of the Senate of Pennsylvania, a longtime security guard in the Senate of Pennsylvania, passed away this past weekend. Paul Vetter, at the age of 39, put up a valiant fight against cancer. He lost out this weekend. It is a great loss to the Senate of Pennsylvania, to those who knew Paul to be the affable, gregarious, and dedicated young man that he was and, more importantly, the loving father and husband that Paul was. He leaves behind his wife, Michelle, and his daughters, Sophia and Maxine.

I want to say, on a personal note, Mr. President, Paul was one of the first people I ever met in the Senate of Pennsylvania when I was elected 8 years ago. He instantly made me feel welcome, and he also had that warm, caring attitude about him that, I think, carried over for all the Members of the Senate, certainly all the employees of the Senate of Pennsylvania.

Mr. President, to honor Paul's memory, I ask that the Senate stand for a moment of silence.

The PRESIDING OFFICER. Members and guests, please rise.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I, too, rise with a heavy heart this afternoon. Mr. President, on April 26, 2010, my district staff, my staff in Harrisburg here, the Pennsylvania State Senate, and our Commonwealth lost a very dedicated employee, a wonderful person, and a fantastic community activist in Frances Accamando. Fran's untimely death at the age of 66 was truly a loss to all of us.

Fran was a dedicated Senate employee who began her service in my district office in Carrick in December of 1998. Fran was an essential member of our staff in the Pittsburgh area. She did as much work as she possibly could for our constituents in that district, and throughout her work, she worked diligently to make certain that she was able to resolve problems and address issues and be a part of our community. Fran was very detail-oriented, conscientious, and so very committed to her job. And she took great pride, as I said, in all that she accomplished in her daily activities and in working with folks in our district office.

Fran was very active, also, outside of our district office activities, Mr. President. She was involved in many, many community-based organizations and dedicated countless hours to improving the Overbrook neighborhood she called home. She became active, in 1984, as a Block Watch captain and later joined the Zone 3 Public Safety Council. In 1986, she took on the presidency of the Overbrook Community Council and remained one of its driving forces for community improvement for more than two decades. In addition, she also found time to join the Neighborfair Board, a citywide marketing group marketing the region, created by the late mayor of the city of Pittsburgh, Richard Caliguiri. Fran was also very active as the vice president of the South Pittsburgh Economic Revitalization Team for over a decade. She joined the board of Economic Development South and was co-creator of the Saw Mill Run Task Force, a very important project at its time.

Mr. President, over the years, when the rains would hit our areas and the creeks would rise, it was not unusual to see Fran Accamando in her high boots, working to help, evaluate, and support the people who lived on Ansonia Place, a flood-plagued part of the city of Pittsburgh. These folks became part of her family. She protected them and, in the end, was the driving force in helping them to relocate to higher ground.

Most importantly, Mr. President, Fran was an outstanding family person. A loving wife, she was married to Marco Accamando for 47 years and cared so deeply for Marco and for their son, Marc, and his wife, Kathy. But among the greatest joys in Fran's life were her grandchildren, Simon, Marc, Jr., and Olivia. The personal loss that Fran's family has suffered cannot be measured.

Mr. President, Fran never sought out recognition or accolades for the many services she performed, though awards would have been well deserved. She always had a smile on her face, a whistle on her lips, and a bad joke ready for anyone who was willing to listen. She will be sorely missed by her family, by our staff, by our constituents, and by our friends and family and neighbors in

the Overbrook area and all those who had the good fortune to have known her.

I, too, Mr. President, ask that the Senate join me in remembering Frances Accamando and recognizing her for outstanding and dedicated service to the people of this Commonwealth, and more specifically, the 43rd Senate District, the city of Pittsburgh, and our Commonwealth. I respectfully ask for a moment of silence on behalf of Fran.

The PRESIDING OFFICER. Members and guests, please stand for a moment of silence.

(Whereupon, the Senate en bloc stood in a moment of silence in solemn respect to the memory of FRANCES ACCAMANDO.)

The PRESIDING OFFICER. The Chair recognizes the gentleman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President, last month, this nation lost two important civil rights activists, Dorothy Height and Benjamin Hooks. Both of these humanitarians spent their long lives striving for equality for all.

Dorothy Height, who died on April 20 at the age of 98, dedicated her life to improving the welfare of African Americans, women, and all people. Although she was born in Richmond, Virginia, Dorothy Height lived in Rankin, Pennsylvania, near Pittsburgh, as a child. She was always a gifted student and was awarded entry into Barnard College. However, when she arrived at the school, she was denied entrance into the college because Barnard had already fulfilled its unwritten quota of accepting two African Americans per academic year. But this did not deter her. She went to New York University instead and earned her bachelor's and master's degrees there.

She began her career as a civil rights advocate at the age of 25, when she joined the National Council of Negro Women, and fought for equal rights for both African Americans and women. For 40 years, until 1997, she served as the council's president. Dorothy Height was a very influential civil rights leader. In fact, upon her death, President Obama described Dorothy Height as "the godmother of the Civil Rights Movement." In the 1960s, she organized "Wednesdays in Mississippi," which brought together black and white women from across the nation to create a dialogue of understanding. I should also note that Dorothy Height stood on the platform when Dr. Martin Luther King delivered his "I Have a Dream" speech in Washington, D.C. She once described her experience by saying, "As I looked out at that huge audience on the Washington Mall, I found it inspiring almost beyond words."

In her lifetime, she met with numerous Presidents. She urged President Eisenhower to desegregate schools, and President Johnson to appoint African American women to positions in government. Additionally, she received a Citizens Medal award for distinguished service by President Reagan in 1989, the Presidential Medal of Freedom by President Clinton in 1994, and the Congressional Gold Medal by President Bush in 2004.

Like Dorothy Height, Benjamin Hooks spent a lifetime dedicating himself to equal rights for African Americans. Benjamin Hooks, who died on April 16 at the age of 85, was the former executive director of the NAACP. He helped stoke the organization's resurgence in the 1970s. He served in the Army during World War II and earned a law degree from DePaul University. Throughout his lifetime, Benjamin Hooks was a lawyer, busi-

nessman, and Baptist minister. He was the first African American to be appointed to the criminal court bench in Tennessee and was also the first African American to be named to the Federal Communications Commission.

Benjamin Hooks was actively involved in the Civil Rights Movement. He participated in sit-ins, boycotts, and other demonstrations sponsored by the NAACP. Dr. Martin Luther King recruited him to serve on the board of the Southern Christian Leadership Conference, which was a driving force behind the Civil Rights Movement. Benjamin Hooks received the Presidential Medal of Freedom from President George W. Bush in November of 2007.

Mr. President, Dorothy Height and Benjamin Hooks shared a belief that everyone deserves to be treated equally. They have paved the way for my generation and the next generation of young leaders. They lived through segregation and desegregation. They fought so that African Americans could rise up and lead and live to help elect the first black American President. Although they are no longer with us, their work and tireless contribution to equality and justice in America will not be forgotten.

Thank you, Mr. President.
