I am pleased to present you with a copy of the Annual Report of the Office of Small Business Advocate for Calendar Year 2010.

In carrying out its mission in 2010, the OSBA was guided by the realization that every dollar a business must spend on utility service or workers' compensation insurance is a dollar unavailable for expanding that business, creating jobs, or increasing pay and benefits.

The OSBA's principal goal before the Public Utility Commission is to assure that small business customers are not required to pay a disproportionate share of any utility rate increase. The most significant savings because of the OSBA's activities in 2010 are as follows:

- Small business customers will pay about \$20 million per year less for electric, gas, water, and wastewater service than they would have under the proposals of the party advocating for residential customers.
- Small business customers will pay tens of millions of dollars less in smart meter costs than they would have under the proposals of the party advocating for residential customers.

## PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, first of all, I rise to wish Mrs. Tonya Stack a happy Valentine's Day, and all the valentines out there a happy Valentine's Day. The groaning is jealousy about my forethought, and anyone who follows me wishing a happy Valentine's Day is a copycat.

But, Mr. President, speaking of love, I rose last week to talk about the issue of adultBasic coverage, which is a highly-regarded insurance program that we have in the State of Pennsylvania. Started under Governor Ridge, it was designed to provide insurance for hardworking Pennsylvanians who may not be able to afford that insurance.

There are about 17 days left before that program officially ends, and there are 42,000 people currently insured under that program. Those folks are at home trying to take care of their loved ones, and they are watching us to see what we do on this issue. I was pleased last week, when I raised this issue, that the Majority Leader responded that it was an issue of importance to him and that it would play out and get worked out during the budget process.

One of the ideas that I have advocated is to plug the financial holes that the ABC program has right now by using a portion or, in fact, the entire reserves that the legislature now possesses. The amount that I have most recently seen is close to \$200 million in legislative reserves. So I think that that would be a very good use of that money. I understand that Governor Corbett has also gone on record saying that it might not be a bad use of that money, to fund the ABC program. The folks who are worried about not having insurance--what are we going to do when 42,000 people are suddenly without insurance? It is just not an issue that we should have to deal with.

I understand many of the arguments, too, that we have not necessarily done a good enough job in the way the adultBasic insurance program is run. There needs to be more accountability.

I have advocated that there needs to be cost sharing by recipients of the program. We need to make sure that we observe who is on the waiting list and who is eligible for that on a more quarterly basis to make sure there is more accountability. I am sure we can also do it for cheaper than the \$14 million a month that we have been spending on it.

The bottom line is that this is an important issue, and it is one that we should get to, and I am hopeful that we will. I want to continue to make sure that--we stood last week at a press conference, and we had Senator Yudichak, Senator Farnese, Senator Solobay, and also Representative Boyle with us, but I know there are numbers of Members, both Democrat and Republican, who know this is an important issue. So we look forward to moving forward on it.
