The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, the resolution I offer designates March 2011 as "Brain Injury Awareness Month" in Pennsylvania. Traumatic brain injury is the leading cause of disability and death from birth to age 40. Brain injury due to trauma may be caused by a direct blow to the head, being shaken violently, or by falls, motor vehicle crashes, bicycle accidents, sports and recreational injuries, shaken baby syndrome, gunshot wounds, and assaults.

The signs and symptoms of traumatic brain injury can be subtle and may not appear for days or even weeks after the injury or may even be missed. Mild traumatic brain injury is often underdiagnosed and misdiagnosed, with symptoms not always immediately apparent. It is estimated that there are between 50,000 to 125,000 mild traumatic brain injuries, commonly referred to as concussions, resulting from sports and recreational accidents in Pennsylvania every year. Nationally, children and youth 5 to 18 years of age account for 2.4 million sports-related emergency visits for traumatic brain injuries annually. Over 130,000 Pennsylvanians are living with a long-term disability resulting from traumatic brain injury. Also, more than 50,000 Pennsylvanians are treated and released from emergency rooms for traumatic brain injuries annually. The cost of treating, rehabilitating, and caring for the victims of traumatic brain injuries in the United States is approximately \$30 billion each year.

This Commonwealth has a number of leading research centers for brain injuries, including the Penn Center for Brain Injury and Repair at the University of Pennsylvania, the Moss Rehabilitation Research Institute, the Brain Trauma Research Center at the University of Pittsburgh, and the Center for Injury Research and Prevention at the Children's Hospital of Philadelphia. In addition, the State has three organizations specifically devoted to brain injury, including the Brain Injury Association of Pennsylvania, Inc., the Acquired Brain Injury Network of Pennsylvania, the Pennsylvania Brain Injury Coalition, as well as two organizations with a strong focus on brain injury, including the Disability Rights Network of Pennsylvania and the Pennsylvania Association of Rehabilitation Facilities. That being said, I ask for your support and adoption of this important resolution.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise today to talk about a new initiative which Senate Democrats launched last week called Pennsylvania Works. If you have not already had an opportunity to review it, Mr. President, I believe that our plan is worth taking a look at because we believe it has the potential to spur the creation of tens of thousands of jobs here in Pennsylvania. Furthermore, Pennsylvania Works will reduce State spending by \$150 million, while giving businesses across this Commonwealth the incentives they need to make community investments.

Over the past several months, Senate Democrats have stressed the need to work aggressively to bring more jobs to Pennsylvania. While aware of the trying budget process which awaits us in the legislature here over the next couple of weeks, all Members of the Senate Democratic Caucus agree that jobs must remain the number-one priority here in Harrisburg. Throughout this Session, we must bear in mind how imperative it is that we continue to look at the big picture and make wise investments in our future to speed up economic recovery here in Pennsylvania.

Our Pennsylvania Works plan focuses on six key areas: small businesses, workforce training, critical State investments, clean and green energy, infrastructure investment, and tax fairness.

Mr. President, there are a number of things that we can do as a Commonwealth to become a better friend to small businesses. The Small Business First program is a very popular and very successful DCED program. By increasing the maximum loan amounts and repayment periods and decreasing maximum interest rates for all Small Business First loans, we believe we can generate more small business investment. Refocusing programs like the Second Stage Loan Guarantee Program and lessening the restrictions in place to limit the program is another part of our plan to help free up capital and make sure that the funding originally allocated to this particular program is not lying stagnant. A reconstituted \$50-million small business investment guarantee program will provide a needed catalyst to spur our private banks and our other commercial lenders to provide access to capital for our small businesses.

Mr. President, workforce training is the second key component. A recent Department of Education report found that only 20 percent of our current workforce holds the necessary skills that 60 percent of our 21st century economy will require. If we want to compete in the national and global economy, a well-trained workforce is essential.

We can accomplish that by consolidating several of our current programs. Pennsylvania needs a one-stop workforce investment in education service. By consolidating all job training programs under the Department of Labor and Industry, we believe we can focus training and education programs to align skills training with industry employment needs. Consolidation would include programs like the Vocational Education Programs, Youth Development Institutions, Corrections Education and Training, and New Directions for public assistance recipients. The restructuring would allow Pennsylvania to fully leverage Federal subsidies through the Workforce Investment Act, the Vocational Rehabilitation Act, the Perkins Act, TANF welfare-to-work programs, and Social Service Block Grant subsidies to directly invest in employer-directed training programs.

We can also look at successful models in other States. By creating a Train-to-Work PA program, we can have an individual employer-driven program coordinated through workforce investment boards and the Department of Labor and Industry. This would be modeled after the very successful Georgia Works program, which Senate Democrats have talked about before. Priority for training and Train-to-Work programs in Pennsylvania will help those applicants who are currently receiving unemployment compensation benefits. We can invest Federal dislocated worker funds to partially subsidize wages for on-the-job training opportunities leading to full-time permanent employment. The department already has waivers in place from the Federal Department of Labor to use dislocated worker funds for this particular purpose.

Mr. President, our third point is making critical investments to create jobs. Pennsylvania has funded a number of very successful programs to create jobs and grow our economy. Many of these investments have been critical in transforming our economy into what it is today, a regional leader emerging from the deep economic recession in much better shape than most other States.

Now, we must take a new and careful look at the entire investment portfolio we have. We need to identify what works and fix what does not work. One thing that our plan does to address this is to recapitalize Business in Our Sites. The Commonwealth Financing Authority's infrastructure investment program is designed to create shovel-ready sites for new development. Our plan proposes a fresh \$75 million recapitalization of this successful program by reallocating previously authorized CFA funds from underutilized program accounts.

Clean and Green Energy is another important component of our six-point plan. Pennsylvania is primed to become a world leader in clean and green energy. Our prior investments, coupled with the efforts of our world-class educational institutions, have positioned Pennsylvania at the forefront of many emerging energy sectors. Industry leaders include Plextronics for solar research, Gamesa in wind energy development, Westinghouse in nuclear research and development, and the Marcellus Shale industry, which has untold potential to create new jobs and new commerce in this Commonwealth.

The Clean and Green Energy component of Pennsylvania Works is a package of initiatives designed to encourage the construction of green buildings and to seize Pennsylvania's opportunity to become a world energy leader. The exploding Marcellus Shale industry has generated thousands of good-paying, family-sustaining jobs. Senate Democrats want to continue to promote this industry while at the same time protecting and reinvesting in our local infrastructure and making certain that the resources that belong to all of us are protected and that the environment is protected as well.

Mr. President, we cannot overlook the infrastructure investments as we move forward. It is critical to creating jobs and stimulating the economy. For Pennsylvania to move forward, we must invest. Our roads must be up to par to protect Commonwealth residents and commerce. Our water and sewer systems are old and outdated; our gas utility lines are failing; and we need to upgrade our communications technology. Some of these issues can be addressed immediately. We should explore public-private partnerships, tolling, and bonding as short-term solutions to our transportation funding woes. And the Commonwealth Financing Authority should act in April to release the remaining \$172 million of H_2O funding for water and sewer projects.

Finally, Mr. President, we believe that we must do something to bring tax fairness to Pennsylvania. How do we do this? We do this by reducing the corporate net income tax to 7.5 percent by closing the Delaware loophole, which allows companies to take unfair advantage of the tax structure here in Pennsylvania. We also believe that we can increase the single sales factor, a method for dividing business income amongst States for the purpose of taxation. We propose increasing the single sales factor to 100 percent to give home-based Pennsylvania corporations more favorable tax treatment in their Pennsylvania sales. We also believe that increasing the net operating loss ceiling is an important tool for new- and early-stage businesses that may have suffered

losses in their early years of development. We believe that we can increase this amount from \$3 million to \$5 million and from 20 to 25 percent of taxable income. Reducing corporate tax rates and implementing principles of tax fairness will make Pennsylvania more business-friendly in a competitive State. The tax fairness components of the Pennsylvania Works package is a package of common-sense reforms to our Tax Code that we believe will stimulate economic growth and business development.

Mr. President, a great deal of time, thought, and planning went into this Pennsylvania Works project. Pennsylvania Works uses innovative ideas that will spur job creation, promote a business-friendly environment, and expand business opportunities. Senate Democrats believe that every issue and every decision made in the coming months should be gauged by the importance of job creation and retention. Pennsylvania Works was crafted to avoid new spending, as I said earlier, where possible, and to increase efficiencies and eliminate redundancy in State government. By being a better friend to small businesses, creating a tax climate to make businesses want to stay here in Pennsylvania and allowing them to create new jobs here, and by making sure that our workforce training targets the areas where it is needed most, we stand to help tens of thousands of people find meaningful work in this Commonwealth.

Mr. President, right now, I and my Senate Democratic colleagues see this as the first and highest priority. We hope that all of our colleagues will take a look at our plan and join us as we go forward in this worthy endeavor. Mr. President, thank you very much.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, next week, Governor Corbett will address us in a Joint Session for the first time to lay out his agenda and to deal with the very crucial issue of our huge budget deficit. I like a number of the things that I have heard from Governor Corbett and his proposed cabinet Secretaries so far. I feel very optimistic and hopeful that he brings the right kind of focus, the right kind of background, and the right kind of determination to the job. So I am hopeful that Democrats and Republicans can work together in a common way to solve the problems with which our State is dealing.

One of the issues that I have talked about and the Governor has commented on is the issue of adultBasic coverage, which we have had here in Pennsylvania. The adultBasic coverage, as you know from hearing me talk about this issue a number of times, was originally started by Governor Ridge and has been very successful at providing low-cost health insurance for hardworking Pennsylvanians who otherwise would not be able to afford health insurance. As of yesterday, the program has expired, and it has essentially gone out without so much as a whimper. It has been a disheartening process to watch that program fall by the wayside.

Nonetheless, I have not given up on continuing to advance one idea, which is Senate Bill No. 420, of which I am the prime sponsor. I have 11 cosponsors. That bill, as you know, advocates spending a portion of the \$190 million that the legislature currently has in reserves toward funding the adultBasic insurance program until we can come up with a more permanent solution.

I have also been one of the individuals who have said the adultBasic program, although it is a great program, is like many other government programs - it needs better accountability, it

needs to be run more efficiently, and at the end of the day, the dollars that are expended through that program and many other government programs need to be guarded and protected as though they are the last nickel in each and every one of our pockets.

So we can run that program better, we can run it more efficiently, and using the legislative reserve is but one option. I have heard a couple of other options. Representative DeLuca has an idea to fund the program through proceeds from the auto CAT Fund. This is a good idea. I have heard other folks, albeit not present legislation on it, talk about using money that may be in the surplus this year. That is an idea to which I am open. Others have said that the problem they have with the ABC funding mechanism is that they think that the Blues, who have previously funded the program to the tune of over \$500 million, should continue to fund the program. Philosophically, I am not sure if that is what I think private industry or corporate interests should be involved in. Nonetheless, I have not seen any legislation promoting that type of issue, and we cannot consider anything until we have a bill on it.

The bottom line is we have 41,000 people right now who have no health insurance. This is an old argument that we have made, that when folks do not have insurance, usually their first entry into the health system is through the emergency room doors. And thank God, under Pennsylvania law, when a person comes through the emergency room doors and they are sick, our healthcare providers have a duty to take care of those people. But ultimately, the cost of doing that is passed on to all of us, the taxpayers. So it is a "you can pay me now, or you can pay me later" situation. The bottom line is providing affordable health insurance is still a big problem, and we cannot let these 41,000 people slip through the cracks.

So I look forward to continuing to work with my colleagues, with Governor Corbett, on that issue. And then, just one last piece, too. You know, when we talk about the budget, we are really talking about corrections, welfare, and education. That is 73 percent of the budget, those three items, and all three of those items need major reforming.

A hot-button issue that is going to be discussed in this Chamber and throughout the legislature is the idea of educational reform, some people call it vouchers, some people call it school choice. A big part of that is the fact that there is EITC money which helps kids go to the schools to which they want to go. It helps their parents or parent afford to send them to the schools they want. That is one of the more attractive things I see in educational reform, the increased EITC money.

Nonetheless, in this Caucus here on this side of the aisle, we had a hearing yesterday in which Democrats attacked Democrats in a type of rhetoric which, in my opinion, does not set a good example for the people out there who count on us to solve these problems and not become acrimonious. We can have great and strong opinions, but we should always try to be agreeable, even when we disagree. That is something of which I think we should all be mindful, that our tone and our rhetoric should never take such a strong tone that it cancels out what our good intentions are and the people we are trying to stand up for, which is ultimately our greatest resource, and that is our young people for whom we are hoping to get the best possible education. So I look forward to working with you, Mr. President, and all the Members of this great Chamber and with the Governor to solve the problems of

Pennsylvania. We look forward to doing that, and I think that we can accomplish great things.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President, yesterday I talked about adultBasic healthcare insurance, and I also introduced Senate Resolution No. 43. I just am sincerely asking that it be considered to be brought up for a vote and that we approve it. I have to keep talking about this because it is so important to so many people, working people in my district and across the State who do not have healthcare. I think it would be irresponsible of me to let this issue pass, to let the insurance expire and say nothing. It is not right treatment to the taxpayers of Pennsylvania, and I do not think it is unreasonable to do a 90-day study of this program.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I just want to rise very briefly and lend my support to Senator Kitchen's very realistic and reasonable request that we entertain the resolution to which she made reference. Without question, the adultBasic issue is very, very important in this Commonwealth, and unfortunately, in our opinion has not gotten the attention that it deserves. I do not think folks recognize the significant impact it is going to have on a number of industries in this Commonwealth, particularly the healthcare delivery system.

Mr. President, when we met with a number of the organizations that have the program, of the 40,000 individuals who are responsible on the adultBasic program, a collective number of them indicated that less than 10 percent last week had transferred over from the adultBasic to the Special Care program. If they got up to 25 percent, which would represent about 10,000-plus individuals, it still leaves about 30,000 people, possibly--I will even give you 20,000 people--who do not have insurance as we stand here today.

At the end of the day, what does that mean? You have families who are not able to get the healthcare that they want and need and pay for. They are ready, willing, and able to pay additional amounts, but at the end of the day, those folks will end up in our hospitals and our emergency rooms at an accelerated amount of money, an increased amount that it will cost to treat conditions that are getting worse because they have not been able to get to the doctor's office. We need to take a look at the impact of the loss of adultBasic in this Commonwealth, and it is important that we take the opportunity to look at the study that was developed by the resolution developed by Senator Kitchen. I stand behind her in that request and hope that we can move forward along those lines.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, along those same lines that Senator Costa referred to, which has also been a collective voice by many Members of our Caucus, not just now, but over the years, this has been an issue of finding health insurance for those individuals who are in the adultBasic program. And so that we are exactly clear on that, these are individuals who cannot afford to purchase health insurance on their own but are working individuals who, unfortunately, do not make enough money to pur-

chase on their own but make more money than would be in the State's Medical Assistance program. So they are caught in a very difficult circumstance. They are caught in a very difficult situation. And, you know, when we take them off of the rolls of adultBasic, then they wind up getting care somewhere else. Someone has to treat them in some fashion, and usually what happens in these circumstances is these individuals wind up in our emergency rooms. They wait because they cannot afford the alternatives that are available to them. They make too much money to get into the State's Medical Assistance program and not enough money to afford some very expensive insurance that exists out there, so they wind up in a high-cost alternative that currently is available. But when you talk about a high-cost alternative, you are talking about a program that now rises from a monthly premium of \$36 a month to a monthly premium of almost \$150 a month. And then that also puts them in a circumstance where, if I understand the information correctly, they only get four hospital visits during the course of the year. That is not a viable option, especially in an economy, Mr. President, where the need for services like this is increasing.

We have an 8.5 percent unemployment rate. Folks are struggling to make it on a daily basis, and adultBasic was designed for those individuals who fit into that category. As I said, they are working individuals, trying to make it on a daily basis. There are probably about half a million people or so who are on the waiting list to get into the program, and probably hundreds of thousands more who thought this would be a good idea to get into at some point but never got the muster up to even apply to get on the waiting list.

We have worked over the years--and Senator Costa did a really good job in terms of pulling everybody together about two Mondays ago to try to get everybody in the room. The Blues were there. All the representatives from all the Blues across the Commonwealth were there. Other insurance carriers were there. The Blues indicated they have been putting up money and have spent exorbitant amounts of money over the years as their contribution to this program, and I think that needs to be noted. They have put up money, and it really is, in this circumstance--we were not able to bring everybody together. We still need to come back to the table, considering Senator Kitchen's resolution, come back to the table, considering all the other conversation that occurred, come back to the table to try to get this thing worked out. To leave these folks hanging without any care or, in fact, not just without any care but what seems to be any hope for some care sometime in the near future, I think, really does not represent the best in us as a State. In many respects, it represents the worst in us.

So I hope that we can figure out a way to get everybody back to the table, get all of the insurers, not just the Blues, but all of the insurers, to figure out a way that they can kick in to come close to matching what the Blues have put in; figure out a way to get some State support, maybe do some creative financing and try to get the Federal government to step up in some fashion; to do something creative so that we do not leave these folks hanging, because right now, they have been hung out to dry and we need to figure out a way to get them taken care of.
