The Senate met at 11 a.m., Eastern Standard Time.

The PRESIDENT (Lieutenant Governor Jim Cawley) in the Chair.

SPECIAL ORDER OF BUSINESS SENATE RESOLUTION ADOPTED

Senators VOGEL, SCHWANK, SCARNATI, PILEGGI, ALLOWAY, ARGALL, BAKER, BOSCOLA, BREWSTER, BROWNE, DINNIMAN, ERICKSON, FERLO, FOLMER, FONTANA, GORDNER, GREENLEAF, HUGHES, KASUNIC, KITCHEN, ORIE, PIPPY, RAFFERTY, ROBBINS, SOLOBAY, STACK, TARTAGLIONE, WARD, WAUGH, YAW, D. WHITE and BRUBAKER, by unanimous consent, offered **Senate Resolution No. 254**, entitled:

A Resolution designating the week of February 20 through 26, 2012, as "FFA Week" in Pennsylvania.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Beaver, Senator Vogel.

Senator VOGEL. Mr. President, today I offer a resolution designating February 20 through 26 as "FFA Week" in Pennsylvania. The Future Farmers of America was founded in 1928 as an organization for students to interact with leaders in the agricultural community to develop leadership, personal growth, and career success through agricultural education. Since then, it has grown into a diverse, national organization with over 540,000 members throughout the United States, Puerto Rico, and the Virgin Islands, of which 43 percent are young women who have committed themselves to agriculture.

GUESTS OF SENATOR ELDER A. VOGEL AND SENATOR JUDY SCHWANK PRESENTED TO THE SENATE

Senator VOGEL. The FFA has been a pivotal organization in my district, and has helped to create several young leaders in agriculture. One such individual is Tyler Claypool from Mohawk FFA in Lawrence County, who currently serves in a leadership position as State sentinel. There are also a few members visiting in the gallery today. I would like to introduce Jenna Moser, State Reporter from Philadelphia; Sarabeth Royer, State Secretary from Lancaster County; Matthew Dodson, State Chaplain from Franklin County; Tyler Schaeffer, State Vice President from Cumberland County; and Michael Brammer, executive director of the Pennsylvania FFA.

Agriculture is the nation's largest employer and number one industry in our great Commonwealth, and the FFA plays a substantial role in contributing to its success. Not only are they our future farmers, they are the future of our agriculture, preparing themselves to supply our food and fiber for years to come. For this reason, I would like to recognize February 20 through 26, 2012, as FFA Week in Pennsylvania, and ask for its unanimous adoption.

The PRESIDENT. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, I join my colleague, Senator Vogel, in welcoming our State FFA leaders. I would ask everybody to take a look at these youth because they truly will be the future leaders of agriculture in this Commonwealth and in this nation. As a former FFA advisor myself in high school, as well as working with the Delaware Valley College FFA chapter, I know full well the impacts of an organization like FFA. It is more than just Future Farmers of America, as many of us grew up understanding it. It is about the leadership and the innovation that we will need for agribusiness in the future. So I am delighted to have them here today and to join with Senator Vogel in celebrating FFA Week. Thank you.

Senator PILEGGI. Mr. President, it is my pleasure this morning to introduce my constituents, Denis Stephano, who is president of the United Steelworkers Local 10-234, and Dave Miller, who is president of the United Steelworkers Local 10-901. They are visiting Harrisburg today with other members and leaders of the United Steelworkers to raise awareness about the impact of the shutdown of the three major oil refineries in southeastern Pennsylvania.

Mr. President, since the announcements were made by Sunoco and ConocoPhillips in September to close their refineries in Marcus Hook Borough and Trainer, approximately 2,000 workers have been directly impacted and 10,000 more individuals indirectly impacted. Mr. President, Denis is seated in the gallery with my other guests today. I ask that we extend our traditional warm welcome.

BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 405 (Pr. No. 1534) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of December 31, 1965 (P.L.1257, No.511), known as The Local Tax Enabling Act, further providing for delegation of taxing powers and restrictions.

On the question,

Will the Senate agree to the bill on third consideration?

AMENDMENT OFFERED

Senator BLAKE offered the following amendment No. A5908:

Amend Bill, page 1, line 23, by inserting after "restrictions": and for payroll tax; and providing for payroll tax in cities of the second class

Amend Bill, page 4, by inserting between lines 9 and 10:

Section 1.1. The heading of section 303 of the act, amended July 2, 2008 (P.L.197, No.32), is amended to read:

Section 303. Payroll Tax in Cities of the Second Class.--* **

Section 1.2. The act is amended by adding a section to read:

Section 303.1. Payroll Tax in Other Political Subdivisions.--(a) Except for a city of the second class that levies a payroll tax under section 303, a political subdivision subject to the provisions of this act may levy, assess and collect a tax on payroll amounts generated as a result of an employer conducting business activity within the political subdivision. The rate of the tax shall not exceed the rate necessary to generate the same amount of revenue the political subdivision generated from a business privilege tax or mercantile tax levied by the political subdivision in the year immediately preceding the year the payroll tax will first take effect under section 301.1(f)(12). For purposes of a payroll tax levied, assessed or collected by a political subdivision, the business activity shall be directly attributable to activity within the political subdivision. For purposes of computation of the payroll tax imposed under this section, the payroll amount attributable to the political subdivision shall be determined by applying an apportionment factor to total payroll expense based on that portion of payroll expense which the total num-

ber of days an employe, partner, member, shareholder or other individual works within the political subdivision bears to the total number of days that employe or person works within and outside of the political subdivision.

- (b) A charitable organization that qualifies for tax exemption under the act of November 26, 1997 (P.L.508, No.55), known as the "Institutions of Purely Public Charity Act," shall calculate the tax that would otherwise be attributable to the political subdivision, but shall only pay the tax on that portion of its payroll expense attributable to business activity for which a tax may be imposed under section 511 of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 511). If the charity has purchased or is operating branches, affiliates, subsidiaries or other business entities that do not independently meet the standards of the "Institutions of Purely Public Charity Act," the tax shall be paid on the payroll attributable to the for-profit branches, affiliates or subsidiaries, whether or not the employes are leased or placed under the auspices of the charity's umbrella or parent organization. Nothing in this subsection shall restrict the ability of a charitable organization to contract with the political subdivision to provide services to the city in lieu of some or all taxes due under this section.
- (c) For purposes of the payroll tax assessed under this section, an employer is conducting business within a political subdivision if the employer engages, hires, employs or contracts with one or more individuals as employes and, in addition, the employer does at least one of the following:
- (1) maintains a fixed place of business within the political subdivision;
- (2) owns or leases real property within the political subdivision for purposes of such business;
- (3) maintains a stock of tangible personal property in the political subdivision for sale in the ordinary course of such business;
- (4) conducts continuous solicitation within the political subdivision related to such business; or
- (5) maintains a base of operations in the political subdivision. If an employer maintains more than one base of operations, the political subdivision shall only be able to tax the payroll generated by the base of operations.
- (d) All employers in the political subdivision shall file quarterly returns and make quarterly payments as provided for by ordinance enacted by the political subdivision. Every employer making a return shall certify the correctness of the return. A political subdivision may audit, examine or inspect the books, records or accounts of employers subject to the tax imposed under this section.
- (e) A political subdivision may enact ordinances, or resolutions if the political subdivision is a school district, and regulations necessary to implement this section. The ordinance or resolution levying the tax authorized by this section must permanently replace the political subdivision's existing mercantile tax and business privilege tax.
- (f) Taxes, additions and penalties collected under this section shall be used by the political subdivision exclusively for the general revenue purposes of the city.
- (g) An employer shall not offset the amount of tax paid under this section by reducing compensation or benefits paid to employes.
- (h) A political subdivision may bring an action for the recovery of taxes due and unpaid under this section, in accordance with the following:
- (1) Except as set forth in paragraph (2), the action must be commenced within three years after the later of the date:
 - (I) the tax is due; or
 - (ii) the declaration or return has been filed, whichever is later.
 - (2) The time limit in paragraph (1) shall be modified as follows:
- (I) If no declaration or return was filed although a declaration or return was required to be filed under this section, there shall be no limitation.
- (ii) If examination of the filed declaration or return or of other evidence relating to the declaration or return in the possession of the political subdivision reveals a fraudulent evasion of taxes, there shall be no limitation.
- (iii) If there is substantial understatement of tax liability of twenty-five percent or more and no fraud, an action must be brought within six years of the time specified in paragraph (1).
- (3) This subsection shall not be construed to limit the governing body from recovering delinquent taxes by any other means provided by law.

- (I) If the payroll tax is not paid when due, interest at the rate of six percent per annum on the amount of the tax and an additional penalty of one percent of the amount of the unpaid tax for each month or fraction of a month during which the tax remains unpaid shall be added and collected. If an action is brought for the recovery of the payroll tax, the employer shall, in addition, be liable for the costs of collection and the interest and penalties imposed under this subsection. A political subdivision may, by ordinance or resolution, establish a single period during which interest or interest and penalties which would otherwise be imposed for the nonreporting or underreporting of payroll tax liabilities or for the nonpayment of payroll taxes previously imposed and due shall be waived in total or in part if the taxpayer voluntarily files delinquent returns and pays the taxes in full during the period so established.
- (j) In addition to any other additions, penalties or enforcement proceedings provided for by ordinance of a political subdivision or a law of this Commonwealth for the collection and enforcement of taxes or the submission of information to a government entity:
- (1) An employer that intentionally makes a false statement on the employer's return commits a misdemeanor of the second degree and shall, upon conviction, be sentenced to pay a fine of not more than two thousand dollars (\$2,000) or to imprisonment for not more than two years, or both.
- (2) An employer that intentionally fails to file a return required by this section commits a misdemeanor of the third degree and shall, upon conviction, be sentenced to pay a fine of not more than one thousand dollars (\$1,000) or to imprisonment for not more than one year, or both.
- (3) A person that intentionally fails to appear before the tax collector in person with the employer's books, records or accounts for examination when required to do so under this section or an ordinance or that intentionally refuses to permit inspection of the books, records or accounts of a employer in the person's custody or control upon request by the tax collector commits a misdemeanor and shall, upon conviction, be sentenced to pay a fine of not more than five hundred dollars (\$500) or to imprisonment for not more than six months, or both.
- (k) As used in this section, the following words and phrases shall have the meanings given to them in this subsection unless the context clearly indicates otherwise:

"Employer" means a person conducting business activity within a political subdivision subject to this section. The term does not include a governmental entity.

a governmental entity.

"Payroll amounts" means amounts paid by an employer as salaries; wages; commissions; bonuses; net earnings; incentive payments, whether based on profits or otherwise; fees; and similar remuneration for services rendered, whether directly or through an agent and whether in cash, in property or the right to receive property.

in cash, in property or the right to receive property.

Amend Bill, page 4, line 10, by striking out "of section 301.1(f)(12)" and inserting:

or addition of sections 301.1(f)(12), 303 heading and 303.1

On the question,

Will the Senate agree to the amendment?

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lackawanna, Senator Blake.

Senator BLAKE. Mr. President, there are a few things I would like to say about this amendment and provide some context for why I am presenting it. First of all, the intent and effect of Senate Bill No. 405 is not intended to be adjusted by the amendment I am presenting. In fact, I support the bill in its current form. My amendment does not change the intent, or at least it is not my intent for it to change the bill, but it does address an issue germane to the subject matter of the bill, namely, the business privilege tax. Basically, what is known to be true is that right now the business privilege tax can only be levied in those circumstances where it is levied and, in fact, by law, it cannot expand to any other taxing jurisdiction. So, the effect of Senate Bill No. 405 or my amendment is only in those circumstances where the tax is actually levied by the local jurisdiction, it cannot expand.

The business privilege tax is an onerous tax because it is based upon gross receipts, Mr. President. A gross receipts tax. Again, I want to emphasize the fact that right now, it is a gross receipts tax, so the companies that are bound to pay this tax are paying it on the total revenue of the company, notwithstanding any concerns they have with other taxing liabilities or expenses in the operation of the business. The intention of my amendment is to simply provide an option for the local taxing authorities that are levying a business privilege tax at present to transfer the manner in which they levy it from a gross receipts tax to an assessment on payroll. It is basically intended to be an option to provide a more fair tax on existing businesses that are bound to pay it. If you are a small business, you have a smaller payroll, thus you would have a smaller tax burden, if in fact the local taxing authority opted to take advantage of what my amendment would enable.

Mr. President, part of the impetus for this was that in Pittsburgh some years ago, they were given this option to move to a payroll assessment versus a business privilege tax and, again, it is more business friendly, in my opinion, to be a payroll tax as opposed to a gross receipts tax. Another issue back home, I asked the taxing authority about the business privilege tax that they collect, and I asked the tax collector in terms of what revenues they are getting, and they quote a number. For the city of Scranton, for example, it is approximately \$2 million, about \$1.8 million.

The next question I posed was, do you know what is paid for by businesses within your jurisdiction versus that which is paid for those outside that jurisdiction? And the answer to that question is "no." It is unclear. In my estimation, if they did a payroll assessment, they could have greater clarity to the burden, distribute the burden more widely, and allow it to be a more business-friendly tax where it is, in fact, levied.

The last thing I want to say, Mr. President, is it is not the intention of my amendment to modify what Senator Browne is trying to correct with respect to double taxation. If, in fact, there is a base of operations subject to the tax, they should only be permitted to be taxed in that one jurisdiction, and if an employer maintains more than one base of operations, the political subdivision shall only be able to tax the payroll generated by that base of operations. I am not intending, in any way in this amendment, to modify what Senator Browne is attempting to do with respect to Senate Bill No. 405.

So again, I am trying to provide an option for those jurisdictions that levy a business privilege tax to move to a payroll tax, which would be more business-friendly and would allow a distribution of the revenue in a manner more friendly to the business community.

The final thing that is important to say about this amendment is that it is intended to be revenue neutral. What I mean by that is if the jurisdiction does opt to go to a payroll assessment versus a gross receipts tax, they cannot collect any more revenue than they were already receiving under the previous circumstances of the business privilege tax.

Thank you, Mr. President. I would appreciate support for this amendment.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lehigh, Senator Browne.

Senator BROWNE. Mr. President, I respectfully ask the Members to vote "no" on this amendment to Senate Bill No. 405.

Although the intent of the sponsor of the amendment is good in what he is trying to accomplish, I believe the bill, in regard to the proper intent and the purpose of Act No. 511 of 1965, is properly served by this bill. This was done because of a series of court cases that, over the last several years, have caused a tremendous amount of confusion in regard to the compliance and payment of the business privilege tax. Right now, there are circumstances where businesses are paying on the same receipts, both in their base of operations and where a transaction is actually consummated in a temporary location, which leads to double taxation on those receipts, which is directly contrary to the intent and the purpose of Act No. 511.

What the sponsor is trying to accomplish here is to insure that there is no loss of receipts or another option for receipts in the jurisdiction where the transactions are taking place through a payroll tax. The challenge with that is that contrary to the way the bill is written, what the bill provides for is if there is a tax in the jurisdiction where the transaction is, the business can credit that tax against those same receipts and the same taxes back in the base of operations. But if a jurisdiction decides to use this option, it will be able to replace those receipts. However, the business itself will still be in a situation where the receipts pertaining to that payroll will be taxed in the jurisdiction where the payroll is, but also be taxed in the base of operations. I believe, from the sponsor's testimony, that is not the intent of what he is trying to accomplish. He is trying to accomplish a revenue neutral scenario. But the way the amendment is provided at this point, I believe it is contrary, in terms of its language, to the intent of what is trying to be accomplished in Senate Bill No. 405 to provide some more certainty and fairness in the business privilege tax under Act No. 511, and therefore, respectfully, I ask the Members to vote "no" on this amendment.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lackawanna, Senator Blake.

Senator BLAKE. Mr. President, again, notwithstanding the description of Senator Browne, and I appreciate—I had been trying to make this option possible without allowing double taxation, and included language in the amendment that I thought avoided that. If it does not meet that intent, I am willing to discuss that with Senator Browne, but it is not the intent of the amendment as I put it up.

Senator PILEGGI. Mr. President, I request a legislative leave for Senator Earll.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lackawanna, Senator Blake.

(a) Severely disabled veteran plate.--On the application of a veteran whose service-connected disability is certified at 100% by the service unit of the armed forces in which the veteran served or by the United States Veterans' Administration or who has a service-connected disability of the type enumerated in section 1338 (relating to person with disability plate and placard), the department shall issue a special registration plate designating the vehicle as belonging to a severely disabled veteran. The registration plate shall have a white background, shall have blue numbers or letters as the department may determine, shall have the words "disabled veteran" in at least ten-point bold type

inscribed in red at the bottom of the plate and shall include the international symbol for access for persons with disabilities. [Only one] \underline{A} special registration plate [shall be] issued to a veteran under this section[. It] may be used only on a passenger car or truck with a registered gross weight of not more than 10,000 pounds. In the case of a motorcycle, the department shall issue a decal containing the international symbol for access for persons with disabilities and the words "disabled veteran" for display on the registration plate.

- (c) Disabled veteran plates.--On the application of any veteran having a disability certified by the service unit of the armed forces in which the veteran served or by the United States Veterans' Administration as service-connected, the department shall issue a special registration plate designating the vehicle as belonging to a disabled veteran. The registration plate shall have a white background, shall have numbers or letters as the department may determine and shall have the words "disabled veteran" in at least ten-point bold type inscribed at the bottom of the plate. [Only one] $\underline{\mathbf{A}}$ special registration plate [shall be] issued to a veteran under this section[. It] may be used only on a passenger car or truck with a registered gross weight of not more than 10,000 pounds.
- (d) Prisoner of war plate.--On the application of an ex-prisoner of war whose imprisonment while in the service of the armed forces of the United States is certified by the appropriate branch of the armed forces, the department shall issue a special registration plate designating the vehicle as belonging to an ex-prisoner of war. The registration plate shall contain the letters "POW" and such other numbers or letters as the department may determine and shall have the words "prisoner of war" in at least ten-point bold type inscribed at the bottom of the plate. [Only one] A special registration plate [shall be] issued to an ex-prisoner of war under this subsection[. The special registration plate] may be used only on a passenger car or truck with a registered gross weight of not more than 10,000 pounds.

Section 2. Title 75 is amended by adding a section to read: Amend Bill, page 1, line 15, by striking out "2" and inserting:
