#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Fayette, Senator Kasunic.

Senator KASUNIC. Mr. President, I rise to speak on Senate Bill No. 1049, which unanimously passed the Senate a few moments ago. Mr. President, we all know that here in the Commonwealth of Pennsylvania, we have some of the most pristine rivers and streams, along with many impoundments. In fact, we have some of the most angler-friendly waters in the entire United States located right here in Pennsylvania. But just like everywhere else in the country, Mr. President, the demand for fishing licenses in the Commonwealth has declined over the last several years.

What Senate Bill No. 1049 will do is provide the Pennsylvania Fish and Boat Commission with flexibility to provide licensing that will allow them to increase their capability to attract and maintain the current anglers we have in the Commonwealth of Pennsylvania and, hopefully, add to those ranks. As I said earlier, just like everywhere else, the number of people who are enjoying the great outdoors, particularly here in the Commonwealth, has declined over the years. We, here in the legislature, along with the Fish and Boat Commission, and obviously, the Game Commission, our parks, and such have been trying to encourage more people to take advantage of the great outdoors and the many attractions that we have here. As I mentioned, we have rivers, streams, and impoundments of which we are so proud.

Mr. President, Senate Bill No. 1049 will allow the Pennsylvania Fish and Boat Commission to have an array of options, including offering multiyear licenses, group license sales, and promotional discounts. Hopefully, by doing this, it will add to the

incentive of getting people involved and bringing them back to Pennsylvania's great outdoors. It is my hope, with the enactment of this bill and some good marketing by the Pennsylvania Fish and Boat Commission, we will be able to do just that and reverse that decline.

So with that, Mr. President, I thank my colleagues here in the Senate for the quick and expedient passage of this bill. Hopefully, it will see quick action in the House. I thank my colleague on the other side of the aisle, Senator Alloway, who helped me with this, and worked very hard and diligently in getting this bill passed. It was a lot of work, a lot of effort, and a lot of teamwork went into this, including help by the Pennsylvania Fish and Boat Commission. I also thank the staff of Senator Alloway and my own staff for the hard work and dedication they put into it, too, and thank my colleagues here in the Senate for the unanimous vote.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, I rise to offer some initial thoughts as we find ourselves once again in the budget season with March, April, and May, leading to the June 30 deadline. I will comment on where or how I believe this administration and the direction in which it has decided, once again, to take the Commonwealth, with which many of my colleagues on this side of the aisle strongly disagree. Unfortunately, Mr. President, for the second straight year, not only do we have a priority problem, but we are beginning to see a consistency where there is a lack of leadership, a lack of leadership in executing where we, as the Commonwealth, need to go to build a better future for the people whom we were sent here to represent.

Senate Democrats alone represent almost 5 million people. Their lives are real, their problems are real. The daily struggles that they have to deal with--and when you look at this budget and at the priorities that this administration has set for itself, you cannot help but see the comparisons to what is going on around the country. We know right now, Mr. President, that there is a debate going on in Washington as to what role government will play in the lives of people across this country. That is nothing really new, but I find it very surprising that beltway Republicans seem to be focusing on everything from social issues all the way down to restricting women's access to healthcare, but what they are not focusing on is the same thing that this administration has failed to pick up and carry the ball over the line on, and that is job development and job creation.

Unfortunately, for the second straight year, we are looking at significant losses in our budget, and we are looking at significant losses in jobs. Half a million people, Mr. President, around the Commonwealth of Pennsylvania are still unemployed. Yet, when I think about and look at what this administration has set as its priorities--now just think about that, almost half a million people, probably more, are out of work, they are not out of work for 6 months, they are out of work for years--and what has this administration made its number one priorities to take on after the oath of office? Well, one of the first things we worked on was changing how the electoral votes in the Commonwealth of Pennsylvania are apportioned, so that his side can win more elections. Then, we went after restricting women's rights and access to healthcare. Then we talked about making English Pennsylvania's official language.

Then, unfortunately, Mr. President, we took the greatest and most unfortunate swipe at the people of Pennsylvania, many will not even realize what just happened moments ago in the meeting of the Committee on Appropriations, where we went to great lengths to set back voting in the Commonwealth of Pennsylvania, to create obstacle after obstacle to people exercising their most fundamental right that has been protected by the people who are mentioned in the halls that we walk through each and every day. House Bill No. 934 is a travesty because it attempts to create a feeling among people that there is this idea of voter fraud, when what we really have in Pennsylvania, Mr. President, is a lack of voter enthusiasm.

What we did today, make no mistake about it, will go down in history as one of the most unfortunate days in the history of this General Assembly. We should be focusing on the issues that affect each and every one of the people whom we represent. Jobs, in 2011 alone, Mr. President, we were a national leader, but today we trail the nation in job creation. And sadly, once again, the Corbett budget plan has called for nearly \$400,000 in budget cuts to early learning and targeted programs for struggling students, but the pain is not limited in K through 12. Just think about that, Mr. President. Who do you go after? What line item do we think is expendable that this administration thinks can be cut and slashed? Education, for the second year in a row. For the second year in a row we see the funding for State-related schools such as Penn State, Pitt, Temple, and Lincoln go down, this year by nearly 30 percent, in addition to last year's 19-percent cut. What do you say to those students and parents who are barely making ends meet, to be able to help their children realize the American dream of going on to college, that they are expendable, that their lines can be cut? That is a question that, to this day, this administration has failed to answer. State schools such as West Chester, Indiana, Slippery Rock, Kutztown, and others are going to suffer an \$82.5 million cut on top of last year's 18-percent cut.

There are many of us here who believe that in difficult times, you know, like my good friend from Philadelphia has said many times over the last few weeks, you do not put your foot on the throats of people who need your help at the time they need it the most. You lend a helping hand. That is what government is supposed to do. It is supposed to help people, not hurt them. It is supposed to work and develop programs that get them back to work, not keep them in a state of poverty and force them to come with their hands wide open just for some help. The cuts that we have seen in the last 2 years are not only unfair, but they are unwise. They do little to help people break the cycle of poverty in which they have found themselves, through no fault of their own. We know that. But to turn their backs on them or to tell them that they have to tighten their belts or live within their means or that big corporations, you know, they do not do what government does.

Quite frankly, Mr. President, as I sat through the last 3 weeks of budget hearings and I heard the same rhetoric over and over and over again by the department heads and Secretaries who appeared before us, it was extremely, extremely troubling, because they did not offer answers, they just offered the same rhetoric. Well, times are tough. We have to cut. We are trying to do a lot with very little. There is no new money. Resources are low. But yet, we find no problem in letting the Marcellus Shale industry off the hook. This industry was ready, willing, and able to pay a reasonable, rational source of revenue, and we just let them

off the hook and decided to keep our foot on the throats of people who need it the most.

So, Mr. President, I will and intend to take the podium a number of times throughout the next several months, most likely to my own detriment, I am sure, but I believe to take the podium is necessary because I have seen the way things work here, and there are not many opportunities to be heard and to call out this administration on what I believe is a major failure of priorities and leadership. There is still time to correct these problems and to lead this Commonwealth and to be the Governor that many, many people across the Commonwealth of Pennsylvania believe he still can be. But this idea that you have to balance a budget on the backs of working families and the poor is simply unconscionable. Again, I will say it for the last time here today, we were not sent here to hurt people, we were sent to help them. We must find ways to do that during the next several months, because if we do not, the mistakes that we make in this budget cycle will come back to haunt us for years to come.

### The PRESIDING OFFICER (Senator John C. Rafferty, Jr.) in the Chair.

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise to echo the very eloquent comments of my colleague, the gentleman from Philadelphia, particularly as it relates to his assessment, and I believe the assessment of a number of my colleagues on this side of the aisle, and quite frankly, a number of folks throughout this Commonwealth, on the issue of priorities. When we talk about what the needs are of Commonwealth residents, how we put people back to work, and how we address many of the social concerns that they have, Mr. President, I think we have missed many opportunities.

More specifically, when we talk about opportunities, for the past 8 months, we have been waiting for leadership, as you well know, Mr. President, on the issue of transportation. That is a conversation that must take place and needs to take place, but yet has failed to be able to do so. As we talk about some of the concerns of this particular budget, Senator Farnese laid out some of the concerns as it relates to education. But, you know, we have not heard a lot about the folks in the Department of Public Welfare, DPW, and the existing and ongoing cuts that will take place there, but more specifically, the recommendation that we do more of a block grant back to our counties.

Mr. President, when a group of those individuals, the disability community, who would be impacted most significantly, wanted to come and make their case to this government, to come into their home and house, and to be able to demonstrate and state their case, what did the administration do? They put into place an order that restricts their access to elevator banks and restricts their access to the second floor. Mr. President, we think that is totally inappropriate. This Capitol belongs to the people of this Commonwealth. They should have the right to come here, speak, and express their frustrations and concerns about the budget allocation process that we are going through and to protect what they believe are very fundamental programs that are essential to their well-being. To be denied that opportunity to make that case directly to the chief official in this Commonwealth is

something that has been unprecedented, and I hope it is a policy that they will rescind as soon as possible. Mr. President, we think that is awful that is the case, and we continue to push my colleague, Senator Tartaglione, a woman who has been confined to a wheelchair, if she was part of that group, would not have the ability to go up and spend time articulating why it is necessary to be able to make changes to the proposed budget as we go forward.

Mr. President, there are a number of other issues along those lines. Senator Farnese talked about how we are restricting and limiting a woman's right to healthcare, a major, major concern that we need to address. Then today, with respect to the voter ID legislation, we had an opportunity to put something in that bill, an amendment that would have dealt with a reform issue that so many folks have talked about in this Commonwealth. Mr. President, the bill that we voted on, House Bill No. 934, has been premised that there is an issue with respect to voter fraud in this Commonwealth. I do not believe, and many, many Members on this side of the Chamber do not believe, that fraud is as rampant as discussed by so many folks. What we are doing is limiting and, more importantly, diminishing a person's right to access the ballot box.

Today, Senate Democrats offered a series of amendments which we believe would enhance the opportunity for people to go down a course where they would present the appropriate level of identification to exercise their right to vote. Again, I must stress, it is a fundamental constitutional right to vote. It is not something that we take lightly. It is something that is extremely important to the people of Pennsylvania, and we need to work and make sure we preserve that as much as possible and, quite frankly, take steps to encourage people to participate in the process. That is something I think we should be addressing.

As a number of my colleagues have indicated in the meeting of the Committee on Appropriations today, this is a solution in search of a problem. Senator Hughes articulated a number of States that had a handful of incidents with millions of votes being cast, again, a solution in search of a problem. But today, aside from the other amendments that were offered which were directly related to House Bill No. 934 on voter ID, we had an opportunity to adopt an amendment along the lines of campaign finance reform. The premise, by the maker of House Bill No. 934, is that the integrity of the election process is what we are talking about. Mr. President, I would submit to you that there is no greater opportunity to address the integrity of campaign finance reform vis-a-vis the electoral process than by having campaign finance reform legislation in place.

This legislation has been around for a number of years, legislation that both Democrats and Republicans support, as evidenced by the number of cosponsors on the legislation we have introduced. But the fact of the matter is, that measure was tabled today. To us, Mr. President, a vote to table a campaign finance reform amendment is a vote to say that you are okay with the way that campaigns are financed in this Commonwealth. We do not agree with that. We need to put limits into place. If there is one thing that people saw when the Marcellus Shale debate took place over the course of the past couple of years, it was the level and the amount of money that made its way to candidates, both at the gubernatorial level and the Senate and House level.

Mr. President, people were offended and began to question the integrity of this Chamber, of the House, and of the administration because of the amount of money that came from the Marcellus Shale industry to those individuals. We have to address that integrity issue. That was an opportunity to do so. We missed it. It was another opportunity where we should have done something constructive to allow the people of Pennsylvania to recognize that their elected officials are not going to be in a position where they are going to accept resources and create the perception that contributions drive the legislative process here.

So, Mr. President, I echo the very eloquent comments of my friend and colleague, Senator Farnese, when he talked about priorities and missed opportunities. We clearly missed one today, and we are proceeding down a path, as it relates to the voter ID legislation, that is going to limit and diminish individuals of this Commonwealth the right to be able to vote. As my colleague, Senator Wozniak, indicated today in the meeting of the Committee on Appropriations, people are going to think it is going to be okay to require photo ID to go and vote until they wake up and realize how limited that opportunity is. Then to say that we are going to give someone a provisional ballot and ask them to come back 6 days later to verify that they are who they say they are does not make sense to me, is something we do not need to be dealing with in this General Assembly, and it does not rank up high on my priority list of what needs to be done. First and foremost should be job creation and making sure we get this budget done on time with the resources that we have and does not decimate education as we go forward.
