#### **SENATE RESOLUTION No. 65, ADOPTED**

Senator PILEGGI, without objection, called up from page 4 of the Calendar, Senate Resolution No. 65, entitled:

A Resolution amending the Rules of the Senate, providing for affiliation with nonprofit entities.

RESOLVED, That the Rules of the Senate of Pennsylvania be amended by adding a rule to read:

#### XXXVIII AFFILIATION WITH NONPROFIT ENTITIES **Requirements and Prohibitions**

1. In order for a Senator or a Senate employee, including a family member of that Senator or Senate employee, to be affiliated with a nonprofit entity, that nonprofit entity must meet all of the following:

(a) Have a formally established board of directors with at least four members that is fully accountable for the nonprofit entity's overall operation.

(b) Have a written set of bylaws or rules, approved by its board of directors, which establishes its composition and governance process.

(c) Require official action of the board of directors to be approved and executed in a manner consistent with its bylaws or rules.

(d) Not receive grant funding directly from the Commonwealth that comprises its sole source of operational funding.

2. A Senator or Senate employee, including a family member of that Senator or Senate employee, who is affiliated with a nonprofit entity, may not do any of the following with regard to a nonprofit entity with which that Senator or Senate employee, including a family member of that Senator or Senate employee, is affiliated:

(a) Exercise sole and unilateral control of a final action of the nonprofit entity regarding allocation or disbursement of grant funding that the nonprofit entity receives directly from the Commonwealth.

(b) Direct a Senate employee to staff or provide services to the nonprofit entity as a condition of employment.

(c) Direct the personnel or other resources of the nonprofit entity for the benefit of a Senator's campaign.

(d) Commingle funds from a Senate district office allowance or any other Senate expense account with the funds of the nonprofit entity with the knowledge and intent that those funds are to be used for the direct reimbursement of expenses incurred by that nonprofit entity.

(e) Maintain a Senate district office within or contiguous to the same office as the nonprofit entity.

3. A Senator or a Senate employee, including a family member of that Senator or Senate employee, shall not be subject to the requirements of this Rule if the affiliated nonprofit entity receives no grant funding directly from the Commonwealth.

4. To assure compliance with this Rule by Senators and Senate employees, appropriate training measures shall be implemented by the Senate. Training shall be provided annually for all Senators and Senate employees.

#### Definitions

1. As used in this Rule, the following words and phrases shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Affiliated." Serving:

- (1) as an officer of a nonprofit entity;
- (2) on the board of directors of a nonprofit entity;

(3) as a paid employee of a nonprofit entity; or

(4) as a contractor of a nonprofit entity.

"Family member." A spouse or child. "Nonprofit entity." An entity that is qualified by the Internal Revenue Service as meeting the requirements of section 501(c) of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 501(c)); and be it further

RESOLVED, That this rule take effect 120 days from adoption.

Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Beaver, Senator Vogel.

Senator VOGEL. Mr. President, Senate Resolution No. 65 will establish a new Senate rule relating to Senators who serve on the boards of nonprofit organizations which receive State funds. This rule prohibits Senators and Senate employees, along with their spouses and children, from serving on the board of directors of any nonprofit organization that receives State funding as a number of strict criteria are met. In doing so, we will insure that nonprofit entities will not be created and operated by Senate Members, in order to draw down State grant dollars for the benefit of themselves, their friends, or their families. This is common sense and the right thing to do.

Senator Pileggi and I worked to draft this legislation in response to a number of incidents which took place over the past several years, specifically two former Members of the General Assembly, one former Senator and one former Representative. Both were charged with and convicted of crimes in connection with nonprofit organizations in which they created and ran. Clearly, this is another strong step forward in the ongoing work to reform our State government.

Senate Resolution No. 65 draws clear, commonsense lines regarding what is permitted and what is not for any Senator or Senate employee serving on a board of directors for a nonprofit organization. Serving on the board of a legitimate nonprofit organization is a true public service and something we should encourage. However, the abuses of a few have demonstrated this rule is necessary. I ask for an affirmative vote.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, I rise to support the resolution of the gentleman from the other side of the aisle. I do think that we have to move this body forward. In the past, we have seen how nonprofits can be abused not for the interests of the people of Pennsylvania, so I support what he is trying to do here. I serve on a number of boards throughout the Commonwealth in addition to my Senate duties, but none of them are solely funded by the State. So, I think that the gentleman's resolution is so clearly and narrowly tailored that it will serve the purpose of creating a better government here in Pennsylvania. For those reasons, I support him.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, very briefly, I want to rise and echo the comments of my friend and colleague, Senator Stack, as it relates to the benefits of this particular resolution. A number of Members in this Chamber and throughout this building participate in a variety of capacities with respect to nonprofits, and the benefit of this particular resolution is so narrowly crafted and tailored that it allows for the continuation of those good-faith efforts of the Members.

Mr. President, needless to say, there is enough concern that has been expressed, both currently and also in the past, that requires us to address this issue, whether it is this side of the building or the other side of the building, one party or the other party. The fact of the matter is, this is something that is benefitting the people of Pennsylvania. I ask for its adoption.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, I wanted to come up to the big desk here, up in front of the Chamber. I, of course, enjoyed being ribbed by all of my colleagues on both sides of the aisle, but the reason I came up to the big desk is because I am doing this resolution with my friend and colleague, Senator Rafferty, and I know that is what he would demand.

This resolution designates March as "Irish American Heritage Month" in Pennsylvania. I have seen a few Irish heritage folks around these Chambers, and as we get closer to St. Patrick's Day, we know we will see more who will wish to be Irish, who will act Irish, and we welcome it. It is a part of the celebration of our heritage together here in Pennsylvania.

Irish immigrants arrived on our shores seeking freedom from persecution in their homeland. They arrived penniless and unwanted, but like many immigrants, they carried the hope that America held a future in which they and their children would enjoy bountiful fruits of a nation founded on the principles of liberty and justice for all. As one of the largest groups to emigrate to America, the Irish and their American descendents have made lasting contributions to Pennsylvania and to this great nation.

The celebration of the Irish is brought together on a special day, St. Patrick's Day, on March 17. The St. Patrick's Day Observance Association will host its annual parade in Philadelphia on March 11, a parade tradition that dates back to 1771, Mr. President. The society's theme this year is "St. Patrick, Bless the American Worker." At a time when American workers are striving to revive our economy and move us toward a more prosperous future, this theme resonates in every community.

So, Mr. President, I ask my colleagues to support this resolution, along with my cosponsor, Senator Rafferty, in commemorating Pennsylvania's many Irish Americans. Once again, I have been fortunate to have such a good friend and colleague as Senator Rafferty. We have cosponsored this resolution a number of years together, and I am delighted that we can do it again this year.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Mr. President, I will stand on the floor among all of my fellow Senators, not at the big desk. My friend and colleague, Senator Stack, and I have this opportunity to work on this resolution each year to commemorate our roots as Americans of Irish ancestry living in the Commonwealth of Pennsylvania. And this day, as we go forward and talk about manufacturing, a resurgence in industry, and the use of our minerals here in the Commonwealth of Pennsylvania, I am mindful of what the Irish did to help build the Commonwealth of Pennsylvania, from mining coal, to farming, to building the railroads, to building many of the urban centers, the schools, and the churches. The Irish came over from Ireland, many of them not yet speaking the English language, but speaking Gaelic, and assimilated themselves into our society. They became Americans, and they were proud of that. They became Pennsylvanians, and they were proud of that. They worked hard to make sure that the Commonwealth of Pennsylvania was a vibrant, economically-driven State. They served their country in the Revolutionary War, the Civil War, the World Wars, and in Korea. We take pride in service, service to our fellow human beings, to try to make life better.

I am proud today to stand with Senator Stack to ask for a unanimous vote on the resolution honoring the month of March, particularly March 17, for the Irish. But I would be remiss, Mr. President, if I did not mention that March also brings with it the beginning of spring training. Mr. President, we are very thankful that the Phillies are looking good at spring training this year. So, along with the St. Patrick's Day resolution, we have to remember that the Phillies are in spring training.

In the Lehigh Valley, the people at the nonprofit Northeast Pennsylvania Lions Eye Bank have championed the cause of eye donation for over 50 years of service and are working with over 60 hospitals across the region.

There is no other substitute for the type of tissue with which they work, and the transplant process is therefore entirely dependent on eye donations. Transplant procedures can restore the sight of men, women, and children, ranging from the ages of just weeks old to over 100 years old. So, Mr. President, I am introducing this resolution today to mark this important effort and to recognize the great work that the Northeast Pennsylvania Lions Eye Bank continues to do for the people of our great Commonwealth. Thank you.

## PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, very briefly, I want to remind folks that Thursday of this week is D-Day, the day that we have to automatically, morally, safety-wise, and legally change our behavior while we are driving our automobiles. Thursday is the day that the formal law that was passed here in the State Senate and moved along in the House and eventually became law banning text messaging while driving goes into effect. I remind the public, and I hope that the media will assist in every effort to promote it through public service announcements, newspaper articles, and whatever is needed over the next few weeks and months ahead to remind people of the law.

I think it is pretty obvious, certainly to the elected officials at the State level, this is something that most drivers, even drivers who have used text messaging and still continue to use cell phones without hands-free devices, I think, overwhelmingly, even that majority clearly wants to see text messaging stopped on the highways. There have been thousands of accidents leading to death and dismemberment on the open road, collisions, even pedestrians on the side of streets have been hit and killed as a result of distracted driving, and a large percentage of that distracted driving came from individuals utilizing text messaging activities, including cell phones.

So I remind folks that it is the law of the land Thursday. It is a primary offense. Police officers and State Troopers have the ability to pull you over, and I believe at this point it is only a \$50 ticket. I am not so naive to think that just because we pass a law that it is automatically going to change behaviors. It is probably not going to do that. It has taken years for individuals to get used to the benefit, the law, and the reality of wearing your seatbelt. Again, this is a law that is in place. It will assist the law enforcement officer with the primary offense, but it really comes down to education and advocacy, so let that education and advocacy begin. The law is in place on Thursday.

For instance, in my office store front on Butler Street, I have thousands and thousands of cars driving down the Main Street corridor, especially with Route 28 construction. I have big banner signs up in my windows about the law taking effect and why it is important that people obey the law. So, any effort that we can make, I would encourage all of our colleagues on our Web sites, if you Twitter, if you communicate via newsletters, whatever information, including the media, public schools, or any forum that is out there over the next days and weeks to come, I would please encourage folks to remind all of our family mem-

bers, our friends, our coworkers, to not engage in text messaging while driving. It is the law. Again, I wanted to be brief and just make that clarion call here today.
