The PRESIDENT. The Chair recognizes the gentlewoman from Venango, Senator White.

Senator M.J. WHITE. Mr. President, I rise to ask for an affirmative vote on this bill and to thank the Leadership on both sides of the aisle for moving it as quickly as they have through the process. This is not a new bill. This bill passed the Senate unanimously last Session, but was not taken up by the House of Representatives. This year, I have sicced the Girl Scouts on the House, and hopefully we can get some movement.

This bill provides that in grades 7 through 12, schools must provide information on a form prepared by the Department of Education to the department for posting on the department's Web site as to the amount of resources it spends on boys' sports and girls' sports. Recent audits in some areas have shown that there is severe disparity in scholastic athletic opportunities for young women in our schools. Some schools are doing a magnificent job, but the gap is huge. Other research has shown that young women who participate in competitive sports in school have much better outcomes across the board. They are more likely to graduate, they have better health, they make close friendships, and, generally, are more successful. Two of the studies that have come out recently show that these benefits last well into their 40s. They have better earning power and generally better health and physical fitness.

This is for all of the young women in this Commonwealth who deserve an opportunity for a college scholarship to participate in NCAA sports. We had the Mighty Macs here from Immaculata University this week. They are wonderful role models for girls on teamwork and friendship. I hope we can, once again, pass this bill unanimously and get prompt action in the House of Representatives.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, I also rise to support Senator White's bill, and I thank her for her leadership on this matter, which the Committee on Education unanimously approved. This is a matter of equity and opportunities, and as you heard in the invocation, this is also a matter of possibilities. We want to make sure that every single resident of this Commonwealth has the greatest possibility to participate in athletics and to excel. I think Senator White has made the case in a very articulate manner. I hope we will unanimously support this as we did in the Committee on Education.

I also rise because, as being one of the hosts of the Mighty Macs this week, I want to say, Senator White is absolutely correct. They are role models, and they paved the way, and now we here in the Senate today are going to continue to pave the way of equity and opportunity in athletics in this Commonwealth.

A Resolution designating the month of March 2012 as "Brain Injury Awareness Month" in Pennsylvania.

On the question,

Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise, along with Senator Dinniman, to offer this resolution recognizing March 2012 as "Brain Injury Awareness Month." This is a major issue, particularly in Pennsylvania. It is the leading cause of disability and death from birth to age 40. Over 130,000 Pennsylvanians are living with a long-term disability resulting from a traumatic brain injury, and more than 50,000 Pennsylvanians are treated and released from emergency rooms for a traumatic brain injury annually. It is estimated that there are 50,000 to 125,000 mild traumatic brain injuries, or concussions, resulting from sports and

recreational activities in Pennsylvania every year. There are leading institutions in the State and nation for brain injuries, including the Penn Center for Brain Injury and Repair at the University of Pennsylvania, the Moss Rehabilitation Research Institute, the Brain Trauma Research Center at the University of Pittsburgh, and the Center for Injury Research and Prevention at The Children's Hospital of Philadelphia.

The best approach in dealing with this issue is awareness, prevention, and treatment of brain injuries. This effort, this resolution, along with Senator Dinniman, and approximately 23 other Members of the Senate who cosponsored this resolution with us, will help to bring this issue to awareness. We have seen all too often, if you have an impact on the sports field or recreational field, it is treated with not a lot of seriousness. These statistics show that it is a serious situation, and we have to be very sensitive of how we deal with these injuries. Awareness is one of the major things that we must do, and adopting this resolution will go a long way in helping that. Thank you very much.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, I rise with Senator Greenleaf, as the two of us are co-chairs of the Brain Injury Caucus in the Senate. We share our concern, and we continue efforts for prevention so that people learn more about what causes brain injury, and not get into those situations. The Senate already took some action this year on the matter of concussions and to immediately get people off of the field and not to come on the field until cleared by a physician.

We also want to note the tremendous research that is going on in institutions in the Commonwealth, and the tremendous treatment programs. In my district, we have Bryn Mawr Rehab Hospital, which is part of the Main Line Health system, and Bryn Mawr is one of the best hospitals in the nation. We also have Moss Rehabilitation Research Institute and other institutions in Philadelphia, Pittsburgh, and throughout the Commonwealth who help those who have brain injuries.

But what people do not realize is the number of brain injuries that occur each year, and the devastating consequences for individuals who have severe brain injury trauma. So I rise with Senator Greenleaf and urge the Senate to adopt this resolution and continue our programs of prevention, research, and the best possible treatment options.

SPECIAL ORDER OR BUSINESS GUESTS OF SENATOR ELISABETH J. BAKER PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, it is with great pleasure that I rise to introduce the Blue Knights of Wyoming Seminary and their field hockey team, who are the reigning 2011 Class AA field hockey champions. The Wyoming Seminary Girls' Field Hockey Team has won the Class AA title three times in the past 4 years, and this win will mark the fifth State title that they have attained since 2001. It is also the school's first repeat champion-ship. The team is here today with their head coach, Karen Klassner, and Alexis Kropp, the director of communications at Wyoming Seminary. It is also fitting that we honor these talented student athletes on a day when the Senate considered Senator Mary Jo White's legislation on gender equity in sports, and the establishment of data on interscholastic athletic opportunities in Pennsylvania schools.

Many of these young women will be continuing their academic and athletic careers at our nation's Division I, Division II, and Ivy League schools on academic and athletic scholarships. Field hockey has helped them achieve their goal of a quality education, and it has taught them leadership skills and how to work with others. They are talented young ladies. Senator PILEGGI. Mr. President, I move that the Senate do now proceed to consideration of all bills reported from committees for the first time at today's Session.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognize the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, I am soon going to be introducing legislation that would legalize small sports betting pools. I call them friendly pools. For somebody who might not understand what I am talking about, if you have ever participated in a Super Bowl pool, or a football pool, or currently--which a lot of people are doing--an NCAA bracket. Currently, if you sell a ticket to a pool like this, or if you organize an event like an NCAA tournament pool, you could be charged with bookmaking under Title 18, Section 5514. It is a first-degree misdemeanor punishable with a sentence of 5 years imprisonment, a minimum of 2 1/2 years, and a maximum fine of \$10,000. That is if you do an NCAA tournament pool, if you organize it or sell a ticket to it, or a football pool.

So what this legislation does is say that these types of pools are legitimate and legal here in Pennsylvania. Mr. President, most Pennsylvanians have either played one of these friendly pools at some point or they know someone who has. These pools are fun, and they are spirited and harmless in the way that it tests one's knowledge and luck at sports. No games are being fixed, no one is losing their life savings, and amateurs who run these pools do not receive any compensation. With reasonable constraints, I believe this legislation should be legalized.

Under this proposal, betting pools would be legal if the entry amount is \$20 or less, there is no more than 100 participants, there is an established social, professional, and familial relationship between the contestants, and all pool proceeds are awarded to the contestant or to a clearly identified charity. The reality is, Mr. President, that many law-abiding citizens participate in betting pools at work, with their families, or with friends, or at local clubs, or social organizations. This own building has many pools being circulated today as I speak. All I am trying to say is, why do we want to penalize law-abiding citizens? Why do we want to make them criminals to actually sell a pool ticket?

We are going through March Madness right now and I, Mr. President, have done my own bracket. I am very proud of it. The only thing is, I am disappointed that Villanova is not on this bracket, because if they were, I would have them going all the way--which I would probably lose, but I would still do that because they are my alma mater. I do have Michigan State being the winner. So, Mr. President, all I am saying is, please help me, legislature, pass this legitimate legislation that says betting pools should be legal in Pennsylvania. It is a commonsense bill.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Mr. President, now for something completely different. This weekend, we will be celebrating St. Patrick's Day, and I want to take this opportunity to wish all Pennsylvanians a happy St. Patrick's Day. All too often, St. Patrick's Day has become a day for celebrating, sometimes to excess, and celebrating not just our Irishness, those of us who are Pennsylvanians and Americans with an Irish ancestry, but just a day for a party.

I would like to take a moment to say that we should remember the man on St. Patrick's Day, Saint Patrick himself, who through hard work and determination, turned a pagan nation Christian. And today when you visit Ireland, Catholic churches and Protestant churches proudly carry the name of Saint Patrick. The man, through his humbleness, intensity, and devotion to his faith, was able to turn an island nation to Christianity, and taught that island to persevere and to be accommodating. When at one time the island nation to the east of us came in, they were not so upright in accommodating other religions. But when you visit Ireland today, and I know there are troubles in the north that, fortunately, have been quelled, the Irish Catholics, the Irish Protestants live in peace.

The Lord Mayor of Dublin, when I was studying international law, was of Jewish ancestry. So Ireland is a very tolerant country, and it takes its basis in the teaching of Saint Patrick, a simple man, teaching the truth and teaching people how to coexist. All of us, no matter what house of worship we attend, believe in the one God and thank Him for His many blessings.

So on this St. Patrick's Day, let us take a moment to do that and to realize the importance of Saint Patrick's teachings, and also, those of us Irish Americans, or Americans of Irish ancestry, as I like to say, the role we play in the Commonwealth, not only in governing here today and building our cities, suburbs, and rural areas, but the history that we have. From the colonel of the Pennsylvania Long Rifles in the Revolutionary War, who was from Ireland, to General Meade of Irish ancestry, the victor at the Battle of Gettysburg, the Irish have played a prominent part in the freedoms that we so enjoy in the Commonwealth of Pennsylvania and this country. To each and every one of the people in Pennsylvania, whether you are Irish or not, blessings on this St. Patrick's Day. Thank you, Mr. President.
