The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lancaster, Senator Smucker.

Senator SMUCKER. Mr. President, I think all of us here know that despite some successful efforts toward encouraging development renewal, many of our urban centers are in serious financial trouble. The answer is not simply changing management, for the problems exist under both Democratic and Republican administrations alike.

Municipal officials today have little leeway for expanding the tax base or for building revenues. They are hemmed in by geography, by job shifts, by antiquated infrastructure, mandates, and tax limits, but the service demands and the imposed costs are not shackled by those similar limits. Most local officials today realize that there is no bill on the way coming to the rescue, with State governments struggling to contain costs and the Feds attempting to rein in mushrooming deficits.

Municipal leaders today receive a lot of free advice about the virtues of thrift, but it is time for us to begin giving them the tools to fix problems themselves. Putting in place a State historic tax credit will let our cities, boroughs, and townships better compete for investment capital. I have had developers tell me that the absence of such a credit delays some projects and completely precludes others. In my area, Lancaster has done well in attracting publicly funded and privately funded partnership projects, and there are many more projects that await rehabilitation. Eligibility in this bill, simply stated, any community with a registered historic district can make application, and the money is not going to high-risk, low-return projects. The projects vying for funding will be scrutinized for economic viability and historic integrity.

The historic tax credit is not a new concept, Mr. President. Bipartisan plans have been floated for more than a decade. This approach is tailored to the times of restricted revenues and is modest in scope to lay the foundation of a program. The concentration of the bill is on commercial properties, which offer the biggest boost. Once the economy rebounds, the tax credit could possibly be extended to residential projects.

When State government is scrambling to find funds for core responsibilities, some argue that nothing should be added to the mix. But the counter to that is that with more communities heading toward distressed status, the price tag on turnaround is going up constantly. So the choice is this: offer something now, or be compelled to pay much more later. Renewing historic structures is a tried and tested way of improving municipal finances and civic outlook. This is only the first step in staving off municipal distress, but is a fiscally responsible and economically constructive beginning.

Thank you, Mr. President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, obviously, I rise to support this legislation and any effort by the Senate and the House, in a bipartisan fashion, to give local communities and local authorities, local community development corporations and private individuals, be it on the residential or commercial side, opportunities to invest and reinvest in historic properties. As the author pointed out, this bill has been bandied about for the last few years and has had various sponsors and cosponsors. I have always obviously attached my name to it as someone who is a board treasurer of the Urban Redevelopment Authority in the city of Pittsburgh. The URA can be credited, along with community-based development corporations throughout the city, as well as a large number of private entrepreneurs and investors.

If you look at the redevelopment of the city of Pittsburgh and our communities in the three-county area that I represent, every opportunity that we have for economic reinvestment into a property, especially a commercial property, to give it new life, especially those properties that are considered historic and make a valuable contribution to the Main Street character of our business corridor, it is very expensive, as we know, to renovate and upgrade commercial properties.

I welcome and relish the opportunity to vote for this bill, but I do point out that many of us, at least on this side of the aisle, are disappointed. Under the previous administration, and our good Governor Rendell sometimes gets a bad rap, but part of the viability of the city of Pittsburgh, which many of my colleagues have visited and walked away saying, wow, there really are great things happening in the city of Pittsburgh, the Urban Redevelopment Authority, so many old buildings, I can name hundreds of them that the URA has been involved in renovating, bringing new economic life, taxation, collection of sales tax, jobs, have come about as a result of investment and opportunities. The Federal New Markets Tax Credits, the Federal historic tax credit, and now this program, which I wish was more than \$10 million, and I wish it was a program that could be jump-started later on this year. I believe the program will be put in place, but the program actually will not be initiated until a year from now.

It is nice for us to get up and talk about this one program, it is only \$10 million of tax credits, and it is foregoing revenue at the State level. But I do want to point out that the previous administration, to its credit, made a lot of these types of economic investments, either through the tax credit program, like the R&D Tax Credit, the Film Production Tax Credit. This is not that much of a tax credit, \$10 million, but it is certainly a step in the right direction, so I applaud the bipartisan effort that, hopefully, this bill will be given in final approval.

But, let us be clear. Let us not be two-sided about this discussion. I am pleased to see the Republican Majority voting in favor of this small tax credit. I ask that you consider in the annual budget review and our prioritization of what the expenditures will be that we continue to make prudent economic investments in big cities and small towns throughout the Commonwealth, not only with various tax credit programs, but not giving up on important programs that are funded in the Department of Community and Economic Development.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Mr. President, I was not going to rise, I was going to support this, but I do have a question because my good friend from Allegheny County brought up the wonderful things that happened in Allegheny County and Pittsburgh. I want to know if the sponsor of the bill could answer one short question. I probably already know the answer, but the question is-

The PRESIDENT pro tempore. Would the gentleman please yield.

The Senator is requesting the gentleman from Lancaster to stand for interrogation. Would the gentleman agree?

Senator Smucker so agrees. The gentleman may proceed.

Senator WOZNIAK. Mr. President, I know a lot of the programs we create in Pennsylvania are for the benefit of all of the four corners of Pennsylvania, but some communities have a little more ability, financial backing, and opportunities than other places. In the language in this bill, is there any designation that some of this money is to be spent outside of Allegheny County and outside of Philadelphia County so that the rest of Pennsylvania might enjoy some of this \$10 million?

Senator SMUCKER. Mr. President, there would be an annual application process for any projects that would be eligible within the definition of the bill. The definition would be for historically designated projects, which is a Federal designation, so it essentially would be any borough or city that has a Federal historic district. A project within that district would be eligible.

Senator WOZNIAK. Mr. President, so the answer is it is a competitive bid out there, and the determination would be made project by project, not necessarily community by community. My concern is that \$10 million does not sound like a whole lot, and with two projects in a large city, the \$10 million is gone, and I might have a small project in Lock Haven, and kaput. But I am going to be supporting this anyway because I know how expensive renovations are, particularly if you have to keep things to the historical concept of both the State and Federal government--I have had some issues and successes with that, but I support the language. Thank you.

The PRESIDENT pro tempore. The Chair would be interested in Lock Haven also. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Mr. President, I am up twice today, but this is my resolution. There is an old song by Jim Croce, "You don't tug on Superman's cape. You don't spit into the wind." And let us add this, you do not take on the EPA. But I think it is time we stare them down a little bit.

This is a joint resolution that has to pass the Senate and the House, and it is going to memorialize Congress to at least ask them, cajole them, and resolve that they might take a look at the requirement that the States have to hook up to an auto emissions test. Statistics and empirical evidence show that we have almost

a 96-percent compliance rate. Some studies have that at 98 percent. The Federal government and the automobile industry have done their job. The cars of today are far cleaner than they were in the late 1980s and before the Clean Air Act of 1990. Every one of us who are in a noncompliance county have to take our automobiles every year to show that they are worthy to be on the roads of Pennsylvania. If you are in a county that is in compliance, it does not matter what kind of automobile, all you have to do is do a simple smell and gas test to see if the vehicle is okay.

It is interesting, and I just say this anecdotally, because I do not really know, but some people have told me that Penelec took their motor pool out of an area that had to be checked every year and claimed a county that did not have an inspection area as the home base for their vehicles so they did not have to make the expenses of the auto emissions.

It is a redundant system now. Our automobiles tell us when they are making mistakes. For once, maybe once in the history of the United States of America, we can look at the EPA and remove a regulation. A time has come, it is over, it is not needed anymore, and even those conservationists and the environmentalists are not in disagreement with me.

So, I want to make this language as strong as possible. I hope we have unanimous support here in the Senate and the House, and maybe let us begin that process that at least puts some common sense back into the Environmental Protection Agency. They are there to protect the environment, but they are not there to keep a thumb on the good citizens of this nation.

Senator FARNESE. Mr. President, I am pleased to offer this resolution designating April 2012 as "Pennsylvania Donate Life Month," to bring attention to the need for organ donations and the great work done by our State's 18 transplant centers. It is estimated in the United States that 113,000 people are in need of lifesaving organ transplants, a number that each year seems to grow. In Pennsylvania alone, approximately 8,000 people are awaiting such a transplant. For every person who donates organs or tissue, a potential 50 lives can be enhanced or saved, and up to 8 people can be taken off the waiting list for organ transplants.

The important work done by our medical personnel and donation centers in Pennsylvania has made the Commonwealth a leader in the field of donation and transplantation, for which recognition is deserved. However, it is important to highlight that despite progress being made in better educating our citizens about donation through Pennsylvania's Organ and Tissue Donor Awareness Program, demand continues to outweigh donations. I hope that by offering this resolution today we can encourage everyone in Pennsylvania to become an organ donor.

National Library Week has been observed each year since 1958 and celebrates the contributions that libraries, librarians, as well as library workers have made across the country. This year's theme of "You Belong @ Your Library" emphasizes that there is something for everyone at the library. In these difficult economic times, the library is a place of resources for job seekers, free activities for children, access to computers, or discovering a new favorite book.

In addition, Mr. President, the Pennsylvania Forward Program for libraries was conceived to give a voice to what the library community already knows, which is that with the right support, libraries are ideally positioned to be community centers for information, technology, and learning that will fuel education and economic opportunity. Pennsylvania is home to approximately 3,000 libraries based in schools, colleges, and universities, and another 460 public libraries that receive State funding. Pennsylvania libraries serve over 7 million residents each year through regular library services, and over 30 bookmobiles that allow outreach to those who would not ordinarily be able to visit the library.

With many Carnegie Libraries in my district, I see how beneficial this library system is to my constituents. I am also honored to inform you that the Carnegie Library saw the fifth-largest increase in usage in a study of 15 metropolitan libraries across the country.

Mr. President, National Library Week highlights the capacity of our nation's public, academic, school, and specialized libraries to help us transform our lives and communities. Thank you for your support on this resolution.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, I rise along with my friends and colleagues, Senator Dinniman, Senator Schwank, and Senator Leach, to seek unanimous adoption for this resolution which honors April 15 through April 22, 2012, as "Days of Remembrance of the Victims of the Holocaust" in Pennsylvania. From 1933 to 1945, 6 million Jews across Europe were systematically slaughtered under Hitler's Nazi regime. Millions of other people were also tortured and killed, including gypsies, disabled people, prisoners of war, Christians, and other people who resisted Hitler's agenda. The Holocaust remains one of the world's darkest periods in modern history, yet it is a part of our history that must never be forgotten because it must never be repeated. We can take steps today to combat bigotry and hatred. We can make every effort to treat each other with mutual respect. Pennsylvania can also stand up to nations that preach hatred and support terrorism

In 2002, Mr. President, we enacted a divestment law that requires Pennsylvania's public pension plans to divest from companies that have major business activities in the rogue nations of Sudan and Iran. A few months ago, Mr. President, the office of the State Treasurer released the first comprehensive report on the outcomes of this divestment law. I am pleased to say that 10 companies have already ceased operations in Sudan and/or Iran, and thus are no longer prohibited investments by the Commonwealth of Pennsylvania. Further, six companies have declared they plan to divest or are in the process of doing it and ceasing their involvement with these regimes in order to avoid divestment.

Additionally, in the future, Mr. President, I plan to introduce legislation that would prohibit the Department of General Services from entering into a contract with an individual, organization, financial institution, company, or government entity that provides goods and services, or a line of credit worth at least \$20 million, to any energy sector in Iran. This legislation is one more way to let Iran know that we will not do business with a nation whose leader has threatened to wipe Israel off the map.

We must remember the Holocaust by standing up immediately, Mr. President, to those who espouse hatred. We must know we are all under the threat whenever one person, or one nation, or one people is threatened. By honoring the Days of Remembrance of the Victims of the Holocaust, we here in Pennsylvania can insure that men, women, and children who suffered and died will not be forgotten. In fact, they will never be forgotten, Mr. President. We can pledge to condemn all forms of anti-Semitism, ethnic intimidation, and hatred.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, I thank Senator Stack for his resolution. Indeed, it is important that we remember these Days of Remembrance of the Victims of the Holocaust. But in this remembrance, we must be committed to making sure that there is no future holocaust. Since the 1930s and 1940s, we have seen a holocaust in a number of places, where people of one

ethnic group or religious group kill mass numbers of people in other groups.

Human beings are capable of doing horrible things, and human beings are capable of doing the most wonderful, compassionate things as well. It is through history, it is through remembrance that we renew the human spirit, we renew the capability that we do what is right. Here in this Chamber we have a series of stained glass windows, and one of those windows above me says "history." History is not just to tell us what occurred in the past, history is also to inform us, to help us make sure that the mistakes of the past do not happen again.

So I rise in support of this resolution so that we may not only remember with respect, dignity, and love those people who perished, but we also will recommit ourselves with every fiber of our bodies to make sure that never again will a holocaust occur to any group of people in the world. It is an important time for us to remember that we are all united together. In the words of Martin Luther King, "We are caught in an inescapable network of mutuality, tied in a single garment of destiny."

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, it has been about 16 months or so since West Penn Allegheny Health System was clearly in financial trouble, and there was a pronouncement and an announcement by the Highmark organization out west that they would indeed intervene and acquire the facility, the assets, and many of the professional physicians and groups that are part of the West Penn Allegheny Health System. That system is not only vital to the healthcare delivery complement throughout the three-county area that I represent, and certainly the city of Pittsburgh, but a system not unlike UPMC that has thousands of employees, well-paying jobs, and has really been part of the vibrancy of the city of Pittsburgh and our region.

We talk about how the region has successfully transformed itself with the demise of primarily steel, and how we are touted as kind of an "eds and meds" community that continues to have important manufacturing and other sectors, but clearly the powerhouse institutions, the healthcare facilities, and certainly the educational colleges and universities that we have throughout Allegheny County are really quite remarkable, contributing significantly to the vibrancy of our city.

Obviously, everyone has concerns about what is going on now, I do not want to recount the trials and tribulations of this past week involving the now former CEO of Highmark. I am really not that interested, quite honestly, in the lifestyles of the rich and famous. I am more concerned about the downtrodden, those who are in need of healthcare, and the healthcare professionals who work in this system. What is important right now is a continued, focused effort--despite the soap opera that is going on, I am sure there will be a lot of intriguing details yet to come out. I would hope that in the main editorial boards, the letters to the editor, and the public's concern can rather not be preoccupied with the one situation that is going on, which will certainly be a soap opera that will be unraveled in the media. I hope that we will return to the focus of how critical it is that we continue to survive and maintain these important healthcare facilities, their jobs, and all the services that they provide. I am talking about the continued support that I have certainly, and many in my constituencies support, the formal acquisition by Highmark of the West Penn Allegheny Health System.

I want to briefly call to the attention of many that it is important that individuals who are interested in supporting the acquisition, that they either appear at the formal hearing coming up by the Pennsylvania Insurance Department, or at least go to the excellent Web site that the Insurance Department operates, and sign up, or at least submit your testimony, even if it is just indicating that you support the acquisition. The formal public hearing will be on Tuesday, April 17. It will be at the Westin Convention Center Hotel on 1000 Penn Avenue near the convention center. There is a registration form on the Pennsylvania Department of Insurance's Web site. Folks can sign up and indicate their interest in either submitting testimony or speaking. I encourage everybody to get involved in this process. I hope people get involved because they want to support the acquisition. It is very critical that we get a broad-based indication from the public.

There will be a review not only by the Pennsylvania Insurance Department, but this is a matter that will have to be reviewed by the Orphans' Court in Allegheny County, as well as the IRS has to review certain aspects of this acquisition, and it could conceivably go to the Department of Justice for their type of review possibly, I am not sure. The Attorney General of Pennsylvania

may want to possibly intervene or comment on the Act 94 provisions. Again, there are just a lot of reviews that have to go on, but time is of the essence.

It is the hope and prayer of many in the community that I represent that the proceedings will continue posthaste and that there will be, hopefully, a positive recommendation and action by these various authorities, especially the Department of Insurance, to indeed approve the acquisition to maintain the jobs, the community livelihood, and certainly the healthcare delivery system. That portion which several of the hospitals, clinics, facilities, doctors, nurses and para-professionals represent that are part of the West Penn Allegheny Health system include West Penn Hospital in Bloomfield, Allegheny General Hospital in the North Side, and certainly the Alle-Kiski Valley Hospital as well.

So again, please get interested in this subject, sign up, and be supportive of the public hearing. It is an open public hearing and will begin in the morning at the convention center. There will also be a 7 p.m. public hearing. I will be speaking right at 7 p.m., submitting testimony. We are encouraging folks to come out for the proceedings at the beginning of the morning. Certainly, for those who have to work during the day or do not have time during the day, please come out en masse, large numbers. We need people to fill the room at this hotel in support of the acquisition. If they need information, they can call my office on Butler Street, 412-621-3006. Get involved, speak up now, and let us continue to fight for the necessary healthcare that we need.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, we had a spirited debate here last week on the Senate floor about the Federal healthcare reform. We had to talk a lot, we had a nice, healthy discussion about healthcare, but we also had a nice, healthy discussion about language, about how we refer to terms and policies. Some people call the Federal healthcare act by its official name, the Patient Protection and Affordable Care Act, and some people call it, I do, by its nickname, Obamacare, and some people have other names that we will not even get into. But whatever you want to call it, it is a monumental healthcare reform law that could make a fundamental difference for millions of lives.

While we are talking about nicknames, Mr. President, I have one for the administration's policy on healthcare and welfare. The Governor does not like Obamacare, but the more I think about it, I think we should call his program "Corbett Don't Care," or to be grammatically correct--I would get in trouble if I were not--"Corbett Doesn't Care." We will call it the "Corbett Doesn't Care" plan, and under that plan, the Governor's ideological and public policy plan is to destroy education funding, higher education funding, and human services for the disabled and the elderly, and pass the costs on to the local governments through increased property taxes.

Now, let us compare. We have on the one side Obamacare, and the other side we have "Corbett Doesn't Care." Obamacare would help uninsured Americans get insurance by setting up large insurance pools and giving consumers an online one-stop shop called the insurance exchange. It would also create an opportunity for insurance companies here in Pennsylvania to sell much more insurance and probably create more jobs. But Obamacare also bans insurance companies from using preexisting illnesses to determine insurance premiums or deny people health insurance.

So let us break that down again. People watching at home, people who maybe work here, people who are passing by, you and your children will not be denied coverage just because you have a preexisting condition. What is a preexisting condition? Well, it is another way of saying you are likely to get sick. So under the Obamacare plan, you cannot be denied insurance for probably having to need it. Obamacare does not require everyone to purchase insurance, so healthy people are going to be pooled with sick people and the premiums are spread out over a large group of people. The likely result would be cheaper insurance for everybody, and a tax credit would be provided to people to help them buy insurance.

According to the Pennsylvania Department of Insurance statistics, 90 percent of uninsured Pennsylvanians would absolutely be eligible for a tax credit to buy health insurance under Obamacare. So Obamacare tries to help people buy health insurance, tries to help people get healthy, tries to hold down costs. Is it perfect? Absolutely not. There is a lot more that could be done, there may be a lot less that could be done. But the bottom line is, I think it needs to do a better job of holding down cost controls and it needs to make sure that the ability of States to make the decisions that they think are best are retained. It does some of those things.

The "Corbett Doesn't Care" plan does not try to help people. The "Corbett Doesn't Care" plan eliminated the adultBasic health insurance for working Pennsylvanians. The "Corbett Doesn't Care" plan led to 89,000 kids getting kicked out of the Medical Assistance program. The "Corbett Doesn't Care Plan" led to 14,000 school employees being laid off during the worst recession since the Great Depression--and that was begun under, and it is a subject for another day, not Obamacare, not "Corbett Doesn't Care," but that was "Hoover Care." "Corbett Doesn't Care" has led to huge across-the-board tuition hikes across the State. "Corbett Doesn't Care" cut funding to disability programs at a time when autism and other disabilities need the most help.

So, Mr. President, folks can rail against Obamacare all they want. Obamacare, or the Affordable Care Act, or the Federal act, whatever you want to call it, folks can try to create loopholes to block the healthcare law. They can claim they are just protecting American rights. Heck, they can throw around the word "mandate" all they want. We did it a lot last week. I am sure people will continue to do it. I know some people call it a bad word, but it seems to me that the Governor and some Members of the legislature want to do some mandating of their own. They do not want mandates for health insurance, but they want to mandate the credentials you need to exercise your fundamental right to vote.

It is convenient that the Governor and some of my colleagues on the other side of the aisle want to selectively place mandates on the citizens of the Commonwealth. If you look at the numbers, Mr. President, the "Corbett Doesn't Care Plan" will take a

much worse toll on Pennsylvanians than Obamacare. The Federal government does a lot of things I do not like, and I certainly do not agree with many of the findings of the Supreme Court, but what they taught me back in law school was that the Supreme Court is the law of the land, and they are arguing Obamacare right now. In any event, we need to stop with the partisan nonsense going on here. We need to get to work to try to find new ways to bring revenue into our State to improve our schools, to fund our addiction recovery programs, to fund our transportation crisis, and move this Commonwealth forward.

Whatever your thoughts are on Obamacare or "Corbett Doesn't Care," but at the end of the day, I think, Mr. President, as far as the people of this State who are hurting right now with this legislature's program, it should care, and that should be our plan, that this legislature does care.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, I have to give a round of applause to my good friend and colleague, Senator Stack, because I think he came up with a good one there with the "Corbett Doesn't Care" healthcare program. He has been known to come up with some good ones, and that may be one of his best ones.

We are clearly operating in an environment where the healthcare of the people of the Commonwealth of Pennsylvania is becoming a conversation that has been pushed to the bottom, not raised to the top. We need to be in a situation where, Mr. President, we put the people of Pennsylvania first, not put them last, and one of the ways that we put the people of Pennsylvania first is by dealing with the issue of the uninsured and how many people in this Commonwealth have no health insurance and how, in fact, this administration is not doing anything to lift a finger to help them get the insurance that they so desperately need.

The number-one reason why folks are filing for bankruptcies, Mr. President, is because of unpaid healthcare bills. Those bills come about as a simple result of the fact that millions of people across this nation and in the State of Pennsylvania have no health insurance, and there has been no help, no support, no lifting of any finger to try to help the people of Pennsylvania in that respect by this administration.

I raise that in the context, Mr. President, of where we are right now as a result of our budget situation. Mr. President, I have a lot of fine staff people who help me, help our Caucus, and work with our constituents to try to figure out this budget situation and the deficit that was projected. They come up with a lot of technical terms, but we need to figure out how to make it as plain as possible so we can get through this understanding so that we can shape the right policies for the people of Pennsylvania, because we want to put the people first. We do not want to put them last, which is what this administration is trending to do and has done.

So what we know is this, Mr. President, that in February of this year, the Governor projected that we would have a budget shortfall, a budget deficit of \$719 million. Now, that is what he projected, Mr. President, that we would be short \$719 million by June 30 of this year. So, because we had that hole of \$719 million, we had to do a lot of additional cutting in the State budget to fill that hole. That is his budget proposal. That is what he is standing on. His Budget Secretary, as late as this weekend, said that is the deal, that is the reality, that we are short \$719 million,

that we are going to be short \$719 million by June 30, and that we have to cut our way to fill that hole.

Well, Mr. President, I have to say that the numbers are in, and my staff people have spent an inordinate amount of time helping me to understand exactly how these numbers work and how the calculations come together. But the truth of the matter is this: the amount of money that has come into the State coffers so far is beginning to fill that hole and is beginning to fill that hole dramatically. More dollars are coming into the State coffers, the economy has picked up nationally, the State has picked up on that national return, and more dollars are coming to the State. So, in fact, Mr. President, the State's budget deficit will be nowhere close to \$719 million, because new resources are coming in. The State's economy is picking up. New resources are coming in. So, that \$719 million hole is starting to fill up. We are filling up that hole with new State resources, which means we do not have to make the cuts that the Governor is projecting for us to make. That is bottom-line, that is clear.

Now, I am not making this stuff up. This is not voodoo economics that we are talking about here. This is not made-up stuff that we are calculating here with some mad mathematician sitting in the background calculating these numbers. This is real stuff.

First of all, Mr. President, the Independent Fiscal Office, an office that was created by this General Assembly, by the House and the Senate and signed off by the Governor, started operating several months ago, they projected about 2 weeks ago that the budget deficit would not be anywhere close to \$719 million, probably closer to \$500 million. Well, that is a \$219 million difference. By rough calculations, that is about a 28- to 30-percent difference. They say the hole will be about \$500 million. The Governor said the hole will be about \$719 million. So, there is a huge difference right there.

But then, we have all of the numbers in for all of the months leading, including the month of March, and if you can see this chart, Mr. President, you will see all of the lines, it is July through March included right there. So, again, these are not made-up numbers, these are numbers consistent with the Governor's Office, the Secretary of Revenue, the Budget Office, all of the four Caucuses have these exact same numbers. In fact, one of the reporters, I believe, already reported on this, I believe it was Capitolwire or something along that line. It is already public information. They have already written about this. I believe that, more than likely, Mr. President, where we are right now is closer not to a \$719 million deficit, not to a \$500 million deficit, but somewhere closer to a \$350 million to \$400 million deficit. That is the kind of revenue that is coming into the State coffers. We believe that number is going to do even better over the next 3 months, in April, May, and June. So, what started out as a huge hole of \$719 million is starting to fill up, and it is filling up dramatically.

So, we need to pay close attention to this, we need to pay attention to these charts, and we need to look at the work of the Independent Fiscal Office and examine that correctly because we are making budget decisions over the next 3 months that are based on these numbers, the numbers that we have right here. The voodoo economics of this administration are not adding up. The mathematics are not adding up, Mr. President. More closely, we are in a situation where we are coming to, where we will have extra dollars that we can reinvest in Pennsylvania's people. We can put Pennsylvania's people first. We can talk about funding

education, we can talk about funding higher education, we can talk about reducing the cuts to human services, we can talk, most importantly, about doing things that put Pennsylvania's people back to work and not have to do it by creating any taxes. No new tax increase needs to be had.

We will be talking about this more in the coming days, Mr. President, but I think it is important to note, and I think it is important to make part of the Official Record that the rate of economic growth in Pennsylvania's economy is such that the \$719 million projected budget deficit is a myth. It will not be. It will not occur. I can say this just as sure as I said with last year's budget crisis, when the Governor predicted a \$79 million budget surplus, and the surplus wound up being almost \$800 million. That is what happened last year, and the same is going to occur this year.

So, the math that we are dealing with is not working out. What is happening is that the deficit hole is starting to be filled up by economic activity, largely generated by the Federal government. The turnaround in the Federal economy is having an impact here in the State. So, that is a good thing. We are going in the right direction economically. That is a good thing, and it is making itself evident in the State coffers, as more dollars aer coming in.

So, Mr. President, over the next couple of days, we will talk about this in more depth and more detail. In the next several months, we will be having budget negotiations and budget conversations, and hopefully, the Democrats will have the opportunity to be at the table in full discussion and full negotiation. We have commitments from the Governor's Office directly that he will not exclude the Democrats in this process. The Senate Democratic Caucus and the House Democratic Caucus will be at the table. We expect that to play itself out all the way to the end. We expect to provide significant ideas and options that put Pennsylvania's people first, does not destroy the State budget, does not raise any taxes, and, as I said, puts people, Pennsylvania's people first, utilizes the tax dollars that are already in existence to make significant investments in things that are important to put Pennsylvania's people first, put Pennsylvania's people back to work, which is job number one, putting Pennsylvania's people back to
