Nine percent of children who will have a stroke will die. More than half of the children who suffer a stroke will develop lifelong cognitive or motor disabilities. Very little is known about childhood strokes, treatment and prevention, and only through medical research and education will effective treatments and prevention techniques be developed.

A constituent of mine, who is a stroke survivor and is an inspiration to me and to everyone he meets, Taylor Heath, from Mohrsville, beat the odds to survive a childhood stroke. Taylor, due to his mom's love and phenomenal care, is an active 13-year-old who loves playing basketball and video games. He is currently in the sixth grade in a cyber-charter school. He is a straight-A student who loves pushing himself to excel. When he grows up, he wants to be a doctor so that no other kids have strokes.

While the stroke damaged 97 percent of the left side of his brain, he remains positive, outgoing, and welcomes the opportunity to educate others about his stroke. His mother, Emilie, is amazed daily at how much he accomplishes for a child whom she was told to consider institutionalizing due to the extent of damage. She is thrilled at what an amazing young man he is becoming. I ask the Senate to designate May 5, 2012, as "Childhood Stroke Awareness Day" in Pennsylvania.
