SENATE CONCURS IN HOUSE AMENDMENTS

**SB 1433 (Pr. No. 2257)** -- The Senate proceeded to consideration of the bill, entitled:

An Act providing for the Homeowner Assistance Settlement Act; establishing a fund for the purpose of funding the Homeowner's Emergency Mortgage Assistance Program; and providing for the effect of noncompliance with the notice requirements of the homeowner's emergency mortgage assistance program and for allocations from the fund.

On the question,

Will the Senate concur in the amendments made by the House to Senate Bill No. 1433?

Senator PILEGGI. Mr. President, I move that the Senate do concur in the amendments made by the House to Senate Bill No. 1433.

On the question,

Will the Senate agree to the motion?

The PRESIDENT. The Chair recognizes the gentleman from Columbia, Senator Gordner.

Senator GORDNER. Mr. President, I want to take a few minutes to speak about this legislation and the importance of it to Pennsylvania homeowners, especially those who are having some difficulties with their mortgage and need some assistance. The HEMAP program was started in 1983, and over the almost 30-year history, over 46,000 homes have been saved from foreclosure as a result of the HEMAP program. Over the years, we have appropriated about \$245 million to HEMAP, but it is a loan program. As a result of repayments on interest and principal, another \$275 million has come back into it, which has resulted in over \$500 million worth of loans to homeowners who are in trouble.

One of the things that I always point out, which I think is incredible, is that there is an 85-percent success rate in regard to this program, an 85-percent success rate to make sure that the American dream holds true in regard to homeownership. As most of us know here in the General Assembly, as a result of budget issues, the program stopped taking new applications in September of 2011. So since that time, there has been no new applicants to the HEMAP program.

Mr. President, we have a solution to the problem though. As a result of action taken by 49 States and their Attorneys General in regard to unfair lending practices by our five largest lending institutions across the country, a settlement was reached to help provide moneys to those affected, as well as those States that are affected. I want to thank our Attorney General, Linda Kelly, for helping to guide this to a conclusion during her term in office. As a result of this settlement, there will be about \$64 million to \$65 million that will be available to go into some funding. And what Senate Bill No. 1433 proposes is to put this money into a trust fund, which will allow dollars to be able to go for important purposes over the next 5 years. Ninety percent of the moneys will go to PHFA for the HEMAP program, 5 percent to the Attorney General for housing consumer protection programs, and 5 percent to legal assistance relating to housing issues.

I will mention how important and what a great job PHFA has done over the years, especially Brian Hudson, who is an outstanding executive director. This is important legislation, this is legislation that impacts people, that helps people. The PHFA does a great job identifying those folks who will be able to be successful in using this program to remain in their homes. I want to congratulate several staff people who were very instrumental in regard to this bill getting to the final spot here: Josh Funk, who is with my office and now is with the Majority Leader's office; Todd Roup, my chief of staff; Kathy Eakin, who does an exceptional job in the Majority Leader's office; and I want to mention the Majority Leader himself. Senator Pileggi, from the beginning of this issue coming before me and introducing the legislation, gave a green light and said we need to get this done before we leave in June. I am pleased that on June 13, not June 30, we are actually going to be able to send this to the Governor.

I also thank my colleagues on the Democratic side, Senator Costa. There have been a number of other folks, Senator Fontana is another one who I know that this issue has been very important. But this is a bipartisan issue, it passed the House unanimously, I am expecting a unanimous vote here in the Senate as well. This is the sort of issue that is important that we do get together as Democrats and Republicans, House and Senate, in order to get something done.

Finally, I will say, again, that over the life of HEMAP, 46,000 homes have been saved from foreclosure. As a result of our action today, for at least the next 5 years, there will be hundreds, if not thousands, of people who will again be given a lifeline as a result of our State's HEMAP program. I urge support for Senate Bill No. 1433.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, I have had the honor and privilege of serving a three-county area of many small-town communities, and certainly the heart of the city of Pittsburgh and the lowest-income communities in the great city of Pittsburgh. Unfortunately, these communities, first and foremost, have been

decimated over the years, especially the mid-1980s on, with the loss of important jobs, the middle-class, well-paying jobs, and that is true, unfortunately, in communities throughout the Commonwealth. The HEMAP program, the Homeowner's Emergency Mortgage Assistance Program, has been a vital mainstay in providing an opportunity for homeowners to rework their mortgages and try to retain what should be, and what has been, their most important asset of their lifetime, and that is their own home.

Unfortunately, and I appreciate all the commentary here and the description of refunding this program, but a year ago this program was de-funded by the Corbett administration. I always find it interesting, folks get up and they appropriate money. We had a situation yesterday where, rightfully, we are providing an opportunity to continue funding of the \$25 million annually to support our volunteer fire units, hoping to even raise it a little bit more. And folks are voting for the money, which is great, we all support that, but they do not want to support the casino industry or did not want to technically take a vote for gaming.

So again, before we move on with some of my closing comments, I just want to point out that this program should have never been de-funded a year ago by the Governor in his Budget Address. Many of us on this side of the aisle voted "no" because this was a very vital program to the livelihood and the ability of many of our homeowners to sustain their life's asset. Certainly, as my colleague just spoke, Mr. President, Senate Bill No. 1433 should be supported and passed today. It is obviously a step forward. The refunding of the HEMAP program, which, as I pointed out, should never have been discontinued in the first place, is obviously a positive involvement and an appropriate use of the windfall we received.

While I will be voting in the affirmative for this legislation, I do want to put on the record, at least, concerns that community groups such as Community Legal Services and the Housing Alliance have with language added to the bill to address the so-called Vukman decision, a case in Superior Court. The bill will, rightly and retroactively, correct a court decision to resolve a very, very big problem with Act 91 foreclosure notices provided to homeowners who are late on their mortgage payments. However, this bill not only retroactively fixes the problems with those notices from years 1999 to 2008, but changes the notice procedures prospectively. It remains to be seen to what degree banks will change their Act 91 notice procedures due to these changes. Some believe that a worst-case scenario may be that if a bank fails to send a notice, that it would be able to defend the action in court. This notice is an essential protection to homeowners, and this should not be permitted to happen. I believe it is incumbent on this Chamber to remain vigilant in the protection of homeowners in the foreclosure process.

Today, if a homeowner shows a mortgage lender did not properly serve the Act 91 notice, it can use that as a protection in the foreclosure process. We may be turning that on its head today, or worse, completely eliminating that protection. I truly hope this does not become the case, but I wanted to put on the record that this concern is held by many in the homeowner protection advocacy community across our Commonwealth. All this being said, the Pennsylvania Housing and Finance Agency has made a recommendation to support this new language and believes that concerns I have mentioned here are misguided. I will put my faith in the PHFA organization, and, in particular, Brian Hudson as the executive director.

I will be voting for this legislation. But like other bills that come before us, there is another bill upcoming on regulations for the small business community which I will be seeking to amend to have a 3-year sunset. I think it is very important that we move forward progressively to begin applications anew come the month of July, for our homeowners who are upside down in their mortgages. Again, I caution that we need to always monitor and see how the program will take effect, how it will be implemented, and how the banks will react pending this final passage here today.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Washington.

Senator WASHINGTON. Mr. President, I, too, am happy to see that the funds that have been released by the government will be used as soon as possible for HEMAP applicants. In Pennsylvania, particularly in the Fourth Senatorial District and the Philadelphia area, we have the highest number of foreclosures in the State of Pennsylvania. The good part about it is that people who are in the process of having their houses foreclosed on will now see a light at the end of the tunnel. When we talk about families and keeping families together under one household, this is extremely important.

Immediately after we got the announcement, I worked with my Senate Democrats, and we sent a letter to the Governor about this particular issue. I want to thank my colleague on the other side of the aisle. I certainly wanted to be the lead person on this particular issue, but we do not work like that in here, and I understand that. But the point of the matter is that it is done. I am happy to see that the program will be up and running again as soon as possible, because \$18 million immediately, and then \$12 million in future years is a lot of money, a lot of homes, and a lot of families. So thank you.

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, very quickly, this is a very good bill and a fair bill. What it is all about is that school districts can send their students to a private nonprofit or profit institution. But because of an aspect of the School Code that goes back into the past, the local school districts actually end up being responsible for the payments. This is very unfair to a local school district. This has resulted in a number of court cases, and while this does not affect current court cases, it will eliminate any confusion in the future.

It is a good bill and it is fair. If a school district is contracting with a private nonprofit, that is the party that has to pay, not the other school districts that happen to be in the same place as the nonprofit. I probably confused people more than I helped, but it is a good bill and one that I am glad that we are finally going to pass, out of fairness to all of the districts. I am happy to see this bill come forward, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Columbia, Senator Gordner.

Senator GORDNER. Mr. President, I want to take just a few minutes in regard to this bill, House Bill No. 1913, as well as the bill right after this, House Bill No. 1916. For a lot of folks, the

flooding that we had last August and September is a distant memory. But for a lot of folks in the communities I represent, the northeast, northcentral area, those represented by Senator Baker, Senator Yudichak, Senator Blake, Senator Yaw, the memory still holds. When I drive near the Bloomsburg fairgrounds, I see a whole series of homes that are unoccupied and unlivable because of the flooding that occurred, and are waiting for a Federal flood buyout. I see streams that are still littered with all the debris that came through the flooding that cannot be fixed.

One of my prouder moments here in the Senate was last September, when, in a bipartisan manner, Senator Blake, Senator Yudichak, Senator Yaw, Senator Baker, and I unveiled a package of bills to deal with the devastation of the flood, as well as to deal with issues in years to come. Last November, as a matter of fact, this Senate passed an eight-bill package. A number of bills to deal with bridges, highways, flood control projection, tax abatements, farmers who were affected, and with small businesses. We passed those bills back in November and sent them over to the House. Unfortunately, not one of those Senate Bills has moved out of a House committee since we sent them over in November. The House earlier this year did move House Bill No. 1913 and House Bill No. 1916, which we have before us today. House Bill No. 1913, by Representative Culver, provides options for local municipalities as it relates to tax abatement. This is a similar bill to the one introduced by Senator Blake that we passed back in November. I want to thank Senator Blake for his sponsorship and for this bill coming to us. I urge its support.

I want to focus, though, on House Bill No. 1916. As this came over from the House, it dealt with flood control projects. What we have done in the Senate is add more projects to this, bridge projects, highway projects, as well as some bonding. I want to talk about what this does and the importance of it, not only now and not only relating back to September, but to the future as well. There is no longer a flood control line item under the Department of Environmental Protection in our budget. We are poised, in the next couple of weeks, to pass a capital budget debt authorization bill that no longer includes flood control projects. If we do not do this bill, other than a few dollars left with the Commonwealth Financing Authority, there will be no moneys available to the State for flood control efforts at any time in the future.

So if the Federal government were to come and say to this community, we have some moneys, but you are going to have to come up with a 30-percent match, State moneys are not going to be there to do that. So, we need to provide this mechanism, this bonding authority to provide some opportunities for flood control projects in the future, whether they are smaller projects, which many of our communities may need, or larger projects that the Federal government and the Army Corps of Engineers may be involved in.

Let me also talk about the Federal reimbursement for highways and bridges. Ultimately, according to our Secretary of Transportation, we may get around 65- to 70-percent reimbursement from the Federal government as a result of the flooding that occurred with our bridges and highways. But as of a couple of months ago, we had not even received 20-percent reimbursement yet, not even 20-percent reimbursement. We were still getting some Federal reimbursement from flooding that occurred 4 or 5 years ago, according to our Secretary of Transportation. So where is the money that is being used for all the work that was done back in August and September? It is coming out of our

existing Federal highway pot. Well, we all know of the transportation crisis, we know of the funding crisis, and as a result of us advancing the moneys from the Feds, we are doing less highway projects, less road projects, when we are looking for ways in order to do more.

This bonding mechanism would provide an opportunity for us to get some moneys, so that we would not be dipping into existing projects to pay for the results of August and September.

So while I support these efforts, I am concerned about where they go from here. We know that these House bills are going to go back to the House, but I just want our fellow Senators to know that, as of right now, there is no agreement with the House, there is no agreement with the Governor that these bills, as they exist, will get to the Governor's desk for signature.

So I urge all of our Members, whether you were affected by the flooding in August and September, or whether you are concerned that you may be affected by flooding in the future, unless we do bills like House Bill No. 1913 and House Bill No. 1916, there are not going to be any moneys available for any sort of flooding occurrences in the future, whether they are small or large projects. I urge support for House Bill No. 1916 and would, again, urge my colleagues to talk to your House Members, talk to the Governor's Office, so that we can get these issues done before we leave in June.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Blake.

Senator BLAKE. Mr. President, I just have a few brief comments to echo the remarks of Senator Gordner and to express thanks to my colleagues Senator Baker, Senator Gordner, Senator Yaw, Senator Argall, and Senator Yudichak, all of whom worked together last year to put together the package of bills in response to the flooding events in Pennsylvania. Mr. President, when I began my career in public life, it was in flood control work. I can tell you that when communities and residents of Pennsylvania are concerned about whether they can go to sleep at night because 3 inches of rain might be threatened tomorrow, I think they deserve some peace of mind from the General Assembly of Pennsylvania and from the Governor.

I commend the House colleagues who have put up the bills that are being considered in the Senate today, House Bill No. 1913 and House Bill No. 1916. Again, I want to express deep thanks to Senator Gordner for his leadership. I do call out his concerns about our obligation to cost-share with the Federal government, the essential flood control and infrastructure improvements, as a result of flood-prone areas of the State. We are a water-rich State, but as you know, Mr. President, there are times when those benefits can become threats, and that is why the Commonwealth needs to step up and do its share to pay for the improvements that protect our citizens. So again, I look for support for House Bill No. 1913 and House Bill No. 1916, and appeal to our House colleagues and the Governor to sign them into law. Thank you.

An Act amending the act of December 18, 2001 (P.L.949, No.114), known as the Workforce Development Act, amending the title of the act; and establishing the Keystone Works Program.

#### HB 1820 (Pr. No. 3687)

An Act amending the act of January 17, 1968 (P.L.11, No.5), known as The Minimum Wage Act of 1968, further providing for minimum wages and for exemptions.

Senators GREENLEAF, FONTANA, STACK, DINNIMAN, BAKER, HUGHES, BREWSTER, COSTA, PILEGGI, SOLOBAY, SCHWANK, PIPPY, ERICKSON, ARGALL, YUDICHAK, TARTAGLIONE, BOSCOLA, FERLO, ALLOWAY, RAFFERTY, WAUGH, EARLL, BRUBAKER, FARNESE and PICCOLA, by unanimous consent, offered **Senate Resolution No. 329**, entitled:

A Resolution designating September 29, 2012, as "William Penn Day" in Pennsylvania.

On the question, Will the Senate adopt the resolution?

And the question recurring, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, the resolution I offer designates September 29, 2012, as "William Penn Day" in Pennsylvania. William Penn, the Founder of this Commonwealth, was born in London, England, on October 24, 1644. The Province of Pennsylvania was acquired by William Penn from King Charles II of England in payment of a debt the King owed his father, Admiral Sir William Penn, for which William Penn received a charter from King Charles II dated March 4, 1681.

William Penn invited people from diverse nationalities and creeds to join with him in a Holy Experiment, where men might worship God according to their own light. His own prayers were that Pennsylvania might become the seed of a nation. In fact, Penn's hopes for a new land are best captured in a quote which wraps around the Rotunda's interior, just below the main cornice, as a reminder for legislators and citizens, and it reads: "There may be room there for such a holy experiment. For the nations want a precedent. And my God will make it the seed of a nation. That an example may be set for the nations. That we may do the thing that is truly wise and just."

His own prayers were that Pennsylvania might become "the seed of a nation" as I have just stated, and William Penn had a strong faith in a representative form of government, public education without regard to race, creed, sex, or ability to pay, and respect for the civil liberties of all persons. Many of the liberties and rights that we enjoy today can be traced to William Penn's efforts.

William Penn initiated the first call for a "united states" in his 1697 "A Plan for Union for the English Colonies in America." He also developed the first practical plan for world peace and for

"united nations"--and he used those words: united nations--in 1693, which was 251 years before the United Nations was established.

Further, William Penn established the first constitutions, including religious liberty and tolerance, self-government, and taxation only through representation, in modern history. On October 28, 1701, Penn's third revision of Pennsylvania's Constitution was adopted, the "Charter of Privileges." The "Charter of Privileges" so firmly established and grounded Pennsylvania as a keystone to other colonies that it evolved into the outline and later adoption of American liberties.

With the Constitution of the United States in 1751, the General Assembly commissioned a foundry in England to forge the bell, which ultimately we refer to as our Liberty Bell, and it was to celebrate the 50th anniversary of the "Charter of Privileges." The Liberty Bell is fondly associated with the year of 1776 when the Declaration of Independence was read in Philadelphia, but it was actually created 25 years previous to the Revolution in honor of William Penn and his great "Charter of Privileges" of 1701.

The Declaration of Independence and the Constitution of the United States were adopted in Philadelphia, and this nation was then established. Thomas Jefferson, the third President of the United States and writer of the Declaration of Independence, duly recognized William Penn's indelible influence upon this American nation and stated that he was, without doubt, quote, "the greatest lawgiver the world has produced." In fact, if you read the Declaration of Independence, there is a phrase in there that we are all familiar with, and that is "inalienable rights" that mankind has. That was set forth in Penn's writings almost a century before.

Woodrow Wilson, the 28th President of the United States, stated that in speaking of the phenomenon in Pennsylvania, "America did not come out of New England," it came out of the acts and thoughts of William Penn. May Pennsylvania continue to be the beacon to the world that he envisioned it to be, and I ask for the adoption of this resolution.

And the question recurring,

Will the Senate adopt the resolution?

A voice vote having been taken, the question was determined in the affirmative.

All our veterans, especially from World War II, we owe each and every one of them, those who made it home and those who are still serving, our gratitude, and we need to thank them day in and day out and keep them in our prayers and support.

D-Day was an important day for democracy in this world, and we continue today, in the Republic of the United States of America, to have a democracy because those brave, great men were willing to take to the shores of Normandy to fight for our freedoms here. Let this day never be forgotten in United States history. Let the memory of those individuals who made the ultimate sacrifice and those who survived D-Day - the soldiers, airmen, sailors, Marines, Coast Guard - let them all know that we deeply appreciate their sacrifices and their efforts on our behalf today. Mr. President, thank you very much. All of us need to remember in prayer during the month of June those in World War II who made that ultimate sacrifice.
