The Senate met at 11 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Jim Cawley) in the Chair.

PRAYER

The following prayer was offered by Senator JOHN R. GORDNER:

Shall we pray.

Dear Heavenly Father, as I am here this morning, I think back a week ago Monday to the passing of my father-in-law after a quick 9-week battle with cancer, and what a loss that was to our family. I think of last Thursday, just 6 days ago, as we were getting ready for that funeral service and received a text through our phone of a new baby. ELECTION OF SECRETARY OF THE SENATE

The PRESIDENT. The Senate will now proceed to elect the Secretary of the Senate.

The Chair recognizes the gentleman from Jefferson, Senator Scarnati.

The PRESIDENT pro tempore. Mr. President, it is my distinct pleasure and honor to nominate Megan Totino Consedine to serve as Senate Secretary and Parliamentarian. As all of you know, this is a very demanding and challenging position, one that is critical to the effective operations of the Senate. The person taking the office will have large shoes to fill. We will miss you, Mark, and we are sincerely grateful for your service, your friendship, and your contributions to this institution.

In Megan Consedine, I feel confident that we found the right individual who will serve with integrity, independence, and a commitment to excellence. She will be the first woman in Pennsylvania history to serve in this role, but Megan is used to being a trendsetter. I am sure by now that you are all familiar with Ms. Consedine's very impressive resume. She most recently served as a deputy general counsel in the Governor's Office of General Counsel. She also served as assistant counsel to the Department of the Navy, as a special assistant to former Governor Tom Ridge, and as an adjunct professor at Widener University School of Law and Harrisburg Area Community College.

But there is far more to her qualifications than what you see on paper. Serving as Secretary of the Senate also requires a vast knowledge of the legislative process, respect for the institution, and the ability to be fair and even-handed. Megan possesses these important qualities. She is also an extremely smart, engaging person, someone with whom you immediately feel comfortable. I interviewed Megan for this position over dinner, and after 2 hours, in which we talked about every aspect of her background and the position, I came away with one simple thought: she is perfect for the job. Since then, she has been working very diligently to meet with Members, learn every aspect of the position, and understand her responsibilities. In fact, the day she was offered the job, she went home and made 50 flash cards, one for each Member of the Senate, so that she would be ready for her office visits. Each night, her young daughter would quiz her on the flash cards. So Maura, you should definitely have a leg up on your classmates when you take civics next year.

I am sure after your meeting with Megan you will agree with me that she is independent, approachable, and meticulous. She has high standards and strong principles, but do not mistake her wonderful smile for being soft. You do not work as a lawyer in the Navy if you do not have some backbone. I know that Megan will serve with integrity and distinction and bring her unique style and attributes to this very important role. I look forward to serving with her and to making this Chamber an open, bipartisan institution we can all be proud of.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I have the honor and privilege today to rise and second the nomination of Megan Consedine as the Secretary of the Senate of Pennsylvania. The Secretary of the Senate is a very important position in our form of government, particularly here in this Chamber. It requires someone who is strong-willed, fair-minded, knowledgeable in the rules, and measured in disposition.

Since 1981, the Secretary of the Senate has been someone who has possessed all of those characteristics. Mark Corrigan has served this body very well. He knew the Senate Rules, but as important, he also knew the Members. In fact, Mark has had a very keen mind for the historical and important role that the Senate plays in making laws and rebalancing our House colleagues when they legislatively go astray. In fact, some have said that Mark has been here so long that he held open the door for President Teddy Roosevelt when he declared this building one of the most beautiful buildings he has ever seen, back in 1906. We know that is not true, but there is no question that Mark appreciates and understands the value of history. He has in fact lived it in many respects.

There is no reason to believe that Megan will not be able to pick up where Secretary Corrigan has left off. As was mentioned by my colleague, President pro tempore Scarnati, Megan is well schooled in the law and has a broad and deep range of experience. She has served in the Governor's Office of General Counsel, as assistant counsel for the U.S. Navy, as a professor, and as a special assistant to the Governor. She will no doubt be able to manage the rules and be able to make rulings based on that experience, and that is important to all of us.

The Secretary-Parliamentarian role is multifaceted, and the Senate Rules dictate almost two full pages to describing the duties of that office, from making rulings, conducting business, keeping official records, supervising central staff, posting roll calls and Journal entries timely, attesting to writs and warrants, and a host of other items, the Secretary must be a steady force and an adept administrator.

Today, we are doing something that we have not done since Ronald Reagan was President, and before Sandra Day O'Connor, the first woman Justice of the Supreme Court of the United States, took her seat on the bench of the highest court of the land. Today, we are electing a new Secretary of this Senate. This is the one and only time that there should be anything political about this office.

Today, I am asking my colleagues as a body to support the nomination of Megan Consedine to serve as our Secretary of the Senate. I am sure she will do a wonderful job. She is qualified. She is prepared. Our Senate Democratic colleagues look forward to working with her, and I am sure we will continue to be pleased.

Mr. President, it is my honor and privilege to second the nomination of Megan Consedine to serve as Secretary of the Senate. Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, I rise to second the nomination of Megan Totino Consedine to serve as Secretary of the Senate of Pennsylvania. I know that Megan will serve the Senate well in this capacity.

Some might think the responsibilities of the Senate Secretary were established by William Penn in 1682 as he crossed the Atlantic Ocean on the *Welcome*. In fact, the Secretary's role, as we know it, has developed in recent decades. The position of Secretary was first created in statute in 1911. The qualifications for the position were described as having, "a thorough knowledge of parliamentary practice and legislative procedure." That is how we see the Secretary, first and foremost, as Parliamentarian of the Senate. That is one of the Secretary's most important duties, and it is one of the most visible. However, the position involves much more.

The late 1960s and early 1970s were a time of significant change and reform in the General Assembly. New rules adopted for the 1972-73 Session included for the first time a full and detailed section dedicated to the duties of the Senate Secretary. Today, Senate Rule VI spells out the Secretary's duties. In addition to serving as Parliamentarian, they include, among others, directing the Senate's most important and fundamental functions, such as printing and numbering bills, incorporating amendments into bills, preparing the daily Senate Calendar, supervising the Senate Library, Senate Security, the Senate Bill Room, the Senate Print Shop, the Senate Reporter's Office, and the Senate Page service, in addition to that, serving as the Senate's appeals officer for Open Records requests. The Secretary supervises a staff of approximately 80 people with a payroll of \$5.6 million.

In my personal experience as a Member of the Senate, and in the experience of every Member serving today, with the exception of one gentleman from Montgomery County, the role of the Secretary has been defined entirely by one man, Mark Corrigan. Mark is an exemplary public servant and has been a distinguished Secretary of the Senate. Mark began working as Secretary in June of 1981, 31 years ago, when he replaced W. Thomas Andrews. Prior to Mr. Andrews, Mark Gruell, Jr., served as Secretary of the Senate for 17 years, from 1963 to 1980.

When she is confirmed today, in addition to becoming the first woman to serve in this role, Megan will be just the fourth person in the last half-century to serve as Secretary of the Senate. I know from meeting her and speaking with her and looking at

her credentials that she has the skills, the talent, and the temperament to continue this strong tradition of long-serving, extraordinary Senate Secretaries.

On a more personal note, I am pleased that Megan is a Delaware County native. She is the daughter of Dr. Joseph Totino, a prominent eye surgeon well known in our community for his skill and integrity. In fact, in talking with Megan, I was pleased to know that her grandmother and my grandmother were personal friends, so the connections really go back. It is an extraordinary family in our community. I know her professional career has been here in the mid-State, but she carries on that family tradition of excellence.

Mr. President, it is my honor to second the nomination of Megan Totino Consedine to serve as Secretary of the Senate of Pennsylvania. I ask for an affirmative vote.

NOMINATIONS CLOSED

The PRESIDENT. Are there any other nominations or seconds? Seeing none, the Chair declares the nominations for Secretary of the Senate closed.

The candidate for the Secretary of the Senate is Megan Totino Consedine of Cumberland County. All those in favor of Megan Totino Consedine for the office of Secretary will please say "aye"; those opposed, "nay."

A voice vote having been taken, the question was determined in the affirmative.

The PRESIDENT. The Chair takes pleasure in declaring Megan Totino Consedine unanimously elected Secretary of the Senate of Pennsylvania.

Her father, Dr. Joseph Totino; her fiance, James Patrick Caviston; her children, Maura Grace and Jack; her brother, sister, sister-in-law, and niece, Matthew, Amy, and Michaele Totino, and Sara Doud. Welcome to the floor of the Senate.

(Applause.)

The PRESIDENT. The Chair would like to now take this opportunity to politely remind all guests that the taking of still pictures and videotaping in the Senate Chamber is not permitted. The Secretary-elect, Megan Totino Consedine, will remain at the bar of the Senate and you may take as many pictures as you want at that time.

OATH OF OFFICE ADMINISTERED TO THE SECRETARY-ELECT

The PRESIDENT. It is an honor and privilege to have with us today a personal friend, the Honorable P. Kevin Brobson, Judge of the Commonwealth Court of Pennsylvania. He has kindly

consented to be with us today to administer the oath of office to the Secretary-elect. Will the Secretary-elect please present herself at the bar of the Senate.

Members and all guests will please rise.

Judge Brobson, will you now administer the oath.

Judge BROBSON. Please place your left hand on the Bible, raise your right hand, and repeat after me:

I, Megan Totino Consedine, do solemnly swear that I will support, obey, and defend the Constitution of the United States and the Constitution of this Commonwealth, and that I will discharge the duties of my office with fidelity.

Congratulations.

(Applause.)

The PRESIDENT. On behalf of all the Senate, the Chair would like to thank Judge Brobson for presiding at this ceremony and to congratulate our newly-elected Secretary of the Senate.

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for drivers in funeral processions.

Amend Bill, page 1, line 3, by inserting after "processions": and for use and display of illuminated signs.

Amend Bill, page 2, by inserting between lines 1 and 2: Section 2. Section 4307(a) of Title 75 is amended to read: § 4307. Use and display of illuminated signs.

(a) [General rule.--Except as otherwise provided in this section, no vehicle shall bear or display any illuminated signs, letters, numerals or figures of any kind whatsoever.] Specifications and prohibitions .--

(1) Except as otherwise provided in this section, any lighted lamp or illuminating device upon a motor vehicle, other than head lamps, spot lamps, auxiliary lamps, flashing turn signals, emergency vehicle warning lamps and school bus warning lamps, which projects a beam of light of an intensity not greater than 100 candela:

(i) Shall be so directed that no part of the high-intensity portion of the beam will strike the level of the roadway on which the vehicle stands at a distance of more than 75 feet from the vehicle.

(ii) Shall measure not greater than a five and one-halfinch width by four and one-half-inch height or five-inch circumference for round versions and be located in rear corner or rear-side corner windows only as not to obstruct the driver's view.

(2) Flashing lights are prohibited on motor vehicles, motorcycles and motor-drawn vehicles except as a means for indicating a right or left turn.

No person shall drive or move upon any highway any vehicle or equipment with any lamp or device that displays a red light visible from directly in front of the center of the vehicle or equipment.

Amend Bill, page 2, line 2, by striking out "2" and inserting:

On the question,

Will the Senate agree to the amendment?
