RE: Distribution of State Ethics Commission Rulings

On June 26, 1989, the revised Public Official and Employee Ethics Law was enacted which re-authorized the State Ethics Commission. The State Ethics Commission is responsible for issuing various types of rulings on matters within its mandated jurisdiction. Pursuant to the law, the Commission is mandated to forward, quarterly, a copy of every Opinion, Advice of Counsel, and Order issued to one law library in each county, one public library in each county, the State Library, each authority appointing a Commission member, the Pennsylvania Association of County Commissioners, the Pennsylvania Association of Boroughs, the Pennsylvania State Association of Township Supervisors, the Pennsylvania State Association of Township Commissioners, the Pennsylvania State School Boards Association, and the

Pennsylvania League of Cities. Your agency is either specifically identified in the above requirement or has been selected as a library to which this mailing will be made pursuant to the above authority. As such, enclosed please find decisions of the State Ethics Commission from January 1, 2013 to March 31, 2013. Due to budgetary restraints, a CD containing said rulings will replace paper copies that were previously sent.

For your information, the Commission generally issues these types of decisions as follows:

<u>Commission Opinions</u> - Opinions are advisory rulings issued by the State Ethics Commission regarding the duties and responsibilities of public officials and employees under the Public Official and Employee Ethics Law. Opinions are cataloged by year of issuance followed by the sequential number of the opinion during that year. As such, opinions relating to 2013 will begin with the number 13-001 and proceed there from as decisions are rendered.

Advice of Counsel - The Commission's Chief Counsel is authorized to issue similar advisory letters. Such letters are issued generally when there is prior precedent for counsel to rely upon in issuing a decision or when the provisions of the State Ethics Act directly provide the answer to the question posed. Advice of Counsel letters are numbered with the year and a 500 series number that progresses in order therefrom as rulings are issued. If more than 100 such letters are issued, a 600 series number will then be used.

Orders - Commission orders are issued at the end of an investigation and are determinations as to whether or not there has been a violation of the State Ethics Act. Commission orders are categorized numerically from the date of the first Order in 1979. That is, the first Order issued was order No. 1. All Orders proceed therefrom.

It is recommended that Opinions, Advices of Counsel and Orders be maintained separately (in numerical order) so as to afford better retrievability.

The enclosed items are being forwarded for retention, cataloging and for the purpose of being publicly available for review by citizens of the Commonwealth of Pennsylvania who may have an interest therein. Additional mailings will be made on a quarterly basis henceforth. SENATE RESOLUTION No. 79 CALLED UP OUT OF ORDER, ADOPTED

Senator PILEGGI, without objection, called up from page 4 of the Calendar, as a Special Order of Business, **Senate Resolution No. 79**, entitled:

A Resolution opposing the International Olympic Committee's decision to eliminate wrestling from the Summer Olympic Games beginning in 2020.

And the amendments made thereto having been printed as required by the Constitution,

On the question,

Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Mercer, Senator Robbins.

Senator ROBBINS. Mr. President, I rise today to ask my colleagues to support Senate Resolution No. 79, calling on the International Olympic Committee to restore wrestling as a recognized sport for the 2020 Summer Olympics. I am sure most of my colleagues are aware that the IOC's executive board voted in February to remove wrestling from its list of recognized competitions beginning with the 2020 Summer Olympics. And, I know most of my colleagues are aware that I have participated as a wrestler and as a coach. So, it probably goes without saying that I believe the International Olympic Committee made a serious mistake by eliminating this sport.

This action by the IOC strikes at the very heart of the Olympic ideal. It was a main competition in the ancient Olympics, and there is a reason why wrestling was included as a sport when the modern Olympics were started in 1896. Wrestling is a sport that features one-on-one competition, testing the strength, endurance, and skills of each individual. It has a clear scoring system and does not rely on the arbitrary decisions of judges. And let us not forget that wrestling's popularity spans the globe, particularly among Pennsylvania scholastic athletes. Penn State is a colleagiate leader in the sport today, and widely known as a training center for some of the best athletes in the field.

Mr. President, we should also stand for America's wrestling tradition in the global arena. United States wrestlers earned two gold medals at the 2012 London games, and we own a record of 113 Olympic wrestling medals. I ask my colleagues today to stand with me and call on the International Olympic Committee to reverse its decision.

GUESTS OF SENATOR ROBERT D. ROBBINS PRESENTED TO THE SENATE

Senator ROBBINS. Mr. President, finally, joining with me here today on the Senate floor in support of Senate Resolution No. 79 are: coach Greg Strobel, two-time NCAA champion, former United States Olympic wrestling head coach, and current Vice-President of USA Wrestling. Thank you, Coach, for being with us. He is with his wife, Donna.

(Applause.)

Senator ROBBINS. Mr. President, of course, later you will hear more about this gentleman and his team, but we have with us coach Cael Sanderson, four-time NCAA Champion and undefeated in his college career, 2004 Olympic Gold medalist, and current Penn State head coach.

(Applause.)

Senator ROBBINS. Mr. President, we have University of Pennsylvania's head coach Rob Eiter, five-time United States Open National Champion, 1996 Olympian, and as I said, current University of Penn head coach.

(Applause.)

Senator ROBBINS. Mr. President, also Jake Herbert, two-time NCAA Champion, Pan-American Champion, and member of the 2012 Olympic team.

(Applause.)

Senator ROBBINS. Mr. President, I will finish up with Jake Varner, two-time California High School State Champion, and we did allow him into Pennsylvania for today. He is also the 2011 World Bronze medalist, and 2012 Olympic Gold medalist. (Applause.)

Senator ROBBINS. Mr. President, I ask my colleagues to vote in the affirmative on Senate Resolution No. 79.

GUESTS OF SENATOR JAKE CORMAN PRESENTED TO THE SENATE

Senator CORMAN. With us today to celebrate this honor are head coach Cael Sanderson; assistant coach, Cody Sanderson; Adam Lynch, director of operations; and Andrew Alton, a Penn State athlete. As we all know, winning a NCAA Division I title is a top achievement in collegiate athletics. For the Penn State wrestling team, this is the third-straight NCAA and Big Ten title, becoming only the third team in NCAA history to win three consecutive championships. In addition to the team level accomplishment, Penn State had two individual wrestlers winning national titles. Quentin Wright from Bald Eagle Area High School in the 34th Senatorial District in Centre County, and also Ed Ruth, who won a national title and is from Dauphin County, here in the Harrisburg area. They both won individual titles in their

respective weight classes, and head coach Cael Sanderson was named National Wrestling Coaches Association Coach of the Year.

Mr. President, I would like to also point out another accomplishment, just as impressive. Of the team's 37 student athletes, 15 were named to the Academic All-Big Ten Conference team. Wrestler Matt Brown won the Elite 89 Award for the top student athlete at the national championship with a 3.97 grade point average. A Resolution designating the month of April 2013 as "Pennsylvania Donate Life Month."

On the question,

Will the senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, I am going to make some remark on my resolution, which designates April 2013, as "Pennsylvania Donate Life Month." But, most of us, very quickly, have just learned that there have been some bomb explosions at the finish line of the Boston Marathon. And, of course, as we await further information, our hearts and prayers go out to those folks. Right now this is literally coming across the wire. We do not know if there have been any injuries, we are just getting information, but I am certain we will keep all of those who are in Boston right now for the marathon in our prayers and thoughts.

Mr. President, I am pleased to offer this resolution again this year designating April 2013, as Pennsylvania Donate Life Month, and to be joined by my good friend and colleague, Senator Boscola, and my other colleagues in the Senate. We felt a need to bring attention to the necessity of organ donations and the great work done by our State's 18 transplant centers. I present you with some numbers to think about, Mr. President: 117,000, the number of people estimated to be in the need of lifesaving organ transplants in the United States; 6,200, the number of individuals awaiting lifesaving organ transplants in Pennsylvania; 460, the number of individuals and families in the Commonwealth in 2012 who elected to support life through organ donations after death; 50, the number of lives that can be enhanced or saved by each person who donates organs and tissues; 8, the number of people who can be taken off the waiting list, Mr. President, for organ transplants by each person who donates organs and tissues.

The important work done by our world-renowned medical personnel and donation centers in Pennsylvania has made our Commonwealth a leader in the field of donation and transplantation. Senator Boscola and I present this resolution to the Senate today to honor their work and to encourage all citizens in Pennsylvania to designate themselves as organ and tissue donors. You can do so at the time of a driver's license renewal or by visiting www.donatelife-pa.org.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, I also rise to offer my support for this resolution which recognizes April as Pennsylvania Donate Life Month. Organ donors are among our society's biggest heroes. Being an organ donor can literally save someone's life, give a person eyesight, or help someone live a healthy, active life. Mr. President, over 6,000 Pennsylvanians are on an organ transplant waiting list hoping and praying for such a hero. Often when we talk about a donor's parent, spouse, or loved one, they will tell you that they found great comfort in knowing that another person was able to walk, see, or live because their loved

one gave such a noble sacrifice. Can there be any greater gift or legacy to give another?

Mr. President, last month, I visited the northeast Pennsylvania Lions Eye Bank. While there, I learned so much about how critically important it is to donate organs. Specifically, I was touched by the story of Krysta Hankee, a very, very young woman whose ultimate death in 2007, which was very untimely, her decision to give the gift of life caused others, including her grandfather, to consider organ donation, and, as a result, he became an organ donor. So, Krysta's selfless act should be a lesson to all of us about the importance of organ donation.

Mr. President, while we have been very successful in making Pennsylvania a world leader in organ donation and transplantation, there remains a huge demand for donated organs and tissue. I am told that just one donor can potentially save or help 50 people and take 8 people off the waiting list. So raising awareness and encouraging more people to designate themselves as donors is not just the important thing to do, it is the right thing to do. We must do all that we can to continue this wonderful cause that makes such gifts of life possible.

Thank you, Mr. President.

And the question recurring,

Will the Senate adopt the resolution?

A voice vote having been taken, the question was determined in the affirmative.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, I rise to talk about an issue that, of course, we cannot lose sight of, and that is job creation and economic development in Pennsylvania. We are still in dire straits here in Pennsylvania. We have gone from being 8th in job creation to 43rd in a relatively short amount of time. I think that we have to focus on ways to invest in our future, Mr. President. In the past, I have said nothing could be more wrongheaded than cutting education at a time when we should be investing in our greatest asset possible, and that is our young people. We should be finding ways to help them afford a great education that we can offer here in Pennsylvania, as opposed to going into bankruptcy trying to achieve that. So that is where our focus should be, on the future, Mr. President. We should be focused on young people's education, and that is the only way we can turn things around and come up from the bottom on job creation.

This upcoming budget is probably, to be on the optimistic side, much better than previous years, Mr. President. Our budget gap is about, at this moment, \$200 million, which is just a fraction of previous budgets that we have had to solve. So I think that this will be one that we should be able to achieve in a moderately short amount of time and with as little pain as possible. And while we are at it, Mr. President, this is something I have talked about in previous years, we have a lot of money uncollected here in the Commonwealth of Pennsylvania, which we could easily use to plug the budget hole and then turn around and invest in those young people I have talked about. One of the bills I have spoken about in the past is a pay-your-own-fair-share bill. This is something I have worked on with members of our State Supreme Court. The court records show from the data we have

collected that there is \$1.5 billion in unpaid fines and costs to our court system. That is just outrageous, Mr. President. So I believe that we should go full-court in trying to collect a large percentage of those unpaid fines and costs.

What my legislation proposes to do is to deny anyone a renewal of their driver's license or auto registration if they have not paid any fines and costs that they may owe. This is not an expensive thing to do. We would be able to collect a lot of revenue. On the most conservative estimate, we would be able to collect a half-billion dollars, Mr. President, which would give us a \$300-million surplus in this year's budget, and we could put that money to use on job creation and economic growth. So on the high end, the more optimistic, we should be able to collect \$1 billion, and I will give you other speeches as we go on, Mr. President, on what we could spend that money on. But those are things we should do.

Also, according to the Auditor General's report, Eugene DePasquale has found that there is about \$40 million in unpaid corporate taxes. If we could collect at least half of that, we would have yet even more money to put back in our budget. So, we should deal with tax delinquents, court delinquents, and corporate tax delinquents in the same way, they all need to pay their fair share if they want to do business in Pennsylvania. So that is something we are working on.

Another thing that sinks our budget year after year and hurts our economy in Pennsylvania is uncompensated care to our healthcare systems. Mr. President, I know that you have been a big backer of hospitals and health systems and physicians and nurses. We have among the best healthcare systems in the world. One of the problems that CEOs of the health systems tell us time and time again is that the issue of uncompensated care costs them billions of dollars a year. These are expenses of patients who do not have any kind of insurance. We are a humane society, and when someone gets sick and they do not have insurance, usually the first place they will go is to an emergency room. They will get care, but then the healthcare system has a huge debt. That ultimately comes out of everybody's pocket who has insurance. Your rate goes up, my rate goes up.

So we have to find a way to provide health insurance so that we can deal with the issue of uncompensated care and encourage our health systems to expand, not retract, to create jobs, not to cut jobs. That seems like a commonsense thing, Mr. President. The Medicaid expansion is one way to do it, but if Governor Corbett and others do not want to do it that way, we have a tried and true method, Mr. President, that you have heard me talk about before, the adultBasic program, which we let lapse. But the Commonwealth Court has said letting that lapse and not funding it was unconstitutional. We have 6 months until Obamacare kicks in. Why not fill that gap of uncompensated care by reinstating the adultBasic program? I have a bill circulating to do that. Before we let the adultBasic program lapse, it was covering 41,000 people, and a half-million people were on the waiting list. Most of the people on the adultBasic program, about two-thirds were working women. Since that time, many working women, a majority of those on that program, do not have health insurance and they are living day-to-day trying to work a job dealing with other health issues.

We have to deal with that issue, we have to stand up for working women and make sure that they have insurance. This is one way to do it, Mr. President. All these things tie into turning our economy around. We need to be a leader in Pennsylvania and not a follower. We need to consistently be in the top 10, not the bottom 10. Let us work to do that.
