The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Jim Cawley) in the Chair.

### GUEST OF SENATOR EDWIN B. ERICKSON PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Erickson.

Senator ERICKSON. Mr. President, I have the extreme pleasure to introduce Reverend Dr. Wylie W. Johnson, who is the senior pastor of the Springfield Baptist Church, in Springfield, Pennsylvania. Dr. Wylie Johnson was ordained to the Baptist ministry in 1982, and served 5 years as assistant pastor of First Baptist Church in Metuchen, New Jersey. Following that ministry, Colonel Johnson was commissioned and served 10 years of

ministry in the active U.S. Army Chaplaincy prior to coming to Springfield. His education includes a doctorate of ministry, master of divinity, master of strategic studies, and bachelor of arts. Reverend and Mrs. Johnson celebrated 40 years of marriage, and are blessed with four daughters and four grandchildren.

Colonel Johnson's military ministry spanned more than 25 years, and he is a veteran of five conflicts and a graduate of the Army Senior Service College. Chaplain Johnson served in Honduras, Korea, Qatar, Somalia, Haiti, Germany, Afghanistan, and Iraq, as well as numerous locations in the continental United States. His awards include the Legion of Merit, two Meritorious Service Metals, the Master Parachutist Badge, and the Air Assault Badge.

Reverend Dr. Johnson voluntarily serves as the Springfield Township Police Chaplain, and as Chaplain for the Delaware County Chiefs of Police. He also serves on the executive committee of the Delaware County Suicide Prevention and Awareness Task Force, and is the serving president of the Springfield Ministerium. He is a strong supporter of veterans affairs, and a regular speaker at public events in the region. I ask the Senate to extend its warm welcome to Reverend Dr. Wylie Johnson.

### GUEST OF SENATOR ANDREW E. DINNIMAN PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, it is my honor today to introduce Mr. Steve Silva. Today in the Committee on Education we passed a bill, my bill, that creates what we call Aidan's Law. Mr. Silva lost his child to sudden cardiac arrest. He and his wife, Christy, have devoted their lives to making sure that no other youngster dies of sudden cardiac arrest in this Commonwealth. Today, in the Committee on Education, thanks to the leadership of Senator Folmer, we passed an AED bill, a diffibrillator bill, and this bill will save hundreds and hundreds of lives in our public schools. This Saturday in my district, we will have thousands

of people come together to fight the fight to get defibrillators in every school. Steve and his wife have organized events within their district, Mr. President, where doctors come up from A.I. duPont Children's Hospital, and other children's hospitals, so that we can check each child, and we could discover children who would be subjected to sudden cardiac arrest.

So, I ask that we give a warm welcome. Here is someone who, after the loss of his child, dedicated himself in his life to making sure that no child is going to be lost again in this Commonwealth from sudden cardiac arrest. I hope that this bill will pass today, under the leadership of Senator Pileggi, I hope that it will come before this Senate so we can affirm our belief in the value of human life and the life of each and every child within the Commonwealth. Finally, Mr. President, Mr. Silva and his wife are constituents of Senator Rafferty. He teaches in Penncrest High School, which I believe is in Senator Pileggi's district. I ask for a warm welcome and a show of our support for his efforts to make sure that every child in this Commonwealth is protected.

Thank you, Mr. President.

### GUESTS OF SENATOR MICHAEL BRUBAKER PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Lancaster, Senator Brubaker.

Senator BRUBAKER. Mr. President, we all know what drives the United States and the Pennsylvania economy, and that is small business. Today, in the gallery, Mr. President, we have Kline's Services located in Salunga, Lancaster County. It is a third generation family-owned business that specializes in commercial wastewater management, residential septic tank cleaning, sewer and drain cleaning for residential customers, and more. What began, Mr. President, with one small septic truck in 1955 has grown to be the premier wastewater management company in the region and, potentially, the country. Their growth has been spectacular. They not only treat their employees well, Mr. President, they not only do great services, but they have recently won an environmental award from our Governor. This business was one of 19 organizations that was involved in 16 very important environmental projects statewide. They ultimately won the award by the not-for-profit Pennsylvania Environmental Council.

Mr. President, seated in the gallery today are Dave Kline, Brian Schreiber, Barb Culton, and Brandon Kline. I ask my colleagues in the Senate to give them the warmest Senate welcome.

#### **BILL ON CONCURRENCE IN HOUSE AMENDMENTS**

#### SENATE CONCURS IN HOUSE AMENDMENTS

**SB 334 (Pr. No. 1143)** -- The Senate proceeded to consideration of the bill, entitled:

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in preliminary provisions, further providing for definitions; in organization, further providing for Chief Justice and president judges; in community and municipal courts, further providing for the Philadelphia Municipal Court and for jurisdiction and venue and providing for hearing officers; and, in traffic courts, further providing for jurisdiction and venue and for the Traffic Court of Philadelphia.

On the question,

Will the Senate concur in the amendments made by the House to Senate Bill No. 334?

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, I move that the Senate do concur in the amendments made by the House to Senate Bill No. 334.

On the question,

Will the Senate agree to the motion?

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, in 1978, the president judge of the Philadelphia Traffic Court was convicted of taking \$32,000 in gifts and bribes. Seven years later, in 1985, 12 people were convicted after prosecutors uncovered a massive ticket-fixing scheme that included more than \$100,000 in illegal payoffs to traffic court employees. A few years later, in the early 1990s, management of the traffic court was so bad that an article in the Philadelphia Inquirer described it as, quote, "a place where no one can be quite sure what's what and who's in charge," end quote.

Earlier this year, the U.S. Attorney's Office indicted nine current and former traffic court judges, along with three other individuals. The indictment said that, quote, "the defendants participated in a widespread culture of giving breaks on traffic citations to friends, family, the politically connected, and business associates," end quote. Four months ago, the Senate unanimously passed legislation to eliminate the scandal-plagued traffic court in Philadelphia. Today, the situation is so bad that only one of the court's seven judges is still serving. This court has proven to be immune to all reform efforts. It is time, it is past time, to finally do away with this institution.

Senate Bill No. 334 is before us today for concurrence with agreed-upon House amendments. This bill would create a new traffic division in the Philadelphia Municipal Court to handle the responsibilities of traffic court. Hearing officers under the supervision of the court's president judge would handle cases related to traffic violations. When Governor Corbett signs this bill into law, the elections currently scheduled to fill the current vacancies on traffic court will be cancelled and municipal court will immediately begin the process of creating the traffic division. I support the House amendments and ask for an affirmative vote on concurrence in amendments to Senate Bill No. 334.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, I stand to salute the Majority Leader, Senator Pileggi, on moving forward with this legislation. I know we started some time ago here in this Chamber, and we are back here on concurrence, but it is sad to make the admission, as a Philadelphian, that this is a court which is beyond saving. There is no doubt that there are many excellent employees and folks who work in traffic court, but with the recent scandals, the indictments, the guilty pleas, it is clear that the people of Philadelphia and the people of Pennsylvania deserve better. In many regards, the key feature was that we needed a transitional phase. It appears to me from Senator Pileggi's legislation that transitioning to a hearing officer model underneath the president judge of municipal court is a workable solution. Nonetheless, we have a court system in Philadelphia that over the years has handled many challenging pieces of litigation and case dockets and has achieved some very positive things. At a time in the past they were overwhelmed and had trouble, it is now one of the best judiciaries in the nation. So, we need to make sure that we do not overwhelm the court system, that we continue to make sure that the municipal court has the resources and the personnel that it needs to do its job effectively now with this additional task of dealing with issues formerly under traffic court.

I am happy that this is a day of reform and moving forward and serving the people of Philadelphia and the people of Pennsylvania. I think it is going to be a better day that we have to look forward to, and I look forward to working with my colleagues on both sides of the aisle to make sure that Philadelphia has the best judiciary across the board, from traffic court to common pleas, that it can have.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, very briefly, I do not want to reiterate the comments made by my colleagues, and specifically, the comments of Senator Stack, I was one of the first folks to vote for this in the Committee on Judiciary when it first came out. I think that what we are doing today is necessary and a needed reform. But I think at some point after today, we need to put this issue behind us. This should not and cannot be an indictment against the city of Philadelphia or its judiciary. Rather, we must recognize that we have many, many excellent jurists within the city of Philadelphia who take their job very seriously, who take their oath of office, and who dispense justice each and every day under very difficult and trying circumstances. This certainly is a necessary reform. I am proud to support it. I was proud to support it when the Majority Leader introduced it and I thank him for his leadership on this. I hope that as we pass this bill and it becomes law, that we do not and cannot look with disdain or blemish on the city of Philadelphia or its judicial system. We should know, many of us know, many of us understand, that the men and women who serve as jurists in the city of Philadelphia do so at a considerable risk to themselves, taking less pay, sort of cutting themselves off from being able to earn significantly more in the open market. They should be applauded. I think as we move forward here today, we need to put this behind us and make sure that we never forget that the men and women of Philadelphia's judiciary are dedicated and dispense justice in a very fair, ethical, and appropriate manner.

Thank you, Mr. President.

The name is Scottish for "Hill by the Waters," and that is fitting as the borough is situated on a hill just above the Ohio River, 9 miles from the city of Pittsburgh. The borough is now home to 148 homes, a community park, and the Shannopin Clubhouse, the only commercial property in Ben Avon Heights. The community is served by the Avonworth School District. Ben Avon Heights is celebrating the 100th anniversary of its founding with several community events, including a golf outing, family picnic, and architectural tours of the community.

The rich community history began in 1906, when Walter P. Fraser of Ben Avon bought 84 acres of the former Taylor farm and used 40 acres to build the Ben Avon Country Club and used the remaining acreage for residential development. The original intent was for the homes to serve as summer homes for Pittsburghers in what was considered at the time a rural area. By 1913, the development had progressed and the borough was incorporated. The Ben Avon Country Club closed in 1917, and the golf course property was divided into additional housing lots. Three years later, Shannopin Country Club opened its clubhouse in the borough and golf course in neighboring Kilbuck Township. The current Ben Avon Heights borough boundaries were finalized in 1936, when a portion of the John Wilson farm was annexed. The community remains a lovely place to live and raise a family.

I respectfully ask my Senate colleagues to join me in supporting this resolution recognizing Ben Avon Heights' centennial.
