**GUESTS OF SENATOR MICHAEL J. STACK

Senator FARNESE. Mr. President, very briefly, I rise, of course, in support of the child protection legislation we are considering today. Many months of hard work have gone into these bills and I thank the Members, staff, and stakeholders who were involved in that process. In particular, Mr. President, I thank Senator Vulakovich, my counterpart on the Committee on Communications and Technology, for his collaboration on Senate Bill No. 24, as well as Senator Washington's office, and our former deputy chief counsel, Commissioner Gladys Brown, for their assistance throughout the negotiations.

It is a good day here in Harrisburg, Mr. President. We are moving forward with meaningful legislation that will provide children with the necessary safeguards and make accountability for their safety even more prominent. As you know, Senate Bill No. 24 will provide for electronic, confidential reporting and the establishment of a statewide database of protective services and provide for collaboration amongst agencies charged with the welfare of children. I stand in support of this legislation and the other bills which are part of this package, which will also be voted on today. Again, I thank those who have worked so hard on these very important and critical issues.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Vulakovich.

Senator VULAKOVICH. Mr. President, I think there is no need for me to repeat everything that Senator Farnese has just said. I thank him for his support on this piece of legislation, and everybody on the committee and the staff who worked very hard on Senate Bill No. 24. I think it is going to be a part of larger pieces of legislation that will be very beneficial to help us do the right thing for our children with regard to children in abusive situations. So, thank you, everyone, and I ask for unanimous support on Senate Bill No. 24.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise in regard to this legislation. First, I want to congratulate Senator Browne for introducing this legislation. It deals with many issues that will protect our children and I congratulate him and his work on this issue. In particular, this bill deals with one issue that has been a real injustice and an outrage for many years in the area of dealing with individuals who file false child abuse reports. This is a common situation occurring in the domestic relations area. If you check with your local courts you will find out that there are many complaints filed for a variety of reasons in order to give one party or the other an advantage. For example, recently, I had one of the individuals who administered the Domestic Relations Office in Philadelphia, and I mentioned this to him and he said that, yes, it is a problem that there are many false complaints that are filed involving that process. He told me verbally, so this is anecdotal, that 90 to 95 percent of them are unfounded. So, it is important that this legislation addresses that issue.

The only reason I rise is to make sure that the language is clear as to who it applies to. If anyone is charged with such an offense, it is covered. Right now, the legislation says a false report of suspected child abuse against a person, school employee, private residential rehabilitative institution employee, detention facility employee, or child care services employee. In statutory construction, there is a principle where a specific will cancel a general term. So, what I am concerned about is that the way it is worded now, I understand what the sponsor and also the staff means because we have talked to them. What it means is that it applies to false reports against any person, and the specific employees listed afterwards in no way limits the general meaning of the word "person," so that it can be filed against any person, as well as and including, but not limited to, these individuals who have been listed in the legislation. So, that is my interpretation of it, that is the sponsor's interpretation of it, and the staff and drafters' interpretation of this legislation, and I believe everybody here on the floor knows that is the intention of the legislature.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Fontana.

Senator FONTANA. Mr. President, I rise to urge the Senate to pass Senate Bill No. 31 and every other bill in this legislative package, which will go a long way to make our children safer. I want to publicly thank the Members of both the Committee on Education and the Committee on Appropriations for their bipartisan support - Senator Folmer, Senator Dinniman, Senator Corman, Senator Hughes - and all the Leadership in the Senate as well as in their efforts to prioritize this legislation.

Mr. President, I have been fighting for passage of this bill, this common sense legislation, for almost a decade. The bill would help protect our kids and insure their safety in schools. It does away with the separate reporting requirement for school employees and mandates that suspected child abuse be reported within 24 hours to the proper authorities for investigation. Senate Bill No. 31 would remove the different reporting requirements for school employees and put them on the same level as other mandated reporters. It requires that incidents be reported within 24 hours to ChildLine or to the police.

Mr. President, let me briefly tell you why I first introduced this bill back in 2005. A constituent called me and told me her son had been taken to the emergency room with bleeding brush burns, choke marks around his neck, and broken blood vessels on his face, all caused by a school employee. Even though the mother, the emergency room doctor, and social worker all tried reporting the incident to ChildLine, they were told that the law prevented the investigation. To me, it is an outrage that we have a lesser child protection standard in our schools, and that is why I have reintroduced my legislation over and over and over again.

I am proud today that the bipartisan Legislative Task Force on Child Protection endorsed my bill earlier this year as part of its package of recommended bills. We have a public and ethical

responsibility to protect our children and insure their safety in our schools. It does not matter who is suspected of abuse, each case should be handled the same. Senate Bill No. 31 is a good step in that direction, and I ask everyone for an affirmative vote.
