The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise to offer this amendment but to give a little bit of background on this amend-

ment. It deals with human trafficking, both the main bill, Senate Bill No. 75, and the amendment. It is an issue that we have to deal with in Pennsylvania and it is a worldwide problem. There are millions of people who are subject to human trafficking. There are billions of dollars and monies being made by engaging in human trafficking, and it is the fastest-growing criminal industry in the world. About 33 percent of the victims in America are Americans, and it is happening here in Pennsylvania. There were two recent instances where this has happened, both in Philadelphia and also in Lancaster County, where a young girl ran away from home--and by the way, the statistics indicate that 1 out of 3 runaways are lured into prostitution within 48 hours of them running away.

So, I think it is important for us to deal with this issue because the statute that we have now is not adequate, it is not definite, it is not specific, it does not deal with sexual human trafficking. It is mostly directed toward labor human trafficking. We need to improve the bill, and this amendment is proposed to do that.

Now, in regard to the bill itself, it was introduced months ago, earlier in this Session. I want to thank Senator Leach for his involvement, he has been involved in this issue for a long time, interested in this, and he introduced other pieces of legislation that deal with human trafficking. He and his staff have been very helpful and involved in this process. I would also like to thank Senator Dinniman, who has been a tremendous advocate for this issue. In fact, he had a rally, a meeting of over a couple hundred people in his district last winter in regard to this type of legislation. So, this legislation was introduced and it dealt with a couple of things, and this amendment deals with all of these issues. It has a more defined definition of human trafficking and more clearly defines what sex and labor trafficking is. It increases the fines and penalties for trafficking and involuntary servitude. It adds penalties for business entities including licensure revocations and forfeiture contracts. It creates a Pennsylvania Council for the Prevention of Human Trafficking, increasing the training for our first responders, and expanding the resources available to victim services providers.

This legislation was the result of a 2010 study by the Joint State Government Commission that we all voted for and created. They came back in 2012 with the study results. I wanted to wait so that when we passed something, it was going to be comprehensive, tough legislation that changed the culture in Pennsylvania and the rest of the nation, that if it has that effect, and hopefully it will, that we have to stop treating victims as criminal perpetrators. They are the ones who are the victims, they are the runaways who are really subjected to sexual exploitation. The pimps are not to be glorified as they were glorified in a rap song not too many years ago. It is important for us to do that, and this bill attempts to do it in a variety of ways, as I just mentioned.

The amendment, when we reported it out of the Judiciary Committee last spring, there were some issues. The interest groups that stepped forward were in favor of the legislation and they just wanted to modify some of the provisions in the legislation. So, my staff spent the spring, the summer, and the first part of this fall dealing with those issues to come to a consensus, to deal with the things that fine-tune the legislation.

So, this legislation deals with every aspect that I just mentioned of what the bill deals with. We now, I believe, have a consensus. I am sure there are other things that will come up as we progress with this legislation as it goes from the Senate to the

House. But I believe that all of the stakeholders are pretty well on board with this amendment. Hopefully, there will be no delays in its passage. Pennsylvania needs this legislation, our children, the victims of sexual predators, need this legislation. I ask for a favorable vote on the amendment.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Leach.

Senator LEACH. Mr. President, I rise in support of the amendment, and I want to thank a number of people. Certainly, I want to thank Senator Greenleaf for being a great partner to work with on this bill. We worked together on the posting bill last Session which required the phone number of the Polaris Project, a private organization which rescues the victims of human trafficking, to be posted prominently in places where the victims of human trafficking might see it.

We know for a fact that, Mr. President, that bill is already saving lives. But, we knew we needed further legislation and so we went about the business of drafting and working with the advocates to come up with this legislation. For people who do not know, and I did not know this before I got involved, human trafficking is the second-most pervasive crime in the world after drug trafficking. It affects hundreds of thousands of people in the United States alone. It is modern-day slavery.

There is labor trafficking, where people are forced to work in restaurants, nail salons, and other places against their will for little or no pay, in terrible conditions, and then there is the sex trafficking, where people are often forced to work in the sex industry against their will. There are many ways in which this is done, Mr. President, whether it is threats to their physical well-being, threats to their family, actual beatings. To tell you one story we heard: there was a young girl who ran away from home, met up with some trafficker who wanted to put her on the street, and she refused. She had the courage to refuse. So, he beat her, but she still had the courage to refuse to do it. So they bought her a dog, a puppy, and she became very attached to that puppy. Then they started beating the puppy mercilessly, and that was when she was finally willing to go out on the street. That is the type of thing that we are combating in this legislation. I have to say that after this bill passes, Pennsylvania will be the most progressive State in the nation in terms of combating human trafficking. We cannot say that about a whole lot of issues, but on this issue, we will be a leader in the nation in combating human trafficking.

So, I am very grateful to Senator Greenleaf and his staff for working so well with my staff. I also want to talk about my staff a little bit, three people in particular: Sarah Charles, who has been tireless in her efforts to bring this to the attention of the public and to the attention of me, and to spread the word about this; Zach Hoover and John Tew, my chief of staff and legislative director, who worked very hard on the language of this bill for month after month after month to get this bill just right. They are the brains behind my operation, Mr. President. I am merely the eye candy, and I acknowledge that.

I want to say a word about the person who first got me involved in this issue, because I sort of vaguely knew about it, and, of course, you know, I am against human trafficking but I was not in the weeds on it. I did not fully understand the ramifications and the magnitude of this issue until a woman named Julie Janovsky, who, at the time, was head of a group called the Polaris Project, came to my office and sat with me and educated me about this issue. After that meeting, I said I want to make this one of my top

priorities, and it was her efforts that really brought this to the attention of so many people in the State of Pennsylvania. So, thank you to her, thank you to the Polaris Project, thank you to Senator Greenleaf and to my staff, and to everyone here who has worked to eliminate and to combat this horrible, horrible crime of human trafficking. I urge a "yes" vote on the amendment and a "yes" vote on the bill when we consider it, and then we can all go home and say that we have saved lives here in the Pennsylvania Senate and the Pennsylvania legislature this year, and there is not much better you can say than that.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, I rise to fully support the amendment and fully support the bill, and to thank Senator Greenleaf and Senator Leach, and all of who have been involved on this piece of legislation. This is an important piece of legislation. Do you know that human trafficking, slavery, is still alive and well in Pennsylvania? Who would have ever dreamt, as we look at that picture of Lincoln in front of us from the Battle of Gettysburg, who would have ever dreamt that 150 years after the Civil War, that slavery is still alive and well in this Commonwealth? But with this bill, we are going to eradicate it once and for all and good people will, again, prevail in the Commonwealth.

Senator Greenleaf mentioned, Mr. President, that it is unbelievable the dimensions of human trafficking and slavery worldwide, that after money is spent in the drug trade, the second-largest illegal global operation is in the trading of human beings. This is now even larger than the trading of weapons, believe it or not. We good people have to arise and people of faith have to say enough is enough. We need to stop human trafficking both here in the Commonwealth and globally.

You know, Mr. President, that human trafficking is not just in a few hidden places in Pennsylvania. It is all over. It is in the suburbs, it is in the cities, it is in the rural areas, and we have to stop it. Human trafficking takes place in two different dimensions. The first dimension, Mr. President, is that it is our own citizens, usually young people from 12 to 18 years old who run away from home. Then, the statistics show us that within 48 hours, one of three such runaways are approached in the street by someone who pretends to be a friend and they end up in prostitution and other sex-related types of activities and they are trafficked. We need to protect our young people in this Commonwealth, and this bill goes a long way in doing it.

But the other types of human trafficking involve people coming from abroad, coming into this nation illegally who then are stripped of any documents, who are held virtually as prisoners and are either forced into the sex industry, or their labor is exploited in sweat shops. One thinks, and one had hoped and prayed that these types of activities had ended in this nation. It is tragic that they still exist, but thanks to this bill, and thanks to this Senate, and hopefully the House, and hopefully with the signature of the Governor, that once and for all this State, which had been the center of the emancipation movement, this State, which had been the center of the abolitionist movement to end slavery, this State, which is so proud of its role in the Civil War which ended slavery, that this State will once again arise and be a model and example for this nation as we together, as all good people, people of all faiths, people of all colors, and all genders,

and all ethnicities, together will say once and for all the words that we have learned from Martin Luther King, "Free at last, Free at last, Great God a-mighty, We are free at last." That is what we aim to do with this bill. We want all people in this Commonwealth to say that together, "Free at last,...Great God a-mighty, We are free at last."

Thank you, Mr. President.

And the question recurring,

Will the Senate agree to the amendment?

Senator BAKER, Mr. President, Senate Bill No. 923 will expand an essential program of the Pennsylvania Department of Military and Veterans Affairs that helps military families who are facing critical needs. The Military Family Relief Assistance Program was launched in 2005 as part of the "Support our Veterans' initiative. The program has, indeed, supported our soldiers for the past 8 years with grants totaling up to \$3,500 in emergency aid. Consider some of the past recipients of this program. One applicant was wounded during deployment and could no longer work. While waiting for his incapacitation pay to begin, his mortgage and household bills became overdue. Another soldier with PTSD was without a job but searching desperately. He had no place to live because he could not afford the security deposit on an apartment, or the cost of setting up his utilities. These are just a few of the richly deserving recipients of the MFRAP program. Unfortunately, many others do not qualify for help: the father who is behind on his bills due to unexpected costs of a severe car accident; the mother who lost her job and does not have money to pay for heating oil; the family who is displaced because of a fire in their home. They have fallen on hard times through no fault of their own after laying their lives on the line for our country. Thanks to the generosity of many Pennsylvanians who voluntarily checked off a donation on their personal income tax refund, we could be helping more soldiers and more military families like these struggling heroes. Money does currently exist in the program that is not being used because the guidelines are too narrowly drawn.

So, this bill extends the program through June of 2020, and it expands the rules in significant ways like helping with any emergency circumstance such as a death, a fire, a job loss, and those that are not just related to deployment. The eligibility would be extended for 3 years after deployment instead of the 1-year term. It is wonderful that many Pennsylvanians have been so generous in taking care of veterans with these short-term crises without hurting the long-term stability of this fund. Military families have called this program a lifesaver, so I thank you for considering this important bill. Its passage will be a belated Veterans Day thank you and an early Christmas present for those who have given so much. I urge an affirmative vote.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, I rise to also support this legislation, and I commend Senator Baker for the great job that she has done on behalf of service people. Pennsylvania has probably the highest level of National Guardsmen and women who have deployed to Iraq, Afghanistan, and other places around the world. The effects of these deployments on families is sometimes insurmountable. Senator Baker is so right that both the economic and emotional impact is something that is not always immediately felt, and so expanding this program's eligibility out from 1 year to 3 years is so sensible and so important. So, I commend her for really just a superb job on improving this program and we look forward to continuing to support our servicemen and women for the unbelievable job they do here and around the world keeping us safe. When we were closer to September 11, 2001, we were much more focused on this, and as the years have gone by, we seem to have let ourselves not really focus on the fact that these are people doing this job now, keeping our country safe, and fighting for us. So, I rise in support of the legislation. It is something that we all really need to keep in mind and I think we do it in a bipartisan way as Republicans, Democrats, Members of the Senate, and Members of the House. We support our men and women who are in uniform.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, I just want to make an announcement and to, hopefully, speak very briefly about an important issue affecting so many of our elderly, our older residents, not only here in our great Commonwealth, but certainly all older residents, 62 and older across this great country. It has to do with the whole issue of Social Security and Medicare, specifically efforts that are being made or proposed, both by the Obama

administration, some Democrats, and many Republicans in the U.S. Congress, who are speaking about curtailing benefits to Social Security and to the Federal Medicare program, a very wrong-headed approach, as far as I am concerned. I am sponsoring a nonpartisan luncheon, an educational forum, this Friday under the theme of "No Grand Bargain." Basically, this will be a luncheon at 12 noon in Oakland. Folks can call my office about it. The fact of the matter is that what is happening are various proposals that are part of a so-called grand bargain, a debate, basically, over the Federal budget deficits, and as I indicated, both the Obama administration and others have proposed changes to the formula that determined benefit levels for Social Security and other government programs, as well as the income tax brackets, switching to a relatively new formula, the so-called chained CPI. that would help the Federal government save money by slowing increases in benefits and raising additional tax revenues. Proponents of this proposal argue that the chained CPI is a more accurate formula and that any impact on beneficiaries of the government programs affected would be mitigated by increased tax revenue from the wealthy. However, research and data effectively refute those arguments by showing that, one, switching to the chained CPI would result in cuts to already modest Social Security benefits. Secondly, it is likely that the chained CPI is not an accurate measure of the inflation rate seen by most of our seniors, and, number 3, the chained CPI would lead to tax increases for working Americans.

I will not go through a lengthy explanation of the chained CPI. but at the forum on Friday over lunch we will welcome a number of speakers. The president of the United Steelworkers Union, Leo Gerard, will be speaking. We have also invited Professor Wayne Burton, who happens to currently be the statewide president of the Pennsylvania Alliance for Retired Americans. We have a financial policy analyst from the Center for Economic and Policy Research from D.C., her name is Nicole Woo; and Dr. Andrew Coates, a very good friend, he is the president for Physicians for a National Health Program. He is an internist from upstate New York and a member of the Fellow of the American College of Physicians. As well, we have local folks, like Ed Grystar, who is a union leader in western Pennsylvania who has very much been identified with the whole initiative toward a single-payer healthcare approach. It will be a very informative and important luncheon. Folks who are interested in attending can call my district office at 412-621-3006.

Again, there has to be a little bit of an effort made. A lot of times when we see legislation sneak through the legislature, whether it is here at the State or even at the Federal level, it happens sometimes late at night or during the holiday season when a lot of folks are not necessarily focused on what the legislative agenda or antics are up to. I would hate to see that in the committee that has been created by the Congress and the President, who have been meeting pretty much privately around the so-called budget deficit, the sequestration issue, and this notion of a so-called grand bargain, that the folks who will be losers under any scheme are really not that actively involved or aware of what is going on. I think that is very unfortunate, and I think it is a mistake. The Congressional Budget Office did a study and it shows nationwide that the numbers from that study would represent a shift to the chained CPI--if they went to a chained CPI, it would lead to a reduction in benefits of \$1.6 billion in 2015, \$14 billion in 2020, and \$23 billion in 2023, which is the last year in the CBO budget, a 10-year budget horizon.

My point is, look, the state of our economy is not that great. The state of the economic livability of our residents across the Commonwealth and across this great nation leaves a lot to be desired. The income gap in our society, the disparity gap, is the greatest it has ever been in the history of our economy, dating back to the early days of industrial capitalism. More and more people are leaving the middle class and it is almost accepted now that we have no more middle class. You are either part of the very wealthy in this society in our great country, or you are those individuals who try to eke out an existence at the bottom rung of the economic ladder. We need a strong middle class in this country in order for rich people to keep their wealth. The fact of the matter is, any notion of further curtailment of benefits of Social Security I find reprehensible. Over 40 percent of the recipients of Social Security are primarily women and, in particular, despite the notion of the philosophy of the three-legged stool, that when people are working in their career they try to not only pay into their Social Security account, they work for better wages, and they also, hopefully, can set aside money in a 401(k) or pension plan, but the fact of the matter is, many people only survive on the limited Social Security benefit. Not everybody has the benefit of either a public sector job, a unionized job, or even a private sector job that would pay them enough to either have a formal pension and/or a 401(k) or an IRA savings account. That is the harsh reality, and when we see the disparity growing greater and greater, the last thing we need to be talking about is further curtailing the minimal benefits available under Social Security. If anything, I would tend to encourage folks to re-read a speech given by Senator Warren recently on the floor of the U.S. Senate where she very eloquently and articulately states a proposal that we should be talking about raising the Social Security benefit and the COLA for older recipients of Social Security who have even less income on a monthly basis.

So, this luncheon will focus in on the grand bargain, which should be rejected, and will try to explain to people why a so-called chained CPI is not in the best interest of working people, and certainly our retirees. I hope people come out and try to better understand these issues, and to the extent that they may want to become advocates, I encourage them to do so. This is a nonpartisan luncheon, it is not meant to recruit anybody on any side of the issue. Folks who may not agree with me on this proposal and my own views on it are welcome to attend. Again, it is nonpartisan, or bipartisan, or whatever you want to call it, and I encourage folks to attend and really get involved in a battle that will ensue when we see that the Federal government will once again try to lower the guillotine on those who have the least in our society, something that I would hope that we would all reject.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Mr. President, I will be brief. I want to take this opportunity to wish all of the residents of the Commonwealth of Pennsylvania a very happy and blessed Thanksgiving. I know we left before Thanksgiving, it is a couple days after, but it is a great time for us to, once again, renew our friendship and our ties with our family and our friends, and to realize all of the good that has been given to us in our lives. There is a lot of complaining going on in the world and in the Commonwealth, but a lot of our blessings have been bestowed upon us from our Cre-

ator. I wanted to take this opportunity to say to everyone in the Commonwealth of Pennsylvania to reflect upon those blessings our health, our families, and our friends; a State that is doing its best economically and weathering through the crisis that we are seeing worldwide with the economic downturn. So, I want to take this opportunity to thank the Almighty for watching over us and trusting in Him that He will deliver to us better days.

Mr. President, if I could, too, just briefly say that there has been a lot of coverage on the transportation bill which was recently passed. One thing that the newspapers are not--and I should not say just the newspapers--one thing that the news reporting service is not ascribing to in the transportation bill is that the day this bill becomes an act--the Governor did sign the bill--the 12cent flat gasoline tax that we pay at the pump goes away. I will repeat that. That 12-cent flat gas tax that has been in effect since the 1990s here in the Commonwealth of Pennsylvania goes away. With the oil franchise cap being lifted, and the tax now being put on the oil and gas companies, recognizing that they are profit-making machines--we see that because gas in my district went up 30 cents in 2 weeks' time, there was no hurricane that took out any refineries and there was no war going on, which are their usual excuses. So, recognizing that they are profit-making machines and that they would probably pass down some, if not all, of that cost on the consumer, we eliminated that 12-cent flat tax at the pump.

So, I want to make that clear as we go forward. In the first year, there will not be this tax jump that is being reported. If the gas prices go up 28 cents or 30 cents next year, you know where to look because the oil franchise tax that was lifted, that artificial cap, is phased out over 5 years. So, that fifth year is when you will see maybe a higher amount, but not next year or the following year, and if it is, it will be through someone else passing it through. I just wanted to make sure that was clear and that the people of Pennsylvania realize that this was not an easy vote to make. We are making sure that we are doing the best we could for the residents of Pennsylvania, not only insuring a safe and productive transportation infrastructure system, but we did eliminate that 12-cent gas tax that we have been paying since the 1990s.
