The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, in the interest of brevity, and since I am having a difficult time talking today, I simply will submit my remarks for the record. Thank you.

The PRESIDENT. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentleman from Philadelphia, Senator FARNESE:)

Mr. President, glaucoma is a group of eye diseases that gradually steal sight, without warning, through damage to the optic nerve. This disease group has no cure, although once diagnosed, medication or surgery can slow or prevent further vision loss.

It is the second leading cause of blindness according to the World Health Organization, with over 60 million suspected cases worldwide. Over 2.2 million Americans have glaucoma, half of whom are not even aware they are suffering from the disease. More than 120,000 Ameri-

cans are blind due to glaucoma, and prevalence in African Americans and minorities is considerably higher than in Caucasians.

The Glaucoma Service Foundation, located in my district, has a mission to preserve or enhance the health of all people with glaucoma and to provide a model of medical care by supporting the innovative educational and research efforts of the physicians of the Wills Eye Hospital Glaucoma Service, the largest glaucoma diagnosis and treatment center in the United States.

Senator RAFFERTY. Mr. President, I will be brief. I want to thank the Members of the Senate for their unanimous vote on Senate Bill No. 1239. It is a very important piece of legislation dealing with Commonwealth vs. Musau, I believe the name of the defendant was, a decision by our Superior Court that found a word "notwithstanding" within the DUI statute and rendered the whole subsection underneath it null and void. Therefore, it had a terrible and chilling effect on DUI convictions of second offenses, third offenses because of the Superior Court's decision. So, working with the DA's Association and working with the law enforcement community, Ryan Boop, my chief of staff, and I drafted the legislation. We took exactly the words that the Superior Court recommended be put in the statute, we took those exact words and put them in Senate Bill No. 1239 so we can get this bill to the House of Representatives, through the House so the Governor can sign it so that subsequent DUI convictions will count toward additional time. I appreciate the Senate's consideration and vote in the affirmative.
