I guess I would announce her today as "The Star of the County Down." She traces her lineage back to Ireland, and her name is Mary Brown. She is a Marywood University graduate student. Her undergraduate degree is in social work and administrative studies from Marywood University. Mary received an honorable mention for the Jenkins-Colis Gilroy Medal for Excellence. Mary is a member of the Alpha Delta Mu Honor Society and is currently interning in my office in Scranton. She is facilitating an affordable housing forum on April 4 where PHFA will participate back home in the 22nd Senatorial District. Mary was recently acknowledged with an award for excellence in policy experience for her student placement work while she has been in my office. I would appreciate a warm welcome for Mary Brown.

GUESTS OF SENATOR JAY COSTA PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I am pleased today to welcome to the Senate the State champion Woodland Hills Wolverine Rifle Team. Mr. President, the team competed with precision and had an outstanding season as they faced very tough rivals, Trinity and Hempfield. Mr. President, the Woodland Hills Wolverines captured the WPIAL Section 2 Team Rifle Championship and then went on to win the WPIAL Team Rifle Championship as well. They began their play early in December with the win against, as I mentioned earlier, Trinity, and proceeded to roll through their season posting 16 perfect 800 scores out of a possible 17, only 1 point dropped all season long. Mr. President, the Wolverines' record was a team record for our high school.

At the WPIAL championships in February, the team captured the WPIAL title for the second time in the past 3 years and their performance was an all-time record-breaking score for that particular event. Mr. President, eight Wolverines were named to the WPIAL all-tournament team. At the WPIAL individual tournaments in February, four of these athletes placed in the top 10 in the WPIAL - Mike Krivi, Becca DeVito, Maria Brucker, and Sonny Breeger. These young men and women all qualified to compete in the PIAA Individual Rifle Tournament where they all placed within the top 10 status for the Commonwealth of Pennsylvania. Mr. President, no school has ever had four shooters place in the top 10 in this event. At the end of February, the team then competed in the PIAA team championship. They overcame all the competition to become the first of any team in Woodland Hills High School to win a State championship, and five Wolverines were named to the State all-tournament team.

Mr. President, I am very pleased to have here with us today their coaches, Matt Rodrigues and Mario Saramouche, as well as volunteer coaches, Brendan Boyle and Dan Chapman. Some of the team members, Mr. President, whom I have known for many years, are team captains, Miranda Johnson and Laura Valenti, who not only are great rifle people, but they are also good battery in softball. I can tell you that from personal experience. The team is also joined by Maria Bruker, Nick Fisher, Mike Krivi, who I mentioned, Seamus McGuigan, Jake Klimko, Miguel Breight, Becca DeVito, and Sonny Breeger. I am very honored and proud to welcome this fantastic group of young student athletes from the Woodland Hills High School and from the 43rd Senatorial District, and extend congratulations to the team, their coaches, and their families on a record-breaking season. I ask that my colleagues give these individuals a warm Senate welcome.

**SPECIAL ORDER OF BUSINESS
ELECTION OF THE CHIEF CLERK
OF THE SENATE**

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, as a special order of business, I ask that the Senate proceed with the election of the Chief Clerk of the Senate.

With Donetta D'Innocenzo, I feel confident we have found the right individual who will serve with integrity, independence, and a commitment to excellence. She will be the first woman in Pennsylvania history to serve in this role, but Donetta is well accustomed to being a leader after working in State government relations for almost 30 years. I am sure you are all aware by now of Donetta's impressive resume and recognize that she possesses a wealth of knowledge of business management, State government, and strong leadership skills.

Serving as Chief Clerk of the Senate requires respect for the institution, being a strong organizer, and ability to work effectively in a very bipartisan manner. Donetta brings to the table previous experience working as Chief Clerk, having served as the Acting Chief Clerk in the 1990s as well. I know Donetta will be an outstanding addition to the Chamber and provide excellent management as Chief Clerk of the Senate. Since December, when Donetta began to serve as Acting Chief Clerk, she has been working diligently to meet with Members of this body, learn every aspect of the position, and has done an excellent job of managing her responsibilities. And I am sure that after meeting with Donetta, you will agree with me that she is independent, that she is approachable, and she is clearly motivated. She has a high standard of strong principles.

Her family and guests who are joining us today know how hard Donetta has worked to get to this point. I would like to recognize a former colleague of ours here, Judge Michael Fisher, and Colonel Joseph Greenfield, who are here with us today for this important ceremony. We are also joined by three individuals who we can truly say know the journey Donetta is about to begin. We are very pleased to have with us today former Chief Clerks from the Senate: Russ Faber, Stanley Rapp, and Gary Crowell, each of whom served this Chamber with distinction. I know that Donetta will continue with that legacy and serve with integrity while bringing her unique style and attributes to this very important role. I look forward to serving with her and continuing to make this Chamber an open, bipartisan institution that we can all be proud of.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise to second the nomination of Donetta D'Innocenzo to serve as Chief Clerk of the Pennsylvania Senate. For nearly 30 years, Donetta has been involved in various aspects of State government. She is knowledgeable and experienced, forthright and earnest. She is a leader, as was mentioned, and is someone who has skillfully handled difficult tasks. I think it is very clear that Donetta's past experience illustrates the kind of person that she is and what she is capable of doing in the future. For the last decade or so she worked in the private sector for a company that closely interfaced with government. In this job, she had to learn quickly and be knowledgeable about the workings of the General Assembly and its Members, while simultaneously building relationships and credibility with not only Members, but also staff. Before she moved into the private sector, Donetta served as a bureau director for the Department of General Services and was director of communication services, comptroller, and as was mentioned, for a time even served as the Acting Chief Clerk here in the State Senate. Her vast experience and knowledge will benefit her and will be beneficial here in the Senate as we begin to tackle many new challenges.

The Chief Clerk of the Senate's job is multifaceted and involves multitasking for making sure that the institution's bills are paid, insuring that there are quality and cost control measures in order to experience expertise about our financing and operating rules and how they apply it to difficult situations. There is no question that the job could be difficult. A quality Chief Clerk is a person who can both stand firm and work through problems at the same time, and because of her experience here, Donetta is well aware of how the Senate operates and what makes this institution work well. For many years the Senate has been served by Russ Faber as our Chief Clerk. He has done an excellent job and set the bar very high. I think Donetta is a wonderful selection to follow in Russ's footsteps. Mr. President, I sincerely believe that Donetta has the qualities, experience, and background to be a superb Chief Clerk. I think she will do well because she understands that the Senate is made up of 50 individual Members from two different parties with lots of different characteristics and personalities who come together to do a job for all of the citizens of Pennsylvania.

Mr. President, I believe that Donetta understands that in her job, partisanship has no place. Fairness, balance, and honesty are the attributes that a respected Chief Clerk needs in order to succeed, and I believe that Donetta has those traits and would be successful in serving Members on both sides of the aisle. For those reasons, Mr. President, it is without equivocation that I second the nomination of Donetta for Chief Clerk, and I ask my colleagues for an affirmative vote.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, I rise today to also second the nomination of Donetta D'Innocenzo to serve as Chief Clerk of the Senate of Pennsylvania. The nonpartisan office of Senate Chief Clerk has existed for at least 80 years. It is an institutional office. It is a nonpartisan office. In addition to the

duties that previous speakers have mentioned, it includes the important job as the Senate's open records officer and the secretary to the COMO committee. Essentially, in private terms, the Chief Clerk acts as the Senate's chief financial officer, a very important position serving Members from both sides of the aisle, serving staff in that most sensitive and confidential area of finances. Certainly, as we have heard, Donetta has the experience and training to fulfill that job, but what that position demands, above experience and training and knowledge, is integrity and fairness beyond question, and Donetta certainly has those unique and rare qualities which will serve her well in that position. I am certain that she will serve in that position with distinction.

It is very gratifying to me to see the previous Chief Clerks of the Senate here today to share in her special beginning of her journey, and hopefully her journey will be as long as some of the previous Chief Clerks who are here with us today. Mr. President, on behalf of Members of the Senate, I extend my best wishes to Donetta and her family on this momentous occasion and wish her a long and successful tenure. Again, Mr. President, it is my honor to second the nomination of Donetta D'Innocenzo to serve as Chief Clerk of the Senate of Pennsylvania.

Judge FISHER. Mr. President, it is a great honor for me to be here to administer this oath of office as a former Member of this body and as someone who knew Donetta when she first came to the Senate. Donetta actually taught me how to turn on a computer. And as someone who also has known her husband, Jim, for many years as he served as the chief of staff for me when I was in the Senate for many years. So, it is a real honor and privilege for me to be here this afternoon.

Please place your left hand on your Bible and raise your right hand and repeat after me:

(Applause.)

(iv) Caregivers in family day care homes which are subject to registration by the department under Subarticle (c) of Article X of the Public Welfare Code and their employees who have direct contact with children.

(2) Within six months of the effective date of this subsection, operators and caregivers shall receive three hours of training prior to the issuance of a license, approval or registration certificate and three hours of training every five years thereafter.

(3) Employees who have direct contact with children and foster parents shall receive three hours of training within six months of the issuance of a license, approval or registration certificate and three hours of training every five years thereafter. New employees and new foster parents shall receive three hours of training within 90 days of hire or approval as a foster parent and three hours of training every five years thereafter.

(4) Training curriculum shall be approved by the department and shall address, but not be limited to, the following:

(i) Recognition of the signs of abuse and reporting requirements for suspected abuse in this Commonwealth.

(ii) For institutions, facilities and agencies under paragraph (1)(i), their policies related to reporting of suspected abuse.

(5) A person may be exempted from the requirements of this subsection if all of the following apply:

(i) The person provides documentation that the person has already completed child abuse recognition and reporting training.

(ii) The training was:

(A) required by section 1205.6 of the Public School Code of 1949, and the training program was approved by the Department of Education in consultation with the department; or

(B) required by this chapter and the training program was approved by the department.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, thank you for the opportunity to speak briefly. A little bit of a brouhaha has been set off in Pittsburgh. Due to a lack of knowledge and misunderstanding, if not arrogance, by an attorney who is participating in a binding arbitration panel who basically ruled in an attempt to override the law of the land during a collective bargaining arbitration on the issue of city police residency. This gentleman ruled, notwithstanding our legislation and clear law in the city of Pittsburgh, which requires all employees, including all public safety employees, including police, to at all times be domiciled and live within the city of Pittsburgh's boundaries. Clearly, under previous legislation passed by this body and approved into law, it is clear that any individual around the country or in the region or throughout the State can apply to be a police officer in the city of Pittsburgh. They can be conceivably hired, but at the point at which they are affirmatively hired, they must be domiciled, they must live within the city of Pittsburgh's boundaries. This arbitrator basically has turned things topsy-turvy in an area violative not only of city law and code of ordinances, but in violation of a legislation that was amended a couple of years ago by this Chamber, and basically has caused a lot of confusion within the city of Pittsburgh.

I am very concerned because one of my colleagues on the aisle opposite really created some disinformation in an article in the Post-Gazette over the weekend. So, I just want to state the following. First of all, as it relates to the article in the Post-Gazette, the arbitrator, in essence, would allow Pittsburgh police to reside outside city limits, and that action suggests that it be done almost immediately, within 24 hours. This is an order issued but unsigned by the city member of the arbitration panel. It would take place basically in a matter of just a few hours, which would have been Friday or Saturday, over the weekend. But he incorrectly stated that State law has been changed so that the police residency requirement can be lifted through the Act 111 arbitration process. Nothing could be further from the truth. According to the draft arbitration award, the city residency requirement for police will be lifted and replaced with a 25-air-mile residency requirement, basically nullifying the long-held standard of all police officers at the point

at which they are hired, and maintaining their employment, be domiciled in Pittsburgh. A 25-air-mile residency geography pretty much puts police officers at the border of Ohio, West Virginia, and the northern tier of Pittsburgh proper.

The basis for this change is a re-opener clause in the police contract that states if there is a change in State law allowing city residency to be lifted, then it could be subject to Act 111 contract negotiations. While Act 195 of 2012, which amended the original Act 265 of 1951, did amend the relevant law regarding Pittsburgh police residency, it did not make the requirement subject to Act 111 proceedings. There is a big difference there legally. The act now states very clearly, since I wrote the amendment to what was originally an Orie bill that wanted to push through residency and negate the police residency requirement, it was reintroduced by Senator Ward in this Chamber. She had nothing to do with the writing of the amendment that was adopted and she misspoke or actually was very insulting to me in the Post-Gazette article.

The act now states that a city of the second class may require a police officer to become a bonafide resident of the city as a condition of employment. Again, a city of the second class may require a police officer. It did not extend that to other laws involving the collective bargaining and binding arbitration process. It only suggests that the local political elective jurisdiction - the mayor and city council - if they so chose or choose to enact a change in the code of ordinances of the city of Pittsburgh, that they would be allowed to make that prerogative locally, as every other community in the Commonwealth does.

I remind my colleagues that overwhelmingly, most colleagues in this Chamber who represent urban areas, and even small towns and townships, agree with residency. Most communities, overwhelmingly, want their police at all possibility, especially their local volunteer firefighters, to be residents of the particular area in which they are serving. So again, this legislation that we approved with amendment only provided opportunity for the local city council, the local mayor, in this case the city of Pittsburgh, if they so chose to amend their code of ordinances. However, just to be clear, that never happened; it is never going to happen because at least the past mayor, we have yet to hear from the new mayor, but clearly the political local establishment has refused to modify the residency requirement.

More importantly, this past November in the general election, whenever it was, November 6, I guess it was, Pittsburgh voters voted overwhelmingly to make an amendment to their own Home Rule Charter in the city of Pittsburgh, which I think passed by more than 80 percent, emphatically stating that police must live at all times, be domiciled in the city of Pittsburgh.

I want to make it clear that from the beginning of the adoption of the Pittsburgh Home Rule Charter back in 1974, I was one of many citizens testifying in council chambers, long before I was formally elected, the Home Rule Charter was very clear about city employees living within the city boundaries. That has always been in the charter, and more importantly, was adopted as the code of ordinances just a couple of years later. So, for more than three or four decades, it has been clear to everybody, it is a matter of employment contract, everybody who works and gets a job in the city of Pittsburgh, in-

cluding police, fire, paramedics, white collar, public works, you name it, they know they must live in and be domiciled in the city of Pittsburgh. Nothing we did in modifying the recent law would suggest that the binding arbitration process, or in this case, this arbitrator, had any jurisdiction or legal authority whatsoever to do what he did. So, it is certainly my hope, and I would hope that the members of city council, and the new mayor, Mayor Peduto, will immediately file a temporary restraining order, TRO, in an appropriate court of jurisdiction as soon as possible. They should not wait 30 days to appeal this and give the benefit of doubt to an arbitrator who I think lives way out in Upper Merion, or somewhere out in the southeast. I do not know where he lives, but he sure as hell does not know anything about the city of Pittsburgh and what the law is. He should go back to law school because he apparently cannot read the English language very well.

I want to make clear this is an outrageous act, violative of our own law that we passed statewide, violative of the Home Rule Charter, violative of the city code of ordinances, and violative of what is good public policy. You could argue, and I guess the police have argued some merits that they feel about living outside the city of Pittsburgh, and that is their right to do that. I do not disrespect the police for wanting to proceed as a matter of policy, or as a matter of their own rank-and-file interest, but that interest and that advocacy should be directed to Pittsburgh City Council and Mayor Peduto to change the Home Rule Charter. They cannot do it through the back door, and nothing we did in this Chamber, notwithstanding the ridiculous comments made by an individual on the aisle opposite over the weekend in a news article, would suggest that we have done that.

So, I want to clarify that and, again, I call upon the Pittsburgh City Council to defend their integrity, to defend the Home Rule Charter, to defend the city code of ordinances, and to defend the employment contract. It will create a lot of havoc over the next few weeks, and I would hope and pray that the city government immediately files a temporary restraining order in an appropriate court of jurisdiction and not wait 30 days. It is a bad defense move and will create an environment which some judge may feel, well, they did not care quick enough to file a TRO and now a judge is going to be confused about what he or she should be doing. This should be very clear. The written ward [*sic*] and the law is very clear -- I said "ward" because I am upset with Senator Ward for her comments in the newspaper. I meant to say "word," not "ward." So, I apologize for that. In any event, I hope that we can move on.

Thank you, Mr. President. And happy St. Patrick's Day.

Senator RAFFERTY. Mr. President, I want to take this opportunity to wish the Members of the Senate and everyone at home watching on PCN a very happy and holy St. Patrick's Day. May they all enjoy the vestiges of being Americans of Irish ancestry, or at least for one day pretending to be. Senator Smith and I were just talking about all of the festivities happening today and we want to take this opportunity, and I want to take this opportunity, to wish everyone of Irish ancestry a

very happy St. Patrick's Day, and those who want to celebrate today, a very joyous occasion with spring just around the corner. Happy St. Patrick's Day.

The PRESIDENT. The Chair returns the wish to him and wishes everyone a happy St. Patrick's Day.

The Chair recognizes the gentlewoman from Philadelphia, Senator Washington.

Senator WASHINGTON. Mr. President, I rise to support my friend and colleague, Senator Mensch, and to thank him for introducing his very important resolution. As many of you know, I am a survivor of child abuse and this cause is very dear to me. For the last couple of years, we have been working very hard on a package of bills to strengthen our child protection laws and insure that no child has to live in fear or shame the way I myself and many others had to. We have made great strides in our efforts to pass the package of bills, but we have more work left to do. I hope that we can continue to advocate for our children during child abuse prevention month. We can finish the task of overhauling the way we define, address, investigate, and prosecute such terrible crimes.

Again, thank you to my friend from Montgomery County for being a true champion for children. I encourage my colleagues and thank them for their support on the resolution.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President, I want to take this opportunity to thank my friend and colleague, Senator Folmer, for pushing through a very, very important bill, Senate Bill No. 437. About 2 1/2 or maybe 3 years ago, the bill, which seemed like it was moving, then all of a sudden it stopped. I talked to my very good friend, Senator Dinniman, because he was on the committee, and I said to him, what can I do, because I do not want to give up on my bill. It is a bill to boost ROTC, to really make it into the wonderful program that it has always been but will be enhanced because the instructors are people who have at least 20 years in the military, thanks to this bill. I think that our children who want to see that training and want to be a part of it, we owe it to them to do our very best. So, Senator Dinniman kept it in front of Senator Folmer, who pulled the train, who took the bill, and Lieutenant Cianfrani from the Philadelphia School District, who is representing the military, and I am happy to report that now it is law. Those qualified men and women can help our children make the most of this program. So, Senator Folmer, I publicly thank you, and I love you.
