HB 43 (Pr. No. 3541) (Amended)

An Act amending the act of December 4, 1996 (P.L.893, No.141), known as the Volunteer Health Services Act, further providing for purpose and for definitions; providing for approved organization procedure; and further providing for liability and for prescription of medication for family members.

HB 272 (Pr. No. 3542) (Amended)

An Act amending the act of May 1, 1933 (P.L.216, No.76), known as The Dental Law, further providing for definitions, for general powers of the State Board of Dentistry, for reason for refusal, revocation or suspension of license or certificate, for penalties and for reporting of multiple licensure or certification; and providing for restricted faculty license.

HB 336 (Pr. No. 3543) (Amended)

An Act amending the act of July 2, 1993 (P.L.345, No.48), entitled "An act empowering the General Counsel or his designee to issue subpoenas for certain licensing board activities; providing for hearing examiners in the Bureau of Professional and Occupational Affairs; providing additional powers to the Commissioner of Professional and Occupational Affairs; and further providing for civil penalties and license suspension," further providing for definitions and for civil penalties.

Senator VULAKOVICH. Mr. President, I rise today to call on my colleagues to support Senate Resolution No. 325, recognizing May 7 as "Pennsylvania Health Care Information Technology Awareness Day." In terms of e-health, Pennsylvania continues to make extraordinary progress in improving the quality of life in our citizens through technology. As information is more easily accessible, we are seeing a healthcare environment where treatments and diagnosis are achieved more efficiently and with less delay. This is especially important when time is of the essence, such as in emergencies and when treating critical illnesses and diseases. Numerous clinical studies have shown that healthcare professionals make better, quicker decisions, have better accuracy, and outcomes dramatically improve when they have comprehensive background information about their patients. Then there is another benefit of electronic information sharing, and that is reduced costs. Immediate results can be seen by reducing paper cost, which eliminates the need for bulky storage and excessive staff time. Additional savings are achieved by eliminating the need for unnecessary tests and duplication of tests. Both of these actions result in immediate savings in the healthcare office and reduce the need for medical insurance claims. As this new exchange of information develops and grows, I believe we will see even more benefits for providers and consumers.

BILLS ON CONCURRENCE IN HOUSE AMENDMENTS

SENATE CONCURS IN HOUSE AMENDMENTS

SB 31 (Pr. No. 1849) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending Title 23 (Domestic Relations) of the Pennsylvania Consolidated Statutes, in child protective services, further providing for definitions, for persons required to report suspected child abuse and for investigating performance of county agency; repealing provisions relating to definitions, school employees, administration, investigation, responsibilities of county agency for child protective services and report information; and further providing for services for prevention, investigation and treatment of child abuse.

On the question,

Will the Senate concur in the amendments made by the House to Senate Bill No. 31?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, I move that the Senate do concur in the amendments made by the House to Senate Bill No. 31.

On the question,

Will the Senate agree to the motion?

The PRESIDING OFFICER. The Chair recognizes the gentleman from Allegheny, Senator Fontana.

Senator FONTANA. Mr. President, I rise today to urge concurrence on Senate Bill No. 31. Mr. President, this legislation will clarify and strengthen child abuse reporting in our schools. Today's vote is the culmination of nearly a decade of advocating and fighting for the passage of this bill. This legislation was written long before any of the recently passed child protection bills. Mr. President, I want to thank all of my colleagues for their consistent, unwavering support of this bill, and especially to my staff, going all the way back to my former chief of staff, Amie Downs, to my current chief of staff, Colleen DeFrank, and also

my Caucus staff who helped guide this bill through, and to Senator Pileggi and his staff for keeping it on track these past few weeks.

Protection and safety of our children, Mr. President, should never be a matter of who is Democrat or Republican. It is always a matter between right and wrong. I want to also thank and acknowledge the Child Protection Task Force for placing a renewed emphasis on doing everything we can to protect our kids, including this proposal that I began talking about back in 2005 as part of the recommendations. Mr. President, this was borne from the unspeakable Sandusky scandal, and the task force spearheaded approval of numerous child protection bills that turned a lot of good, commonsense ideas into law. Senate Bill No. 31 would remove the different reporting requirements for school employees and put them on the same level as other mandated reporters. It would mandate that school employees report suspected abuse to both ChildLine and the school's administrator. Mr. President, I have told this story countless times in the past 9 years as to why I originally introduced this bill. In 2005, a constituent of mine walked into my district office and told me that her son had been taken to the emergency room with bleeding brushburns, choke marks around his neck, and broken blood vessels in his face, all caused by a teacher in his school. Even though the mother, ER doctor, and social worker all tried reporting the incident to ChildLine, they were told that the law prevented investigation.

Mr. President, I could not believe that our State had a lesser child protection standard in our schools, but it did, and that is why I have re-introduced this legislation over and over and over again through the years since 2005. We have a public and ethical responsibility to protect our children and insure their safety in our schools. It does not matter who is suspected of abuse. Each case should be handled the same. Mr. President, this measure is long overdue, and I urge an affirmative vote on Senate Bill No. 31. Thank you.

Senator STACK. Mr. President, once again, I want to point out that I am studying how you stand there and how you conduct yourself because one never knows.

Mr. President, the resolution of which I am a cosponsor with Senator Leach asks Pennsylvania parents to take a few minutes to think about the unthinkable. Parents should not live their lives preoccupied with the idea that there is someone lurking around every corner to take their children away, but it does happen, Mr. President, and it has happened enough in this country to produce some significant need to make gains in the protection of children. It has been more than 30 years since the disappearance of Adam Walsh from a Florida shopping mall. That high profile case came on the heels of the discovery of 29 children across Georgia whose bodies were found in lakes, marshes, and on roadside trails. Out of these tragedies came better coordination among Federal, State, and local officials in responding to reports of missing children. We have seen the development of the AMBER Alerts and the establishment of fingerprinting programs in local communities. In the 30 years since the first "National Missing Children's Day," government at all levels have made tremendous strides in investigating reports of missing children, and we want to pause to respect that.

But National Missing Children's Day is also a time to remind parents that the best prevention begins at home. Parents should mark this annual event by taking some time to talk to their children about safety, about how they interact with strangers, and about strategies to prevent the unlikely, but not unknown, experience of abduction. The strategies include keeping a high-quality and very current photograph of their child and keeping close track of their activities. These are important conversations to have, and the days leading up to May 25 provide a really great opportunity to have those conversations.

Senator HUGHES. Mr. President, I want to thank my colleagues on both sides of the aisle. Yesterday, we introduced Senate Resolution No. 383 working through on this particular matter. The matter in question, Mr. President, is the issue of the abduction of at least 300 young schoolgirls from a school by the Boko Haram terrorist group in order to have these young ladies sold into slavery, sold into captivity, sold to be wives of individuals throughout the Nigerian country, and maybe other countries across the continent, and maybe around the world. We were able to work out, Mr. President, language and a process that allows us to have essentially the same concerns that we raised yesterday in Senate Resolution No. 383 addressed today and move through the Senate for immediate passage. Once again, just to remind this body and to remind those who are paying attention, and it does bear the need to repeat, but also to add some things that have occurred within the last 24 hours since we rose to this microphone yesterday. It appears that the original incident that occurred on April 14 in Chibok, Nigeria, has now grown to include

several other abductions, both historically that have occurred beforehand, but have occurred since the original abduction on April 14. The plight of these girls throughout Nigeria has grown and is a growing international concern and international outrage on this issue. It is our understanding that the U.S. government has sent support over to Nigeria to help facilitate the Nigerian government in finding these girls and returning them back to safety. I do not need to remind this body, but it is important to note that immediate rescue of these girls is important, because in the context of human trafficking, if something is not done immediately, this underground network of violent individuals who participate in this kind of activity will abduct these young ladies, transport these young ladies to places unknown, and they will be lost possibly for the rest of their lives, and for at least generations.

So, this resolution has importance because it sends a message that this Senate in this State is concerned about this issue for the life, safety, and security of these young ladies, who all they were doing was going to school to get an education. But it also sends a message that we are inextricably opposed and will do all that we can in the issue of human trafficking, because this is just part of a broader problem and that we need to address this problem in all of its forms. So, I want to thank both sides of the aisle for working together for enabling us to pass this resolution with unanimous support. I want to thank the Majority and the President for the cooperative effort and tone that was taken to get this thing done.

Thank you, Mr. President.

And the question recurring,

Will the Senate adopt the resolution?
