TUESDAY, February 3, 2015

The Senate met at 11 a.m., Eastern Standard Time.

The PRESIDENT (Lieutenant Governor Mike Stack) in the Chair.

#### **PRAYER**

Senator CORMAN. Mr. President, I move that the Senate do now recess for the purpose of a meeting of the Committee on Rules and Executive Nominations to be held in the Rules room immediately.

The PRESIDENT. For the purpose of a meeting of the Committee on Rules and Executive Nominations to be held immediately in the Rules room, without objection, the Senate stands in recess.

The PRESIDENT. The time of recess having expired, the Senate will come to order.

#### GUEST OF SENATOR DOMINIC F. PILEGGI PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Pileggi.

Senator PILEGGI. Mr. President, it is my pleasure this morning to welcome back to the Senate Donna Memmi Malpezzi, to thank her for her 41 years of dedicated public service to the Senate and to the citizens of Pennsylvania. Donna is here today with many of her friends, coworkers, and family. I would especially like to recognize some of them, starting with her mother, Kathryn Memmi. Modern politicians have their focus groups and pollsters, and whether Members of the Senate know it or not, we have had, for many years, Mrs. Memmi, who follows the news, I think, 24 hours a day, 7 days a week, and gives us her opinions on what is good and what is bad. So I thank you for that, Mrs. Memmi, publicly here today.

Donna is also here with her husband of over 30 years--I was not sure if it was 34--Dan Malpezzi, who is a partner at McNees Wallace & Nurick, a law firm based here in Harrisburg; her daughters, Katie and Sarah; her son-in-law, Kyle Patrick, who is Sarah's husband; her brother, Skip Memmi, who is a former Derry Township Commissioner; her brother, John Memmi, who Members of the Senate know as Director of Policy in the Senate Republican Policy and Development Office; and her sisters-in-law Molly Memmi and Diane Memmi. We are happy to have you all here today.

We have some special guests from the group of people with whom Donna has worked over the years, including former Senate Majority Leader David "Chip" Brightbill; PUC Commissioner Gladys Brown; Gaming Board Commissioners David Woods and Annmarie Kaiser; former Secretary of the Senate, and now member of the Ethics Commission, Mark Corrigan; former General Counsel to the Senate Majority Caucus, Stephen MacNett; and Legislative Reference Bureau Director Vincent Deliberato. I am sure I forgot someone, but I am sure that Donna appreciates you all being here to celebrate this event with her.

Donna began her career of public service in 1973 as a Page in the House of Representatives when Richard Nixon was our President. Some of the important names in Harrisburg in 1973 that I do not think anyone here had the pleasure to work with, maybe so, Governor Milton Shapp; Senate President pro tempore Martin Murray; and Speaker of the House Kenneth Lee. Donna went on from being a Page to be a legal aide to the legendary Matthew Ryan from 1977 to 1979, when Matt was the House Republican Leader. For a year in 1979 to 1980, she was a law clerk for Judge Warren Morgan of the Dauphin County Court of Common Pleas, then came back to the State from 1980 to 1987 as Deputy General Counsel to former Governor Dick Thornburgh. She came to the Senate first in 1988, as Chief Counsel to then Senate Majority Leader Joe Loeper, where she served in that position for 12 years; followed by service to Senator Chip Brightbill for 6 years; and followed another 4 years in that same position when I was Majority Leader. Donna then served the Caucus from 2010 to 2014 as General Counsel.

Donna brought with her to the Senate, in addition to her experience and legal skills, an extraordinary work ethic. Donna worked very long hours. I think every person in the cleaning crew who covered that part of the Senate knew Donna on a first-name basis. The security guards who worked the night shift

all knew Donna. And Donna told me that my greatest accomplishment as Majority Leader in the first couple of years was getting the Senate Security, I guess it was DGS at the time, to not close the big metal doors on the north side of the building, which when I first got here they used to lock, and Donna would have to walk around to the center door. I think that is still, in her view, my greatest accomplishment, which I was happy to do. They are still not closed and locked, if you notice. It was a direct result of the fact that she was here every night, literally, and walked out after dark.

Another example of her work ethic, she had some really serious and gruesome--I will not get into the details--medical procedures that she had to endure that I think most people would have taken a sabbatical or leave of absence, or otherwise consider if there is a disability provision in the pension plan. I do not think Donna missed, other than when she was under sedation, a day that she did not check the legislative Calendar, the drafting of bills, and literally had work brought to her home by staff so that they could conduct meetings at home with her. That is the kind of work ethic she brought to the service of the Senate.

She also, some of you might know that, and I think she learned a lot of this maybe back at the bakery, I am not sure, but she brought a sense of fiscal responsibility borne of thrift to just about every piece of legislation that passed through the Senate, and I think that is why she got along so well with the staff of the Committee on Appropriations--I see Greg Jordan in the back. Anything that cost money, Donna would be instinctively suspicious of. This has a fiscal impact; how much does this cost? And who knows how many dollars she saved taxpayers by that orientation over the years of her service.

Donna, during her tenure, also became a recognized statewide authority on legislative drafting and process, and developed a special expertise in issues involving healthcare and insurance. She has certainly earned the respect and admiration of her friends and colleagues, and the citizens of this Commonwealth, and this Senate has greatly benefitted by her service.

Mr. President, I ask that we recognize Donna on this happy occasion celebrating her many years of faithful service.

Thank you, Mr. President.

The PRESIDENT. Would the guest of Senator Pileggi please rise so that the Senate may give you its usual warm welcome. (Applause.)

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I, too, want to join my friend and colleague, Senator Pileggi, in recognizing and thanking Donna for her outstanding service, her 41 years of service to this Commonwealth. I want to also thank her family, because as Senator Pileggi referenced, many, many long hours have gone into the work that she has done here at various levels of government service, and we want to say thank you from the bottom of our hearts. I know I speak on behalf of our Senate Democratic Members, but I also feel that I can speak on behalf of our colleagues who work with you day in and day out. One sitting behind you is PUC Commissioner Gladys Brown, who I know the two of you are very close, and I know that when I speak for our General Counsel's office, C.J. Hafner and Ron Jumper, how they feel about the work that you have done and how you have worked very, very closely with them. So we want to say thank you, because our Members have always felt that we have always received a fair shake and a fair analysis of what needed to be done along those lines. So Donna, thank you.

As Members, we do not recognize and see the volume and the magnitude of the hours, research, and the work on legislation that goes on behind the scenes. Senator Pileggi talked about numerous bills that we have worked on. I can tell you, as you all know, a lot of work goes into the drafting of that legislation, looking at different things from different perspectives, raising awareness about potential problems or issues, that just does not happen. That happens because folks have done the research, the reading, have analyzed the legislation, and it allows us to be able to come and speak about the legislation on the floor. So sometimes we lose sight of the background work or the back office work, so to speak, that is being done. I know, Donna, the hours and years that you have provided to this Commonwealth, you have made this Commonwealth a better place. On behalf of our colleagues, we want to thank you and thank your family for allowing you to be a part of this Senate family.

So, all of the best to you in retirement. I know that we will continue to see each other and you will see your colleagues as you move forward into the next chapter of your life. We wish you all of the best, and the best to your family as well. Thank you again.

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, I did want to add one more introduction to the group that is here supporting Donna, and that is the Executive Director of the Office of Open Records, Erik Arneson, is here with us today.

(Applause.)

Senator CORMAN. Mr. President, obviously, Donna is an extremely skilled lawyer and an extremely skilled Chief Counsel, but as I said to her the day she talked about announcing her retirement, I did not really look at her as our lawyer. As a member of the Senate Republican Caucus, and I mean this as the highest compliment, I looked at her as our team mom. Now, as a father of two boys and a girl who play Little League baseball, the team mom has a very important role. We, as coaches, go out there and we are sort of the ruffian coaches trying to get the kids to do all of the things they want to do, and the team mom's job is to make sure that all of the kids are in the right place, doing the right things, and making sure they are getting their uniforms and all of the things they need to be getting.

In a lot of ways, as a member of the Senate Republican Caucus, Donna was the one who was making sure that we were all doing the right things, all in the right place at the right time, and doing it with that motherly touch that she has of being a mother. Making sure Senators stayed in our place, but not directing us, just in a motherly way putting us in our place, and it was done in quite an effective fashion. Like most parents when they are giving you advice or telling you no, which many times she had to tell us no, she did it in a way that you seemed to be okay with. You may not have understood it at the time, but later on you saw the wisdom of the direction that she was leading us. I do not know of many people who put the type of service in their careers that Donna did, going from Page to Chief Counsel. That is fairly unique, and my guess is it will not be repeated anytime in the near future. So thank you for everything you did for us. We look forward to your great times in retirement. I am sure you will be around giving counsel, and if we are smart, we will be taking it as you are offering it in the years to come. Thank you very much.

The PRESIDENT. The Chair recognizes the gentleman from Jefferson, Senator Scarnati.

The PRESIDENT pro tempore. Mr. President, certainly, Donna, my warm wishes to you in your not quite retirement, but leaving the Senate and having a new path in life. Senator Pileggi and Senator Corman both hit on, I think, very, very important descriptions of you in very different ways, but I can tell you that there is not anybody in the Senate who has referred to so many of us as honey as you have. What I can tell you is, being referred to as honey during the early years that I was here in the Senate, when we all come here with great expectations, great ambitions, and great ideas, we find out that we are working with a model of you need 26 votes here. Donna was always very good at sitting us down, especially during the budget, and saying, oh, honey, I know you want that, but it is just not going to happen. You know, I felt good about it. I felt good about myself. It was not as abrupt as some individuals could be.

I am a firm believer that our life experiences mold us in whatever paths or careers we take, and your life experience growing up in an Italian family with a bakery, you learned what no college and no public school could ever teach you. You learn how to work together, you learn how to cry together, how to rejoice together, and most of all, how to be successful together. You were just a great driving force here in uniting people. Those late nights, those many late nights when many of us here were on our way back up to get our vehicles at 10 o'clock after going to an event or a dinner, she was going out those doors with a lot of people who are sitting over there right now, putting in those hours. To the public that may be viewing this, when you want to throw some darts or throw stones at those who work in this building, Donna Malpezzi is the example of working hard, putting in many long hours, sacrificing herself, her health, and her family for the taxpayers.

Donna, we will miss you, we appreciate you, and God bless you in all that you do. Thank you.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Mr. President, just remember today, while the temperature is around zero degrees with wind chills, 15 days until pitchers and catchers report to Florida.

Mr. President, I want to take a minute to talk about Senate Bill No. 4, which we mentioned. Senator Aument and Senator Scarnati worked very hard on this bill. Last year that bill passed through this Chamber, I believe unanimously, and through the House, and it is a constitutional amendment. Some concerns were raised this year by some of the organizations and local governments. What are we doing? Really, we are trying to take back the constitutional authority to the legislature, but knowing that there are some concerns there, we thought that maybe we ought to do at least one public hearing on this. So, I want to publicly thank, because I was one of those who expressed concern, the chairman of the Senate Committee on Finance, Senator Eichelberger, who will be doing a hearing this week on Senate Bill No. 4 to clear the record and to have information disseminated that I think will be beneficial to all. Senate Bill No. 4 may move forward here in this Chamber and then to the House of Representatives.

I also want to thank Senator Scarnati and Senator Corman for agreeing to allow the hearing to go forward. I think it is very important that we standing committee chairs sometimes, we know what is in the bill, the public does not necessarily know what is in the bill, or there may be some misinformation out there, so I think it is a very important step in the process that we, as standing committee chairs, have these public hearings when we do a significant piece of legislation, such as a transportation bill, such as liquor bills, that I think that we really have to learn more to do that type of function as chairs. Again, I want to thank them for allowing this hearing to happen. I think, talking to Senator Eichelberger, some of the witnesses that he has lined up will help clear up the matter once and for all, and I think that it will put us in better shape.

So, Mr. President, I just want to take this opportunity to thank those Senators for working with us. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I just want to rise very briefly to discuss the issue that was raised by my friend and colleague from Montgomery County, the issue of Senate Bill No. 4.

First, I think it is important for the Members to know that we did discuss this legislation intensely last year. Senator Brubaker, I think, was the prime sponsor and we had a lengthy discussion along those lines. The vote total was 30 to 20, 30 Members voted for it, 20 Members voted no. I think what the gentleman was

recalling was the previous Session where I believe it was a unanimous vote at that point in time. I think since then continued opposition has been raised about the validity of, or I should not say the validity but more so the consequences of Senate Bill No. 4 as it relates to amending our Constitution. Mr. President, we had an extensive debate in the Committee on Appropriations last week and it was a 14 to 12 vote, and that particular committee, a bipartisan vote on the negative side, of course, but at the end of the day, the conversation needs to take place. I think it is an important conversation about where we end up with once, if in fact we do get to a place where we amend the Constitution. There are some who believe that Act 55, which has not been ruled unconstitutional, would end up ruling the day if we, in fact, passed this legislation.

There are some who believe that today, and we may hear some testimony to this tomorrow in the committee hearing, that Act 55 does not need a constitutional amendment to allow us to define public charities, and I think that is what is at the crux of this issue. If, in fact, it was an issue that was solely related to developing and investing in this Chamber, and this body, this General Assembly, the authority to craft a public charity act, that would be one thing, but unfortunately, given the language of the Pike case, as it relates to Act 55, and as we move forward, with respect to a constitutional amendment to Senate Bill No. 4 and Act 55, how they are blended together, they rely upon one another as we go forward. The uncertainty along those lines is what is important for us to discuss. What we believe we should be doing is rewriting Act 55, a new Public Charity Act, and we believe that we need to continue to provide to our local governments, our local municipalities, our local school districts, our local counties, the ability to be able to get folks to the table. As I said before on this floor, and I said in those committee meetings, pre-Act 55 you could stack up the payment in lieu of taxes this high from the floor to here. Today, you cannot find a payment in lieu of taxes because we have shifted the pendulum away from our local governments with Act 55 and moved them over to primarily the large institutions. And folks, let us be clear; that is what we are talking about. We are not talking about our small, regional community hospitals. We are not talking about the local nonprofits that do well and would meet the HUP standard, given their own opportunity to do so. We are talking about the large institutions, who many in this room believe have strayed from their mission, they have strayed with respect to their profit motive and the things that they do in our communities, and that is what I think the people in this Commonwealth want us to take a look at. The pendulum has shifted away, now the *Pike* case has brought it back over to the other side.

What do we need to work towards? We need to work toward the appropriate balance, in my view, where we give our local governments the authority to be able to get folks to the table and have a meaningful, reasonable, rational discussion about what role public charities play in terms of providing services to our local governments, how they help us pay for our police protection and fire protection if they exist in those communities, how they help us pay for other municipal services and public work services and what role they play in giving back to our communities. That is what needs to be at the table. Unless you have a proper, appropriate piece of legislation that does that, Act 55 does not do that. There are some who believe the *Pike* case goes too far. We have to find that happy balance, and our belief is, if

we do a constitutional amendment before we have that discussion and that conversation in great, great detail, we will end up with Act 55 again, which to me is too far on the one side. And I think too many folks along those lines, and unless we incorporate openness and transparency and how we define and how we work to make certain that these nonprofits continue to serve the mission that we provide them to serve, we provide them with the tax-exempt status, and call upon them to provide services. Until we take a look at that, we should not be moving forward with Senate Bill No. 4. We should wait until that conversation takes place and go forward from there.

At the end of the day, who is paying for this? At the end of the day, it is every single one of our taxpayers who are paying because they are losing the opportunity to be able to work with a nonprofit, our large institutions being able to receive from them resources that they can then apply to services in their respective communities, again, most notably police and fire and municipal, public works type services. When you do not have those resources coming in for our large institutions, every one of our homeowners is paying for that, and every one of our folks who are working in their communities, their tax dollars are being used to cover the cost of what otherwise would have been covered by these large profit institutions. They need to be a part of the solution in our communities, and when you look around this Commonwealth, particularly a lot of our middle class cities, our third class cities in particular, and I know we deal with it in the city of Pittsburgh as a second class city, when we look at our large third class cities and how much of their property is consumed with nonprofit, large institutions, how we are disadvantaging and asking the people in those communities to share disproportionately in the burden of providing the services in our Commonwealth. So I ask all of my colleagues, that while we are going to have a hearing tomorrow, my hope is that we can put off Senate Bill No. 4 until we have the appropriate discussion on how we define public charities, and find out from this hearing whether or not we have the legal authority to even amend Act 55 to allow us to put together language as it relates to the *Pike* case and trying to find that appropriate balance.

I thank the Members for their patience. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Rafferty.

Senator RAFFERTY. Mr. President, just a brief comment. I agree with my colleague on many of his stances. It was not a partisan vote in the Committee on Appropriations. Mr. President, I just want to reiterate that if this legislation does move forward in the Senate of Pennsylvania, there is time, and I agree with him, we have to put out the parameters because it is townships. I can cite a township in my district that has three facilities, two of which use every first responder for that municipality and pay nothing, so it is happening all throughout this Commonwealth.

It is time we addressed it, gave those local governments some of the authority, and worked with them on it as well. I know Senator Eichelberger and some of the other Members who were very instrumental in Senate Bill No. 4 are not going to say, all right, we passed Senate Bill No. 4, and sit back. I agree with the gentleman from Allegheny County. I think there has to be discussion on it, and we have to plan for what we are going to do to allow those municipalities to rightfully have some kind of payment in lieu of taxes for the services rendered. Not just first responders, but all of the services rendered there within that munic-

ipality. I think that tomorrow, and I will go back to my original comment, a public meeting, public education, information obtained is a big first step in the right direction, and I commend Senator Eichelberger again and the Committee on Finance.

Thank you, Mr. President.
