With the help of medical specialists and a good social support system, a woman with Turner syndrome can live a happy and healthy life.

Dana-Lynne Bozym from Throop, Pennsylvania, the 22nd Senatorial District, is a very proud mother of Carly-Joy, a beautiful little 7-year-old who was born with Turner syndrome and is truly a miracle. She is a miracle because only 1 percent of children afflicted with this syndrome survive full-term pregnancy. Although only 7, she has endured many traumas and she only wants to use it to her benefit. She someday wants to become a children's heart doctor. Instead of becoming a cardiologist, she is going to become a pediatric cardiologist. She says she wants to help babies and have them not be afraid of doctors or pain. So for little Carly-Joy and other miracles out there, let us join the host of other States who have declared February as "Turner Syndrome Awareness Month."
