Prior to this year, she medaled at the State meet in her freshman and sophomore years, helping her team win the 2013 Class AA State team championship. Leading up to her win this year, she also won her conference and district meet. She is a three-time district medalist in cross country. Ally is a junior at Dallas High School, where she is active in all school events. She is vice president of student council and she is also part of the student leadership in civics club, which is a group that is designed to better serve the community by offering community service projects, and many are focused on our veterans. She is a member of Junior Leadership, a program for high school juniors teaching them how to better provide leadership abilities in working for large charity events. She has written articles for her school newspaper, and she is the sports editor.

I also would like to introduce the second-place PIAA champion, Lindsey Oremus. She is the daughter of Chris and Maureen Oremus. She has been a member of the cross country team at Dallas High School throughout her 4 years of high school. She has qualified to run in the State meet every year, with her biggest accomplishments coming during her junior and senior years. As a junior, Lindsey finished 14th individually to help her team become the PIAA State Cross Country Champions. This past year she finished fifth, and Lindsey brought home the silver medal individually. In addition to her love of cross country, she competes on the track team, where she runs the mile. She finds time to be involved in school projects, she is student council president, and is a member of the Dallas High School Mini-THON club. Lindsey also volunteers for her local ambulance association, the Franklin-Northmoreland Township Volunteer Ambulance Association, and is a junior firefighter with the Franklin Township Volunteer Fire Department. Lindsey, as a senior, has been out visiting colleges, and she hopes to obtain a career in college while both running and pursuing her degree in nursing.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, I want to thank you first for the opportunity to have the ability to speak to my colleagues, as well as to those of our public, our constituents who follow what happens in the State Senate. What I want to begin today, Mr. President, is a conversation on the pension issue, something that has been much discussed over the past few years and I believe is one of the most pressing problems facing us here in Pennsylvania. It is a huge issue, one that impacts every citizen in the Commonwealth, whether they are retired, current or future employee of the State or our school systems, a municipal worker or municipal government leader, and everyone else who, as a result of this crushing debt load that we face and the unfunded liability, is paying more and getting less in terms of an education or government services.

Why are we not discussing this? I guess that is why I am standing here today, Mr. President. I cannot understand why we have not had a full conversation about the issue of our pension problem, how we got here, and what we are going to do in the future. I know plenty of plans and legislative initiatives have been released, and I know there are more to come. I personally would say that all of them have missed the mark. While most of them purport to resolve the pension funding problem going forward by switching new employees and school personnel to new pension plans, they do nothing to resolve the \$50 billion unfunded liability that we face right now. Furthermore, all of the legislative initiatives to date only address State and school employees. It is widely recognized, and even our State Auditor General recently released a report on the fiscal problems facing municipal pension plans in communities large and small throughout the Commonwealth. What is truly missing from the conversation to date has been a focus on policy. The solutions brought forth have been political, rather than thoughtful approaches to the pension issue.

I think, Mr. President, that it is time to reframe the conversation. We need to look beyond the numbers. This is not just about a choice between a defined contribution plan or a defined benefit plan, or some other variation thereof. But also, it is about workforce development. What do we want our future workforce to look like in the Commonwealth? This matters to our future, certainly, and our economy. We should be talking about retirement security for employees and a sustainable funding formula for future benefits. We can get to that, Mr. President, but we have to commit to a data-driven, transparent, and open process that brings the stakeholders of pension plans to the table, as well as expertise to give us the best menu of options for the way going forward. That is what I really believe has been missing from this conversation.

Next week, I will introduce legislation that calls for that process through the establishment of a public pension review commission to initiate a process similar to what we did when we looked at transportation funding—and it worked. It was a way to get to the best ideas, and then the legislature has something to vote on that is substantial, and people have a transparent and open process and something to understand exactly what this government is doing. I hope to encourage the public, as well as my fellow legislators, to consider this, learn more about it, and I hope that we can begin that conversation. I know for sure, Mr. President, I will continue to talk about this because I think there is a way to get to some of the best solutions, and I hope to be part of it. Thank you very much.

The PRESIDENT. The Chair thanks the Senator for her leadership on this issue, and also now recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, I want to rise today and just say a heartfelt thanks and gratitude to so many of the Members in this Chamber who, over the last several days and week since my father's passing, have extended condolences and sympathies. I cannot tell you how much that has meant to both myself, of course, and my mom during this very difficult time. I apologize, I lost my voice today, Mr. President, actually probably over the last couple of days. Every time I thought about it, and I have said it many times here, we argue about issues in this Chamber and debate, sometimes very heated, but at the end of the day there are good, genuine people in this room who come here with the best of intentions. At times like this, when you really need support, they are there, and it does not matter what side of the aisle you are on. I really appreciate that, and I know that my mother appreciates that as well.

As you know, on a personal note, Mr. President, my dad was a big fan of yours. He really enjoyed watching your campaign and was really delighted with the opportunity to vote for you. I remember him talking to me about it many times. So I want to thank you again, and thank everyone for their support. It really is amazing. I was giving my dad's eulogy yesterday and thinking about it, my mom and dad were married 49 years, Mr. President. They would have been married 50 years in May. Two folks who met when they were 13 and 14 years old. So truly a love story that is really one for the books and it was really very, very touching to hear my mom talk about the two of them and how they met.

So, thank you again, Mr. President, for allowing me to take some time today to thank everyone for reaching out and being there for me. I sincerely appreciate it. Thank you.

The PRESIDENT. The Chair also recognizes that your dad was a great guy whom we will all miss, and our prayers and sympathy are with you and your great mom, Madeline. Your dad is in heaven and knows that he has a great son, and he was very proud of you for all of your accomplishments. So the Chair once again thanks the Senator.

The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, just a comment. First, I add my voice to the chorus of the people who support the Senator from Philadelphia and what he is going through right now. It is always a tough moment for all of us. We certainly support him and his family during these days.

Briefly, Mr. President, I took note of the Senator from Berks County and her comments dealing with pensions. I applaud her for stepping up and saying or identifying that this is a problem. There are some in this building who do not think that it is a problem. I suggest that it is, and it is a significant problem. Certainly, we have had commissions in the past that have been very successful, and maybe her idea may work as well, but this is a thisyear issue. There is no waiting past this budget for this issue to be resolved one way or another. I know my friends on the other side of the aisle put a plan together last year, and the last couple of years, to try to deal with this issue. We put some ideas forward as well. This year we have to come together and solve it. The taxpayers are going to demand it. They are going to need it. If we are going to make the proper investments of basic education in the classroom, if we are going to make the proper investments in economic development, if we are going to make the proper investments in areas around State government that we would like to do, we have to harness the growth of our contributions to the public pension system, and we need to do it this year, Mr. President.

So we look forward to the debate, we look forward to the comment. I am sure, like any good compromise, it will not be all of our ideas or all of your ideas, but at the same time we need to get to common ground with the other side, with the Governor, and with the House, because the property owners back home are going to demand it as their property taxes are going up, their services at the local level are being cut because they have to pay their obligation. Our lack of investment money into basic ed and everything else is because of the money we are putting into the pension fund. So we look forward to the discussion, we look forward to the debate, but make no mistake, it is a this-year issue. We cannot wait any longer.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I want to thank the gentlewoman from Berks County for her comments, and the Majority Leader's comments regarding this issue. We agree that this needs to be a discussion that needs to take place. I think what we have to recognize, however, is that as we go forward, we have to make certain that what we talk about through this process is relief in a variety of ways, school district relief, for example. It is the short-term relief that we are looking for, whether it be for our school districts or whether it be for our Commonwealth as whole, and that plays itself into the discussion as it relates to our budget.

With respect to long-term relief, I know there are issues and concepts out there that have been advanced that I think present potential problems for us, as we talked about before. I think that is something we have to be cognizant of. We do not want to make worse or exacerbate the unfunded liability issue that is out there, for example. So we need to be cognizant of that, but at the same time, we know that we have to make long-term changes as we go forward. But, most importantly, we are looking, in this particular budget, to begin a process that provides short-term relief to our school districts and to our Commonwealth to allow us to be able to manage and use those resources that we will be able to save from doing that to offset the significant structural budget deficit that the Wolf administration was left with so that we can manage through this process and make investments in Pennsylvania as we go forward.

So we look forward to that conversation, Mr. President. Thank you very much.
