We had to talk about property tax reform.

Your support, involvement, and enthusiasm helped motivate these young men to win at the highest level.

As I followed their path to the title, what impressed me most was their sense of loyalty. Jake dedicated his postseason to his friend and former training partner Nick Gavazzi. In February of this year, the 2014 valedictorian of Charleroi Area High School, Nick Gavazzi, a member of the Clarion University wrestling team, died tragically in a car accident. Off of the mat, Jake wore a sweatshirt with a photo of his friend with the message, "Wrestle 4 Nick."

These two young men have revealed their character on and off of the mat and have made their South Park community proud. On behalf of the Senate of Pennsylvania, I would like to congratulate Jacob Wentzel and Gregory Bulsak. I respectfully ask my colleagues to join me in welcoming these young men in giving them a round of applause.

The Cougars won the championship game by defeating Archbishop Wood Catholic High School by a score of 46-40. Through their hard work and determination, the team amassed a season record of 28 wins and 3 losses. Please join me in recognizing their outstanding accomplishments.

Also visiting the Capitol today from the district are the South Side/Western Beaver Co-op Gymnastics Team and their coaches. They won the gold division in the Pennsylvania Scholastic Team Gymnastics Competition by capturing first place with a score of 145.6, edging out Moon High School.

At this time, we wish to recognize his life and legacy and reflect on his service to the Commonwealth.

A graduate of Duquesne University and the university's school of law, Senator Lamb served in both the Pennsylvania House of Representatives from 1958 to 1966, and in the State Senate from 1966 to 1976, where he was elected Senate Majority Leader from 1971 to 1974. After retiring from the legislature, he remained active as a member of the boards of trustees of the University of Pittsburgh and Robert Morris University. He served as vice chancellor of government relations, also at the University of Pittsburgh, and was the first board chair for the Port of Pittsburgh Commission. In 1986, he answered the call of then Governor Bob Casey to become his Secretary of Legislative Affairs.

In his later years, Senator Lamb resided in Mount Lebanon, Pennsylvania, in the 37th Senatorial District, which I have the honor to represent. Our hearts go out to his wonderful family, his wife, Barbara; his children, Thomas Jr., whom many of us know, James, Michael, and Barbara; and his many grandchildren, siblings, and extended family.

A Navy veteran of World War II by circumstance, lawyer by trade, and consensus builder by nature, Senator Lamb's career in public service is a lesson in what this legislative body should be, and is, frequently at its best, a place where relationships matter and compromise is to be respected and worked toward. A study in humility, Senator Lamb will be greatly missed by all. I respectfully ask my colleagues to observe a moment of silence for

our former colleague Senator Thomas F. Lamb and ask that we keep the Lamb family in our thoughts and prayers.

Cystic fibrosis, commonly referred to as CF, is a genetic disease affecting about 30,000 children and adults in the United States, more than 1,600 of whom live in the Commonwealth. The disease causes the body to produce an abnormally thick, sticky mucus that clogs the lungs. These secretions result in life-threatening lung infections and obstruct the pancreas, preventing digestive enzymes from reaching the intestines to help break down and absorb food. More than 10 million Americans are symptomless carriers of the defective CF gene. With advances in the treatment of CF, the median age of the survivors has risen to 41.

I want everyone here to think about this young woman. She won the Miss Philadelphia contest by singing and she has to do 2 hours of treatment every day just to be able to exist. She is an inspiration for everyone who has ever suffered with this disease or has friends who do. I am especially pleased to welcome her to

the Senate, and I ask that we all give her a very warm welcome and wish her much success in the Miss Pennsylvania contest in June.
