Studies have shown there is a genetic component to this disease, but we really need people to realize the dangers and hopefully we will get people who are willing to offer a lung for transplant. Thank you very much. I ask for unanimous approval.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

We all want to wish Senator Farnese a very happy birthday.

Senator FARNESE. Mr. President, thank you. My mother is home right now probably smiling and cheering that you let the cat out of the bag.

The PRESIDENT. Well, she should be very proud of her son, the Senator, as we all are.

Senator FARNESE. Mr. President, I wanted to rise today to speak about an issue that I know many of us--I think we all want to believe in our hearts and our minds that when it comes to issues of equality or free speech or acceptance or tolerance, that especially we as legislators, as people who are elected by our constituents and our peers to represent them, that we believe in those principles and that we expound those principles of equality and that we protect the right for all citizens to be free, to be heard, and to express themselves, no matter how they feel. Of course, we know from the rule of law that there are limits, reasonable limits, of course, put upon our freedoms that we enjoy as citizens.

Something earlier today came to my attention by a dear friend of mine, a woman who I know very well, a friend of mine, Patty Armando. She brought to my attention the case of Evan Young. Evan Young was a high school senior at a charter school in Boulder, Colorado. Now, Evan Young was the valedictorian of his class, a young man with a 4.5 GPA, who is on his way to a full scholarship, I believe, at Rutgers University. He was chosen to give the valedictorian speech and, in the process of that, gave his speech to his principal and the administration at the school. Well, lo and behold, after reading the speech, the school board found out that, in addition to being an extensively bright and articulate young man, and a student who was on his way to a full scholarship with a 4.5 GPA, he also intended to come out to his classmates and also, Mr. President, to his parents, who at this time had no idea that he was gay. He did that because he believed that his school and the principles that they espouse are those of tolerance and acceptance and of free speech. Well, to make a long story short, the school board got hold of the speech and quickly prohibited him from giving it. To make matters worse, they went out and outed Evan Young to his parents who, at this point, did not know that he was gay. They prohibited him from speaking at the May 16 graduation ceremony.

I say this because, how many times do we talk about tolerance, acceptance, issues of free speech? Whatever you want to grasp onto there. We, as citizens, not just as elected officials, but as citizens, have to come to realize that there are still places in our own country where we are not accepting of individuals, that we are not tolerant of individuals, and that we will do whatever we can, unfortunately, to quash or to prohibit their right to speak freely, to speak about themselves. What more free way is there, Mr. President, than to speak about one's own self? About what one feels in their heart and about what one feels that they want to share with classmates with whom they have spent at least 4 years, and in some cases longer times, that relationships that go on, that hopefully will carry on through their time in college. This young man learned a very important lesson and a very harsh one, that there are places in this country, in the United States and in the world, quite frankly, that do not allow freedom of expression and the harsh reality of this young man, Evan Young, was that he found out that this very place was home, a place that he called home. This charter school in Boulder, Colorado, Mr. President, actually, the name of the school is Twin Peaks, and I happen to be a huge fan of the television series, which was a long time ago and it only had two seasons, but I am hoping that they are going to bring it back, and although they may have darn good coffee, they certainly do not know a damn thing about equality and freedom of speech, and they should really get their heads put on right.

What this young man did was he went out and made sure that his message was delivered. A blog known as Out Boulder put a copy of his speech or his remarks--he never got a chance to actually give those remarks, Mr. President, he was prohibited from doing so, he never got a chance to give the speech that he had prepared--but he was able to post a statement online. I would like to read that to you because I think it is critically important for us to think about this. I mean, here we are, an 18-year-old student graduating, which is most likely supposed to be one of the greatest times in his life and in the life of his family and his friends. He achieved something that does not happen very often, and that is why there are only one or two folks who actually are valedictorians. This young man came face to face smack with the harsh reality that there are people, literally in his own home, who are intolerant of him and wanted to silence him and, in fact, tried their best to silence him. I give Evan Young credit because he would not be silenced and the community around him would not allow him to be silenced. His family and his friends were strong enough that they rallied around him and they insured that he got an opportunity to speak. This is what he said: (*Reading*)

My name is Evan Young. I was the valedictorian of Twin Peaks High School's 2015 graduating class, but was not allowed to deliver my prepared speech at the graduating ceremony on May 16th.

The school's administration maintains that I was prevented from speaking "to preserve and protect the mission of the school." However, my school's mission is one of promoting tolerance and respect, and it is these values I sought to promote in my graduation speech. The central message of my speech was that you must learn to respect people even if you disagree with them, a lesson which I learned during my four years as a student at Twin Peaks High School, and I thought briefly disclosing my sexual orientation in my speech would be the perfect catalyst for this discussion.

I understand such a revelation might be difficult for some people, but my main point was precisely that even if they don't agree with me we can respect each other's opinions. My friends and I disagreed about many things over the years, but we learned to overlook our differences and respect one another. In my speech, I merely asked the audience to do the same to me.

Lastly, I'd like to make clear my reasons for bringing this to the press. I'm not angry or bitter, and my frustration at being prevented from speaking at my graduation has largely subsided.

I love my school, and I want nothing to happen to it save that which will improve it in the long run. Nor am I doing this for publicity or even to seem like a hero. I'm not a hero and the overwhelming support I've received from friends, family, and even people who I've never met show that I had nothing to fear to begin with.

Rather, I'm bringing my story forward so that it may serve as an inspiration, not only to other LGBT students, but to any student who is in some way different. I want them to know that they should not be ashamed of who they are. They can celebrate their uniqueness, no matter what people in authority tell them. They can achieve academic success, if they let nothing hold them back. They can become virtuous and compassionate; their differences don't make them morally inferior. That is what my school is all about.

So, I read that because I think that in many ways Evan Young is a hero, because he espoused the principles that our country was built upon. Like the people we have around us in this magnificent Chamber, he had the guts and the determination to speak his mind, to let people know how he felt, and to share something very important with the people whom he loved and he trusted, which were his family and his friends with whom he was graduating. Unfortunately, there was a group of people who were intolerant to his beliefs and intolerant to what he wanted to do, just like years ago our forefathers found the same intolerance when they chose to exercise their independence.

I think there is a lot that we can learn from Mr. Young. I think that there is a lot that we can learn that says we are not as far along as we should be as a country, as a civilization, as a world, and as a people when we still do what we can to extinguish freedom of speech and expression. We all know, Mr. President, that freedom of speech and expression is not an absolute right, that there are reasonable restrictions placed upon it. I have stood at this pulpit many times and made that argument on other issues, on other rights that have been given to us through our Constitution and that we enjoy as citizens. You certainly cannot go into a crowded movie theater and yell "fire" and expect to be protected by free speech. This young man, I think, honed in on something that we need to be more cognizant of and to realize that we are not a tolerant people, all of us. We are not where we should be. We practice it and we try, but we still are held back by our own inferiorities and our own fears. I hope that Evan Young, in his speech and the folks who hear his speech, are motivated to come out and to share their beliefs and to share what they feel is

important to them, because at the end of the day, that is what this great country was built upon. It was started because of intolerance, and I hope, Mr. President, that at some point in its history that we are able to say that intolerance has been extinguished. But we are not there yet.
