**SENATE BILL RETURNED WITH AMENDMENTS**

The Clerk of the House of Representatives returned to the Senate **SB 293**, with the information the House has passed the same with amendments in which the concurrence of the Senate is requested.

**BILLS REPORTED FROM COMMITTEES**

Senator WARD, from the Committee on Community, Economic and Recreational Development, reported the following bill:

**SB 756 (Pr. No. 1009) (Amended)**

An Act amending Title 64 (Public Authorities and Quasi-Public Corporations) of the Pennsylvania Consolidated Statutes, in Commonwealth Financing Authority, further providing for First Industries Program expiration provision.

Senator SMUCKER, from the Committee on Education, reported the following bills:

**SB 694 (Pr. No. 693)**

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in grounds and buildings, further providing for approval by department of plans of buildings and exceptions, providing for accountability and reducing costs in construction process, further providing for limitation on new applications for Department of Education approval of public school building projects; and, in reimbursements by Commonwealth and between school districts, further providing for definitions, for approved reimbursable rental for leases hereafter approved and approved reimbursable sinking fund charges on indebtedness, for payments on account of leases hereafter approved and on account of sinking fund charges on indebtedness for school buildings hereafter constructed and for payments on account of building costs and providing for lump sum reimbursement for construction or reconstruction.

**SB 862 (Pr. No. 981)**

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, further providing for criminal history of employees and prospective employees and conviction of certain offenses.

**HB 131 (Pr. No. 1695) (Amended)**

An Act amending the act of December 15, 1982 (P.L.1266, No.287), entitled, as amended, "An act conferring limited residency status on military personnel, their dependents and civilian personnel assigned to an active duty station in Pennsylvania," further providing for attendance at State-related and State-owned institutions of higher learning and community colleges.

**HB 762 (Pr. No. 1051)**

An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in preliminary provisions, providing for powers and duties of the Secretary of Education.

**SB 282 (Pr. No. 1008) (Amended)**

Anthony is the son of Tom and Janean Litz. He is using one of his scholarships to pursue an associate's degree in automotive and diesel technology. He would like to further his education at Kettering University and hopes to become a mechanical engineer.

So proudly, these two impressive students are joined by Dr. Mark Watson, who is their automotive technology instructor; Robert Schwartz, who is a school board member; and Dr. Joann Hudak, who is the assistant superintendent. Senator ALLOWAY. Mr. President, Senate Bill No. 78 is one of the many bills that we put forth as our pet protection package here in Pennsylvania, and I want to speak to this bill. This bill, very simply, allows the Department of Agriculture's Dog Law Enforcement to, whenever they identify a bad kennel owner and they close that kennel down, that kennel owner cannot just transfer that license to a family member, a spouse, a brother, sister, or a child and continue to operate a bad kennel. I ask for an affirmative vote on this bill.

This bill is part of a larger package that we started a couple of years ago here in the Senate. I want to recognize my friend from Chester County, Senator Dinniman, for his work along with me on this pet protection package. I want to thank my colleagues who have worked hard to try to gain consensus on these bills. I know sometimes these bills can become emotionally driven. We have tried to stick to the facts and be reasonable. Senator Dinniman has been there working with me to move this package forward, and this is one of that package that we are highlighting. I ask for an affirmative vote.

Senator DINNIMAN. Mr. President, I want to thank Senator Alloway for working with me on this legislation that has gone through various committees, not only the Committee on Agriculture, but the Committee on Judiciary and others. Dogs are not Republicans or Democrats. Dogs are our friends. And when any legislator goes home, his wife might not say hello from the other room, his children might ignore him, but we know that dog comes and welcomes us home, so let us be thankful for that.

This legislation is aimed to create a more humane Pennsylvania. Many of these bills do not just involve protecting the pet, but involve protecting human beings as well, because the way we treat animals is reflective of the way we treat each other. So I want to thank Senator Alloway for his leadership. I hope we can get the whole package through today. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Franklin, Senator Alloway.

Senator ALLOWAY. Mr. President, this, again, is another bill that is a part of our pet protection package here in Pennsylvania. We have worked on this bill for a couple of years now. This is known as the anti-tethering bill, which is a little misleading. It sets reasonable guidelines. I want to say for the record that as the maker of the bill, the legislative intent is not to go out and use this bill as a hammer to go after people. This bill has a large education portion to it where we want people to understand that when it is zero degrees out and the wind is blowing, that it is not okay to tie your dog out all night to a tether, and that is just something that people need education on.

So, I want to thank, again, there are a lot of Members of this body who had input into this bill. We worked with a lot of different interest groups who were concerned about this bill.

Also, I want my colleagues to know that this bill was pretty much lifted identically from the Pittsburgh ordinance. The city of Pittsburgh passed this legislation quite a few months ago and it has been working out well there. We felt that this was something that was reasonable, that we could live with, and we took the language with this bill. We have had hearings. I want to thank Chairman Greenleaf for coming down to my district to air a hearing to make sure we got the facts out there, and I think this is a great step forward for all Pennsylvanians and for the ones that we love. I actually have a sticker in my office and it says, "Dogs are family. Would you tie grandma out on a chain?" So, please remember that when you are voting today.

Thank you, Mr. President. I ask for an affirmative vote.

The PRESIDENT. The Chair recognizes the gentleman from Monroe, Senator Scavello.

Senator SCAVELLO. Mr. President, I want to commend Senator Alloway for Senate Bill No. 373. For the past 10 or so years I have introduced something similar, not exactly the same, in the House of Representatives. Why I did it--in my district, two dogs were left out in about 2 feet of snow, and then we had a heavy rain afterwards when the temperature dropped, and the dogs froze to death. You just cannot do that. If you want an animal, take care of the animal. Do not just tie them out to a tree and forget about them, not feed them, not give them water, and that is what this is really about. This is about treating dogs like they were really your friends, because they are. I think that it is about time that we protect them, and this bill will do that.

Senator HUTCHINSON. Mr. President, I rise to offer this resolution recognizing Friday, June 5, 2015, as "PA Sustainable Forestry Initiative Day" here in Pennsylvania. For 20 years, the Pennsylvania Sustainable Forestry Initiative and their implementation committee have met monthly in State College to encourage and promote efforts to preserve the vitality of one of our State's greatest national resources, that being our forest areas. Since its inception, the committee has worked to establish a logger training program and provide educational outreach to landowners and the public. More than 7,000 individuals have participated in the logger program over the past 20 years, with approximately 700 maintaining a current training status each and every year, and some loggers having completed more than 100 hours of total training.

Mr. President, the benefits of this training program were further recognized and bolstered when the Bureau of Forestry adopted a policy back in 2007 that required all commercial timber harvesting activities on the State's 2.2 million acres of forestland be done by trained loggers. More recently, the Pennsylvania Game Commission also recognized the benefits of the training program and encouraged its loggers to participate. In addition, more than 26,000 landowner outreach packets have been distributed, and the Internet has allowed for an even further audience for this great information. Pennsylvania was also part of a joint effort involving people of all ages and backgrounds from across the United States and Canada who came together last month to break the Guinness World Record for the most trees planted in one hour by small teams. Mr. President, as a member of the Pennsylvania Hardwoods Development Council, as well as chairman of the Joint Conservation Committee, I support and appreciate these efforts and ask for an affirmative vote on our resolution today.

Senator TEPLITZ. Mr. President, I am submitting my comments for the record.

The PRESIDENT. Without objection, the remarks will be spread upon the record.

*(The following prepared remarks were made part of the record at the request of the gentleman from Dauphin, Senator TEPLITZ:)*

Mr. President, on Wednesday, April 15, 2015, the Senate Committee on Finance voted unanimously on Senate Bill No. 386. As a Member of the committee, I voted in favor of reporting the bill out of committee.

Subsequent to my vote, I realized that this bill involves a company that is a client of the government relations firm affiliated with the law firm with which I am affiliated. The government relations firm and the law firm are separate entities. If I had been aware of this information at the time of the Committee on Finance meeting, I would have requested a ruling from the committee chairman pursuant to Senate Rule 20(c), asking whether I was permitted to vote. In order to address this issue after the fact, following discussion with our Caucus counsel, I sent a written request to the Secretary of the Senate dated April 20, 2015, explaining the situation and asking her to rescind my vote and report my status as "not voting."

By correspondence dated May 15, 2015, the Senate Secretary advised that she cannot make the change and recommended that one way of addressing the issue would be to submit this explanation for the record during Petitions and Remonstrances, in addition to requesting rulings if faced with any future votes on Senate Bill No. 386. Accordingly, during this first Session week back since receipt of the aforementioned response from the Senate Secretary, I am submitting this explanation for the record.

My colleagues and the public should be assured that my committee action was unintentional and that I will request Rule 20(c) rulings on Senate Bill No. 386 and other legislation as appropriate in the future.
